# Impact Clay to relocate its services to Celebration Church

ORANGE PARK – Impact Clay is taking over the emergency food operations from Clay County Emergency Operations Center and is setting up a home base at Celebration Church.

When emergencies like the ongoing COVID-19 pandemic or Florida’s yearly swell of hurricanes hit, food banks become more necessary than ever. They operate throughout the year, giving food to those in need, but it’s during emergencies food banks are able to flex their provisional strength by helping the community. Because more food is given to those in need during these times, food banks, churches, local municipalities and other organizations steer closer to emptying their shelves.

Impact Clay is looking to change that. “We’re pushing people toward food banks now and Celebration Church is leading that charge,” Impact Clay Project Facilitator Gabrielle Gunn said. “Everyone

partnered with us and everyone that’s a part of this upcoming project will go there when they need food.”

The Impact Clay program primarily will serve as storage and clearing house for other food banks. Celebration Church will act as a food bank with Christina Mireles leading Celebration-Impact Clay project known as Food for Clay County. Impact Clay is kicking off with a large food drive and rally next month.

The idea behind is the rally is simple: each food bank or organization that’s a part of the project is assigned a specific food item or necessity. They’ll spend the weeks leading up to the event on July 25 stocking up as much as possible on this assigned item. They’ll bring this item to the food drive in July and by the end of the day, assuming each food bank does their part, Celebration Church will be a treasure trove of essential goods.

This will turn Celebration into a home base of sorts as it will act as the food bank for food banks. If a food bank is running

low on canned vegetables, they can ideally replenish their goods with a quick trip to Celebration. The same goes for dozens of other types of items in hot demand at local Clay County food banks.

“The reason for this is that the EOC is getting people back to food banks,” Gunn said. “There may be an influx in people in need and the food banks are going to feel that. The goal is to create a food drive so large that it [Celebration] can supplement all of the food pantries.”

Mireles said this is just the beginning of what’s planned between Impact Clay and Celebration. She said it’s a huge transition from what the EOC has been doing and that she hopes it continues to grow into mul-

iple partnerships throughout Clay County. She said if you’re someone not part of a food pantry but someone who wants to get involved, she suggested reaching out to a local food pantry. If you’re part of a food pantry wanting to help out, Mireles can be reached at cmireles@celebration.org. “Impact Clay is super grateful that the Celebration Church has taken on the lead,” Gunn said. “The goal for this project is to be a centralized communication point and location for people that want to know about what’s related to food in Clay County.”

## Orange Park schools selected to join Florida Civics and Debate Initiative

**Project part of state’s \$5 million project to promote research-based debate**

ORANGE PARK – Two Clay County schools are receiving funding from a state initiative to kickstart expanded civics education and create two debate teams.

Orange Park High and Orange Park Junior High will use \$5 million from Gov. Ron DeSantis’ Florida Civics and Debate Initiative to create debate teams for students when the 2020-21 school year begins in a few months. The Clay County School District social studies specialist Kelly Watt will help lead the initiative at the schools as she and school volunteers create an environment welcoming of research-based debate.

“It’s an initiative to encourage students in junior high and high school to engage in debate and the big idea is that we know there are tons of benefits for speech and debate,” Watt said. “Right now, in Florida, we want to ensure we have a way to teach civil discourse to our students. Civil discourse is the hallmark of a good citizen.”

DeSantis announced in January that a multi-year \$5 million grant from the Marcus Foundation, Inc. had been secured to elevate civic knowledge, civic skills and civic disposition for middle and high school students through speech and debate. DeSantis announced roughly six months later that he and Florida Commissioner of Education Richard Corcoran had selected 60 schools, representing 28 districts in the state, to participate in phase one of the Florida Civics and Debate Initiative using the Marcus Foundation funding. OPH and OPJH are two of those 60 schools and Watt said the district believes them to be a per-

fect fit for the initiative.

Watt said one of DeSantis’ focuses in office has been the elevation of civics education in Florida. She said he wants Florida to have the best civics curriculum in the nation and these new debate teams will help the state reach that goal. Seventh grade civics in Clay County has been in the top five of the state for a few years now and Watt said this initiative could help them climb even higher.

“It’s important that we teach civics and nurture that in our classrooms and outside of our classrooms with things like debate teams,” Watt said. “Our students need to understand the importance of civility in discourse. As citizens, we have to listen and respect each other, respect each other’s claims, reason with facts and research....applying critical thinking to carefully articulate ideas and support them with research is key. It helps grow the kinds of citizens we need.”

This initiative provides funding to create the debate team, purchase necessary supplies and equipment, pay for training for volunteers, cover the cost of travel and more. Watt said the main takeaway from the funding is that every student that wants to participate will be able to participate and they’ll be able to do so without worrying about money.

“I think those schools receiving the funding, it validates what we stand for and what we believe our students can do,” Watt said. “We’ve always made decisions based upon the firm belief that our students are truly capable of impacting the community. They’re not just going through the motions. They’re learning how they can change, help and impact their community.

“Their experiences matter and this will give them the opportunity to learn to articulate and share their experience, their beliefs and their story and that will make a difference in the world.”

# Project REACH lends support to homeless, unaccompanied children

ORANGE PARK – Homelessness and financial hardship can affect anyone, including Clay County.

When those two things affect minors, it often causes even more problems because it can keep said minor from going to school and getting an education.

These situations can be all too common. The COVID-19 pandemic has created even more of this, with many people being laid off from their jobs.

Project REACH was designed to help homeless and unaccompanied children residing in Clay County.

Minors classified as unaccompanied, are homeless and not in the custody of a parent or guardian. Many children in this condition do not have the means or anyone to provide them with adequate personal hygiene items. In these types of situations, the children will often be reluctant to attend school, and their educational opportunities will invariably suffer.

If they do try to attend school, they may be mocked and ridiculed by their peers. Their mental states will suffer as will their performance.

The Backpack Project wanted to help with these problems. They partnered with Project REACH, to try to identify and help unaccompanied children in Clay County.

Project REACH is a local program designed to help such children to enroll and succeed in school.

They provide many things to help, such as free school meals, school supplies, transportation, tutoring, and case manage-

ment. However, Project REACH, as helpful as they are, has limitations in how they can spend money. They aren't authorized to spend money on hygiene products.

The Rotary Club of Orange Park Sunset decided to help. They purchased 100 backpacks. Hygiene supplies were then purchased.

In March, the bags were assembled; 50 for boys and 50 for girls. The girls' bags contained hygiene items specific to females, including sanitary napkins. On the whole, the bags had shampoo, conditioner, deodorant, bars of soap and toothpaste.

Susana Bentley is with the Rotary Club and was involved in the effort.

"Homeless children; either their parents lost their jobs and cannot pay rent and end up living out of their cars," Bentley said in an explanation of the status of homeless and unaccompanied children.

"Or parents are not involved, and the kids still want to go to school, so they end up

couch-surfing and living with their friends. The Rotary Club intended to provide basic necessities for those children so they can continue to go to school."

The COVID-19 pandemic, though, reared its head and delayed the handout of the bags. Finally, the bags were delivered to Grove Park Elementary School last Wednesday, where they would be handed out to the children who had been identified as unaccompanied youth.

Fourteen members of the Rotary Club of Orange Park Sunset assisted in the preparation of the backpacks.

"The best thing about it," said Bentley, "Is that we are trying to keep the kids in school so that they can avoid poverty. The longer they stay in school, the better-educated they're going to be, and the more successful in life they're going to be."

## Scott warns Floridians the recent surge of COVID-19 is very real

U.S. Sen. Rick Scott discussed the state's recent spike in COVID-19 cases Monday morning, a topic he's been compelled to address more of late.

With daily record case counts commonplace in recent days, the former two-term Governor sounded caution about the virus, by no means resolved.

"Some might be tied to testing but it's clearly not all tied to testing," the Senator said on CNBC's Squawk Box Monday morning.

"We clearly haven't beat it. I think everybody is concerned when they read about the number of cases being up. The deaths aren't growing like that, so that's a positive," Scott said.

When asked if there was a possibility for deaths to catch up to the surge in cases, the Senator demurred.

"You sure hope not," Scott said, adding that "so far" the health care system has handled the surge.

"We clearly haven't beat it. We've got to keep focusing ... we've got a lot of work to do," Scott said, noting the potential of the disease surging in places that may have thought they'd beaten the coronavirus.

"I hope we can stop this and it doesn't come back in places where we've seen a downturn," Scott added.

The Senator also weighed in on the ongoing feud between the current Florida Governor and the Governor of New York, who floated the idea of quarantining travelers from Florida because of COVID-19 fears.

While Gov. Ron DeSantis quipped that Gov. Andrew Cuomo shouldn't sequester Floridians in "nursing homes," a reference to an order earlier in the spring to release COVID discharges back to long-term care facilities, Scott steered clear of the personal attack.

"Every Governor's got to figure out how to keep everybody ... they're responsible for the people of their state," Scott said. "I think Gov. Cuomo's got to make a decision about how you keep people safe and at the same time how you reopen your economy."

Indeed, tough decisions loom, both for parents deciding whether to send their children to schools in the fall, and for potential travelers to the Republican National Convention.

"August is going to be a tough choice month for a lot of people," Scott said about school reopening, which is a "tough job to figure out."

## NASCAR owes fans explanation after racing to conclusions to finding 'noose' in garage

The conversation at the Talladega Superspeedway is generally about racing. NASCAR turned it into race.

Sure there were a few Confederate flags outside NASCAR's most-exciting racetrack ahead of last week's 500-mile race, clearly in defiance to stock-car's recent ban of the battlefield flag. A plane pulled a banner over the track with a Confederate flag and the words "DEFUND NASCAR."

And shortly after the race was scrubbed and moved to Monday by thunderstorms, Darrell "Bubba" Wallace's race team said it found a noose in its garage stall.

Wallace, the only fulltime African American driver in the Cup Series who was a catalyst behind removing the flag, never backed down. In fact, his resolve to racial prejudices and the symbols that come with it, was strengthened.

NASCAR jumped quickly to seize the opportunity to insert itself into the political conversation of the moment, turning Monday's race into a 200 mph civil rights rally.

The problem was, there was no noose. A crewman from another team simply tied a loop at the end of a garage door rope so they could close the door.

And they did it last October.

The FBI sent 15 investigators to Talladega to investigation. It didn't take them long to determine the entire episode was an overaction.

Since the garage area has extremely limited access due to the coronavirus, it should have been easy to find quick answers.

And in the process, they diminished many of the positive conversations Wallace embraces.

I've been around the garage area for more than 40 years. I've seen hundreds of garage ropes with loops or knots to provide something to grab to pull the door down. Go check your own garage door.

NASCAR got it wrong.

The country got it wrong.

The national media got it wrong.

Wallace didn't. His message was on the mark, even if it was based on a false premise.

Bubba wasn't involved in NASCAR jumping the gun – and gaining national attention. His message of equal treatment for everyone wasn't affected by NASCAR's premature announcement. In fact, it's clear he's still clinging to the false claim.

His reaction, however, doesn't help move the sport forward. He admitted Tuesday night the rope was a pulldown, but he said the loop, while it didn't operate like a noose, still appeared to be a noose.

To be true, that means someone would have guessed properly eight months ago

Doctors Lake Phosphorus Removal Pilot Project already showing a lot of promise

Editor:

Another great partnership project is now operational in Clay County as the St. Johns River Water Management District continues work to improve water quality across the region.

Known as the Doctors Lake Phosphorus Removal Pilot Project, this full-scale dem-

onstration project is focused on removing phosphorus from treated wastewater using state-of-the-art technology — an important measure to reduce the overabundance of nutrients that cause algal blooms in Doctors Lake. The project broke ground in September 2019 and officially started operation June 5, 2020, removing dissolved

phosphorus from treated wastewater from the Clay County Utility Authority's Fleming Island Regional Wastewater Plant.

At the project site, treated effluent is pumped and distributed over a vegetated filtration bed that uses engineered media to remove phosphorus. This media binds with phosphorus, removing it from the water. The phosphorus remains bound to the engineered media, so no byproduct is produced. This water is then reused for irrigation in the Doctors Lake watershed.

The District has conducted water quality sampling on Doctors Lake since 1984. For 32 of the last 36 years, Doctors Lake has experienced algal blooms, fueled by excessive nutrients. The project is expected to reduce the phosphorous concentration in the watershed by 90%, and to help improve water quality in Doctors Lake and the Lower St. Johns River Basin (that por-

tion of the river in north Florida).

As we evaluate the one-year demonstration project progress, we will be evaluating the potential to scale and adapt this type of system to help reduce nutrients in other waterways in the region and Florida, another valuable tool for our water quality improvement efforts. It's these kinds of forward-thinking projects that will help reduce the intensity and frequency of algal blooms that continue to impact our beautiful St. Johns River and other waterways.

Thank you to Gov. Ron DeSantis, Sen. Rob Bradley and Rep. Travis Cummings for their leadership and commitment to projects benefitting the St. Johns River, as well as to CCUA for the continuing partnership.

that Wallace's team would occupy that particular stall.

He went on CNN Tuesday night and "... None of the allegations of it being a hoax will break me or tear me down. Will it piss me off? Absolutely, but that only fuels the competitive drive in me to shut everybody up to get back on the race track next week in Pocono under a tremendous amount of B.S."

NASCAR issued a statement Tuesday night saying it was relieved Wallace wasn't the target of a hate crime in the garage area. The group also said it will continue to strive for to "providing a welcoming and inclusive environment for all who love racing."

What NASCAR didn't do was apologize for putting the sport, and everyone else, on edge.

Keep in mind, this is the same organization that ran commercials a year ago proudly stating it's a sport where its members don't kneel during the National Anthem.

Wallace's car owner, Richard Petty, has a history of being colorblind. He often gave parts to Wendell Scott, creating a spot on his hauler called "Wendell's drawer," and



that was in the 1960s at the height of the Civil Rights Movement. Scott is the only African American to win at the Cup Series level, taking the checkered flag at Jacksonville's Speedway Park in 1964.

The only other African American to win in one of NASCAR's three national series is Wallace, where he won six truck series races.

Wallace finished 14th in Monday's race. Nobody will remember that. But the memory of hundreds of crewmen, drivers and NASCAR officials standing with Wallace before the race is something that won't — or shouldn't — be forgotten.

Neither will the fact NASCAR's reputation, especially among its fans and race teams, was smeared by impulsive and unverified claim.

"Masks at recess" was one potential precaution he endorsed.

Likewise, Scott sounded a note of caution regarding the Republican National Convention.

"I like everything to be in Florida, but we have to do it safely," Scott said, offering yet another rebuke to the idea of a 2016 style convention with attendees shoulder

to shoulder and not wearing masks.

"Let's try to get back to normal as fast as possible but do it safely so we don't have an uptick of cases," Scott added.

# One person's clutter is another person's calling

## Rosie Baskett helps residents organize their belongings

FLEMING ISLAND — In modern life, we often hold onto a lot more than we need. Our lives and our spaces become cluttered. That can affect us in multiple ways.

Clutter can be a detriment to our physical and mental health, our relationships and our productivity. Luckily for First Coast residents, Rosie Baskett of Fleming Island is here to help. Baskett is one of fewer than 450 certified KonMari consultants in the world.

Marie Kondo is an expert in tidying up and the art of decluttering. She is also a bestselling author and has her own show on Netflix, called "Tidying Up with Marie."

Kondo is the developer of the KonMari Method of decluttering. The basic premise of the method is to tidy up by category rather than by room. In this way, the result is for the client to be left with a house full of items that spark joy, and for the client to never go back to a life of clutter.

"I read the book, 'The Life-Changing Magic of Tidying Up,' by Marie Kondo," said Baskett. # Pop Warner football coming to Oakleaf Youth Sports this fall

OAKLEAF — A local nonprofit sports association is home to one of the longest-tenured youth football and cheer programs: Pop Warner.

Pop Warner isn’t anything new. It’s been around for years and years and it’s often the starting point for children interested in football and cheerleading. Oakleaf is now home to Clay County’s newest 501(C)(3) youth program and in just a few months, the program will begin its inaugural year. It hopes to teach participants not only how to play football and cheer, but the fundamentals of good sportsmanship as well.

“Our primary mission is youth development by emphasizing discipline, fundamentals and sportsmanship in the field of play, in addition to scholastic achievement,” Oakleaf Youth Sports president Tony Hart said. “This is our inaugural season and we are excited.”

Hart said OYS recognizes that other Oakleaf-based sports associations already exist but said those other programs are members of an independent conference with participants that are only eligible for play in the North Florida region. Hart said OYS provides teams with the opportunity to expand beyond this region through a playoff system.

This playoff system leads all the way to the national championship at Disney World’s Wide World of Sports. Hart said that OYS is just shy of 100 participants, having just reached 92 registrations. They hope to hit 100 before the season begins.

“Participants range from ages 5 to 14 and are required to be a resident with a zip code of either 32065 or 32073, or they can be a 32068 resident attending school at a 32065 or 32073 location,” Hart said. “Our volunteers range from active and retired military, Jacksonville Fire and Rescue Department, state employees and number of small business owners.”

Hart said all volunteers have been

screened through Florida Department of Law Enforcement Level 1 Background checks and are USA Football Head-Ups certified. They must renew that certification every year they plan to participate as volunteers as well.

It’s a unique year to begin a sports association like this, Hart said, pointing out that because of the COVID-19 pandemic, all registration had to take place online. She said that despite the initial challenge, it has allowed OYS to use its website as a one-stop shop for all things football and cheer related for the program. After Gov. Ron DeSantis elevated Florida to Phase Two, OYS held its first community day on June 6.

“Our guests included Associate Pastor Josh Evans of Trinity Baptist, Adriel Rocha from the Jacksonville Jaguars Public Affairs Office, Frank Garis and Merlin Smith, Oakleaf High and Oakleaf Junior High football coaches respectively, and more,” Hart said. “In addition to that, we had food trucks, prizes, a live DJ and a bounce house. It was a success, and all were enthused about our uniform reveal.”

As for getting around the coronavirus, Hart said conditioning was held in a modified circuit training forum with no player contact and limited contact with equipment. Groups are held to 12 or less and stressed to spread out and socially distance while resting or under instruction. The players are enjoying themselves despite these regulations, according to Hart.

“The players are really enjoying themselves and the situation demands the coaches to be creative with the workouts,” Hart said. “We await the final word from the conference on game play, we continue to prepare for whatever safety rules are implemented.”

For anyone interested in joining OYS during its inaugural year, Hart said to check out the OakleafYouthSports Facebook page. You’ll find pictures and videos from conditioning and community events there, as well as links to get involved.

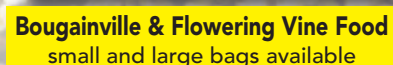
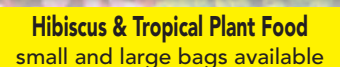
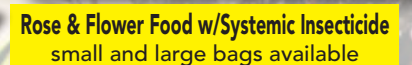

## Edward Daniel VanDyke

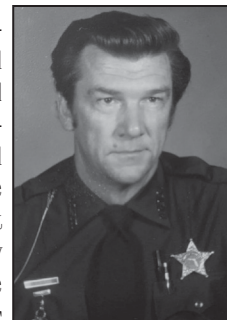

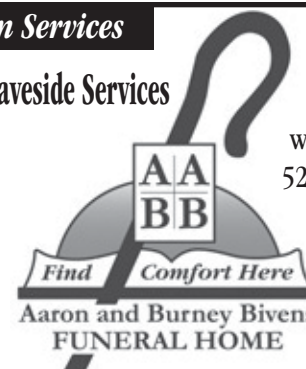

derful. We traveled to Pensacola to visit our Nanny and PawPaw every year and he would stay up all night driving to get us there. He enjoyed watching The Lawrence Welk show on Saturday night with Nanny.

Our Mother died in 2004. Our parents had been married 49 years. She was sick for the last 13 years of her life and my Dad along with Sonya took care of her. Life shouldn't happen this way, but he lost my sister, Sharon Opal in 2012 and my brother Steven Daniel in 2018 and Stevens wife Dana in 2013. He was also preceded in death many years ago by his parents Berge Baxter and Bessie Mae VanDyke, brothers Vernon, Marcus and Arnold and a sister Lucille and his great-grandson Garrett James Stoddard.

In 2005 he married Wilma Sue Hankins and in 2017 they moved to Warsaw, Missouri.

He lived in Orange Park since 1973 so Orange Park was truly his home. He knew just about everyone in town until the growth explosion happened in Clay County.

When our Father passed away, he had only a few grey hairs. He did not look like he belonged in a nursing home. He so desperately did not want to be there, he said he didn't belong with all those old people. He had several strokes and was a shell of what he once was. We, like many have

been affected by Covid 19 and our Dad spent the last week of his life alone with no visitors and he couldn't hold a phone so we could not even talk to him. We are celebrating his life but also mourning his sad passing.

He was far from perfect and not everything was good. There were many rough times, but we know through it all he loved us very much. We will hold his memories close to our hearts and cherish the good ones and the bad ones. (that's life) He was

affectionately known to his grand-children and great-grand-children as "Popsy." He loved to tease all of them. His namesakes are his grandson Chance Edward and his great-grandson Kash Edward. He named Sandy after a wonderful friend of his growing up and Sonya Danielle and Steven Daniel after himself.

Please cherish all the sweet memories you have of our father and remember him fondly.

## Man claiming to be brother of David White’s killer threatens CCSO

ORANGE PARK – A man claiming to be the brother of the man who shot and killed Clay County Sheriff’s Office Detective David White was charged with threatening to shoot a Clay County Sheriff’s Office deputy at the jail after he was arrested for simple domestic battery.

Todd Allen Tilley, 42, of Orange Park, was charged with corruption by threatening a public servant when he told the arresting officer he would “put a bullet in your [bleeping] forehead just like my brother did to David White, that’s a guarantee.”

White was shot and killed by Ted Tilley during a drug raid at a Middleburg mobile home in 2012. Tilley was killed during the exchange of gunfire by other deputies.

Four other people, Ryan Christopher Wilder, Chasity E. Prescott, Jennifer S. Alder and Jerry Daniels all were charged with murder.

CCSO deputies were called on June 20 for a domestic disturbance. Tilley and his wife were arguing over him drinking too much alcohol, according to the arrest report.

The victim said she was struck during the argument. Deputies said she had a red mark on the left side of her face, so Tilley was arrested.

His threatened the arresting officer has he was being placed into a holding cell, CCSO said.

His bond was set at \$27,505.

## Man surrenders at InTown Suites following SWAT standoff

ORANGE PARK – A man wanted for making written threats to hurt someone was arrested June 23 following a short standoff with the Clay County Sheriff’s Office SWAT team at InTown Suites

on Blanding Boulevard Daniel Holtzlander eventually surrendered without incident after he was holed up into his room with his child.

He was wanted in Jacksonville for simple assault and intimidation by sending threats.

Deputies got a tip Holtzlander was in Orange Park. When they got to the hotel, a roommate left the room and told CCSO Holtzlander had his

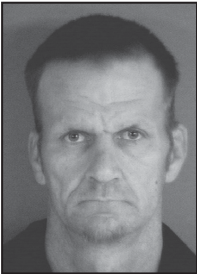

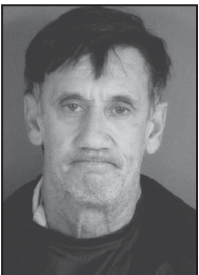

counted for in the budget most recently approved on March 27, 2020.”

The BCC had a lot of questions following Nagle’s presentation. Chairman Gayward Hendry asked if the CARES Act funding should be used for reimbursement of what’s already spent or if it should be used toward new things. Nagle said things like overtime staff payment for police officers and firefighters will be reimbursed through other means and because of that, he recommended that the county use this funding

for new purchases and other costs.

Nagle gave the BCC a large list of possible purchases and spending costs. The BCC, wanting more time to go over the list, approved a small portion of the spending and will go over in detail the other sections at a later date. Ward said that with the BCC approval Tuesday night that Clay County is heading in the right direction in terms of handling the coronavirus pandemic.

“Every penny has to be spent by the end of December,” Ward said. “That’s a quick turnaround but I really believe this can impact the face of the future of Clay County.”

Basketball is not the only activity happening at the gym. When people are there for it, pickleball is also played there.

Regardless of their activity happening, or the maximum 30-person occupancy, people are simply happy that the gym is open again.

"Everybody is just happy and glad that the gym is back open," said Detwyler. "That's been the positive reaction from all the guys coming in; girls and boys."

# Customers show support by keeping Clyde's Cozy Corner Café busy

KEYSTONE HEIGHTS — Connie Murray usually gets to Clyde's Cozy Corner Café at 5 a.m. — two hours before the doors open — and she leaves a few hours after the grill is turned off and the last customer leaves.

In between, she has a fulltime job as an auditor.

Murray was supposed to be a silent partner at one of the town's iconic diners. That all changed when her best friend and business partner, Teri Ankeney got sick.

"When I'm tired and trying to get up in the morning, I get inspired by how hard the people here have supported us," Murray said. "Everyone has really stepped up. Everyone has rallied around Toni."

Ankeney was diagnosed with cancer two years ago. Her treatments are grueling; her battle is relentless and leaves no time to be concerned with daily specials and schedules.

Her recovery has united an entire city.

Other businesses, including other restaurants, have joined with community organizations of clubs to lend their support.

"When we expanded, other restaurants donated extra tables and chairs to get us going," Murray said. "Even the health in-

spector's been good by working with us."

Others have chipped in to help with permits and licensing, Murray said. And many who know Ankeney — and some who don't — have donated handmade trinkets, novelties and crafts to sell at the diner to help with costs.

There are books and ceramic cats on the shelves, next to unique living room ornaments, candles and paintings. Items carved and cut from wood are made by Ankeney's parents. Make no mistake: it's not about buying a piece of treasure. It's lending support to a treasured friend.

"Keystone Heights has humbled me," Murray said.

Ankeney revived the town's American Legion Auxiliary and she's been a strong supporter of the local American Legion and AMVETS posts.

Unlike other establishments, the COVID-19 pandemic didn't cripple Clyde's. The restaurant was closed for a week while it went through a rigorous cleaning project and reorganization of its menu and kitchen.

Loyal customers took their meals home. "When we closed for a week, I went

home and cried," Murray said. "When we reopened with takeouts, many people were tipping more than their food costed. I still went home and cried, but it was for a good reason."

The diner is open again and the locals have returned to enjoy breakfast and lunch. The kitchen is staffed with graduates of Keystone Heights High. In addition

# Florida's First Coast Relief Fund assists 87 nonprofits

JACKSONVILLE — Florida's First Coast Relief Fund has surpassed the \$3 million mark in grants awarded to nonprofit organizations responding to immediate needs during the COVID-19 pandemic. More than 85 agencies are recipients of nearly \$3.3 million since grantmaking began in March.

The Fund is a collaboration between The Community Foundation for Northeast Florida, Jessie Ball duPont Fund, Jewish Federation and Foundation of Northeast Florida, United Way of Northeast Florida and United Way of St. Johns County.

"By far, the greatest need we've seen to this point is for food and financial assistance," said Kathleen Shaw, a member of the Relief Fund's grants committee and vice president of Programs at The Community Foundation for Northeast Florida. "We

have been able to make grants to some of the big regional food suppliers, like Feeding Northeast Florida and Barnabas, but we've also made grants to many smaller organizations so they can acquire food from the regional food banks and get it into their clients' hands as soon as possible."

Applications from nonprofits are still coming in, and members of the Relief Fund's grant committee continue to meet weekly to review, approve and ensure grants go out the door quickly.

Priority is given to agencies in Duval, Nassau, St. Johns, Baker, Clay and Putnam counties that provide food; housing; financial assistance for individuals and families; child-care support for first responders and other frontline staff; medical, safety supplies and equipment; and technology support for safety net providers.

Organizations in Clay County that benefited from the grants included: Abundant Life Community Center, American

Red Cross, BASCA, Ascension St. Vincent's Healthcare Foundation, Catholic Charities, Center for Sustainable Agriculture Excellence and Conservation, Changing Homelessness, Clay Behavioral Health Center, Clay County Education Foundation, Clay County Habitat for Humanity, Downtown Ecumenical Services Council, ElderSource, Episcopal Children's Services, Farm Share, Feeding Northeast Florida, Hart Felt Ministries, Hope Haven, Horn of Salvation Ministries, Hunger Fight, Iglesia de la Ciudad/City Church, Mercy Support Services, Ministerio Renacer Inc., Northeast Florida Healthy Start Coalition, Northeast Florida Women Veterans, Northeast Florida Young Life, Pine Castle, Salvation Army, St. Mary's Episcopal Church and Outreach Mission, The Way Free Clinic, Tom Coughlin Jay Fund, UF Health, Volunteers in Medicine, Yoga 4 Change and Youth Crisis Center.

"We're continuing to see requests from the organizations serving our most vulnerable neighbors and are grateful to the coalition of public and private donors answering the ongoing call to help," said Katie Ensign, vice president for Placemaking and Administration for the Jessie Ball duPont Fund. "Florida's First Coast Relief Fund is working closely with local systems addressing these critical issues — including homelessness, food insecurity, mental health services, small businesses resilience, and

emergency response services -- to ensure that grants are helping to build a more effective community infrastructure to quickly and efficiently get assistance to those who need it most."

Fortunately, generous donors continue to support Florida's First Coast Relief Fund. Recent gifts of \$1 million from the City of Jacksonville and \$500,000 from The Humana Foundation bolstered the fund to more than \$5.4 million — more than was raised for relief following Hurricanes Matthew and Irma.

The City of Jacksonville (\$1 million), The Humana Foundation (\$500,000), Jessie Ball duPont Fund (\$500,000), Shad Khan (\$400,000), The Jim Moran Foundation (\$250,000), J. Wayne and Delores Barr Weaver (\$250,000) and the Michael Ward and Jennifer Glock Foundation (\$250,000) were among those to contributed to the fund.

Florida's First Coast Relief Fund is administered by United Way of Northeast Florida with 100% of donations going to nonprofit agencies that provide direct services to individuals with needs that are not met by government programs.

to pushing a pencil with her 9-to-5 job, Murray has learned to push omelets and make sure everyone's coffee mug is filled.

"It's been a challenge," Murray said. "It's not easy to find good help. We're fortunate to have a really good group in here now. The kitchen staff is incredible.

"When I went into this three years ago, I was supposed to be a silent partner. That changed two years ago. Now it's 14-hour days. It's a lot, but it's worth it. Toni's my best friend and that keeps me going."

fitness level at his first week of conditioning as impressive.

"The returning kids did the work during the shutdown," said Knauss. "We had a surprising number of kids cleared quickly to play. We had 77 kids show up with some not paperwork ready to participate. I was shocked at the readiness."

## Jaguars looking to July 28 training camps

JACKSONVILLE - With an anticipated July 28 start date for training camps in the National Football League, the Jacksonville Jaguars completed most of the virtual off season preparations; virtual team meetings and no on-field work.

In a *Jaguars.com* article by Jaguars senior writer John Oehser on June 12, Jaguars head coach Doug Marrone sounded positive about a strong return to normalcy for the Jaguars who finished 6-10 last year.

"We really didn't have any glitches," Marrone said during a video conference with local media Friday morning. "We really have been able to do everything that we needed to do to get done - except for the stuff that's on the field."

The Jaguars training camp dates on not set yet as the NFL deals with Coronavirus Pandemic situation as it evolves moved from off season work starting in April, on-field practices in May and June with a three-day minicamp in mid-June. Currently, just rehabbing players can enter the Jaguars practice facilities.

For Marrone, the challenge is to ramp up the pace once the players hit the field.

# Indians ready to go

KEYSTONE HEIGHTS - Keystone Heights High School football coach Chuck Dickinson has always dealt with small teams, but energetic output.

"We do what we do," said Dickinson, nearly 30 years as the Indians mentor. "The virus is just a new challenge for all of us. We had the small groups, one coach and all the safety precautions, but in the end, the learning curve is just a matter of getting to work."

Dickinson, with a region playoff finish last year, thinks the lack of a spring season is most detrimental to fall football.

"Not having the ability to see the guys we think would be our players in the fall first in the springs games and then throughout the summer makes it tough," said Dickinson. "Our small roster always makes me have to evaluate much more in the offseason because we don't get a lot of guys coming back each year."

Dickinson's roster last year had upwards of 30-32 players at the end of the 7-3 campaign with a handful of freshman elevating to the the varsity to supplement the late season push into the playoff.



The Indians will be led by quarterback Gage Stevens who returns without most of his rugged offensive squad including running backs Ty Friedlin and Colby Townsend, but coach Chuck Dickinson often finds a way to keep the Indians run game chugging along.

"One positive was anticipating about 15 kids ready with paperwork to be able to go, but having 30 with everything done," said Dickinson. "I think the kids and the parents had plenty of time to get things done and the enthusiasm to get on the field was very high."

Losing a strong tandem running back system with Colby Townsend and Ty Friedlin both graduated and most of a strong offensive line gone, Dickinson's ability to evaluate incoming talent has become a front-burner issue.

"At this point, I like seeing Chris Hoffmeyer, a returning offensive lineman, effort coming in," said Dickinson. "Our system is mainly line up and go forward and that depends on physical conditioning up front.

We are not quite there yet, but it's only week one. We're definitely behind the eight ball."

Dickinson named quarterback Gage Stevens and utility back Colton Tibbetts as leaders on the field in week one.

"The overall physical shape was not as bad as I was anticipating," said Dickinson. "We've been adding more each day. Some are okay, some have not done a whole lot. The older guys have done stuff on their own."

Phase one, for Dickinson, was mainly conditioning and paperwork with week two featuring weightlifting.

"We'll set up an indoor group on the weightlifting and also have an outdoor group," said Dickinson. "One of our needs

always is the weightroom because of the small roster and the rugged attack. Our weightlifting team in the spring got shut down and that has been one of the big keys for our football season."

With the uncertainty of the future for high school in general as well as sport, Dickinson said the restrictions on verbal communications has made things stressful.

"We have to walk them off the field to the parking lot and on their way home with little interaction," said Dickinson. "What's missing is a little of the structure of knowing a schedule after the spring game so the kids can get their own schedules set up for practices, school and just each day prior to the season."

see what’s going on in their head, but all we can do now is walk them off the field six feet apart and make sure they leave. It’s tough. Football is emotional.”

At his first week of conditioning, Springs noted 30-40 athletes on the field with the bulk of time dedicated to paperwork and physicals.

“All of it was conditioning with little football stuff out there,” said Springs. “It’s a little more challenging because of the virus safety aspect. The focus is more on the safety then football, but it is necessary and we have to do it.”

Springs noted there is a monitoring group that maintains protocol.

“As the head coach, I’m walking around making sure kids are six feet apart and drinking their own water,” said Springs. “It’s different because I’m not that engaged in football yet.”

With some key returners; T.K. Kocak and returning quarterback transfer Grant Travis, leading the Golden Eagle troops, Springs sees more work needed for the newer, younger athletes.

“You can tell those guys have used personal trainers and kept their own conditioning to a high level,” said Springs. “We are kind of behind in that part of summer conditioning. The skill players stayed in shape with some of the lineman a little behind.”

Springs lamented the separation of himself with his team and hoped that the distancing aspect could be overcome in the

future. “It’s a little negative and I miss that part of coaching,” said Springs. “Next week, we can add the weight room into the week’s preparations; 20 kids at a time, plus we will put some weights outside, with a third group on the field.”

Springs noted a bonus of having an actual football for the upcoming week.

“We are allowed to have a ball, but we can’t have contact; blocking, tackling, and we have to clean the ball after someone touches it,” said Springs. “Little steps are all we can do.”

Springs noted the challenge is a new aspect of his coaching tactics, but that every team is going through the same process.

“We are all in the same situation and we are all learning the best way to approach this,” said Springs. “Each phase of the four is built off staying with the process for each one.”

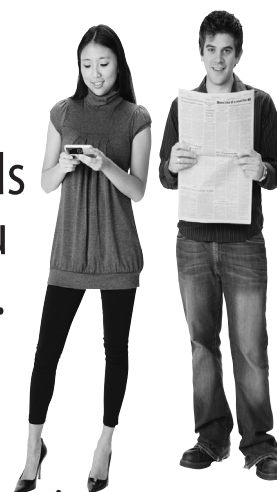
