These tips can help make turkey teriffic

Sweet potatoes may be stars; cornbread dressing a contender. Dinner rolls are divine and green bean casserole a go-to. But Thanksgiving dinner isn't complete without turkey.

Even in households that don't eat meat, plant-based turkey alternatives find their way onto the dinner table in a nod to Thanksgiving tradition. Given the emphasis placed on the main course each Thanksgiving, cooking a turkey can be intimidating. These turkey-cooking tips can calm anyone's nerves and result in a mouth-watering main course.

- Allow ample time for thawing. Some people may not be able to buy a fresh turkey, and millions of individuals purchase frozen turkeys each year. The Food Network says it can take 24 hours per every five pounds to thaw a turkey. Therefore, if you have a 15-pounder, allow for three days for thawing. Always thaw a turkey in a refrigerator.
- Get the right size bird. The general rule of thumb is 1 pound (uncooked) to 11/2 pounds of turkey per person if you're buying a whole turkey. Rather than purchasing the largest turkey you can find for a large crowd, consider two smaller turkeys or one turkey and one breast to make cooking more even. Smaller birds are more tender as well.
- Adjust the temperature. The food and cooking resource TheKitchn advises preheating an oven to 450 F, then dropping the temperature to 350 F after putting the turkey into the oven. Cook, on average,

13 minutes per each pound of turkey. The turkey is done when it registers a minimum temperature of 165 F in the thickest part of the thigh.

- To brine or not to brine? Many food fanatics swear by brining turkey to achieve more moist and flavorful meat. However, a wet brine may not lead to the crispiest skin possible. Good Housekeeping suggests trying a dry brine instead. This involves rubbing salt all over the raw turkey, placing the bird into a large plastic bag, and refrigerating overnight or up to two days before cooking; otherwise, purchase a kosher turkey, which already has been salted from the inside out.
- Avoid stuffing the bird. Rather than stuffing the turkey and cooking everything en masse, prepare the stuffing mixture separate from the turkey. This reduces the risk of contamination from the turkey's raw juices and helps to achieve a crispy coating on the stuffing guests will enjoy.
- Make an aromatic roasting rack. Turkeys typically are placed on a metal rack for cooking so the juices do not cause the turkey to stick to the pan. However, you also can cut onions and lay them with a bed of whole celery stalks and carrots to elevate the roast. This creates extra flavor in the bird and the vegetables also can be served or mixed into the stuffing.

Some turkey-roasting techniques can ensure a moist and flavorful main course this Thanksgiving.

OPCC Board of Directors Meeting

It appears the weather changes have brought an end to cabana meetings until next year. We had a good turnout this month with questions from those in attendance. Attending our monthly meetings remains the best way to see and hear what is happening in our community.

Our finances remain within the budget. The 2024 budget will be available within the next few weeks and will be presented at the November meeting. There will be an open meeting prior to the official approval for our residents to ask questions and make suggestions. A large portion of our budget is determined by the big expense items (gate/security, landscape maintenance, shared expenses, and management costs). While we welcome suggestions, there is little wiggle room in our budget. I recommend that you look at the 2023 budget that is available on our website to get a true picture of what is required.

Tied to our budget is the recently completed Reserve Study that provides guidance about what we should plan/budget in the future. This study is available on our website. The numbers are truly daunting, but something we must factor into our plans to prepare for costs that will be coming. As our community ages, costs that have not been a big concern in the past, will certainly arise. Loch Rane's costs over the past couple of years should be a wakeup call for us.

The ARC approved one request for tree(s) removal, one roof, and one room extension.

By the time this issue arrives, our planned roadwork will be completed. My thanks to our Roads Committee for tackling the hard work in determining what sections of our roads need work most while staying within our budget.

More effort is going into the golf course property as The Grove Team pursues what the final plan will be. They expect to begin work on the Club House in early 2024 as they continue to pursue the possibility of bringing back all/some of the golf course.

The state law restricting minors from driving golf carts went into effect October 1. Drivers under 18 must be at least 15 with a learner's permit or 16 with a driver's license.

Candidates for the two open seats on the Board of Directors must submit their candidate applications by 5 p.m. on November 9. The applications can be placed in the mail slot at the Community Building.

The next monthly meeting will be held at the Community Building at 6 p.m. on November 21.

Loch Rane Board of Directors Meeting

The October 2023 meeting of the Loch Rane Board of Directors was held on 10/26 in the Community Building and sparsely attended by residents.

Roving Patrol Discussion:

Chuck Bryner has been researching the roving patrol activity for the past few months and has unfortunately discovered some significant deficiencies compared to what we expect per the contract with Giddens security. The current contract dictates the roving patrol is on duty 8 hours a night from 6pm to 2am and is tasked with driving the patrol car through every street in the neighborhood (both OPCC and LR). According to the GPS tracking on the vehicle (provided by Giddens), they were able to identify a significant shortcoming in the distance traveled each evening compared to reasonable expectations for patrolling the community in nightly 8-hour shift.

Giddens themselves agreed that the distance traveled by the patrol car each evening was not in line with our expectations for an 8 hour shift and provided the options to either correct the problem to improve the performance of the roving patrol so that it provided the community with the expected level of "roving" for the full 8 hour shift in line with the cost of the roving patrol officers salary and Giddens provided vehicle/gas. (in 2023 this cost was approximately \$75,000 dollars give or take).

Another option offered was to reduce the hours of the roving patrol and thus reducing the cost of the gatehouse security contract by a significant margin each year not only saving both communities a hefty amount of money and putting things more in line with what was recorded during the sample GPS data provided by Giddens.

A final option would be to eliminate the roving patrol entirely thus saving the association approximately 75 to 80 thousand dollars a year for this line item alone which is a fairly significant number. Though this would result in the only security staff day or night being those physically in the gatehouse itself.

Side note: We have reached out to CCSO to explore the option of employing off duty uniformed officers in patrol cars on a nightly basis to provide a much more effective and visible deterrent as well as providing a legitimate law enforcement presence within the community during overnight hours. The downside to this, however, is that the hourly cost of an off duty CCSO deputy is roughly 2 times that of the roving patrol thru Giddens and as such if this option

were pursued, budget limitations would likely result in only a few hours each night that a CCSO deputy would actively patrol the neighborhood streets.

The LR BOD is working together with the OPCC BOD to discuss these findings and explore these options further in the hopes of making a decision before the gatehouse security contract is renewed next year! Residents' opinions are instrumental in helping us decide which option would be the best for both communities so if you have an opinion on the matter, please reach out and let us know!

Gatehouse Lighting:

We would like to thank https://getlitjax.com for their work in replacing the lighting at the gatehouse, it looks terrific! This company is owned by a Loch Rane homeowner, and they performed this job at a deeply discounted rate! Feel free to reach out thru their website if you have the need for holiday lighting yourself or just to say thanks! It is fantastic when residents and or their businesses are able to improve the community itself!

Road Paving:

Kudzue Paving has put us on the schedule for December 7th and 8th to perform the repaving of Glenlyon and Cameron Drive. Their original quote from earlier in the year only fluctuated by a few hundred dollars and thankfully they were able to find a week before the end of the year to complete the project. Homeowners on these streets please mark your calendar and ensure that no vehicles are parked on the street at all during these two days. The final cost for this contract is \$163,500 (part of the 2023 special assessment funds)

2024 BOD Election:

The seats of 3 BOD members are up for election in 2024 and one other BOD member has informed us they will not be able to complete their 2-year term after this year is up. We urge anyone who wishes to volunteer to serve on the BOD to submit their bio to lockrane@thecamteam.com BEFORE the November meeting next month to ensure they are included on the ballot. Instructions on how/where to submit your bio are posted on the lockraneonline.com website, were included in an eblast last week, and will also be published in the Behind the Gate newsletter for November. I assure you that it is a unique experience that will provide you with a much more enlightened view on what it takes to manage our neighborhood!

How to participate in GivingTuesday
