Manager's Report

The March Management Report included the ARC Project Tracker, Violation Log, Lake Doctors Report, February Gatehouse Summary, and the February Steering Committee Meeting Minutes. There were no questions.

Committee Reports Architectural Review Committee (ARC)

At the March 18, 2025, meeting the ARC gave approval to 5 Initial Projects including 1 Tree Removal - Retaining Wall Upgrade & Driveway Replacement, 1 Driveway Paver Installation, 2 Roof Replacements and 1 Backyard Patio Installation. Six Final Project Inspections were approved including 1 Patio Enclosure, 1 Driveway Modification, 1 Tree Removal, 1 Driveway Paver Installation and 3 Roof Replacements.

Roads

The new committee member, Greg Van Such, reported that the committee will be talking to paver companies to get bids to do the needed road work. They will also be looking into financing options. Work is in progress with pressure washing the curbs, sidewalks and pool parking lot.

There are no algae issues as of now. Lake treatments are in progress and repairs to the fountains are underway.

Landscape

The new chairman of the Landscape Committee, Ken Hahn, reported that a dead oak tree at the playground has been removed. Moving vans for a resident moving out of the neighborhood damaged sod in the common area along the sidewalk. The sod will be replaced, and the resident will be billed. Tree trimming is needed at the pool parking lot and along the Boulevards. It has been reported by aaoO Services that no water is getting to the wing walls. Trees need to be trimmed at 2439 Country Club Blvd. so that lighting from the streetlight in that location can be improved. aaoO Services has provided irrigation reports for Loch Rane and OPCC. Copies are in the office at the Community Center.

Street Captains

Most of the Street Captains are continuing to go door to door to encourage owners to participate in the vote on the Amended & Restated Covenants.

Community Center

Now that the weather is improving plans are being made to complete the work on the deck at the Community Center.

Gatehouse Report

The February 2025 Gatehouse Summary was included in the Board meeting package. There was some discussion about barcodes and getting people to use GateKey. The gate supervisor is working with the various entities at the Country Club to prepare appropriate verbiage to add to the existing Gate Entry Policy.

Old Business Gatehouse Repairs & Maintenance

hold due to the need for additional bids since the work required is more extensive and expensive than initially planned. Kintesh Patel reported that they now have 3 bids to do the needed work. The lowest bid was from First Coast Alarm for a total of \$21,108.60. The second bid was from our current provider, Integrated Access Solutions, in the amount of \$22,279.12. The third bid was from Security101 in the amount of \$26,763.71. The bids will be reviewed and carefully

Update on Amended & Restated Covenants

Since the February 4, 2025 meeting to vote on the Amended & Restated Covenants and Restrictions the Street Captains and other volunteers have been going door to door to try to get ballots. As of this meeting date, a total of 309 ballots have been received. 75% of the property owners must cast a YES vote for the Amended & Restated Covenants to pass. Non-vote is a no vote. If the Amended & Restated Covenants do not pass, we will continue to operate under the almost 40-year-old Covenants. In 2017 the Association filed a Notice of Preservation so unless our Amended & Restated Covenants pass our current covenants are preserved.

Update on Corrections Needed regarding ownership of Loch Rane Blvd and the Gatehouse in the Clay County Property Records

Work is in progress on this project. Loch Rane had their attorney research this, and they have provided a copy of the report to Tom Mackin who gave it to our attorney to review. Then the two Associations' attorneys will work together to resolve the issue.

New Business Pool Repairs and Maintenance

We were sent a reminder from The Division of Environmental Health and Safety Florida Department of Health in Clay County that the Wading Pool main drain outlet cover will expire on 05/01/2025 and must be replaced. This work will be done in April by our pool company.

The floor was opened to members and a few topics were discussed including

- · Apparent violations of exterior lighting on housing and in trees in the neighborhood.
- Questions about work being done at the
- Suggestion to send out an email for volunteers to work on the deck at the Community Center
- Suggestion to get the word out about rules for where trash cans are supposed to be placed in driveways for pickup and how long trash cans can be left in the driveway
- Discovery of beavers found dead in traps between the 1st and 2nd tees
- Suggestion that we consider doing a video about things we need done in the neighborhood such as voting on the Amended Covenants and post it on Facebook
- Request to get an update on the scoping of the drains throughout the neighborhood

The next meeting will be held at 6 p.m. Tuesday, April 15, 2025, at the Community Center.

Renovations at the gatehouse

The project is still effectively on hold awaiting bids for interior work, electrical work and new

Gatehouse News

It was hoped we would be able to get a count of the numbers of vehicles that enter the bar code lane to have a full count of the vehicles entering through the gates but the system in place does not have an option to count the number of times that bar is raised to generate the report. The representative from the company was able to teach the current site supervisor how to go into the system to purge outdated or inactive bar codes. This has not been done for years and will take some time to complete. Should you receive a call asking to verify the vehicles you currently own, know that they are déleting bar codes for vehicles and homeowners that have left the community.

Do you have someone who visits you 10 or more times a month? There were 79 homes in February for which this was true. Those homes can now purchase a bar code for that vehicle so they may use the bar code lane rather than using the visitor lane each time they come. You as the homeowner must come in person with the vehicle and individual to register them under your name and address. A bar code will be issued. Bar code pricing remains at \$15 and you must bring cash. Doing this for the two communities will remove nearly 2000 cars a month from the visitor lane streamlining access for both those with the new bar code and everyone else still in the visitor lane. See the gatehouse for current bar code hours. The requirement that a vehicle be registered to the address in Loch Rane has been relaxed by the Steering Committee.

Infrastructure for 2025

As we enter 2025, the rebuilding of Dunster Court is necessary due to an abandoned drain pipe under the surface, which has begun to form a depression in the cul de sac. It remains the top priority at the moment. We still hope to reline more of the drains under the roadways. There are still 1,235 linear feet of drains under street surfaces to be relined. Two of the Board members, Gary McMahill and Charle Honaker walked every road scoring them for signs of aging such as spiderwebbing, linear cracking, surface spaulding and scored them objectively to determine which roads are nearing the end of their life span. This will be used in the future as a basis for choosing which roads to repair as money becomes available. The permit from St Johns Water Management District to allow us to begin improving the retention ponds owned by Loch Rane has been granted and published. The next step expected to begin this month is to gather estimates from multiple companies to perform the work as designed and approved. All work must be completed within 5 years.

CAM Team Responsiveness

The phone call and email logs for the CAM Team for February were again supplied and reviewed. As was the case last month, the responses were clearly documented and we found one email that was not answered in a timely manner and two that were held until the board had a chance to weigh in on a response.

The Grove

There was no first-hand information on the Grove. There were a couple of copies of the membership pamphlet floated for all in attendance to see but things are very much not yet finalized. Although they have already accepted some memberships, the

membership application was removed from the website this week. We have no first-hand news. As soon as we get anything confirmed, we will share it.

Bylaws

Loch Rane operates under its original bylaws drafted decades ago. The Board was tasked with looking over the first four articles for review and suggestions before the next Board Meeting. Our plan is to share any proposed changes with residents well before any request to vote on them occurs. Articles 1 thru 4 are to be discussed at the April meeting.

Community Yard SaleThe yard sale for Loch Rane and Orange Park Country Club will be held Saturday, May 3rd. Applications will be available in the display box at the community building beginning April 1st. The deadline to apply is April 30th. The cost is \$15 per household to participate.

Loch Rane Summary of the Special Meeting

March 25, 2025 By Chuck Bryner

This special meeting of the Board of Directors was held to discuss a Special Assessment for Loch Rane for 2025. The total streets already repaved, the need to prioritize Dunster for repair in 2025 and the road survey of all the streets in the neighborhood undertaken by Board members Gary McMahill and Charles Honaker were discussed. The linear feet of pipes already relined and the length of the drains under the road surfaces yet

to be relined were covered as well as their costs. The looming costs of servicing the pond at the end of Kilchurn and the end of Arran Court are not yet known. Bids are to be obtained. Priorities for the special assessment will not be announced until these bids are obtained. The Board had previously thought to keep the amount of the special assessment level at \$1,000 per lot for 2025. The floor was opened for questions or comments. One topic was that keeping the amount of the special assessment level over the past 4 years has us losing ground to inflation. Each year we are able to do a little less. This will result in it taking more time in years to reach the end but there is a light at the end of the tunnel. The consensus of those in attendance was to keep the amount level at \$1,000 for 2025. The Board agreed and the amount for \$2025 is to be \$1,000. It will be due May 1, 2025. As usual, the payment may be divided in half. The first half has a deadline of May 30th to avoid late fees or interest. The second half comes due September 1, 2025 with a deadline of September 30th

LRIA/OPCCOA Steering Committee Report

The March meeting minutes and financial report were approved following a discussion of corrections.

The Joint Landscape Committee

provided a written summary of their plans. Key points included:

- Inspection of the boulevard for dead vegetation, branches requiring trimming, and potential new planting areas
- Contracting with AAOO for tree maintenance services
- Spring flower planting completed on April 7th
 - Summer planting scheduled for late

June/early July

- Discussion of fertilization, irrigation mapping, and addressing truck-induced grass damage
- Liaison with the Roads Committee regarding entry improvement to eliminate the problematic curb

The Roads Committee deliberated on the line painting proposal and concerns regarding the transition to thermoplastic stop bars. This matter was tabled pending further research. **Gatehouse interior renovations** remain on hold. Three bids for new camera installation are under evaluation, with proposals averaging \$22,000, plus an additional \$3,000-\$4,000 for additional electrical work. This instal-

lation must precede the completion of remodeling work. Both boards are awaiting bid comparisons from James Hudgins and Kintesh Patel, as well as approval from both HOAs before the Steering Committee takes action. The Height Bar discussion was deferred to the next meeting.

Gate Entry Policy

A comprehensive discussion addressed concerns regarding the gatehouse ID entrance policy, specifically the inconsistent ID checks by staff and vendors soliciting residents during community access. The committee will investigate this matter and consult with gatehouse personnel to understand the reasons for inconsistent policy enforcement.

Updates from The Grove

No updates were reported from the Grove at this time.

The next meeting of the Steering Committee will be held April 17, 2025 at 6:00 pm.

Spring Cleaning and using the Community Garage Sale

Don't forget a fourth choice is to sell something at the **COMMUNITY GARAGE SALE on Saturday, May 3 from 7:00 am – 2 pm, rain or shine.** Keep an eye out for the registration form.

Where do you begin? Start in one area and complete that before moving on to the next area. What is the one area that always seems to gather more unused or unwanted items than any other? Is it the kitchen? Is it your closets, spare bedroom, or your garage? Many of these locations are loaded with items you may no longer want or need. The easiest way to handle it is to do one area at a time.
