





Lewisburg approves bonus; continues searches

The Lewisburg City Council approved a bonus for some employees and made moves toward solving some long standing issues on Tuesday night.

The council approved a one-time bonus payment for city employees not part of the police or fire departments. Full time employees will receive a \$1,000 bonus and permanent part time employees will receive \$500.

The bonuses, approximately \$65,000 in total, will be funded through the city's American Rescue Plan Act funds distributed by the federal government.

Last month, the council approved a \$2 per hour raise for the police department's certified officers, using unspent city funds already in the department's current budget. The council preferred the one-time bonus

instead of a raise for other employees until the city's budget for the fiscal year beginning July 1 was better defined.

Council approved \$13,680 from ARPA funds,

to conduct a traffic study with recommendations for solving the long-standing issues with traffic on Hull Avenue and White Drive. Motorists have long used the residential

streets as a cut through, which one resident who addressed the council described as "increasingly dangerous due to excessive speeding and reckless driving."

Some councilmen asked if a 2018 county wide transportation planning study conducted by the Tennessee Department of Transportation would serve the same purpose, but Councilwoman Vickie Michael pointed out that document was merely a broad planning tool, not an actual study.

Speed bumps were discounted outright due to their interference with road plows during snow events. The possibility of deadending Hull Avenue in order to finally solve the problem was also touched on.

The only resolution drawing an opposing vote at the meeting was a proposal to authorize a request for proposals from search firms to seek candidates for the city's treasurer position.

The Municipal Technical Advisory Service, a University of Tennessee related office which provides consulting services to state municipalities, suggested the measure after several rounds of advertising and interviewing for the position have not been successful in identifying a qualified candidate.

The council has scheduled another round of interviews for the position on Wednesday, after the press time for today's edition.

Councilwoman Patty Parsons voted against the resolution after questioning why the resolution was needed with interviews the next day.

The remaining four council members voted in favor since the authorization was on an "as needed" basis. If Wednesday's interviews result in an offer, the RFP would not need to be issued and if the interviews do not produce a candidate, then the city would gain four weeks to begin the process without having to wait until June to approve the resolution.

The council will also be interviewing candidates for the position of city attorney, later in the month. Tuesday's meeting was the last in the position for Quinn Brandon Stewart, who is resigning from the position she has held since February of last year.

The council agreed to sell an additional acre on East Hill Street to the Marshall County Emergency Communications District. The sale of two acres to ECD was approved last month but after reviewing the site for a planned

stand-alone building for 911 services the dis-

trict decided a further acre was needed. The price per acre was \$50,000.

Council voted to extend for another 60 days the sale contract for approximately 94 acres in the I65 Commerce Park. The potential developers of the site presented to the council an outline of the proposed \$80 million project to build industrial space. Site planning, prior to seeking capital for the project, has taken longer than anticipated due to the amount of rock that would need to be moved to level the site for development.

Cornersville talks pigs and a penny

Cornersville moved toward the coming fiscal year and way back in the town ordinances at Thursday's monthly meeting.

Aldermen voted, on first reading, to approve the proposed budget and set the tax rate for the next fiscal year, which begins July 1

After some discussion, the aldermen agreed to set the town's

property tax rate at 70 cents per \$100 of assessed value, an increase of one penny from last year's rate.

While each penny in the tax rate brings in approximately \$3,000 in taxes, the additional funds will help build the town's fund balance, with several capital road projects on the horizon.

Alderman Doris Arthur raised the issue of pigs being kept within the town limits.

Town Administrator Taylor

Brandon told the board that he did find a town ordinance from 1937 that banned hogs inside the town limits as a nuisance.

Town fathers in 1937 were apparently serious about the issue. Brandon said the ordinance allowed for a \$500 fine, the equivalent of more than \$10,000 in

buying power today.

Brandon told the board that revisions to the original ordinance would be needed, such as the





Have you heard of After School Satan Clubs?

According to a story at thehill.com, After School Satan Clubs have been growing like the Dickens since their establishment at the beginning of 2020.

The clubs are associated with the Satanic Temple ("founded in the Year of Somebody Else's Lord 2014") and serve as an alternative to Christian-based extracurricular activities for elementary school students.

It's like Jiffy Lube changing its business model without changing its name. ("No, we specialize in extremely lethargic service, and we would really rather sell you a horse than lubricate your gas-powered vehicle...")

The press releases paint the clubs as focusing on tolerance, empathy and common-sense science ("There's a perfectly good reason Grandpa was wearing his cloth mask in the casket, Billy..."), but I hope they don't devolve into snobbery. You know, like "Yo' momma is so narrow-mind-

ed..." taunts or charitable gestures such as "Here's a new pair of mittens, because your family probably wears them out knuckle-dragging..."

Some organizers of After School Satan Clubs have faced combative Christian parents or even death threats. The organizers are not rolling over and playing dead (mostly because that would start unproductive arguments over whether death means eternal oblivion or Becoming One with the Universe or drinking mead in Valhalla or being reincarnated as a writer who belatedly realizes he should have trademarked Beelzebub's Bungalow or...).

No, sir, they are standing their ground, winning lawsuits and defying their opponents with, "Oh, Mythical Realm of Punishment Concocted to Keep Superstitious Believers in Line, No!"

Expansion into high schools would seem a no-brainer for future growth, but the devil is in the details (so to speak). For one thing, faculty sponsors would have to guarantee that the personal demons they're wrestling with are purely metaphori-

Hyacinth Bean Vine: A "one size fits most" plant

KNOXVILLE, Tenn. - Truthfully, I laughed when I read an excerpt from historical gardening expert Peggy Cornett's book, "Jefferson's Vines of Summer: Beauties and Beasts," where she wrote, "Ask any of Monticello's gardeners and they will tell you that enough has been said about the Hyacinth Bean." Here I am, though, telling you more about it.

The vine's purple stems, leaf veins, flowers and seed pods place it firmly on my list of purple favorites in the garden.

Hyacinth bean goes by many names including Indian bean and Egyptian bean, which provide clues about its origin. Most of the Lablab purpureus plant is edible when prepared correctly, and it has been utilized as a food

crop for centuries in Af-

UT Gardens' May Plant of the rica and Asia. It arrived larity. Ever the plantsman, Thomas Jefferson is thought to have grown it in the early 1800s at Monticello.

In the United States, this plant has been primarily used ornamentally since the early 19th century. Climbing trellises or spreading along the ground, this vine is a fast-growing annual in much of the Southeast but can be hardy in zones 10 and 11. The shape of the seed pods and flowers indicate that it is in the Fabaceae family (also known as Leguminosae) and is nitrogen-fixing. In fact, it's a great cover crop because it provides nitrogen through fixation and leaf decay, and its extensive root system improves the soil's structure. Farmers may like this plant, too, because it can be used as forage for cattle and

Purple in Europe by the early bean vine can be easily be mesmerized by the 1700s and gained popu- grown from seed after buzz of bees and scent fear of frost has passed, in full sun and moist, well-draining soil. Protect young plants from deer and provide adequate support for the vines that can be up to 25 feet long. Flowers are white, blue, or purple, and the seed pods can range from white to red or even dark brown depending on the variety chosen. Seeds for purple flowering varieties are easily found in mail order catalogs and in seed displays at garden centers in early spring. Staking against a trellis or archway, similar to what has been displayed in our UT Gardens, Knoxville, Kitchen Garden, makes for a dramatic moment in any garden while also providing shade in the heat of summer. Look for purple hyacinth bean vine growing this summer at the UT Gardens, Knoxville.

There, and in your own

hyacinth home landscape, you'll of the flowers in late summer through early fall should you choose to add this purple people pleaser to your garden.

The UT Gardens includes plant collections located in Knoxville, Crossville and Jackson, Tennessee. Designated as the official botanical garden for the State of Tennessee, the UT Gardens are part of the UT Institute of Agriculture. The Gardens' mission is to foster appreciation, education and stewardship of plants through garden displays, educational programs and research trials. The Gardens are open during all seasons and free to the public.

First blind man to use a seeing-eye dog was a Tennessean

When you see a blind person with a seeing-eye dog, remember that this practice started with a young man from Nashville. In 1927, Morris Frank was a 20-year-old

student at Vanderbilt University and unhappy about his dependency on others to get around. Frank's father read him an article in the Saturday Evening Post by Dorothy Eustis, an American woman living in Switzerland. In the article, Eustis talked about how shepherds there were training dogs to help blind people. She speculated that this practice could be perfected to help blind people on a full-time basis.

Excited by the idea, Frank wrote a letter to Eustis and received a receptive response 30 days later from Eustis. Frank then took a ship to Europe, where he trained extensively with a German Shepherd named Buddy. The training was hard. But after weeks with the dog, Frank could get around a nearby Swiss village holding tightly to a harness to which Buddy was

strapped.

Frank returned to the United States with a goal of spreading the word about seeing-eye dogs. From the day he got off the ship, he made news. At one point, in front of a group of dumbfounded reporters, Buddy led Frank safely across a busy New York street. "She (Buddy) moved forward into the ear-splitting clangor, stopped, backed up, and started again," Frank wrote in a 1957 book called First Lady of the Seeing Eye - a book I highly recommend to every Tennessee fifth grader. "I lost all sense of direction and surrendered myself entirely to the dog. I shall never forget the next three minutes, ten-ton trucks rocketing past, cabs blowing their horns in our ears, drivers shouting at us . . . When we finally got to the other side and I realized what a really magnificent job she had done, I leaned over and gave Buddy a great big hug."

When Frank returned to Nashville, people were amazed at the sight of the blind man and his dog navigating busy sidewalks. "Now strangers spoke freely to me," Frank wrote. "In the old days, at a streetcar stop, for instance, I often envied two sighted persons, who obviously did not know each other, their ease in striking up a conversation . . . With Buddy there, however, it was the easiest and most natural thing in the world for them to say, 'What a lovely dog you have!"

What astonished people the most was that Buddy had an ability best known as "intelli-

gent disobedience," which meant she would obey Frank except when executing that command would result in harm to her master. For example: if there was a low-hanging branch ahead on the sidewalk, Buddy knew to navi-

gate around it.

Frank co-founded The Seeing Eye, an institution set up to train guide dogs and their blind owners. It operated in Nashville for two years and then moved to Morristown, New Jersey (partly for climate reasons; they found it to be too hot in Tennessee to train German Shepherds year-round.)

As Frank and Buddy traveled the nation, they opened doors for blind people of future generations. In that era there were no laws that required trains, hotels and restaurants to allow seeing-eye dogs to gain entrance. Almost on a daily basis, Frank would go into an establishment and be told that he couldn't bring his dog in. His canned response: "I'm not bringing her in; she's bringing me in!" One time, a railroad porter followed Frank and Buddy to their seats and proceeded to try to drag Buddy back out. However, in the words of Frank, Buddy then showed the porter her "beautiful teeth," convincing him that it was best to leave the

dog alone. When Buddy died in May 1938, she received an obituary in The New York Times. "Buddy had appeared on hundreds of lecture platforms and barked in response to applause; she had been received by Presidents Coolidge and Hoover and other notables; and she had been led into the homes of poor among the blind and had given them hope while they patted her and fingered her harness," the obituary said.

Today, The Seeing Eye reports on its web site (www.seeingeye.org) that it has trained 17,000 dogs in its 94-year history. If you go to Morristown, New Jersey, you will find a statue of Tennesseans Morris Frank and Buddy - probably the only statue of a blind man and seeing-eye dog in the world.

Grace and truth

"For the law was given by Moses, but grace and truth came by Jesus Christ." **John 1:17**

Grace is the opposite of the law. The very nature of grace tells us that it is something not earned, but rather it is a free gift. This gift of grace came by Jesus Christ. Christ lived the holy and perfect life, according to the law, that I was supposed to and didn't. It was Christ who was punished by the holy law that I broke, while hanging on that cross. There on the cross, He willingly took the sin punishment that I deserved because the law found me to be a guilty sinner and condemned me. However, God's grace in Christ forgave me.

Grace does not depend upon us, but upon Christ and what He did as our substitute. Grace is for the undeserving, while truth is reality as defined by God, and both grace and truth are bound up in the person and work of the Lord Jesus Christ. Rockets rally, but Champs cap improbable run to 7-AA title

CHAPEL HILL — The lights were bright, rally caps were on and tensions were high.

With two outs and a runner on second base in the bottom of the seventh of a tied up district championship game, the moment couldn't have been bigger when Noah McGeary stepped to the plate for the Cascade Champions.

McGeary took the first pitch for ball one.

The next pitch floated his way and he sent a hard line drive to the left-center gap to bring Chance Brown home to beat the Forrest Rockets (19-10) 8-7, and secure the District 7-AA title for the Champions' (13-15) first district championship since 2012.

Entering the bottom of the seventh, the Champions were trailing the Rockets 7-6 with the bottom of their lineup coming to the plate.

After two quick outs, it was up to the ninehole hitter – Logan Green – to keep their hopes alive, and on the third pitch of the at-bat, he took one for the team by taking a pitch off his back for a free base.

Brown stepped to the plate next and ripped a line drive to right field to score Green all the way from first base and tie the game at 7-7 before McGeary's walk-

off single.


"Logan Green probably had the biggest atbat of that inning. Up there with two outs, and he's the nine-hole hitter. I'm sure the whole ballpark was deflated thinking it was over," Sheffield said. "He's not the type of guy to wear a pitch, but he took one for the team in that moment. That gave Chance the opportunity to be the senior and dog that we needed with that double down the line."

Cascade was in control for most of the game with a 6-2 lead in hand heading to the top of the sixth inning, but Forrest came through in a big way with five runs on four hits to take a 7-6 lead – their first of the game.

Kason Fuller and Carter Walk started off the half inning with back-to-back singles, and a walk immediately after loaded the bases for the Rockets.





Pessler accounted for two goals and one assist on Tuesday night.



Former Buffalo Bills punter Matt Araiza was not present when an alleged gang rape of a minor occurred at an October 2021 party in San Diego nor was he visible in videos recovered after the incident, which led to a police investigation and a lawsuit by the woman who said she was attacked, according to witness testimony.

The testimony was included in evidence that prompted the San Diego District Attorney to not press criminal charges

against Araiza last year. ESPN obtained and reviewed audio from a Dec. 7, 2022, meeting during which the details were discussed. The meeting was attended by San Diego deputy district attorney Trisha Amador and the woman, as well as the woman's attorney, district attorney investigator Ted Mansour and a selected victim advo-

The purpose of the meeting was largely for Amador to explain why criminal charges could not be filed and answer questions after the San Diego Police Department concluded its investigation in August 2022.

Amador told the woman Araiza left the off-campus party about an hour before the time of the reported rape, according to a witness. Amador said Araiza is "alleged to have left the party at 12:30" and was not "even at the party anymore" when the alleged rape occurred at 1:30 a.m. Pacific, according to video time stamps of the encoun-

Amador also told the woman that nobody outside of her office, including the witness who testified to Araiza's departure from the party, knows about the specific time stamps of the videos recovered from the party. The Bills released

suit that Araiza, then 21, had sex with her in a side yard at an offcampus residence before bringing her into a bedroom where a group of men took turns raping her. She said she went in and out of consciousness as the men assaulted her for about


90 minutes. The woman, who was 17 at the time, reported the alleged rape the following day to the San Diego Police Department, which investigated the allegations for nine months before turning over its investigation to prosecutors on

Aug. 5, 2022. The district attorney's office also was unable to prove that there was awareness of her age or her intoxication level. At least two witnesses at the party allegedly heard the girl say she was 18, while others said they didn't recall her age coming up.

"The DA's Sex Crimes and Human Trafficking Division has a team of Deputy District Attorneys, District Attorney Investigators, and Victim Advocates who are trained on how to be trauma-informed when interacting with victims," Tanya Sierra, assistant director of communications for the San Diego County District Attorney's Office, said in a statement. "It's a priority for our office that we treat victims with dignity, respect, courtesy, and sensitivity.
"Even in instances

where we cannot file charges because we cannot prove a crime beyond a reasonable doubt, we reach out to the victims so they can meet with us so we can explain why the case cannot be filed and answer their questions." Araiza was nick-

named the "Punt God" and honored as a consensus All-American for his booming kicks that helped San Diego State to a school-best 12-2 season in his senior year. He was selected by the Bills in the sixth round of the 2022 NFL draft.

'Sick of him': Chastain drawing ire of fellow NASCAR drivers

Ross Chastain used to be known primarily as the driver with the family roots in watermelon farming, and whose victory lane celebrations usually involved standing on the roof of his car and smashing a melon to pieces on the pavement.

Now, he's becoming known for an aggressive driving style that is repeatedly rubbing others the wrong way.

The latest incident came Sunday at Kansas Speedway, where Chastain first earned a torrent of expletives over the radio from Kyle Busch, then squeezed Noah Gragson into the wall with about 60 laps to go. The latter dust-up led to a wild scene on pit road, where Chastain threw a haymaker at Gragson and the two had to be pulled apart by security.

runs into everyone. When you have guys like Chase Elliott and other guys telling you to beat his ass, everyone is just sick of him."

The incident came six days after the NASCAR Cup Series ran its rain-delayed race at Dover, and Chastain got into the back of Brennan Poole, sending him up the track and taking Kyle Larson out of the race in the process.

Larson vented over his radio about Chastain while Poole was more pointed in his criticism during a televised interview.

"I haven't really seen the replay, but it felt like I just got ran over really for no reason 80 laps into the race," he said. "Doesn't make any sense to me. I guess that's something he's been known to do here recently. Probably needs to get his butt whooped."

Last month, Denny Hamlin had a \$50,000 fine and 25-point penalty upheld after he acknowledged on his on the last lap of the Phoenix race in March. "I got no respect from him,"

said Hamlin, who won Sunday's race at Kansas, "so I chose not to give him any." Chastain, who was fifth at Kansas and leads the NA-

SCAR Cup Series points standings, was even criticized by Hall of Famer Rusty Wallace, who was a guest analyst on the Fox broadcast at Dover: "He's got a steering wheel in his hand and a brake and a gas (pedal) at his feet. He could have controlled that a little better. That was a little too aggressive, in my opinion.

Back in Wallace's day, it wouldn't have taken long for someone to retaliate. Dale Earnhardt had a reputation for policing the way drivers acted on the drack, and many others from NASCAR's heyday did the same thing.

Yet the furor also begs the question: Is Chastain exactly what NASCAR needs these

The series has struggled to wasn't heeded. Or at least,

attract audiences, and sections of empty seats at Kansas Speedway on a bright, sunny Sunday were the latest evidence of it. Many drivers have told The Associated Press that one of the series' problems is the lack of identifiable stars in the Cup Series.

Perhaps Chastain can embrace the role of the villain. There's a fine line to walk between creating drama and creating havoc, though.

Take the incident with Busch on Sunday. Chastain was racing him hard shortly before Busch crashed out of the race — Chastain had nothing to do with that — and the two-time series champion often regarded as something of a villain himself lit into him over the radio.

"He's pissed because I'm pissed that he races like an (expletive)," Busch told his team, "and so I doored him twice down the backstretch like, 'This is your warning, boy."

"Just got fenced by him," Gragson said in explaining their pit-road altercation. "Nobody else has the balls to at least confront him, at least just grab him and do something. That policy will surely be tested in the coming weeks.

Hamlin will put the millions raised into his charity

NEW YORK — Buffalo Bills safety Damar Hamlin will use the \$10 million given to online fundraising campaigns by well-wishers after his on-field collapse to fund his own nonprofit, the Chasing M's Foundation.

The decision, first shared with The Associated Press Monday, begins the 25-yearold's plan for the unprecedented outpouring of support that he received after his heart stopped following a tackle during a "Monday Night Football" game in January.

"We have been very deliberate and intentional about taking our time to set my charity up properly," Hamlin said in a statement. "I'm excited to begin sharing news about programs we are creating to impact a generation of youth and give back to others."

That people continue to give weekly, if not daily, to the fundraiser is just one measure of the emotional power and connection that Hamlin has with so many. So far, they've given more than \$9

million to a GoFundMe campaign and nearly a million to a second online fundraiser set up by The Giving Back Fund, a nonprofit which helps athletes and celebrities manage their charitable giving, according to Kelley Denny, a spokesperson for Hamlin's charity.

Hamlin's marketing representative said in January that his family had arranged for The Giving Back Fund to act as a fiscal sponsor for the funds given to GoFundMe, which allowed Hamlin's team to fundraise as a charitable entity. At the time, Hamlin's team said the millions given to the GoFundMe would eventually be transferred to The Giving Back Fund, but they have not been.

Last week, the news outlet Sportico reported on turmoil within The Giving Back Fund in part sparked by the question of whether gifts to Hamlin's GoFundMe are charitable donations. Marc Pollick, CEO of The Giving Back Fund, disputed the accuracy of Sportico's reporting in a statement and said the organization's leadership "has always operated ethically, appropriately, and legally."

"My charity is not connected to the challenges being faced by the leadership of The Giving Back Fund," Hamlin said in the statement, adding, "Donors will have full tax-exempt status." Hamlin first started Chas-

ing M's Foundation in May 2020 when he was still a student playing with the University of Pittsburgh and applied last month for retroactive tax-exempt status, according to Denny. It was incorporated as a nonprofit in Pennsylvania.

Experts say the question of whether the donors can claim a tax deduction for what they gave to the GoFundMe after his injury may depend on decisions by the IRS. Philadelphia attorney Don Kramer, who edits the website Non-

profit Issues, said the IRS has

the discretion to retroactively recognize Hamlin's nonprofit as tax exempt. That's despite the fact, Kramer said, the cut off for applying for retroactive status is usually 27 months after an organization

is founded. Few donors to Hamlin's Go-FundMe will likely have a significant interest in claiming a tax deduction for their gift. Because of changes in the tax law made in 2017, only those who itemize their taxes, around 11% of filers, may claim deductions for charitable contributions.

"I think the public needs to be educated a little bit more on checking whenever they give money and if they really think they're giving it tax deductible," said Lisa Delpy Neirotti, director of sport management programs at George Washington University School of Business. She encouraged GoFundMe to distinguish more clearly between fundraisers that are set up by tax exempt organizations and those that are

GoFundMe confirmed that they continue to hold the funds given to Hamlin's campaign and will do so until Hamlin requests that they be transferred. The company also said that fundraisers specify when they benefit charitable organizations.

Records filed with the Pennsylvania Secretary of State show that Hamlin applied on May 1 to update Chasing M's articles of incorporation, including its mission. Chasing M's Foundation will support "the aspirations of youth and

community members through sports, education" and other activities and health and safety in sports through CPR & AED train-

Neirotti usually advises athletes to partner with major organizations that are already working on the causes that they care about, instead of starting their own nonprofit. But she said, the windfall of having millions of dollars all at once is unusual.

ing."

"With that amount of money, you really could put it into a endowment that will last forever, long beyond his playing days," she said of Hamlin.

Since being released from the hospital, Hamlin has teamed up with the American Heart Association for a campaign to teach a simple version of CPR. He's also met President Joe Biden at the White House and advocated for access to defibrillators in schools with Congressional leaders. In April, Hamlin announced that he wanted to return to playing and has been cleared to practice with the Bills.

Lora Golke, who leads donor engagement at the Arizona Community Foundation, said that many athletes and their families often underestimate the amount of work that it takes to run a nonprofit or foundation and the expertise and knowledge that

is required. "You have to remember, at the same time, he's an athlete and is supposed to be doing his job. His job is not philanthropy," Golke said. Her organization started a sport and philanthropy center in order to provide advice to former athletes who settle in the state and to its major teams about how they can make a difference in that community.

In his first public statements posted in a video to social media on Jan. 28, Hamlin thanked those who had given money to the fundraiser but added that, "I know that it isn't enough just to be thankful. This is just the beginning of the impact that I wanted to have on the world and with God's guidance I will continue to do wonderful and great things."
