He screams out louder, "Help!" Then out of the darkness he hears a voice saying, "I'll save you. Turn loose of the limb." The man shouts, "I can't!" Then the panicked man feels a hand grabbing him fingerby-finger unloosening his grip and

the man cries out "No!!!" as he falls to the ground. The man was in such darkness that he did not realize he was some three-inches from the ground. This man put himself in an unnecessary state of fear and panic. All he had to do was quit trying and start trusting.

Dear child of God, are you going to trust the voice of the LORD that comes forth from His word even in a season of dark distress?

"Trust in the LORD with all your heart; and lean not unto your own understanding. In all thy ways acknowledge Him, and He shall direct thy paths" (Proverbs 3:5,6).

The Chapel Hill Board of Mayor and Aldermen decided last Monday to move forward with a study that they hope will define the town's future path with its water and sewer system.

Jim Marshall, a utility rate and finance consultant with the firm of Jackson Thornton, presented an outline of what a water system feasibility study would look like.

Alderwoman Marion Joyce initiated the conversation at last month's meeting, wanting to settle the "sell or keep" debate over the town's water and sewer system.

"We've been given all kinds of opinions in the last ten years,' said Joyce. "I want to know, so I can make an informed decision, which is going to be the best option. I don't want to make a decision which will impact the city for 50 years without information."

Marshall outlined the three main questions that would need to be answered: if selling, what would the value be; what are the true current operating costs; and moving forward what needs to be done to maintain and expand the system and how much would it cost.

Marshall said that in his experience municipalities rarely sought to divest themselves of the utility.

"Selling doesn't solve the problems or challenges the system is facing," he said. "You're just asking someone else to do it."

The study was added to next month's agenda, so that the board can vote to proceed since water and sewer funds would be expended.

Marshall estimated four to six months to complete the analysis and formally present the conclusions to the board.

The board officially accepted the resignation of Alderwoman Dottie Morton.

Morton had served on the board since her election in 2012.

Town Administrator Danny Bingham said that he had already received a letter of interest and inquiries from residents interested in filling the remainder of Morton's term.

The board approved, on second reading the proposed budget for the 2023-24 fiscal year, which starts July 1.



CHPD increases "click it or ticket" seat belt enforcement

Chapel Hill, TN – As summer kicks off and families hit the road for vacation, Chapel Hill Police Department is partnering with the Tennessee Highway Safety Office (THSO) to remind motorists to "Click It or Ticket." From May 22 through June 4, participating agencies across the state will increase seat belt enforcement as part of the National Highway Traffic Safety Administration's (NHTSA) nationwide mobilization.

"Buckling up is such a simple task that can keep you and your family safe in the car," said Chief Andrew Kon, "But it's more than that. Buckling up is the law. Our law enforcement officers see the consequences of not buckling up. We see the loss of life. Often, it could have been prevented with the simple click of a seat belt. This should be automatic."

According to NHTSA, in 2020, there were 10,893 unbuckled passenger vehicle occupants killed in crashes in the United States. In that same year, 58 percent of passenger vehicle occupants killed at night (6 p.m. - 5:59 a.m.) were not wearing their seat belts. That's why one focus of the "Click It or Ticket" campaign is nighttime enforcement. Participating law enforcement agencies will be taking a no-excuses approach to seat belt law enforcement. After school shooting, Tennessee governor signs bill to shield gun firms further against lawsuits

NASHVILLE, Tenn. (AP) — Tennessee Gov. Bill Lee has signed off on additional protections for gun and ammunition dealers, manufacturers and sellers against lawsuits within a bill that lawmakers passed after a deadly school shooting in March.

The Republican governor quietly signed the legislation last Thursday. Its provisions kick in on July 1.

The state Senate gave final passage to the bill in mid-April, just weeks after the March 27 shooting at The Covenant School in Nashville that killed six people, including three 9-year-olds. The House had passed it before the shooting.

Lee's choice to sign the bill comes as he keeps pushing for the same Republican lawmakers, who hold supermajorities in the House and Senate, to pass a proposal that aims to keep guns away from people who could harm themselves or others. Lee plans to call lawmakers back into an August special session that aims "to strengthen public safety and preserve constitutional rights" after ing our children and they adjourned last communities," month without taking up his "temporary men-

tal health order of protection" proposal. His office hasn't released the parameters of what version of that proposal, or others, will be considered in the session yet.

The expansion of civil immunity for gun companies was hardly in doubt after lawmakers passed it. Lee has never issued a veto, which lawmakers would have the numbers to override. However, he occasionally has allowed bills to take effect without his signature to signal his concerns or disapproval of a policy.

Democratic lawmakers have blasted the move to prioritize legal protections to the gun industry in the wake of the shooting. Three Senate Republicans voted against the legislation, which came before them in the middle of weeks of public pressure, protests and marches to pass gun control reforms. Only Democrats opposed the bill in the House vote before the shooting.

"With regards to the law, the GOP supermajority is more focused on protecting firearms and manufacturers and dealers than protect-Rep. John Ray Clemmons, the House Democratic

caucus chairman from Nashville, said in an interview Monday.

The bill's sponsor, Republican Sen. Joey Hensley from Hohenwald, said during a floor debate last month that his legislation doesn't prevent any other proposal from passing to make changes after the shooting. He said the bill aims to help out businesses in Tennessee's booming firearms industry.

The Tennessee bill spells out a half-dozen situations in which gun and ammo companies could be held civilly liable in Tennessee state courts, exempting others.

The firearm industry remains largely shielded from liability under federal law. Seventeen states do not have special immunity for the gun industry. Tennessee was already not one of those states before the bill's approval, according to Everytown for Gun Safety, a gun control advocacy group. In recent years, some states have moved in the opposite direction of Tennessee by rolling back legal protections for gun manufacturers

2012 Sandy Hook Elementary School massacre in Connecticut, settled with the families of those killed in the shooting for \$73 million. The families had accused the company of targeting younger, atrisk males in advertising and product placement in violent video games. And in February, fam-

ilies of those killed and injured in a 2018 Texas high school shooting settled a lawsuit they filed against a Tennessee-based online retailer, Lucky Gunner, that was accused of illegally selling ammunition to the student who authorities say fatally shot 10 people. Some of the settlement specifics in the case in the Texas court system were kept confidential.

The owner of the company, Jordan Mollenhour, sits on the Tennessee State Board of Education. The company was accused of failing to verify Dimitrios Pagourtzis' age - he was 17, at the time when he bought more than 100 rounds of ammunition on two occa sions before the May 2018 shooting at Santa Fe High School.

Roane – Tennessee's governor who got little respect

Once the governor of Tennessee, Archibald Roane's political enemies might as well have erased the man from the history books.

Roane was born in Pennsylvania in 1759. When the Revolutionary War broke out, his family sided with the rebellious Americans. Roane was a member of the Ninth Battalion of Pennsylvania militia that crossed the Delaware River with George Washington in 1776, and he was present at the surrender of Cornwallis in 1781.

After the war, Roane got a legal education and migrated to Tennessee. In 1790, in what may have been the turning point in his career, William Blount appointed er was formidable, powerful, and reelected in 1797 and 1799.

In September 1801, Roane was elected to be Tennessee' second governor in an election in which he was virtually unopposed (he received more than 99% of the vote). We can safely conclude that he had approval of John Sevier, the state's extremely popular first governor.

As Tennessee's chief executive, Roane tried to reform the Tennessee militia. He encouraged the federal government to create a road from Nashville to Mississippi. He also tried to deal with ongoing disputes with Kentucky and VirJackson. It later came out that Jackson presented Roane with evidence that Sevier had been complicit in the awarding of land grants to himself and members of his family. Whether or not this evidence was significant in Roane's decision will never be known. But Sevier who was 22 years older than Jackson - denied all wrongdoing, and never forgave Roane.

When Roane's term ended in 1803, Sevier ran against him and won by 6,780 to 4,923 votes. Roane ran against Sevier again in 1805, but lost again.

Roane went back to being a judge, and then a state senator from Knox County, and in 1812 was re-appointed to the highest court in Tennessee (later renamed the Supreme Court of Errors and Appeals). He was also a trustee of Blount College, Greeneville College and Washington College. I believe, however, that Roane was hounded by Sevier's enemies for the rest of his life. "I have known for some time that I had inveterate enemies who would stoop to anything to injure my reputation," Roane wrote in the December 9, 1811, Knoxville Gazette. You have to read between the lines to see the degree to which Roane's reputation as governor was disparaged. Here are three examples:

• When Roane died in 1819, his Nashville Whig obituary downplayed his status as a former governor – only briefly mentioning it about halfway through the article. "He [Roane] was always actuated by the purest motives," the Whig said, a sentence that could be interpreted any number of ways.

• In 1822, when Roane's daughter Anne married, the Knoxville Intelligencer said she was the child of "Archibald Roane, Esq." but didn't point out that the man had been governor.

• When Roane's widow Ann died in 1831, the Whig said she was the widow of "the late Judge Roane," not mentioning that he had been governor.

For nearly 100 years fter his death, Archibald Roane had no tombstone. He was buried with only a small brick wall to mark the spot, in the community now known as Farragut. Talk of a monument began around 1901, but it wasn't until World War I that the Tennessee General Assembly authorized \$500 for the purpose. The large tombstone at Roane's grave was unveiled at a ceremony on June 26, 1918. Bill Carey is the founder of Tennessee History for Kids, a non-profit organization that helps teachers cover social studies.


Six years later, Roane represented Jefferson County at Tennessee's Constitutional first Convention. We don't know much about what he said at that convention, but we can see Roane's signature on our state's first constitution.

Tennessee's first legislature chose Roane to be one of three judges on the state's first Superior Court of Law and Equity – the early equivalent of the Tennessee Supreme Court. John Sevier was Tenginia over the location of Tennessee's border.

But none of those things mattered as much as a decision Roane made in 1803.

In February of that year, the highest-ranking officers of the state militia gathered to elect their major-general. As fate would have it, the vote ended in a 17 to 17 tie between John Sevier and Andrew Jackson. The Tennessee constitution stipulated that the governor cast the deciding vote.

Roane would have been better off not coming to work that day, but he did, and he cast his decisive vote for

Peacock will exclusively carry NFL playoff game

The NFL is taking another big step into streaming by putting one of its playoff games exclusively on a digital platform for the first time.

The league and NBCUniversal announced Monday that the Saturday night game on wild card weekend will be on Peacock.

The Peacock exclusive game on Jan. 13 would start at 8:15 or 8:30 p.m. EST. The game will be broadcast on NBC stations in the markets of the two teams. It will also be available on mobile devices through the NFL+ package. It will be preceded by a late afternoon playoff game on NBC and Peacock that will kick off at 4:30 p.m. EST. Subscription rates for Peacock start at \$4.99 per month. "We had our first season with Amazon (this past year) and I think that with the digital platforms, we're ready for live sports at scale. And the next step is to step into the postseason," said Hans Schroeder, NFL executive vice president and chief operating officer of NFL Media. "We like the plan that Peacock and NBC put together. In this case knowing we're going to have a bigger audience and focused on having the widest reach possible across each platform." The league has made forays into streaming games for nearly a decade, but has gone all in over the past couple seasons. Amazon Prime Video became the exclusive home of "Thursday Night Football" last season while ESPN has had one international game per season on ESPN+ since 2021. Under the NFL's 11-year contract with NBCUniversal that began this season, Peacock has an exclusive regular-season game. That will be on Dec. 23 when the Buffalo Bills face the Los Angeles Chargers in prime time. The Cincinnati Bengals vs. Pittsburgh Steelers matchup on NBC will precede that.

"We spent a lot of time with the NFL and had productive meetings about the proper positioning of that (Peacock) game," NBC Sports Chairman Pete Bevacqua said last week when the regular-season schedule was released. "We think that's going to be a great combination of using the power of NBC with that late-afternoon game and driving that audience to Peacock for the regular-season exclusive game."

The Saturday night wild-card game the past two seasons has drawn over 20 million viewers. Last season's game between the Jacksonville Jaguars and Chargers averaged 20.6 million while Buffalo and New England averaged 26.4 million. Whether Peacock can match or get close to those numbers remains to be seen. Last season's 15-game Thursday night package on Prime Video averaged 9.58 million according to Nielsen and 11.3 million according to Amazon's first-party measurement. The most-watched game was the first one between Kansas City and the Chargers. Nielsen had the average at 13 million while Amazon reported 15.3 million. NBC will have three games during the first weekend of the postseason, marking the first time a network has had that many on a single playoff weekend. NBC also has the prime-time Sunday game on Jan. 14, while Fox and CBS will have the earlier contests. ESPN has the Monday night game to close the opening weekend on Jan. 15. This will be the third year the NFL has played the wild-card games over three days. Under the NFL's contract, each of the four broadcast partners — NBC, CBS, Fox and ESPN/ABC — get at least one wild-card game. Of the two remaining games, one game rotates each year between NBC, CBS and Fox, while the

Burks breathing easier entering 2nd year with Titans

NASHVILLE — Treylon Burks didn't exactly make the best first impression as a rookie with the Tennessee Titans.

The 18th pick overall from Arkansas in the 2022 NFL draft has been busy working to ensure his second season turns out much differently, and he already can see a big difference from a year ago.

"I feel faster because I can breathe," Burks said Tuesday.

The Titans are counting on Burks to be their top receiver this season as they seek to rebound from a 7-10 finish that snapped their threeyear playoff run.

They released veteran Robert Woods, who led them in both receptions (53) and yards receiving (531) in 2022, to create salary cap space. Veteran tight end Austin Hooper, who ranked second with 41 catches, was allowed to walk in free agency.

New general manager Ran Carthon signed only one veteran free agent in Chris Moore just before the draft. He also brought back Nick Westbrook-Ikhine. With only six draft picks, Carthon selected only receiver Colton Dowell from UT Martin in the seventh round before signing some undrafted receivers.

So far, Burks is best known as the player drafted with the selection acquired in Tennessee's trade of Pro Bowl receiver A.J. Brown to Philadelphia. Burks struggled almost immediately upon arriving in Nashville for the Titans' rookie minicamp.

Burks couldn't finish the first individual drill before going inside with a trainer and then to the locker room. He came back out, did a couple more reps and then went back inside. He was seen using an inhaler and acknowledged in training camp that he had to get his asthma under control in the Nashville heat.

That was the start of an injury-plagued season for Burks. He was placed on injured reserve after hurting a toe Oct. 2 at Indianapolis. He missed two more games after a hit to the

head left him with a concussion in a loss at Philadelphia, though Burks held onto the ball for his lone touchdown.

Burks finished tied for third with running back Derrick Henry with 33 catches. He also tied Hooper for third with 444 yards receiving.

That's why the 6-foot-3, 225-pound Burks has been around Titans' headquarters this offseason. As a result, he feels better prepared mentally and physically, ready for the formations and schemes being installed by new coordinator offensive

Tim Kelly. Burks is ready to enjoy himself again.

"That's the main thing, just having fun," Burks said. "Not having that stress coming in as a rookie, like trying to prove this guy this, prove the coach this. Just having fun."

With temperatures already hitting 90 degrees in Nashville, Burks also has been running outside with the Titans' training staff. Burks said he knows how to control his asthma symptoms whenever they start, thanks Todd Toriscelli, the Titans' vice president of sports medicine, and strength coach Frank Piraino.

"It just all goes back to me being here throughout the whole offseason and getting that under control," Burks said.

The Titans will need Burks, tight end Chig Okonkwo — who's also going into his second season — and anyone else who steps up. Coach Mike Vrabel promoted Kelly after firing Todd Downing, and he also hired Charles London as the passing game coordinator and quarterbacks coach.

Tennessee ranked 30th last season averaging a mere 171.4 yards passing per game. The Titans need someone to step up as their No. 1 receiver. Burks said his goal is simply to make plays and be where he's supposed to be and be a great teammate.

If he does attract extra attention from defenders, Burks said what happens next will be simple.

"That's why I've got teammates because if I'm doubled, then somebody else (is) wide open," Burks said.





Lady Rockets add another district title to the record books

CHAPEL HILL — The game plan was simple for the Forrest Lady Rockets heading into the District 7-AA Championship—score at least five runs and keep their opponent under five runs.

That same game plan produced a slew of success throughout the season, and it proved to be sound again in Thursday night's final as the Lady Rockets dominated in the field and at the plate for a 11-1 victory over the Community Viqueens.

Starting pitcher Taylor Moreland tossed all six innings, allowing just one run on four hits, and five Lady Rockets recorded two or more hits with Ella Chilton leading the way with a 3-for-4 day at the plate and a game-high three RBIs.

"Coming into the game, our goal was to score five runs and keep them under five. We feel like we can win a lot of ball games if we do that," Forrest head coach Shelby Lightfoot said. "We pounded the zone well on the mound, hit the ball well, and played small ball when we needed to." Playing small ball has been a point of emphasis for the Lady Rockets all season with the amount of speed they possess throughout their lineup, and they executed that strategy many times in the championship game with four bunts that either scored a run or advanced runners into scoring position. "We're a speedy team and hit the ball well, but sometimes getting three consecutive hits is hard, so we work on small ball as much as we can for those situations," Lightfoot said. "The other team has to make a good catch, throw, and tag, so that's three to our one when we do that. We try to pride ourselves on that." For rest $(\ensuremath{\text{24-11}})$ got to work quickly on Thursday night by securing three quick outs in the top of the first inning after Anna Haskins reached first base on an error in the leadoff spot for the Viqueens (17-11-1), and they followed it up with two runs on three hits in the bottom half of the inning to take a 2-0 lead. Macyn Kirby knocked a leadoff single to start things off, and moved over to third after Moreland laid down a sacrifice bunt. Haskins forced the Forrest into a fly out for the second out of the inning, but an error in the next at-bat scored Kirby from third, and Chilton

followed with a double to score the second and final run of the inning.

Early errors and an absence of energy throughout the past few games has been a thorn in the side of Viqueen head coach Cam Ferrell, and that led to them having to play from behind in the district final.

"Well, the last few games we've played we were flat. I'm gonna have to do something to get their energy up, and we have to stop making mistakes," Ferrell said. "Every time we've played Forrest, we start off with an error that sets us back. If we cut down our mistakes and have some more energy, then this game is a little bit different. Until we do that, it's going to be a problem every time we play."

Community knocked a pair of singles in the top of the second inning which put runners on the corners with two outs, but Moreland locked in to secure an inning-ending strikeout for her first of the game.



and the Lady Rockets only four pitches to secure three outs in the top of the sixth, and Kirby secured the championship in the bottom half with a two-out single to score Haddie Van Platten from second base for the 11-1 finish. Winning is important for any team that puts on a uniform and takes the field, but for Lighfoot there's more to coaching than winning games and hanging banners. "It's really just about the girls. First and foremost I want them to be great young ladies,' Lightfoot said. "It means a lot to me as a coach to have great young ladies on this team. State and everything is nice, but it means more to me to set these girls up for their futures and not just here." While Moreland went the distance for the Lady Rockets, it was pitching-by-committee for the Viqueens with 7-AA Pitcher of the Year, Annie Prince, sidelined with an injury she suffered in the second round of the tournament. Haskins tossed the first two innings while Taylar Wessner came in for three innings of relief, and Maleeah Martin pitched 2/3s of an inning, having come in the game in the sixth inning for Community. 
