# Central Lee moves to hybrid model

### **COVID-19:** Prevalent staffing issues force district to switch Friday

**BY CHUCK VANDENBERG** PCC EDITOR

DONNELLSON - Due to increased positive testing and staff shortages, Central Lee school officials announced they will be transitioning to a hybrid learning model temporarily starting Friday, Nov. 13.

Superintendent Dr. Andy Crozier wrote in an email to district families Thursday afternoon about the change.

"As of today we are beginning to experience a staff shortage due to COVID-19 positive cases, spouses who have been diagnosed, staff under quarantine orders, and/or staff awaiting test results for themselves and other immediate

family members," Crozier wrote.

He said the district has moved quickly to identify exposure and communicated that information within the district.

The hybrid learning will last through Nov. 20 and students will be placed in one of two groups and will only attend in-person classes on their designated days. All students will receive virtual learning on Nov. 23 and 24th, the Monday and Tuesday of Thanksgiving week.

Principals will be communicating directly with parents of students in their buildings. Full details of the tempo-

FORT MADISON – Despite a 14-day positivity rating of 19.8% in Lee County, Holy Trinity Catholic is moving ahead with in-person learning, while the COVID-19 continues to interrupt daily lives.

## FM Firefighters rescue boater Tuesday night on island

FORT MADISON - Fort Madison Fire Lieutenant Neal Gathers said in 20 years of fire service, Tuesday night was near the top of his list of scariest things ever in service to others.

The Fort Madison Fire Department was dispatched to a stranded boater just north of the Burlington Northern Santa Fe bridge at about 4:45 p.m. Tuesday. The boater was in a 25-foot pleasure boat and had been spotted by residents on high point with an anchor in on

the south side of Dutchman Island just north of the bridge.

Gathers said the original call to LeeComm was at about 4:22 p.m. and originally went to Department of Natural Resources officers, but after no

# Waves, wind hamper rescue efforts Tuesday

response was received Lee Comm dispatched Fort Madison Fire at about 4:44 and rescue personnel were on the river at about 5:20 p.m.

The man was taking his boat from Minnesota to Louisiana and got beached due to the high winds on the river - winds that wreaked havoc on the fire department as they tried to get to him.

**Firefighters Justin** Cain, Dale Brisby and Gathers took the boat out.

"When we headed out it was so gusty and dangerous, in 20 years that's one of the five scariest things I've ever had to do," Gathers said.

"We got stuck going out in the main channel - got pushed into the mud then had waves and muddy water coming into the boat and had it half full. We had to throw an anchor out to get pulled out and around and headed up river."

Gathers said firefight-

ers were first told the boat was on the north side of Dutchman, but as they went by, Capt. Mike Schneider radioed out to them that the residents on high point said they could see the rescue boat and it had gone passed the stranded boat.

"We then we had to turn around in those winds and big rollers and head south. We found him right away on the other side."

Gathers said the man wasn't injured and was with his dog. Firefighters loaded up the man, his dog and three bags of personal items and brought him into shore.

They decided to bring the trailer down to Willow Patch, but Gathers said it wasn't any easier trying to get the rescue boat out of the water, than it was starting out because of the large waves and wind gusts.

The man was put up in a hotel and firefighters helped him back to the boat Wednesday morning.

# State overall jobless claims leveling off again

Initial claims on the rise again as virus numbers continue to surge. 55% of claimants say COVID-related

DES MOINES - The number of initial claims in Iowa, filed between Sunday, Nov. 1, and Saturday, Nov. 7, was 5,576, an increase of 967. There were 5,036 initial claims by individuals who work and live in Iowa, and 540 claims by individuals who work in Iowa and live in another state.

The number of continuing weekly unemployment claims was 35,660, a decrease of 1,322 from the previous week. November through February are traditionally the months we see the most unemployment claims, driven by increased claims in construction, agriculture, landscaping and manufacturing due to seasonal layoffs.

For the week ending Nov. 7, 2020, nearly 45% of claimants indicated their claims were not COVID-19 related.

The U.S. Department of Labor adjusted last week's initial claim number to 4,609 (a decrease of 355) and continuing claims to 36,982 (a decrease of 308 for a total decrease of 663 overall). Iowa Workforce Development relies upon the weekly data released by the U.S. Department of Labor to report its numbers and as such, adopts the revisions to the previously published data.

For the week ending Nov. 7, 2020, unemployment insurance benefit payments totaled \$10,139,790.87. The following industries had the most claims:

Manufacturing (1,005)

Industry Not Available - Self-employed, Independent Contractors, etc (743)

Construction (634)

Health Care & Social Assistance (629) Retail Trade (365)

A total of \$1,450,800 in Federal Pandemic Unemployment Compensation (FPUC) benefits was paid, which were retroactive payments as the program ended July 25, 2020. Since April 4, 2020, a total of \$1,619,918,833 in FPUC benefits has been paid.

A total of \$3,621,167.53 was paid in Pandemic Unemployment Assistance (PUA) benefits. Since April 13, 2020, a total of \$143,275,764.92 in PUA benefits has been paid.

A total of \$8,129,629.97 in benefits has been paid in Pandemic Emergency Unemployment Compensation (PEUC) benefits. Since May 27, 2020, a total of \$125,145,460.25 in PEUC benefits have been paid.

A total of \$1,625,662.53 was paid in State Extended Benefits (EB). Since July 21, 2020, a total of \$17,338,284.30 in State EB has been paid. The United States Department of Labor notified Iowa that due to our economic recovery, the State EB program ended the week ending October 31, 2020.

EB cannot be paid to any claimant for weeks of unemployment after October 31, 2020, even if they have not yet received 13 weeks of EB.

Those claimants who lose EB may be eligible for the PUA benefit program if they have remaining benefit weeks available in their current benefit year. Claimants may apply for PUA at www.iowaworkforcedevelopment.gov/pua-information.

The Lost Wages Assistance (LWA) program ended after six weeks of benefits were approved by FEMA. Iowans whose unemployment is the result of the pandemic, and who are eligible for at least \$100 in benefits each week, will qualify for up to a maximum of six weeks of \$300 in additional

weekly benefits. Since September 3, 2020, Iowa has paid a total of \$154,272,900 in LWA benefits. More information can be found here: <u>https://</u> www.iowaworkforcedevelopment.gov/lost-wages-assistance.

IWD has reinstated the work search requirement. Those who will be required to begin work searches will be notified by IWD. We have also posted updates on our website regarding this requirement.

There are currently almost 65,000 job openings at https://www.iowaworks.gov. Not all claimants will be required to begin work searches, including for example, those who are receiving PUA benefits due to a medical condition or lack of childcare.

Employers are required to notify their employees about Unemployment Insurance (UI) benefits in accordance with Iowa Administrative Code Section 871-22.19.

The requirement ensures that workers are aware of the benefits they may be eligible for if they become unemployed or experience a reduction in hours.



worked out a shuttle system between the West Point and Fort Madison facilities.

"The majority of our students will be in class 100%. We will have some students that cannot make it to school and they will have virtual classes, but that number is very small," Huebner said.

Because the school has comparatively smaller numbers, Huebner said he thinks that allows the mitigation efforts to be more effective and take hold.

"Actually, I think the students are safer here in school than they are out in the community," Huebner said.

Because the system is still conducting in-person learning all athletic and extracurricular activities are still moving according to schedule.

Huebner said school officials continue to look at daily cases and if staff were to be limited due to the virus, that would be a point where additional consideration would be given to online learning.

"Luckily right now, we have no staff out and no cases within the staff. As long as we can keep healthy, we're probably okay," he said. The state's coronavirus reporting site has Lee County at a 19.8% 14-day positivity rating with two bordering counties – Des Moines and Henry reporting over 20% and Van Buren at 19.9%.

Despite the lofty numbers, southeast Iowa is in the bottom half of state in overall positivity rates, with five counties in other parts of the state over 30% and Jones County, just west of the Quad Cities reporting at 44.5%.

The state had it's highest day of new individual positive results on Nov. 2 with 5,192 new positive test results. On Tuesday, the state saw a 29.3% positivity rate with 2,213 new cases out of 7,551 individuals tested.

Fort Madison Community School District went to online learning starting Wednesday for two weeks through the Thanksgiving holiday, putting all students on virtual learning protocols and suspending all athletic programs.

Central Lee has announced a move to hybrid learning models starting on Friday, with all students in virtual learning Nov. 23 and 24th prior to the Thanksgiving break.

# Lee County Narcotics Task Force makes two county drug arrests



The Keokuk Police Department, Lee County Attorney's Office, and the Iowa Division of Narcotics Enforcement, assisted the Lee County Narcotics Task Force in this investigation. The defendants are presumed innocent until and unless proven guilty.
