## Minor injury in Sandusky fire

#### **TRAILER FIRE:** Family loses trailer and shed in early morning blaze Thursday

SANDUSKY – An early morning fire at the Sandusky Trailer Park near Montrose resulted in one minor injury and the death of a pet.

According to a Montrose fire official, a call came into LeeComm just after 5:30 a.m. of a trailer on fire in the park located in the 2700 block 340th Street. All the occupants of the structure were able to escape with only a minor injury that was treated at the scene.

The fire quickly spread to an attached shed and then

damaged three vehicles and some siding on a nearby camper trailer in the adjacent lot.

"When we got there the trailer and the attached shed were fully involved. The owner was at home at the time but was able to get out. We believe it was caused by a space heater," said Jason Dinwiddie of Montrose Fire & Rescue.

"We did unfortunately lose a dog in the fire."

Firefighters from Montrose Fire & Rescue, Jackson Township Fire & Rescue, Des Moines Township Fire & Rescue and Keokuk Fire Department were all on the scene, along with Lee County Sheriff's deputies and Lee County Ambulance. The scene was cleared right around 8 a.m.

## **UNEMPLOYMENT** New jobless claims on the rise in state

DES MOINES - The number of initial unemployment claims in Iowa, filed between Sunday, April 11, and Saturday, April 17, was 7,255, an increase of 2,250 from last week's adjusted numbers. There were 6,673 initial claims by individuals who work and live in Iowa, and 582 claims by individuals who work in Iowa and live in another state. The number of continuing weekly unemployment claims was 33,546, a decrease of 46 from the previous week. For the week ending April 17, 2021, nearly 41.5% of claimants indicated their claims were not COVID-19 related, which is a decrease from 45.7% the previous week.

The U.S. Department of Labor adjusted last week's initial claim number to 5,005 (a decrease of 274) and continuing claims to 33,500 (a decrease of 616). Iowa Workforce Development relies upon the weekly data released by the U.S. Department of Labor to report its numbers and as such, adopts the revisions to the previously published data.

IWD will continue to pay eligible claimants for the federal extensions for Pandemic Unemployment Assistance (PUA), Federal Pandemic Unemployment Compensation (FPUC), and Pandemic Emergency Unemployment Compensation (PEUC) through September 4, 2021. If you do exhaust regular state benefits, you will be automatically enrolled in the PEUC program. If you are notified that your benefit year has expired, you must file a new claim online to determine your continued eligibility. Due to current call volumes, we encourage customers to call only if they need assistance filing their claims. Additional customer questions can be answered by emailing uiclaimshelp@iwd.iowa.gov. Thank you for your patience and understanding. Claimants who have received a notice of federal benefit overpayment now have the option to request an overpayment waiver for PEUC, FPUC, PUA and Lost Wages Assistance (LWA) benefits. The overpayment waiver form is available online:

IWD encourages Iowans to be vigilant and take precautions to protect their identities following reports of increased unemployment insurance fraud attempts. Claimants can protect their log-in information such as username, password, and Personal Identification Number (PIN) by making these as challenging as possible. Please be sure to always access our claims website directly via the IWD website rather than through a web browser search. IWD has added enhanced security measures to the claims website to increase the protection and integrity of the unemployment insurance program.

IowaWORKS centers and satellite offices are providing limited in-person services to assist customers with work search activities and basic employment assistance. Services include assistance with job searches, applications, resume preparation, and other services to help Iowans with their employment needs. Individuals should telephone their local office first to schedule an appointment as walk-in services may be limited in order to follow social distancing recommendations. Workshops and classes will not be offered at this time. Customers with questions regarding unemployment insurance benefits should continue to contact the IWD call center at 1-866-239-0843 or email <u>uiclaimshelp@</u> <u>iwd.iowa.gov</u> to obtain information about their claims.

For the week ending April 17, 2021, unemployment insurance benefit payments totaled \$10,240,551.03. The following industries had the most claims: • Industry Not Available - Self-employed, Independent

- Contractors, etc. (1,578)
- •Manufacturing (1,533)
- •Retail Trade (529)
- •Accommodation & Food Services (477)
- •Health Care & Social Assistance (471)

A total of \$19,399,200 in FPUC benefits was paid, which include retroactive payments and reauthorized payments that went into effect on Dec. 27, 2020. Since April 4, 2020, a total of \$1,939,300,933 in FPUC benefits has been paid.

A total of \$4,094,548 was paid in PUA benefits. Since April 13, 2020, a total of \$235,632,356.54 in PUA benefits has been paid.

A total of \$8,278,665.63 in benefits has been paid in PEUC benefits this week. Since May 27, 2020, a total of \$321,027,538.83 in PEUC benefits have been paid.

Claimants receiving unemployment are required to perform weekly work searches. Those who will be required to begin work searches will be notified by IWD. We have also posted updates on our website regarding this requirement. There are currently almost 63,000 job openings at <u>https://www.iowaworks.gov</u>. Not all claimants will be required to begin work searches, including for example, those who are receiving PUA benefits due to a medical condition or lack of childcare.

Employers are required to notify their employees about Unemployment Insurance (UI) benefits in accordance with Iowa Administrative Code Section 871-22.19. The requirement ensures that workers are aware of the benefits they may be eligible for if they become unemployed or experience a reduction in hours.

## Lady Hounds battling a string of one-goal losses

Pothitakis and Walker combine for 3 goals in Fort Madison's 4-3 loss to Burlington

FORT MADISON – Claire Pothitakis scored two goals and Brandy Walker had a third, but the Lady Hounds ran out of time in a comeback attempt against Burlington at home Thursday night as the Grayhounds won 4-3 in Southeast Conference girls soccer matchup.

Pothitakis scored her second goal on a nifty bender into the upper left corner of the goal over four Grayhounds fencing up on a penalty kick. The ball sailed lightly over their heads and spun away from Burlington's keeper Jenna Hentzel into the back of the goal to cut the lead to 4-3 at the 10-minute mark.

Fort Madison would have control of the ball on their offensive third for about the next seven minutes, but the Burlington defense would keep Fort Madison near the sidelines preventing crossing passes into Pothitakis. The Hounds managed another shot on goal in the stretch, but the lofted shot from the center was grabbed up easily by Hentzel.

Fort Madison scored two in the first half, but keeper Kailyn Guzman gave up four against a physical Grayhound front in the half, spotting the visitors to a 4-2 first half lead. Guzman had nine saves on the night and held Burlington scoreless in the second.

"Tonight we started the game well, but then struggled connecting passes and being organized defensively," Head Coach Carrie Burken said.

"After giving up a goal with less than two minutes left in the first half, we got ourselves in a two-goal deficit at halftime. The girls played much better in the second half, scoring one goal and conceding none. It was just one more game where we lost by a single goal. We need to have more consistency in our playing to get us past the "one-goal curse".

Burken recognized Alyssa Fincher on the left side of the defense and Mary Kate Bendlage roaming the middle.

"Alyssa and Mary Kate helped lead the shoring up of the defense in the second half," she said. "And Claire continues to be the focal point of our offense."

Walker had one assist to Pothitakis, two shots and two shots on goal. Pothitakis had an assist for Walker and had one shot. Alana Simpson, Taylor Crabtree and Bendlage had a shot each.

#### PUBLIC NOTICE ORDINANCE NO. D-074

AMENDING TITLE 2

A: An application for appeal shall be based on a claim of one of the following:

• The true intent of these codes or rules legally adopted thereunder have been incorrectly interpreted,

The provisions of these codes do not apply,
Or an equally good or better form of construction is proposed.

B: An application must state the Code section the applicant is appealing, or some other legal or constitutional basis upon which the City's decision or action is objectionable.

C: A filing fee shall be required with an application. Fee shall be set by resolution. If the applicant successfully wins the appeal, said fee shall be reimbursed.

Section 2. The City Council of the City of Fort Madison hereby amends Title 3 of the Municipal Code of Fort Madison, Iowa, "Fire Code," by adding:

5-2-4: APPEALS: All appeals of orders, decisions, or determination made by the Fire Chief relative to the application and/or interpretation of the City's Fire Code, and any other code adopted pursuant to title 5 of this Code, whether expressly or by incorporation, shall be made to the Construction Board of Appeals as provided in title 2, chapter 8 of this Code.

Section 3. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed. Section 4. If any

section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of this ordinance as a whole or any section, provision, or part thereof not judged invalid




