# Shots fired downtown early Sunday

**SUSPECT IN CUSTODY:** Des Moines County deputies make arrest **BY CHUCK VANDENBERG** PCC EDITOR

FORT MADISON - A suspect is in custody this morning after shots were reportedly fired downtown early Sunday.

According to a release from Fort Madison Police Chief Mark Rohloff, at 2:53 a.m., there was a report of shots being fired in the 800 block of Avenue G.

Officers had been there at a disturbance call approximately a half hour earlier and were still in the near vicinity at the time. The involved parties had fled the scene prior to officers' arrival. The block was closed for a period to facilitate interviews and collection of evidence. There were no reports of injuries.

Rohloff said casings were recovered at the scene.

At present, a suspect has been taken into custody by Des Moines County Sheriff deputies after a brief pursuit. The matter is still in the initial stages of investigation and no further details are available.

According to one resident who lives in the area, eight to 10 shots were allegedly heard fired. Police had cordoned off the street and had red light evidence markers out in the middle of the block.

Rohloff said he believes the incident to be isolated between individuals and the public is not in any further danger.

Fort Madison at-large City Councilman Kevin Rink said at Tuesday's council meeting that he's been fielding calls from people who don't have the Internet, and don't get the newspaper.

### First responders minimize damage from pile-up

knifed on slick roadways where visibility was very low as a winter storm Patrol, West Point/Donnellson Police and Iowa Dept. of Transportation crews helped prevent a more tragic outcome.

LEE COUNTY - A Thursday afternoon pile up on Hwy. 218/27 sent one man to the hospital with serious injuries, but Lee County Sheriff Stacy Weber said quick and committed action of county first responders saved many lives.

The pileup started as a result of near white-out conditions on the stretch of 218 north of Hwy. 2.

More than nine semi trailers jack-



dumped rain on the area in the morning and switched over to sleet and snow as tempera-

tures dropped and the wind started howling from the north at up to 40 mph.

Weber said quick action from a large contingent of first responders including sheriff's deputies, Lee County EMS, Donnellson Fire & Rescue, Iowa State

"I stopped counting jack-knifed trail-

ers at nine," Weber said. "In 25 years of law enforcement that was one of the worst pileups I've ever seen."

Lee County Deputy Jacob Riley was first on the scene and was rendering aid to a victim of an initial collision. Weber said Riley then witnessed another accident involving a Lincoln Navigator

### Hancock County ATV accident sends two to area hospitals

HANCOCK COUNTY – According to a report out of Hancock County, two men were transported to area hospitals after an ATV rolled near Hwy. 96 Saturday afternoon.

Hancock County Sheriff Scott Bentzinger reported at approximately 1:59 pm the Hancock County Sheriff's Office responded to an ATV accident on North County Road 1200 approximately 1/2 mile east of State Highway 96.

The ATV was traveling eastbound on 1200 North when it departed the roadway to the south and overturned in a field. There were three occupants on the ATV. Two passengers (Male 30 and Male 31) were transported by EMS to local hospitals.

The driver, Keaton R. Simons, 31, of Hamilton was arrested and charged with operating an ATV on the roadway, reckless driving, and driving under the influence of alcohol. Keaton posted the required bond and was released from the Hancock County Jail.

The Hamilton Police Department, Hancock County EMS, Nauvoo Fire Protection District EMS, Warsaw First Responders, and the Hamilton Fire Department assisted with the incident.

All subjects are to be considered innocent until proven guilty in a court of law.

### Lee County deputy suffers minor injuries during mishap

that had struck a vehicle trying to come to a stop, and was then hit from behind by another vehicle.

Weber said Riley went back to his vehicle to grab a first aid kit, when he saw a semi barrelling down on his cruiser, which was struck before he could get completely clear.

"He got out of his car bloodied up a bit and ran over to the Lincoln where that man was seriously hurt and began tending to him," Weber said.

Weber said the collision wiped out Riley's radio system so he then began communicating with his cellphone to other deputies, as Donnellson Fire & Rescue worked toward the scene.

Firefighters then went to work with Jaws of Life to get the man extricated from the vehicle.

"Donnellson rescue did a hell of a job yesterday. I'd be surprised if every one of those guys don't have frostbite right now. They were not giving up and there were focused on saving that man. There's no question in my mind that that man is alive today because of those firefighters."

Weber said traffic had to be stopped miles to the north and south of the pileup.

"If we hadn't stopped traffic where we did, this would have been so much worse. The deputies and troopers doing that work also saved lives. This was horrible. It was like out of a movie."

Riley was treated for minor injuries and was back at work Friday. Aside from the man taken to Fort Madison Community Hospital, Weber was unaware of any other injuries,

"There were quite a few collisions, but everybody just drove away after we got traffic moving again. There were other semis with minor damage and they just didn't report it. They just pulled away," he said.

Several off-duty Lee County deputies also responded to the scene to help with traffic control.

"I just want to give a huge shout out to all the agencies. They really put a lot of effort in and when they have the pancake breakfasts and things like that, people need to support those. Those fireman worked their butts off out there."

### Fort Madison girls get first conference title in 23 years

WASHINGTON – It's been almost a quarter of a century since the Fort Madison girls basketball accomplished what it did Friday night.

The Lady Hounds won the Southeast Conference title for the first time since 1998 with a 48-18 win over Washington on the road,

Saturday morning head coach Tony Sargent said he wasn't 100% sure of the feat, but said from what he's heard his Lady Hounds had won the conference title in just his second year steering the program.

Fairfield is 6-2 on the year and Fort Madison is 8-1 in conference play. The Hounds have one game left with Burlington on Senior Night at the Hound Dome next Friday. Fairfield has games left with Keokuk and Mt. Pleasant.

If Fairfield wins out right and the Hounds would stumble against Burlington, the two would be tied at 8-2 with the Hounds winning both conference games with Fairfield giving Fort Madison the tiebreaker.

Fort Madison Activities Director Jeremy Swink said he hasn't looked at the tiebreaker language in detail, but said he believes the Hounds have the conference title.

Sargent said he told the girls when he took the post in 2019, things were going to change.

"I said to the girls two years ago, 'You gotta be kidding me – you only have two conference titles since the beginning of time'? That's gonna change," Sargent said. "I don't think they believed me."

The Lady Hounds moved to 15-1 overall and are just one point from being perfect on the year when they opened conference play with a 62-61 OT loss to Mt. Pleasant on Dec. 4.



Camille Kruse led the Hounds Friday with 12 points. Malarie Ross had 10 for Fort Madison who held Washington to just 18 total points, the lowest amount allowed all year. They held Central Lee to 22 back on Jan. 9.

The game was a very low scoring affair in the first half. The Hounds held Washington to just a 3-pointer in the first quarter and another in the second for a total of six points in the half.

"We did a little bit of everything last night 2-3 zones and we played man a lot and pressed a bit which was the first time in a while last night," Sargent said.

"But we were struggling offensively, too. It wasn't pretty, but when you're out of school all day it seems to make the girls a little sluggish. I told the girls after the game if we play like that on Saturday we may not even score."

Sargent was referring to Saturday's game added at Iowa City West earlier this year. The Women of Troy are rated 6th in the state in Class 5A. The Bloodhounds have not yet been ranked by the Iowa High School Girls Athletic Union, despite their almost perfect record.

The Hounds broke things open in the second half going on a 13-5 run behind a couple of 3-balls from Nadia Boeding. Boeding had eight points on the night, all in the 3rd period.

Washington wouldn't get closer than 18 the rest of the night.

The Hound will certainly face stiffer tests prior to the post season with the additions of Iowa City West and Monroe City.

Sargent said Iowa City West should clearly be the toughest matchup of the year for the Hounds.

"I think it's a big test. I mean they've been ranked in 5A most of the year and have a historic program up there. The way I look at it, we need to play some of these tougher teams to get ready for the post season," Sargent said.

Sargent also agreed to a game with Missouri's Monroe City for next Saturday in Fort Madison. Monroe Center City is currently ranked No. 1 in Class 3 in Missouri.

Sargent said the Panthers reached out to him for a game.

"They've been getting some publicity and we've been getting some and they wanted to reach out and see who's best. It's nice when good people want to come and play ya."

BCMoore has the Hounds 31st in the state in Class 4A, just one spot above Fairfield. The data driven system has Fort Madison as the fourth best defense in the state in 4A, but ranks their strength of schedule at 47th out of 48 teams.

"It's going to be interesting that's for sure," Sargent said of the upcoming games. "It's different and gets these kids a taste of something different so we can be more prepared for the tournament."

Brackets for 4A and 5A girls regional play will be released next week. Classes 1A through 3A were released this week.



### Morrison has 17 in Hawks' Shootout win

DONNELLSON – The gym just seemed a little flat at Central Lee on a typical bustling Friday night with the Hawks in town.

But that didn't seem to phase the Central Lee girls basketball team as three players scored in double figures and the Hawks ran away from Wapello in the Southeast Iowa Superconference Shootout, 59-48.

The Shootout pits the teams from the SEISC North and South division against each other according to standings, and the Hawks and Arrows were seeded 4th in the annual add-on.

Central Lee's Makayla Morrison

opened the scoring for the Hawks with a bucket just 34 seconds into the game, but it was a string of 3-pointers about a minute and half into the second half that stood out as a turning point.

With Central Lee holding a 34-27 lead, Morrison would hit back-toback 3-balls from the wing and right baseline to give the Hawks a 13-point lead.

The Hawks kept feeding the hot hand, and Morrison's attempt at three in a row rimmed out. In the meantime, the Arrows' senior Sammy Ewart would miss four straight from the field. Morrison would hit another three on the Hawk's next possession for a 16-point lead at 43-27.

Morrison finished with a sea-

son-high 17 points on the night. Senior Mya Merschman led the Hawks with 22. Alivia Myhre had 13.

Wapello tied the game at 8 in the first quarter, but Myhre would score eight unanswered including a threepoint play with about two minutes left in the first to give the Lady Hawks a healthy cushion

Central Lee would then hold consistent double digit leads throughout the game.

Head Coach Jay Baldwin said Morrison's play showed a different dimension to the Hawks.

"Central Lee plays host to WACO on Monday night for Senior Night. The game was originally scheduled to be played in WACO but has been moved to Donnellson.

fighting to be as objective as possible.

Any cable news network is runnin' to the money. True news can't care about the money. That's an extremely tough row to hoe and needs to be appreciated.

But there is really no excuse for not knowing what's happening locally. There are two viable new agencies in this town and a couple television crews that have been hanging out lately.

Regressive exchanges of information via social media are a weight around our ankles. I stopped to talk to my neighbors about the

marina because I heard one say something about dredging. They were boat enthusiasts who said they've been reading about the marina. They were excited... and they were very informed.

We're still seeing people post they want the city to build new schools rather than the proposed 5-star marina.

Wealthier towns with high property valuations have nicer schools. But it's from money culled from the tax base through school district property tax structures, and state education funding formulas - certainly not the

decisions of city officials, and certainly not city funds. That conversation has to stop.

People still complain about the city using waste water treatment interest reimbursements on new parking lots. That's because those lots are built with permeable pavers that allow storm water to run through the surface, and into the ground reducing the amount that goes back into the storm sewer system. That money had to be spent on storm water remediation.

You probably could have

replaced three blocks of a street, but it had to focus on storm water mitigation. You couldn't use it to repair Avenue F, or build a bowling alley. And that conversation has to stop.

Not knowing what's happening in your neighborhood and at your City Hall is on you.

Get a newspaper. Subscribe to Pen City Current. Do we get it all?... of course not. Do we get a lot?... yep.

Let's talk the south side parking ban on Avenue E. It's unbelievable how many people were upset they didn't know anything about it. PCC only wrote on that issue about 10 times. You weren't looking. It was in the Democrat both editorially and legally. You weren't looking.

The state mandates that municipalities inform people through public notices because throughout time it has been the "best" way to reach all the people. Read public notices in Pen City Current to see how much the city spends on public notices in the paper of record. Now that's good reading.

We run them for free. And that day is coming when all the city will have to do is post it on a dedicated site where everyone can check daily for new information.

The Internet already is akin to a utility and eventually that's where municipalities will publish notices legally. Right now they are still required by law to be posted in newspapers. Pen City Current is not the paper of record, because we don't use the postal service for our products. Feel free to connect dots.

The push back is that local newspapers, which are critical to a functioning society, stand to lose millions across just this state alone, when public notices are no longer required to be published.

I see a day when the city's website has a Public Notices link and everyone with the Internet can check them 24/7 (which you can do at www.pencitycurrent.com now). It's certainly more efficient, especially if the Internet is truly a utility that everyone will have access to. The move will possibly result in a few more streets getting repaired, or city debt retired quicker, or lower property taxes.

Elderly having trouble functioning in this geekie world is understandable. I hate it when Facebook changes abruptly, or our host site updates and things change. I get it.

But there are resources out there. Governor Kim Reynolds said last week that she's reaching out to the state's agencies on aging to help those who don't have access to the Internet stay informed about COVID vaccines. Those agencies can also help you stay connected to your communities.

I think one of the biggest weapons we have in the fight to keep our community viable is information. Those that don't have it, choose not to follow it, or just ignore it, are a weight on the progress.

You're literally choosing to ignore daily options to stay informed, and then complaining that you weren't informed. It's the biggest dichotomy of a socialized world - those that choose to be informed and those who complain that they aren't.

Get a paper, get a laptop, hell, get a friend and have an eight-cent cup of coffee at your kitchen table. Get to living – and get to knowing.

Take a breath and commit to at least being open minded to the good things that are happening right now in your community.

Speaking of good things, the Governor is making national news by relaxing all restrictions for masking in the state with COVID numbers declining. It is a good thing that businesses can open fully again. We need to get back to life, but proceed with caution.

You'll still see me behind a KN95 and a sunflower not just for me, but for you, too... but that's Beside the Point.
