MONTROSE — It isn't an election year for state or federal candidates, but that didn't keep Lee County Democrats from gathering Sunday to hear from Iowans seeking the U.S. Senate and governorship.

Mary Jo Riesberg, chair of the Lee County Democratic Party, organized an ice cream social for the second time at Ivor Fowler Community Center in Montrose. The local party's first summertime ice cream social was held in 2019. There was no such event in 2020 due to the coronavirus pandemic.

With about 15 months to go until the 2022 mid-term elections, three Democratic candidates got a jump start on meeting local voters: U.S. Senate candidates Abby Finkenauer and Dave Muhlbauer, and potential gubernatorial candidate Deidre DeJear.

Finkenauer, who represented Iowa's 1st Congressional District from 2019-2021, was introduced Sunday by her former Iowa House colleague Jerry Kearns.

"There was no greater advocate for working people in the Iowa Legislature than Abby Finkenauer," said Kearns, who

Bass staying in 6 to 7 feet of water

The following is the Iowa Department of Natural Resources weekly fishing reports for area ponds, lakes and rivers.

Big Hollow Lake

Water temperature remains in the low 80's. The thermocline is set up at 5-7 feet deep. Don't try fishing much below that; there is little to no oxygen below 7 feet. Largemouth Bass- Slow: Find bass at the lower end of the lake around the flooded trees in 6 to 7 feet of water. Bluegill -Fair: Most anglers are finding bluegill back in the trees (in the shade) in 3 to 5 feet of water. Channel Catfish - Fair: Catfish don't mind the hot weather as much as the other fish do. Drift cut bait along the face of the dam.

Iowa River

(Columbus Junction to Mississippi River)

Iowa River water levels continue to drop very slowly. A few more sandbars are sticking up out of the water. Channel Catfish – Fair: The catfishing along the back edges of the sandbars is picking up after dark as they move in to feed on the baitfish hiding there. Use cut bait or live minnows.

Lake Belva Deer

Water temperature is 83 degrees. The thermocline is set up at 6-7 feet. Water clarity has improved a little. Bluegill - Slow: Bluegills have moved out to deeper water

for the summer. Look for them in 6-7 feet of water as they adjust to the changing thermocline to stay cool with plenty of oxygen. Largemouth Bass - Slow: Bass are out in the thermocline trying to stay cool. Slow drift/troll crankbaits down 6 to 7 feet below the surface to find them. Channel Catfish - Fair: Catfishing is improving. Catfish don't mind the hot weather as much as the other fish do. Try chicken liver and cut bait in above 8 feet of water. Redear Sunfish - Slow: Work along the old creek channel running down through the lake where sunfish are hunting snails to eat.

Lake Darling

Water temperature is in the mid-80's. Water clarity is around two feet; improving slowly. The thermocline is set up at 5-7 feet. Largemouth Bass - Slow: Bass are taking it easy in the heat and don't seem to be very hungry. Most bass remain out in 6 to 7 feet of water. Bluegill - Slow: Try slip bobbers and worm or vertically jigging in the brush piles and rock piles in 5-7 feet of water. Black Crappie -Slow: Look for crappie to remain in deeper water around the brush piles and rock piles down about 6-7 feet. Channel Catfish - Good: Switch from the stream inlets to the culvert piles near the bank; where the catfish can avoid the heat in the shade. Chicken liver works best. Picked up with the flood waters bring in new food.



Central Lee inducts three new | Muhlbauer says it's time honorees into Athletic HOF

DONNELLSON - The Central Lee Community School District has announced the 2021 inductees to its Athletic Hall of Fame.

This year, the Hall of Fame is honoring a former student-athlete, former coach and the 1966 girls' cross-country state championship

The Athletic Hall of Fame was created as a means of recognizing, preserving and promoting Central Lee's rich history and tradition of excellence in athletics. It emphasizes the importance of high-achieving graduates and former staff members who made a big impact on the school community during their time in Central Lee.

"Over the years, our student-athletes, coaches and teams have accomplished so much, and we are honored to recognize them through our Athletic Hall of Fame," said Dr. Andy Crozier, CLCSD Superintendent. "This year, we are celebrating the achievements of a multi-sport star, a legendary coach and administrator and a cross-country team that overcame the odds to win the state championship in just their first season competing. We look forward to seeing our alumni and honoring these achievements together."

Inductee Sara Newton (née Weirather) is a 2003 graduate who was one of the most prolific multi-sport athletes in Central Lee High School history, earning 18 varsity letters. She claimed all-state recognition in three sports and was named to the Academic All-State team in volleyball. Newton was also a five-year varsity starter in softball and was

instrumental in leading the Central Lee basketball team to a second-place finish at the 2000 state tournament as a freshman.

Also inducted this year is George F. Allen, who served as a teacher, athletic director and coach of multiple sports in Central Lee for 45 years. Over his career, he coached boys' and girls' basketball, baseball, softball, golf, and football. He played a critical role in starting many of the district's athletic programs, along with the Central Lee Athletic Booster Club.

The 1966 Central Lee girls' cross-country team won the state championship in just the first year of the program's existence. The team included Marg Winstead (née Benjamin), Sandy Schaff (née Boecker), Rose Crossan (née Rider), Barb McVeigh (née Millmier), Becky Reynolds (née Mullen) and Karen Sojka (née Reuther). Coach Bruce Knott led the team—and also transported them to meets in his side-paneled station wagon.

Families, staff, alumni and community members are encouraged to nominate individuals for Hall of Fame recognition. A committee then reviews all nominations and determines each year's inductees. Central Lee also has Academic and Fine Arts Halls of Fame.

For individuals to qualify for a nomination, they must have graduated from Central Lee schools or have been a staff member. They also must be at least five years removed from their time in the district. The nomination form is available at https://bit.ly/CL- **HOFNomination**.

retired in 2019 from his post representing Lee County.

Finkenauer lost her reelection bid last year by 2.6 percentage points to Republican Congresswoman Ashley Hinson. Earlier this month she launched her campaign for Sen. Chuck Grassley's seat.

"I know there are policies that move us forward and I know there are policies that hold us back, just like I know there are public servants that move us forward and there are politicians that hold us back," said Finkenauer. "Especially those politicians who have been in Washington, D.C., for decades and have lost sight of what public service is all about."

Grassley, 87, has served in the U.S. Senate since 1981. He has yet to announce whether he will seek an eighth term in 2022.

Finkenauer, 55 years his junior, criticized Grassley for his unwillingness to forcefully speak out against the Jan. 6 insurrection attempt carried out at the Capitol by supporters of former president Donald Trump.

"Sen. Chuck Grassley should have known better, but instead, he didn't stand up for our democracy. He didn't push back against the lies that led to that day, and in fact, months later, he was part of pushing that conspiracy forward," Finkenauer said, referring to Trump's false claim that President Joe Biden did not rightfully win the 2020 election. "I knew in that moment that it was time we spoke the truth."

In addition to Finkenauer, Crawford County's Muhlbauer and Glenn Hurst, a western Iowa physician, are running for Senate on the Democratic side.

Kearns also introduced Muhlbauer, noting that he served in the Iowa Legislature with his father, Daniel Muhlbauer.

A farmer and former Crawford County supervisor, Dave Muhlbauer is new to statewide politics but was the first Democratic candidate to announce his Senate

"I am running for U.S. Senate because it's time for Democrats to step up," said Muhlbauer, noting the warm reception he received from Democrats in conservative Crawford County. "They said, I'm so glad he stood up, now I feel like I can stand up and make change."

DeJear, a 2018 candidate for Iowa secretary of state and chair of Vice President Kamala Harris' caucus campaign, has formed an exploratory committee for governor, which allows her to fundraise. She hasn't formally entered the race to take on Gov. Kim Reynolds, who is expected to seek a second term.

To give the Democrats a sense of hope about their prospects in the governor's race next year, DeJear noted how Fred Hubbell, the Democratic candidate in 2018, won Lee County by 3.3 percentage points.

"We got to recognize where we made our wins and build upon that. Three percent, compared to what some of the other counties did, is something to brag about," De-Jear said to applause. "It's something to brag about."
