### **RIVERSIDE NUTRITION:** Drink line includes shakes, coffees, and boosted teas

FORT MADISON – Herbalife, a dietary supplement popular in the 80 and 90s is making a resurgence in nutrition clubs like Fort Madison's Riverside Nutrition.

The new protein-based drink bar in the former Hope Real Estate building on the southwest corner of 9th Street and Avenue G, is mixing in well with the downtown business culture.

Owners Shawna and Matt Hamilton opened the business

on May 10 and have since seen a remarkable uptick in business that has them considering resetting store hours.

The store is now open 6:30 to 5 p.m. weekdays and then 8 to 1 p.m. on Saturday and 10 to 3 on Sunday.

Shawna said Saturday hours may need to be adjusted because of the heavy business traffic around 1 p.m.

The nutrition club features protein shakes, protein-based iced coffees and boosted teas. Most products are sugar free with the exception of some toppings on the drinks but

## Niazy has done enough to warrant permanent visa

then during Donald Trump's, and now during Joe Biden's. They all are remiss for not formally telling Niazy the U.S. is grateful for his assistance and will give him the special immigration visa to allow him to remain here for the rest of his life.

Zalmay Niazy, now in his 30s, is not just another of the countless foreign-born people who dream of living, working and raising families in the U.S. He is a native of Afghanistan and served our nation during wartime, just as surely as did the hundreds of thousands of American soldiers, sailors, Marines and Air Force personnel who were deployed there over the past 20 years as part of the Pentagon's Operation Enduring Freedom.

Niazy was hired by the U.S. military in 2007, when he was 19, to be an interpreter for American soldiers. This was not a paper-shuffling desk job. Niazy was wounded in the line of duty by bombings and gunfire. His uncle was murdered by the Taliban, the Afghan terrorist group. And he and his family were threatened by the Taliban because he was working for the U.S. military.

After his military job ended, Niazy joined a private company in Afghanistan. In late 2014, during a business trip to the U.S., he learned the Taliban was again threatening his family — and it would not be safe for him to return home.

Niazy traveled to Iowa Falls, where a cousin lives. He applied for political asylum so he could remain here. He waited for the federal government's decision. For six years he waited.

Finally, last month, a letter arrived from the U.S. Department of Homeland Security informing him his request has been denied. The reason: He told immigration officials he had spoken with a member of the Taliban when he was 9 years old.

Niazy explained to the Iowa Falls Times Citizen last month: "They grabbed me by the neck and said, 'You go home and bring bread or we will burn your house."

Fearing the consequences if he refused, the boy did as he was told.

Even though he later worked for the U.S. military for a half dozen years, that encounter at age 9 led U.S. immigration officials to conclude he had engaged in terrorist activities.

Niazy's lawyer, Keith Herting of Des Moines, told the Times Citizen the allegation is ludicrous. "It's galling that this person who put his own life in danger on multiple occasions, he had family members who died as a result of him working to support U.S. forces in Afghanistan, and the response the government is giving him is despicable."

Niazy is a familiar face around Iowa Falls and is known by many as "Zee." People there are raising money to help pay for a lawyer to represent him. He owns his business, Zee's Handyman Services.

He owns his home. He serves as a volunteer on the county's emergency squad. And he has pitched in in other ways, too, from Iowa Falls' yearly Fourth of July parade, to helping his elderly neighbors, the Times Citizen reported.

Niazy's case will be heard on June 28 by an immigration judge in Omaha.

Iowa's U.S. Senator Joni Ernst is one of the leaders of a bipartisan group of senators who wrote recently to President Biden, urging him to increase the number of special immigration visas for applicants from Afghanistan who worked on behalf of the U.S. military during the "War on Terror."

Members of Congress also urged Biden to speed up the visa process, because the last U.S. troops will leave Afghanistan this summer — ending the longest war in U.S. history. There are fears the Taliban will retaliate against U.S. sympathizers once American soldiers are gone.

A bipartisan group of House members, including Mariannette Miller-Meeks of Iowa, wrote a similar letter to Biden last week.

"If we fail to protect our allies in Afghanistan, it will have a lasting impact on our future partner-ships and global reputation, which will then be a great detriment to our troops and the future of our national security," their letter said.


And deporting Zalmay Niazy will not make our nation any safer.



## Wyett Breaks Becerra's Win Streak at Pepsi Speedway

DONNELLSON -Mother nature finally co-operated with the Lee County Speedway in Donnellson, after two straight weeks of being rained out they were finally able to get a Friday night of racing completed. As Roberts Tire Center presented the MOWA 410 Sprint Car Series, along with the weekly classes of IMCA Modifieds, IMCA Stock Cars, IMCA Northern SportMods, and IMCA Sport Compacts. After the final checkered flag waved two driver's visited victory lane for the first time this season, while three other driver's made return trips.

The 18-lap Roberts Tire Center IMCA Northern SportMod feature was the first to take to the track, with Quinton Shelton and Bob Cowman scheduled to lead the field to green. But when Shelton didn't make the call, this would move Joe Roller up to the pole position. Sean Wyett, who originally started 5th, shot out into the lead on lap 1 over Barry Taft and Joe Bliven. Wyett would

start to pull away from the field, when a caution on lap 6 for Matt Tucker's spin in turn 2 bunched the field back up. On the restart Wyett jumped back out front, with Austen Becerra, who started 11th, Taft, and Adam Birck, who started 12th, glued to his back bumper. While Wyett worked the bottom of the track in turns 1 and 2 and the top in 3 and 4, Becerra would work the top in turns 1 and 2 and the bottom in turns 3 and 4 to challenge Wyett for the lead. Becerra got into the guardrail in turn 2 with 3 laps to go, this allowed Wyett to go on to claim his first win of the season breaking Becerra's four-race winning streak.

Up next was the 16lap Donnellson Tire & Service IMCA Stock Car feature, with Beau Taylor and John Oliver Jr. making up the front row. Oliver Jr. would take advantage of his starting spot to grab the lead on lap 1 over Abe Huls and Taylor. Huls, who was working the bottom of the speedway, would grab the top spot away from Oliver Jr., who was working the top of the track, on lap 7. Coming off turn



4 to the checkered flag, Oliver Jr. got enough momentum to edge out Huls at the line for his second win of the season at the track. Jason McDaniel was 3rd, Chris Wibbell came from 7th to finish 4th, with Jason Cook completing the top 5.

Jake Neuman and Ayrton Gennetten led the field to green in the 25lap MOWA 410 Sprint Car feature, with Gennetten jumping out into the lead on lap 1 over Neuman and Chris Martin. The fast pace that Gennetten was setting would quickly put him into lapped traffic. But that didn't slow him down, as he quickly worked his way through the field, leaving everyone else to battle for positions behind him. However one thing that would slow him down was the red flag on lap 18, as Riley Goodno got upside down in turn 4 to bring out the red. He would

On the restart Gennetten jumped back out front and would cruise the rest of the way to score the \$3,000 win. Neuman was 2nd, Terry McCarl came from 8th to finish in 3rd, Martin was 4th, with Tasker Phillips coming home in 5th.

Next to take to the track was the 18 lap Sonny's Super Market IMCA Modified feature, with Jesse Belez and Blake Woodruff making up the front row. Woodruff took advantage of his starting spot to lead lap 1 over Belez and Bill Roberts Jr. But Belez would get by him to take over the top spot on lap 2. While those two driver's battled for the lead, Jeff Waterman, who started 6th, and Michael Long, who started 8th, worked their way up to make it a four car battle for the top


spot. Long made some daring moves to go from fourth into second on lap 15, and then coming to the white flag he would use the top of the track coming off turn 2 to grab the lead away from Belez. Which he held onto for his third win of the season at the Lee County Speedway. Belez settled for 2nd, Waterman was 3rd, Roberts Ir. was 4th, with Woodruff rounding out the top 5.

The final feature to take to the track was the 15 lap AVIS Car Rentals IMCA Sport Compacts, with Chevy Barnes and Dyllan Bonk leading the field to green. Bonk would grab the lead on lap 1 over Brandon Reu, who started 5th, and Josh Barnes, who started 10th. These three driver's raced three wide for the top spot on lap 3, with Josh Barnes emerging with the lead. Josh Barnes then looked like he would be heading for his first win of the season, when on lap 10 he pulled into the infield with troubles. This

handed the lead over to Reu, who went on to win his third of the season at the track. Bonk finished a career best 2nd, Chuck Fullenkamp finished 3rd, Kimberly Abbott was 4th, with Chevy Barnes coming home in 5th.



those can be left off upon request.

Caffeine free drinks are offered and kids drinks that substitute aloe for the caffeine are also available.

Shawna said the club has been very busy.

"We're pretty much steady all the time usually. We have a little downtime from 9:30 to 10:30 a.m. and that's when we restock, then the lunch rush hits. People just come in on lunch breaks to get through the afternoon," she said.

"I honestly feel like it's been busier than I expected. I expected us to do well, but the amount of regulars we see coming back every day to get something makes me very happy."

Customer feedback has shown the flavor is a surprise to people.

"Most of them are telling us they are surprised how good everything tastes," she said. "When we say things are sugar-free, people tend to think of that funky aftertaste of being sugar-free, but on the protein shake side of things, people say they taste like milk shakes and not the typical protein shake."

The couple looked at several buildings in town including some on Avenue G, but decided to go with a rental instead. They currently rent from Wes and Jennifer Holtkamp.

The two also own and operate Learning Tree Day Care Center and have four children so buying a building seemed like a lot to take on with both operations, and Matt working full-time at Silgan in Burlington.

Matt and a friend custom built Riverside Nutrition's service bar as the building was being redone inside.

"We came in when they had everything tore out. We know what it looked like when it was a real estate office as we signed for our first house here. So there's been a lot of improvements," Shawna said.

The service bar was custom built by her husband and a friend.

Matt said he was skeptical of the venture at first but has been pleasantly surprised with the reception from customers.

Other nutrition clubs are open in Burlington, Carthage, Quincy, Galesburg and Macomb. Shawna said she reached out to the owner of the Macomb club who has helped her with inventory and has answered questions about getting started.

"She's helped make this very easy and answered all the questions I've had." The basis of the products is Herbalife, a nutrient supplement direct sales company that had its heyday in the late 80 and 90s. Hamilton said the company made a bold shift to allowing distributors to operate clubs.

She said new product lines like protein bites, pudding pies and waffles and donuts could be available soon.

"We have recipes for donuts and waffles where even the icing is made with protein mix," she said.

With Business 61 being torn up a block south of the club, Hamilton said traffic by the front door has increased and that's been good timing for brand awareness.

The Hamiltons are also trying to come up with something for downtown parades including the Rodeo Parade in September. Shawna said she may do some pre-made mixes so drinks can be made quickly with ice and water and keep customers moving.

She is also considering offering a "flight" with small samples of drinks to allow customers a chance to try different flavors to find a favorite.
