## Police looking for WP man

**MISSING:** 54-year-old hasn't been seen since June 14; foul play not suspected

WEST POINT – West Point police are asking for help in looking for a resident who's been missing for about three weeks.

According to a release from West Point Chief of Police Brad Roberts, a missing person's report was filed on June 15, by family members of Darren E. Bunnell, age 54 of West Point.

Bunnell was last seen on June 12th, 2021 at approximately 7pm, after his father had dropped him off at his residence. On June 14th, a mail delivery worker sighted Bunnell walk-

ing north on 240th Ave., north of West Point.

"No one has seen or heard from Bunnell since that time. No foul play is suspected, and local law enforcement have searched the West Point and rural areas," Roberts wrote in the release.

Bunnell is described as a white male, 5'08" tall, and approx. 180 pounds. He was last seen wearing blue jeans, t-shirt, eyeglasses, and was unshaven.

Anyone that has seen or know the whereabouts of Bunnell, or has information, are encouraged to contact the West Point Police Dept., or the Lee County Sheriff's Office 319-372-1152.

## Central Lee launches new after-school program

DONNELLSON – At its July 6 meeting, the Central Lee Community School District Board of Education approved a new after-school program for K-6 students.

Hawk's Place will provide after-school academic support, physical activities and enrichment opportunities. The district plans to make the program free for Central Lee students for the next two school years, leveraging federal CARES Act funding to provide the service. The district will actively seek additional funding for programming beyond the 2022-23 school year.

"As an elementary school parent myself, I am excited to see another level of programming be made available for the children in our community," said Dr. Andy Crozier, Central Lee Superintendent. "Rural school districts like ours do not always have access to high-quality after-school programs for elementary students. Hawk's Place helps meet that need while also helping us achieve a key objective of our strategic plan."

Central Lee will develop and share more details over the next three weeks while also hiring personnel to support Hawk's Place. The after-school coordinator position is posted to the public, with the application window closing Friday, July 9.

"Providing a safe and supportive environment for students is the mission of Hawk's Place," said Heather Fuger, Principal of Central Lee Elementary School. "We are excited for students to have this after-school opportunity to build positive relationships with staff and other students. Through purposeful learning activities, we will strive to enhance each child's school experience. We will also utilize community partnerships to provide engaging enrichment activities."

## Cow issue moooves to front of supervisor agenda

FORT MADISON – It really has become a case of beef on the lamb.

At Tuesday's regular meeting of the Lee County Board of Supervisors, the owner of cattle that are regularly on the loose in Lee

County told supervisors she is working on getting fencing repaired.

Gina Cramer, who lives in Des Moines Township near Montrose, said for more than 30 years there has never been a problem with her farm, that was originally owned by her grandfather.

She said the farm has about 100 head of a

cattle, but when pressed by Supervisor Gary Seyb, couldn't put an exact count on the animals.

Seyb said that's a critical part of the problem.

"I've worked with cattle on family farms

# Lone Tree sits Crusaders down for the season

*Hellige goes 2 for 3 with 2 RBI, Mueller sidelined with surgically repaired thumb*

WEST POINT – Holy Trinity Catholic’s girls softball team was 600% better this year.

That’s not hyperbole, that’s real math. A team that one just one game last year in its first year of softball since 2012 won six this year.

But one of them wasn’t the Class 1A Region 8 first round game at South Park Tuesday night. Holy Trinity, minus its only 1st team all conference player in 2020 in Brooke Mueller, fell to Lone Tree 10-4 ending the year for Crusaders.

Mueller, the team’s sophomore catcher and offensive spark plug firing next to Kayla Box, had to miss the game with a surgically repaired thumb. She broke it against West Burlington last week trying to tag out a runner at home.

“Taking her bat out of the lineup, taking her out from behind the plate you’re moving a potential all-conference center fielder in Haile (Cain) out of her spot and moving players around – it’s part of the game, you do what you gotta do,” said HTC Head Coach Loren Menke.

Mueller said it was heartbreaking for her not to be with her teammates.

“It was really hard because I love playing with my team

especially at the end of the season. It was heartbreaking to be able to play the whole season and then get to post season and I’m unable to play,” Mueller said.

“I was still very lucky I was able to come and cheer my team on and participate in the dugout with all the cheers and be positive.”

Cain had to move to the catcher’s spot which threw Tee-gan Snaadt, just an eighth grader into center field. Snaadt made several running catches and filled in nicely for Cain. The open lineup spot pushed Kelli Meierotto to second and typical 2nd baseman Laura Mehmert went into left field for a little speed defensively.

But the Lions jumped on starter Mary Hellige hitting through the lineup in the first and second innings enroute to a 6-0 lead after two. HTC managed just two base runners on singles in the first two innings off Lone Tree starter Arlie Lorack.

The Lions would put up two more in the third inning and were looking to add more but a single by Hogan Eden to center sent Kayla Dautremont headed for third. A sharp throw from Snaadt right at the bag got Dautremont by half a step for the third out.

The Crusaders would get on the board in the bottom of the third. Cain would fan to start the inning, then Anna Sobczak put down one of three drag bunts for hits on the night. Mary Hellige would then reach on a fielder’s choice that moved Sobczak to third.

Kayla Box followed with a double down the line over the top of Eden’s glove at third scoring both Hellige and Sobczak. A pop out to first would end the inning with HTC down 8-2.

Lone Tree would add an insurance run in the top of the fourth and seventh and Lorack would hold the Crusaders in check through the sixth inning.

HTC would start things in the seventh with Cain and Sobczak getting on with no outs before Hellige clubbed one to the fence in center scoring two to set what would be the final score at 10-4. Kayla Box reached on a walk to put two on still with no outs, but a strike out and sacrifice bunt moved runners at 2nd and 3rd before a fly out to short ended the game.

“We just had too many errors. It’s hard to win with nine errors,” Menke said. “We left runners on base. We didn’t hit great, but if we would have kept the game a bit more in line, we could have put a scare into them.”

The Crusaders are not graduating any seniors so the whole team will be back for the 2022 season.

“We were better in all aspects. Everything starts with pitching in fast pitch softball and Mary was markedly improved over last year and she works her tail off so she’ll be even better next year,” Menke said.

Sobczak went 3-for-4 on the night with two runs scored to lead Holy Trinity. Hellige had two hits, 2 RBI and a run scored. Box, Menke and Meierotto each had hits in the loss.

Hellige went all seven innings and gave up 10 runs five earned on nine hits, while striking out three and walking three.

Holy Trinity finished the year 6-16 and 4-8 in the South-east Iowa Superconference.

# County could take custody of livestock and assess owners

and we always new how many cows, bulls and calves we had exactly. The fact that you can't tell us how many you have is part of the problem here," Seyb said.

The problem has arisen from what Cramer called the "perfect storm" over the past couple of years where wind storms have knocked down branches and trees that have damaged fencing and she can't get caught up with repairs.

Wessel said he's run the fenceline himself and made repairs to his part of the fence and the Cramer's part of the fence, but has seen such provincial efforts as "Wal-Mart" bags stretched between fence posts to try and keep bulls and cattle contained.

He said he's had instances of cattle wrecking his CRP food plots and hunting grounds for years and it has to stop. He's also seen cattle, including bulls, running through his property and up close to his house.

"I have a place and I like my place. If I wanted cattle there, I'd own cattle. It's very distracting when you go to get the mail and there's cattle poop all over the driveway, or hearing and seeing cattle go running through the yard," he said.

Wessel said he never leaves his property without a sidearm out of fear of encountering a wild bull in the area.

"I haven't had that happen yet, but I can see it happening."

Iowa code requires fence owners in Iowa townships to share fencing responsibility and the shared fencing must be at least the same caliber of fencing by both property owners.

Lee County Attorney Ross Braden said he's had ongoing conversations with Cramer about the issue of the loose cattle and said today's conversation is the same information he's been hearing.

He said upon notification the county could go in and erect a fence along the property that is sufficient to keep the animals contained and assess the cost to Cramer. He added that the county could, if the issue continues to be a problem go into the area and take custody of the cattle and charge the owners per day for holding them.

Cramer said she believes all the animals have now been accounted for, but Wessel said he's encountered them in the last several days. Seyb again pressed Cramer as to how many cattle she currently has in containment and Cramer couldn't give a specific answer.

"It's about a 100 head, but it could be 98 or 99. Sometimes you can't see a calf that may be hidden from view, but that's probably within two or three."

Cramer said she only has six bulls, but Wessel said his encounters with the cattle show that about 30% are bulls.

"I've worked with steer and cattle and I know what a bull is. And I would say 30% of that wild herd is bulls. They may be you calves or young and just learning, but those are bulls."

Supervisor Rich Harlow asked all the parties to attend the meeting and speak during public discussion. Harlow asked that the two keep open lines of communication with the county. Supervisor Chair Matt Pflug said Braden outlined things pretty clearly and Cramer needs to get her cattle on her own property and secure the fence or the county would have no choice to take action.

In other action, the board:

- heard an update from the Iowa Municipalities Worker's Compensation Association on the county's progress on worker's comp rates. The county is saving about \$50,000 compared to it's rates six years ago.

- heard an update on the county's property insurance renewal from John Little with EMS insurance, to include the new property obtained in the acquisition of Lee County Ambulance.

# Regional planning may handle Lee County ARPA funding

FORT MADISON – Lee County officials may look at paying Southeast Iowa Regional Planning Commission to help manage requests for distributions of the county's American Rescue Plan Act funding.

The county has received about \$3.3 million of a total \$6.5 million in funding from the U.S. Treasury as part of the stimulus act. The other payment is expected in May of 2022.

A steering committee comprised of two Lee County supervisors, Lee County Auditor Denise Fraise, County Budget Director Cindy Renstrom, Deputy Auditor Sara Helenthal and SEIRPC Director Mike Norris have been meeting for the last two months to set up


how the funding projects will be accepted and approved.

Lee County Supervisor Gary Seyb asked if Norris thought it would be a good idea to hire someone to help make sure the grant allocations would pass the sniff test with the federal government.

Norris said SEIRPC would be willing to help the county navigate the federal requirements, but said it would involve additional compensation over the current per capita funding arrangement in place between SEIRPC and the county.

"I think maybe we could tackle parts of this. We would have to talk about that and see what it looks like," Norris said.






## SEIRPC would charge county extra to handle requests

"There's a variety of ways we could go about that. The critical pieces are the contracts and the applications, making sure the money is drawn the right way, and then verifying the activities have been completed."

Seyb said it might be more efficient for the county to hire someone to do that work.

"I personally think that might not be a bad idea, especially if the money is not coming from taxpayer funds, it would actually come from grant itself. And that person could then focus also on the requirements of the grant and keeping this group apprised of the rules," Seyb said.

Norris said there could be a potential conflict of interest with SEIRPC administering the Southeast Iowa Housing

Trust and the Southeast Iowa Regional Economic and Port Authority, two groups which could be looking at funding requests from the pool.

Norris said the county could appoint someone to verify any funds going to SEIRPC administered group, and each committee member said they were comfortable with that idea.

Ron Fedler said he was also concerned about non-profits going to both the county and cities for funding help and called it double dipping.

Seyb said the guidance is so broad right now that the steering committee would have focus the projects and funding. He said he's already seen requests come in for essential employees.

Seyb said the county should be reimbursed for any COVID-related losses before any funding is allocated. He also said a new Lee County Health Department building should

be a priority rather than renting the space at the former John Bennett Center at the old Iowa State Penitentiary.

Fedler said he'd rather see a subcontractor do the consulting for the county and not make them a county employee so the county isn't on the hook for the position after the funding has been spent.

Under the APRA program, counties have until Dec. 31, 2024 to allocate all the funds they receive, and then until Dec. 31, 2026 to have all the funds spent.

The federal government is still in the public comment time on the guidelines on what will be allowed as qualified expenditures. Renstrom said she wouldn't expect final guidance on that until the fall.

The committee decided to not meet again until next month to see what progress has taken place at the federal level, and then start preparing an application process for groups to submit proposals.

The county is currently recommending that 20% of the funds go to water/sewer infrastructure to help cities with EPA mandated storm and wastewater sewer separations. Other proposed percentages of spending were 30% for Internet infrastructure, which could be used as matching grants to trigger more state and federal grants; 20% for county projects; 10% for housing projects; 10% for child care projects; 5% for non-profit requests; and 5% for tourism-related projects.
