Former County Attorney's legal battles on hold

ANDERSON: Civil suit dismissed without prejudice; criminal theft charge suspended

KEOKUK – Civil charges against a former Lee County Attorney and magistrate judge regarding his handling of a charitable trust have been dismissed, as an additional criminal charge has been suspended pending a psychological evaluation.

In January Keokuk attorney Ty Logan filed a motion to dismiss charges that were pending against Barry M. Anderson who served as Lee County Attorney beginning in 1974, after a stint as deputy county attorney. However the charges were dismissed without



prejudice, which leaves open the chance to refile charges at a later date if appropriate. The actual charges in the civil case are no longer listed in the court records.

Anderson is also facing a 1st-degree theft charge with the Lee County Attorney's office. That case has been suspended until a July 12 hearing to evaluate a psychological competency review, according to

Iowa court records.

COUNTY NEWS Police chief, County Sheriff applaud new 'Back the Blue' law

LEE COUNTY - Area law enforcement officials are touting the impact of the "Back the Blue" legislation signed into law last week by Iowa Gov. Kim Reynolds.

Lee County Sheriff Stacy Weber and Fort Madison Police Chief Mark Rohloff both pointed to qualified immunity as one of the biggest changes in the bill that will have an immediate impact.

Weber said the language in no way gives a free pass to law enforcement.

"The thing I'm seeing the most pushback on is qualified immunity. Without knowing what that means, people think that gives cops the right to do whatever they want and not be accountable, and that's just not the case." Weber said.

"If an officer is breaking the law or violating policy by doing something inhumane or violating people's rights, we wouldn't have their back anyway and nothing's changed that." Rohloff said the new language may actually help make the career choice to be a law enforcement officer an easier one. "It's tough to get someone into this profession as it is. Much less that they're out there on their own without backing in some cases and they have decisions they have to make in an instant,"

Rohloff said.

"There are situations we encounter where we have to make decisions quickly. We're all human and we make

mistakes. This gives them some legal standing to do what their education, experience, training, and background tell them to do in that instant."

> Weber and Rohloff also pointed to new language

trying to elude as an escape can now face heftier charges even if the pursuing vehicle is unmarked.

Reynolds signed the bill at the Iowa Law Enforcement Academy on Thursday surrounded by officers from the state patrol, county sheriffs including Weber, police officers and other law enforcement agencies around the state.

The legislation makes rioting a felony offense, increases penalties on a range of other destructive behaviors, establishes

The school's fine arts department was selected to participate in the annual event, which is part of a college football game between Big 12 and Southeastern Conference schools. The band will perform in the Liberty Bowl parade on the world-famous Beale Street on December 27, while the choir will perform at Graceland-the legendary home of Elvis Presley.


Central Lee fine arts students will also attend the game and explore other Memphis local attractions during the trip.

"These Memphis performances will be an exciting time for the students," said Tracy Madsen, CLHS Band Director. "Graceland and the Liberty Bowl festivities are great platforms to showcase the department's talented students. Other than being a performance trip, the education perspective is important. Students will have the opportunity to hear performance comments from the judges to better their musical skills, along with visiting the National Civil Rights Museum and other educational and cultural venues."

Iowa State played in the Liberty Bowl in 2017, defeating Memphis 21-20 in front of 57,266 fans. The Cyclones also appeared in the 2012 and 1972 games. The Liberty Bowl is one of the oldest bowl games in college football, tracing its roots back to 1959. "I am excited to see opportunities for our students to perform at venues that provide new experiences for our students," said Dr. Andy Crozier, Central Lee Superintendent. "I have been to the Liberty Bowl parade twice, and it is truly one of the top bowl game parades in the country. The combination of the parade and Beale Street creates a

"I made it clear in my Condition of the State Address that Iowa's law enforcement will always have my respect, and I will always have their back," Reynolds said Thursday. "Today's bill embod-

Former Hawkeye Gesell helps at Central Lee hoops camp

Guard for 2012-2016 tells campers that anyone can make it with hard work

DONNELLSON – Mike Gesell remembers wanting to be a basketball player.

It's why the former Iowa point guard likes making appearances like the one he made on Wednesday at Central Lee High School's boys basketball camp.

"When I was growing up I wanted to play at the next level," said Gesell, who played at Iowa from 2012-16. "Every chance I got to learn from someone or play with someone who had done it, I just tried to soak it in. Now I try to give back some of my experiences, help these kids as much as I can."

His message?

"Anyone can make it with hard work," Gesell said. "I'm from a small town, this is a small town. It doesn't matter where you come from, it doesn't matter your background, if you put in the work, you're going to have the chance to be great. Whether it's basketball or something else, just those habits of hard work can transfer over to any area of life."

Gesell, fifth all-time on Iowa's assist list with 557, works as a financial adviser in the Quad Cities. He played one season of professional basketball in Denmark after his career, but decided to return home."

I'm kind of a homebody, a Midwest guy," he said. "Once the NBA dream wasn't there, I was ready to move on."

I miss (playing) a lot. I tell people all of the time, I don't necessarily miss pro basketball — I only played one year overseas, and I decided that was enough for me. I really miss my Iowa days. Coach (Fran) McCaffery, when he was recruiting me, told me and my parents in my first meeting,

he said, "These four years at Iowa, they are going to be the best four years of your life.' He wasn't wrong. I miss those days, for sure."

Gesell also spoke with members of the Central Lee boys basketball team. "I said, 'Every successful team I've been on has been a really close-knit group," he said. "To this day, I'm still friends with all of my teammates. Your four years at Iowa, you spend literally every waking moment with your teammates. You get to be really close with them."

Gesell tries to get to as many Iowa basketball home games as possible, but didn't get that chance this season because of the restrictions placed on attendance due to the COVID-19 pandemic. Gesell did get to see the team play at the Big Ten tournament, but that was it. The Hawkeyes won 22 games and were a 2 seed in the NCAA tournament, falling to Oregon in the second round.

"It was so much fun watching them," he said. "They had so much talent. It was such a hard year. A normal Big Ten season is so tough, so mentally demanding. To go in a year where you're isolated most of the year, you can't get away and go see family, and get a break at any point, that's hard, and the average person doesn't realize that. My hat's off to those guys, how professional they were all year. They played their butts off all year."

There were times, Gesell said, when he wondered what it was like to play in a season like this.

"Every year we would do a closed scrimmage before the season, and there wouldn't be fans there, and it would feel so weird," he said. "I can't imagine the real games. It's really different."

Central Lee girls on four-game win streak

Lady Hawks knock off No. 13 Van Buren Tuesday in 1st game of rain-shortened twinbill

DONNELLSON – The Central Lee girls softball team has won four in a row after dropping a doubleheader to a strong Davis County team last week.

The Lady Hawks knocked off New London in both games of a double header Thursday and then wrapped up the week with a win over Hillcrest on the road Friday. They also edged No. 13 Van Buren 2-1 in the first game of a doubleheader Tuesday night. The second game was suspended due to weather.

On Friday the Hawks put up five runs in a big first inning and then relied on junior Sophie Turner who scattered just five hits over seven innings to get the win.

Central Lee's Macy Watkins would walk to lead off the Hillcrest game. Halo Arrowood would then work a single. After Meghan Hopp grounded into a fielder's choice that forced Watkins at third, the Lady Hawks would rattle off three straight doubles from Shanna Buford, Makayla Morrison and Abby Simmons to take a 4-0 lead with just one out.

An infield popout would give Hillcrest it's second out,



but a grounder to third turned into an error allowing Simmons to score before another grounder ended the inning.

Central Lee would put up three more in the top of the sixth. Bailey Schwartz wore a pitch and Watkins would reach on an error. Arrowood would single to left to load the bases. Schwartz would score on a passed ball with Hopp at the plate, but Schwartz would have been driven in when Hopp laced a triple to right clearing the bases for an 8-1 Central Lee lead that would hold up until Turner closed things down in the seventh with one on.

Turner went all seven surrendering just one run, unearned in the bottom of the first inning. Arrowood was 3-of-4 on the night with a run scored. Hopp and Buford each had 2 RBI hits on the night. Morrison and Simmons had the other hits for the Hawks.



The former Keokuk attorney and Western Illinois law professor filed a written plea of not guilty in the theft case in April 2020, through is attorney Curt Dial of Keokuk. Dial also represented Anderson in the civil case.

Anderson served as trustee for the Amelia B. Hess Trust out of Pennsylvania.

Anderson had filed an official motion with the court to close the trust in September of 2017 after an initial request was entered in May of that year. Efforts to liquidate assets in the trust began in February 2017.

Attempts to reach Logan for comment on the case were unsuccessful.

According to Iowa Courts Online, Anderson had been ordered, in two separate summary judgments by two district judges, to repay close to \$172,000 plus interest. Those judgments, issued in September of 2020 and November of 2019, had not been satisfied when the case was dismissed, according to court records.

A review of a telehealth evaluation was scheduled with District Judge Wyatt Peterson on Monday. The 1st-degree theft charge is a Class C Felony punishable by up to 10 years in prison and a \$10,000 fine.

Hess died in 1930 and was the mother of J. LaRue Hess, treasurer of the Commercial Trust Corp. of Harrisburg, Penn. The trust was a charitable arm that provided funding to several children's homeless groups including: Emmaus House of Mothersville, Mo.; Uhlich Children's Home of Chicago; Fort Wayne Children's Home; Charles Hall Youth Services of Bismarck, N.D.; and Good Samaratin Home of Quincy.

The Trust was created in February of 1984 and Anderson was the appointed the trustee in March of that year with a \$300,000 bond.

ies that commitment in a historic way. The public peace is too important, and the safety of our officers too precious, to tolerate destructive behavior."

The bill also bans discrimination in the enforcement of the law and establishes a process for citizens who believe their rights have been violated to file a complaint with the state Attorney General.

"Today's bill illustrates an important truth: there is no contradiction whatsoever between steadfast support for honorable and selfless law enforcement officers - the vast majority - and a commitment to improving law enforcement," said Gov. Reynolds.

Governor Reynolds also signed HF 708 at ILEA, a separate bill creating a law enforcement equipment fund in the Department of Public Safety. It was seeded with \$5 million in this year's budget.

Another aspect of the Back the Blue law resets sheriff salaries across the state to be more congruent for counties of comparable size.

That could amount to substantial increase in pay for the Weber, Chief Deputy Will Conlee, Capt. Craig Burch and Jail Administrator John Canida, all whose salaries are tied as a percentage to Weber's.

"There will be an effect on the salary and it should make the position more attractive in the future, but that will be Compensation Board decision and I will leave that up to them," Weber said.

Rohloff said that language shouldn't impact his current salary structure.

Lee County Auditor Denise Fraise said the County Compensation Board is expected to meet Monday evening to discuss the new law's parameters and salary requirements.

Other aspects of the new law involve strengthening language for disorderly conduct and rioting.

"They made that almost zero tolerance, Weber said. "I'm a first amendment guy and will stand for people's right to peaceably assembly. But it has to be

peaceful."

The law also provides some protection for drivers who accidentally hit people who are unlawfully blocking roadways with posted speed limits; adds penalties for people pointing lasers at law enforcement officers, and provides more protection for harassment of any law enforcement officer or firefighter, paid or volunteer.

State Sen. Jeff Reichman said there was rhetoric around the senate bill that it would hurt people who want to have a voice, but he said that's not the case.

"That's not what we're doing at all. You see the difference between people that want to come out and have a voice vs. those throwing molotov cocktails and spraying graffitti on the capitol," Reichman said.

"This will increase penalties for agitators who use mob mentality and work things into a frenzy."

He said civilians would still have an avenue to seek penalties for perceived injustices at the hands of law enforcement, but it would be through the agency itself as they are responsible for the training and history of complaints.

"There are a lot of state's losing officers left and right because they didn't enact this type of legislation. It looks out for officers and protects them against some of these things."
