LCHD has list of 3,300

VACCINES: County has 200 doses for 65 and over starting next week

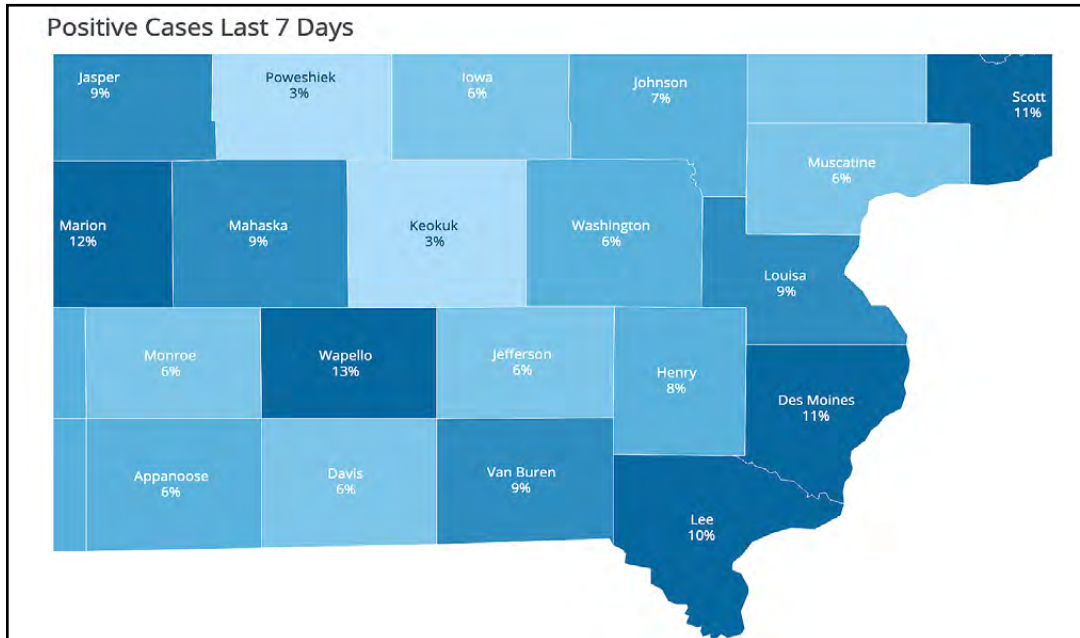
FORT MADISON – Lee County Health officials said they are expecting to see an increase in doses received from the state Monday, a move outlined by Gov. Kim Reynolds on Tuesday.

But with the increase, the county could see a doubling of what they received in their last allocations, which was just 100 doses.

Lee County Health Department Administrator Michele Ross said the county is expecting 200 doses the first week of February, compared to their last allotment of 100.

“Starting next week, 200 individuals from our 65 years of age and older call back list will be vaccinated,” Ross said. “Our call back list now includes over 3,300 individuals from that group.”

Those appointments have already been set for those 200 65 and over vaccinations. The LCHD staff has planned to test a drive-thru

clinic outside the John Bennett center in Fort Madison starting next week.

Those clinics will not be advertised as people without a prescheduled appointment will not be able to show up for a vaccine. Only those 65 and older

who have been contacted by LCHD officials and received a time slot will be able to enter the clinic to get a vaccine.

Ross said the Iowa Department of Public Health determines allocations of doses based on population data from Iowa’s 99 counties. Ross said the doses are prime, or 1st doses. Booster vaccinations will be set up

as the county receives the booster allocations, and should be conducted 28 days after the first dose.

Lee County Health Department has received 600 prime doses to date and 500 booster doses to date. “These all have been accounted for and no doses have been wasted,” Ross

UWGRR gives out 2021 agency allocations

LEE COUNTY – The United Way of the Great River Region held their annual agency allocation event virtually on Wednesday.

And despite a year of cancellations, closures, suspensions, and other pandemic-related issues, the UWGRR, still managed to provide much needed funding to agencies in Clark, Lee and Hancock counties serving more than 58,000 people.

At Wednesday annual meeting, UWGRR Executive Director Karen Siefken said 93 partnering companies, agencies and individuals brought a pandemic-filled 2020 to a bright conclusion of the budget year which allowed many requests for funding to be honored.

The United Way also gave out three corporate awards.

Keokuk Community School District had the highest percentage of growth from employee dollars with a 55.7% increase over 2019 contributions.

Two Rivers Bank and Trust in Keokuk again had every single employee make contributions, while Climax Molybdenum, Freeport McMoRan, had the largest corporate foundation match for the year.

The United Way also got a \$25,000 grant from the United Ways of Iowa to either use for future uses or provide immediate assistance to local agencies faced with added pandemic expenses.

The United Way distributed those funds in their entirety to each school district in the three-county area based

FORT MADISON – Denise Fraise, Lee County Auditor, announces that absentee ballots for the Special Fort Madison Community School District Revenue Purpose Statement Election to be held on Tuesday, March 2, 2021 are now available in the Auditor’s

Office.

If passed with a simple majority of 50%+1, the district will be able to potentially bond against the 1-cent SAVE tax through 2051.

You may vote in person at the Auditor’s Office in the Lee County Office Building, 933 Avenue H, Fort Madison, IA, from 8:30 A.M. to 4:30 P.M. through Monday, March 1st, when this office will remain open until 5:00 PM. If you do not wish to enter the building, curbside voting is available in the alleyway of the same location,

simply call 319-372-3705 when you arrive and someone will come out to your vehicle.

Eligible voters wishing to vote early may complete THE IOWA OFFICIAL ABSENTEE BALLOT REQUEST FORM available from the Lee County Auditor or by downloading the form at <http://sos.iowa.gov>. The request for an absentee ballot may be hand delivered to the Auditor’s office in Fort Madison or mailed to the Lee County

on enrollment.

Seifken said the United Way is working diligently to improve on the 2020 season with a revamped website and growing social media platforms.

“Whatever 2021 brings we will face it together and we will get through it because we are united, we will find a way...a United Way,” Siefken said.

Some changes taking place include the rebranding of the Retired Senior Volunteer Program (RSVP) to AmeriCorps Seniors. The program continues to focus on areas of service in Lee County with regard to health, literacy, the Volunteer Income Tax Assistance (VITA) Program and general community priorities.

Last year RSVP volunteers donated more than 7,200 hours of service in the communities of the three-county service area.

The United Way was still be able to raise just over \$175,000 through the annual giving campaign, spaghetti dinner, golf outing and Restaurant Days.

The 2020 total was just \$35,500 less than 2019. The United Way also received 13 grants for \$72,000 up about \$2,000 from 2019.

The grants provided funding to support volunteer efforts, agency funding and the annual Back-to-School Backpack event.

Ninety-three participating company’s and organizations had employees give donations in 2020.

Seifken said 2021 will be a year of change and additional adaptation as the pandemic begins to release it’s hold on the region.

“In 2021 we will work diligently to increase our annual giving campaign and grow our fundraising efforts,” she said. “We will be releasing our new and improved website and we will continue to improve and grow our social media presence as well.

“We will continue to focus on long-range planning to insure the future and structure of the organization.”

Incoming 2021 United Way President Julie Schilling thanked the agencies in the coverage area for their perseverance through the pandemic.

“I want to thank all our partner agencies for all the hard work you did during the COVID pandemic with your services,” Schilling said.

Fairfield holds on to upset Hounds

FAIRFIELD – The Fort Madison Bloodhounds didn’t get on the board until three minutes were left in the first quarter as they fell to Fairfield on the road Thursday night 55-52.

The Trojans, previously winless in Southeast Conference play, opened up a 14-8 lead at the end of the first quarter, behind J.J. Lanes’s six points.

But Fort Madison would outscore the hosts the rest of the way 44-41, but in the end, the Bloodhounds couldn’t overcome the early deficit.

Fairfield held leads by as much as seven midway through the second quarter and then it was a dogfight the rest of the way. Fort Madison scored five points in the final minute of the first half to cut the lead to three at 28-25 at the half.

The Hounds would get within one at 35-34 with three minutes left in the third, but Fairfield would push the lead back to three at 39-36. A Hound bucket near the end of the third made it a 1-point game again.

The teams would hold at a one point game for the first three minutes of the final period. Fairfield would go up by five with back-to-back buckets at 47-42, but Fort Madison wouldn’t go away and knotted things back up at 52 all with a minute left.

Lane, who finished with a game-high 23 on the night would bury a 3-ball for Fairfield and Fort Madison couldn’t find an answer in the final seconds.

Junior Dayton Davis led Fort Madison with 18, followed by Miles Dear with 16 on the night. Reiburn Turnbull had seven, Philip Goldie had seven and Tate Johnson had four.

Fort Madison moves to 3-7 in the conference and 7-7 overall on the year and hosts Pleasant Valley in an early 1:30 start due to potential for weather. The varsity girls follow hosting Iowa City Liberty.

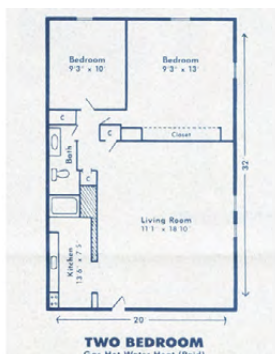
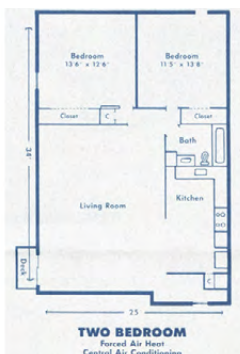

New drive-up clinic set for next week

said.

LCHD has not yet scheduled any employer based clinics as part of the Iowa Department of Public Health's Phase 1b Tier listing. Ross said that won't happen until adequate vaccine supplies have been allocated to meet the demand.

Fort Madison Community Hospital and county long-term care centers have been vaccinated through their respective allotments and protocols. All nursing homes in northern Lee County have received primary doses through the federal partnership with national pharmacy chains, including Walgreens.

Reynolds said Tuesday the boosters should be completed by the first week of February and she's hoping to get any remaining doses not used by pharmacies back in the state's hands for Phase 1b's rollout.

Through Wednesday, 1,943 Lee County residents has received vaccinations. That number includes residents vaccinated by all providers and not just LCHD, including the hospitals and pharmacy chains.

LCHD has been receiving the Moderna vaccine

which requires the booster at 28 days. Moderna sends vials with 10 doses in them, so the LCHD has received 60 vials of prime doses and 50 vials of booster doses.

According to the state coronavirus.iowa.gov website, 1,943 county residents have received a vaccine, while 1,997 vaccines have been given in the county. The difference is individuals that work in health care settings that don't live in the county.

The site reports that 380 county residents have received the full series of vaccines in Lee County, 290 of those have been through county providers.

Statewide 209,575 doses have been administered through Wednesday, 198,764 went to Iowa residents, while the rest have gone to those working in Iowa but living outside the state. The doses statewide are almost split evenly between Pfizer and Moderna.

Across the state 1,460,880 million residents have been tested and 3,568,223 test have been conducted. The state has had 316,679 individuals test positive and 341,976 total positive tests. That would indicate a total number of positive test results to total tests given of 9.6%, where as 21.7% of those residents tested have, at some point, tested positive.

Lee County's 14-day positivity rate of Thursday is 14% tied for 10th highest in the state. It's 7-day rating is 10%, tied for 14th highest currently in the state.

The county has had 3,319 total positive cases through Wednesday and has seen 34 deaths, 28 attributed to underlying causes but positive for COVID, and six directly attributed to COVID-19. The county has seen 2,860 recover from the illness.
