Park Board does deep dive

CREWS OUT: City crews still out cleaning up debris from high-wind event

FORT MADISON – As a result of direction from the Mayor's office, the city's Parks, Recreation and Docks Board spent this weekend visiting all city parks as part of a process to create a five-year plan.

Sunday the board toured Ivanhoe, Shopton, Victory and Old Settlers parks. On Saturday, they toured Riverview, Rodeo and Central parks.

The tours were spurred from a conversation the board had with Mayor Matt Mohrfeld at a meeting last month where Mohrfeld challenged the board to come up with a five-year plan that would outline a long-term vision for city parks.

Board member Hugh Vandegriff said he sees a the board's role as a go-between for the community and city leaders.

"I think the key thing is our role to liaison with the community to get that feedback on what needs to happen," he said, "This is a good first step in getting that feedback. Then we have to ask for more public review."

Going through the parks most needed improvement in handicap parking and restrooms or portapotties. Several parks had trees laying in the park and stump issues.

The group said Central Park was in pretty good

FMCS D offices closed Friday due to COVID

FORT MADISON – The Fort Madison Community School District administration office was closed Friday due to COVID-19.

According to Superintendent Dr. Erin Slater, no other staff were considered exposed due to social distancing and mask requirements. She said the Lee County Health Department was notified of the closure.

"LCHD was consulted, notified of mitigation efforts, and central office staff were notified to work remotely today," Slater wrote in an email to Pen City Current.

She said school district guidelines for exposure are defined as being in the presence of a positive person for 15 consecutive minutes where masks were not worn by both parties. Current district protocols also require any visitors to the Central office to wear masks so no additional exposure was identified.

The office, located at 1930 Avenue M, holds offices for the Superintendent, Business Manager

Sandy Elmore, Tiffany Fullhart, Food Service Director; Kim Harmon, Director of Curriculum and Student Service, transportation staff, and other administrators and assistants.

Slater said the rising number of cases in Lee County is of concern.

The district returned to in-person learning on Monday and as of Thursday, the 14-day positivity rate for Lee County was 15.5. The other three surrounding counties and rates are, Des Moines (19.8), Van Buren (19.8) and Henry County 18.1.

Fort Madison has students from three of the four counties.

"We monitor the county positivity rates for Lee, Henry, and Des Moines counties since we have students from all three counties in our district," she wrote.

"The rising numbers are of concern, so we continue to review daily to make sure we continue to provide a safe environment for students and staff."

She said the office will reopen on Monday.

Vietnam vet carries heavy memories

Soft music plays constantly in Rich and Pat Pendroy's home in Monroe, and in his man cave, which is in the rear of their garage that they converted to a workshop. Rich doesn't say it, but the soft music helps calm his nerves that are frazzled from the explosions and gunfire he went through in Vietnam.

His man cave is every man's dream (and every wife's point of contention). Lining one wall and parts of two others are 20 beautiful deer head mounts (all his own), plus furs and different mounts of fish, fox, mink, badgers, birds, etc. He did the taxidermy himself. He used to be a taxidermist but just does it for himself now, and his kids. He got tired of having to meet other peoples' wishes. He has display cabinets (that he made himself) full of Indian artifacts, and old hand tools. Artifacts are harder to find now, he points out, because farmers don't plow anymore. One of the pictures on his wall is of a yellow Plymouth Roadrunner he purchased when he came home from Vietnam. He wishes he still had that car, but Pat couldn't drive it.

He ran his own construction business building houses, cabinets and doing finish work. He's retired now, and turned the business over to his sons. His man cave and shop are one of the neatest and best organized man dwellings I've ever seen. Once again, he doesn't say it, but I have the feeling that Rich's neatness has to do with the lack of control he had while in Vietnam. There was chaos everywhere in a world gone crazy.

He was a year out of high school when he was drafted into the Army. He found out that if he volunteered for the Marines it would delay his departure by 120 days. He liked the idea of the Marines: pride, valor and honor. He'd seen the movies:

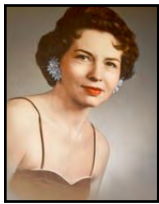

State jobless rate drop slows

DES MOINES - The number of initial claims in Iowa, filed between Sunday, Oct. 25, and Saturday, Oct. 31, was 4,964. There were 4,478 initial claims by individuals who work and live in Iowa, and 486 claims by individuals who work in Iowa and live in another state. The number of continuing weekly unemployment claims was 37,290, a decrease of 2,535 from the previous week.

The U.S. Department of Labor adjusted last week's initial claim number to 4,351 (a decrease of 440) and continuing claims to 39,825 (an increase of 210 for a total decrease of 230 overall). Iowa Workforce Development relies upon the weekly data released by the U.S. Department of Labor to report its numbers and as such, adopts the revisions to the previously published data.

November and December are traditionally a time where we see an increase in unemployment claims due to cooler weather and the end of harvest. Employers in construction, agriculture and landscaping often start to lay off their workforces. It is unclear if we will see manufacturing layoffs given slower

production schedules this year. Thus, we may see an increase in unemployment benefit claims. December through the end of February are historically the time we see the highest levels of unemployment.

For the week ending October 31, 2020, unemployment insurance benefit payments totaled \$10,416,685.95. The following industries had the most claims:

- Manufacturing (1,227)
- Construction (693)
- Industry Not Available - Self-employed, Independent Contractors, etc (593)
- Health Care & Social Assistance (441)
- Administrative, Support, Waste Management, and Remediation Services (294)

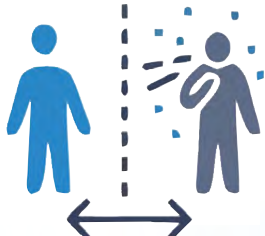

Police chief says no evidence in posted burglary attempt

FORT MADISON – An early morning social media post that has the attention of the city has turned out to be without merit.

A social media post from a juvenile in town indicating there was at least one armed robbery on the city's east side has been taken down after a conversation with local police.

According to Fort Madison Police Chief Mark Rohloff, the post has been investigated and taken down by the individual who posted it. The investigation has turned up no evidence to substantiate the claims.

“These unconfirmed reports had no

basis and police cannot substantiate the claims made in the post,” Rohloff said.

“Our bigger concern is that these types of rumors instill undue public fear.”

The post claimed that a subject had been robbed at gun point by two teenagers while walking home from a convenience store. It also read when the alleged victim notified authorities, Fort Madison police said it was the third report that day.

Rohloff said there are no reports of armed burglaries that day, only one case of someone swiping a skateboard.

shape with the exception of some stumps. Board member Sue Pieper said Fort Madison Rotary is doing an excellent job maintaining the park.

In Riverview Park the board said the Marina needs some work but a separate group is steering those discussions.

Pieper said the group thought a soft launch for kayaks and canoes somewhere along the riverfront would be a good addition as well as more regular cleanup of the embankment.

They also suggested additional historical and wildlife signage along the drive and getting the fountain functional in all seasons. A discussion was rekindled about a possible camper area at the west end of the park in the western most parking lot, and possible

camping space in the timber to the west of the parking lot.

In Rodeo Park the group said full hookups would be a great addition in as well as a few more pads for more campers on both sides of electrical hookups. The horseshoe pits could use renovation as well as some improvements to the kids playground area focusing on younger children.

Pieper said another bridge is needed at the end of Scenic Drive.

"We are so fortunate that a few years ago all of our shelter houses were repainted and are in pretty good shape," Pieper said.

At Ivanhoe, there were several trees that had been uprooted and cut down and there were no benches near the play-

ground for parents to sit on. Board member Jacqueline Lumsden said a shelter house had been taken down where a cement pad sits in the center of the park. The group said it would be nice to have that shelter rebuilt.

Additional items in Ivanhoe included removing some of the bleachers at the ball field and taking down the concession stand.

There were several maintenance items on the restroom including replacing the doors. The group also said putting new updated basketball hoops on the court on the northwest side, and then having someone touch up graffiti in the skate park would be nice additions.

Shopton recommendations included putting

some black screens along the east side fencing to hide some of the run-down structures on the other side. Some small repair to fences around the Featheringill ballfield and possibly adding a few additional playground features for very young children.

At Victory Park, heavy focus was put on the former tennis courts that have wrinkled surfaces. Pieper said the city could look at converting or adding pickleball courts to the surface.

Lumsden, who lives in the neighborhood of the park, said she'd like to see at least one tennis court kept on the property. Pieper said there are 10 courts in town and pickleball is gaining in popularity. The subsurface is cracked and patched and the group thought the whole surface and concrete underneath needed to be replaced.

Other concerns were the surface of the ball field being very hard, bleachers needing replaced, either taking the concession stand down or repairing it and adding handicap parking. Lumsden said she'd like to see fencing replaced

on the southside to keep balls and children from running into the street. She also said the northwest entry needed to be handicap ramped for disabled residents and bicycle riders.

Old Settlers Park has ongoing advocacy from the Old Settler's Association but had a few minor issues that could use attention, Decker said.

Pieper said the board has a new sense of direction and short of that she was thinking of resigning from the board.

"I've been on this park board for a long time and almost got off it because I thought it was kind of a waste of time," said board member Sue Pieper. "But now we have direction and this is getting to be fun."

Decker said some in community have questioned the need for the board

"Everyone was bringing up the fact that what use is the park board if we don't have a say so or know what's going on. And people would go to the council with stuff when they should be going to board first," he said.

Pieper said recent news that the board is

taking a hard look at parks is generating ideas from the community.

"That's what's so much fun," she said "I got so many ideas when I started asking people what they thought we needed."

Decker said parks are key to keeping people in town with options to get outside, but also are critical in recruiting new people to town.

"When people move two things they look at first - schools and jobs - and then they look at parks."

Vandegriff said the whole board has a renewed sense of responsibility and direction.

"I think our goal is really to help establish that vision for five years and then we can really say, 'Here's the plan.' And then as a board we drive against the plan. And I think that's what the mayor is asking for," Vandegriff said.

Pieper agreed. "If you don't have a vision, you're not going to go anywhere."

Lost friend a tough memory as Veteran's Day approaches

John Wayne, Audie Murphy and Gary Cooper as Sergeant York. He talked his buddy David McMath, who had just graduated, into going in the Marines with him, on the Buddy System. They would be together through boot camp and post boot camp training.

They went to Vietnam together and were split into different units—Rich with Hotel Co., 2nd Battalion, 7th Marines; and Dave with Kilo Co., 3rd Battalion, 7th Marines as 0331's, M60 Machine Gunners. The year was 1967.

Like most combat veterans, Rich doesn't talk about the fighting. He doesn't have to. His sergeant stripes in a display case full of medals speak for themselves.

He didn't see Dave for a while. Then one night he heard Dave's company was close by. They were both supposed to go out on patrol the next day, but accommodations were made for them to spend the day together. Their buddies chipped in and supplied Rich and Dave with all the beer they could drink.

That was the last Rich saw of Dave. Rich got a letter from his sister saying, "So sorry to hear about Dave getting killed."

Rich was stunned. He had no idea what, how or when Dave was killed. Rich was to find out later that Dave drowned—how, Rich never knew. But a lot of Vietnam soldiers died by drowning. Crossing those swollen streams and rivers with full packs and weapon was very dangerous.

Vietnam shaped the rest of Richard Pendroy's life. But he's a survivor. Rich's oldest son is named after Dave, which is a pact they made. If either one of them didn't make it home, they would name their first son after the other. Rich has visited the Vietnam Memorial Wall a couple of times and found Dave's name.

On a recent fishing trip to Decorah in NE Iowa, Rich was observing a young Hispanic couple trying to fish for trout. Using a bobber, weight and worm, they had no idea what they were doing. Rich patiently showed them the proper tackle to use. A few minutes later the young

man came running, all excited with a 16" trout. Rich told him some people fish all their lives and never catch a 16" trout.

It was raining. Rich also showed the young couple how to start a fire, and clean the trout.

The next morning there was a note for Rich thanking him for showing them how to fish, start a fire, and clean the fish. The man, who was an artist, had drawn a picture of the trout on the card.

Rich gets a little misty eyed when he tells this story, but not for long. It's getting late, and there's still time to get out into his tree stand for some deer hunting. He uses a crossbow now, because of surgery on his shoulders.

This Veteran's Day, November 11, which is also Rich's wife's birthday, give a veteran a hug. God bless you, Richard Pendroy.

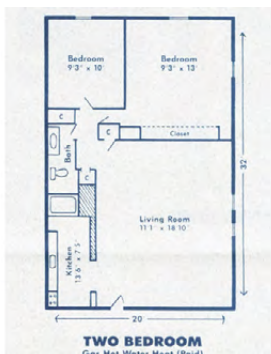
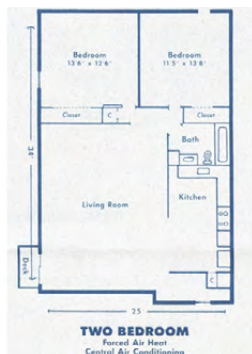
