## County seeing uptick again in COVID-19 cases

LEE COUNTY - County health officials are reporting 86 new positive cases of COVID-19, the disease caused by the novel coronavirus.

The new cases represent all new cases from Monday afternoon March 22, through Friday afternoon March 26, as the county has reduced reporting new cases to Mondays and Fridays. The 86 represents more than 20 per day this week. The county had multiple days with 0 new cases since the beginning of March leading up to Monday.

According to Lee County Health Department data, the new cases represented an uptick in the county's 14-day positivity rating which is still below 1% to .6%. However, the county's 7-day rate is now back at 1%.

The total number of cases is now 3,860 with 3,565 listed as recovered.

The state's positivity rate is closing in on 5% with a 4.7% 7-day positivity rating as of Saturday morning, and 4.3% 14-day rate. That number has hovered between 4% and 5% for the past 30

# Politics has me rethinking my pizza

 $\mathbf{I}$ 've been thinking a lot about my political leanings lately. But to avoid being boring, I've also been thinking about Ron-DaVoo Pizza a lot, too.

We typically order our pizza in Fort Madison, but every now and then you gotta get some of those creations that Ron Litchfield conjures up in the kitchen on Angular in Burlington.

I'm a bit fickle with my pizza, the deeper the dish and the heartier the crust, the more I'm your friend. But the wonkie politician in me tends to lead toward common sense – like a pepperoni with extra cheese. Simple, effective, and typically mainstream.

At the outset of this political session there have been some things that make me think twice about my preferences.

One thing I don't think twice about is Rita Hart skipping the option to have Iowa's Supreme Court pick a bi-partisan panel of judges to verify the election results for the 2nd District U.S. Representative spot vacated by Dave Loebsack.

Hart, the Democrat, currently stands six votes away from the U.S. House of Representatives. Mariannette Miller-Meeks, the Republican has been seated provisionally with the win. It's a win that was validated by the state's canvass board after the 24 counties in the 2nd District recounted the November election.

Hart did an end-run around the state process and went directly to a House committee based on an age-old law that permits the U.S. House to evaluate the election results and ultimately seat the candidate based on that committee's findings.

Hart and her lawyers know Dems have the numbers in the House to overturn

days.

Lee County Health Department will be opening up their COVID Hotline number to continue to schedule appointments for the March 30 COVID Vaccination Clinic at the LCHD Offices (#3 John Bennett Drive) in Fort Madison. This includes those who are 64 and under with certain underlying medical conditions. Some of those conditions include: cancer, chronic kidney disease, COPD, Down Syndrome, heart conditions (heart failure, coronary artery disease, cardiomyopathies), Immunocompromised state (weakened immune system) from solid organ transplant, obesity, pregnancy, Sickle cell disease, smoking, and Type 2 diabetes mellitus.

Anyone who falls in that tier, along with those 65 and over, health care workers, first responders, K-12 school staff, child care staff, tier 2 essential workers (food processing, agricultural production, distribution, manufacturing), and individuals with disabilities living in home settings and their direct care staff can call (319) 376-1077 beginning Monday, March 29 from 8:30 a.m. to noon to schedule an appointment.



## Deacon, Johnson, Rhoer all take firsts at Roth Relays

Johnson's 100-meter dash top 5 in all classes at 11:53

WASHINGTON – Senior Ethan Deacon, and juniors Tate Johnson and Macaden Rhoer led Fort Madison to a first-place finish in the B Division of the Steve Roth Washington Relays Friday at Case Field Friday night.

The meet was moved to Friday after weather clogged things up on the originally scheduled date of Thursday.

Deacon took first place in the seven-team B division with toss of 45-2 in the shot put, a new personal best, and then scored a 3rd place sling in the discus with a 126-7.

Tate Johnson won the 8th heat of a 9-heat field in the 100-meter dash with an official time of 11.53. His time was top five time in all three classes.

Johnson then sprinted the anchor leg of the Hounds' winning  $4 \times 200$  team (1:35.62) with Brock

Califf running the first leg to Jakob McGowan who handed to Andrew Schaefer, before Johnson cleaned things up.

Coach Mike Schneider was all smiles after the 100 meter dash and said Johnson's just a good kid who works hard.

"I think we could've got another .1 of a second out of him if we had him seeded in the final heat, but he was fast today," Schneider said. "I think he could also get a little better start, but I couldn't be happier with his run. He's just a good, hard working kid.

Macaden Rhoer then captured 1st place in the 400 hurdles in a time of 1:02.90.

The Bloodhounds finished with 125 points to take the B Division. They were without a couple varsity runners Friday with Miles Dear out, and Austin Miller, who qualified for state cross country last year, missing from the distance runs with an injury.

Also placing in the field events, Dayton Davis finished 2nd in the high jump clearing 5-8, a personal best for him. Landes Williams cleared 5-4 which was good for fourth place.

Jakob McGowan jumped his way to 3rd place in the Long Jump leaping 19-3.5. Landes Williams competed in the High Jump clearing 5-4 good for 4th place. Rounding out the scoring in the field events was Kane Williams placing 6th in the Long Jump leaping 17-5.5, and Cuyrin Ross placing 6th with a Personal Best heave of 38-6.5 in the shot. Ross also threw the Discus 85-9 placing 12th. Jake Perry competed in the Shot Put with a 33-2 mark and Discus (88-11) placing 13th and 10th, respectively.

"We're a relatively young team experience wise, but this group collectively has a lot of potential. We still have work to do, but I saw a lot of good things from our guys last night," said Coach Chad Hannum.

The Shuttle Hurdle Relay team consisting of Kane Williams, Segoviano, Teague Smith, and Henry Wiseman hurdled to a 2nd place finish in a time of 1:18.10.

Garrett Hannum sprinted the quarter in 55.59. Brock Califf ran a 24.71 in the 200 and Rhoer ran in another hurdle race, the 110 High Hurdles with a time of 18.91, all good for 3rd place finishes. Two relays place 3rd – the 4 x 100 team of Gavin Wiseman, Jakob McGowan, Joey Dodson, and Tate Johnson posting a time of 46.09 seconds and the 4 x 400 team of Califf, Rhoer, Davis, and Nick Fullenkamp gutted out a 3rd place finish in a time of 3:51.81.

The Sprint Medley team of Tanner Stoermer, Landes Williams, Joey Dodson, and Dayton Davis sprinted to 4th place finish (1:44.52). Landes Williams also ran a good race in the 400 (57.09) taking 4th. A much improved Gavin Wiseman placed 4th in the 200 (25.05). Younger brother, Henry Wiseman placed 4th in the 110 High Hurdles (19.80). At this meet they run a fun race for our "weight men". Henry Wiseman joined throwers Deacon, Jake Perry Ross in the 4 x 100 where they placed 4th.

The 4 x 800 team made up of three underclassmen John Cottrell, Dane Butler, George Hantzeas and led by Junior Hayden Wolfe raced to a 5th place finish in a time of 9:59.24. Also placing 5th was Hayden Segoviano in the 400 Hurdles(1:08.83).

Others competing were: 3200-Will Gager 9th(11:45.46) and Cameron Shutwell 11th(14:14.54), 110 High Hurdles- Segoviano(20.37), 800- Cottrell 8th(2:21.75) and Fullenkamp 12th (2:29.39), 200-Kane Williams (25.53), 400 Hurdles- Teague Smith(1:09.18), and the 1600-Hayden Wolfe 9th (5:24.79), Gager 10th(5:28.23), and Hantzeas 12th(6:00.64), 100-Kane Williams 7th(12.20) and Teague Smith 14th(12.92).

The boys run at the 12-team West Burlington Notre Dame Relays on Monday.



## State partnerships making finding vaccines easier by the day

Miller-Meeks' win. At issue is about 22 ballots in question that Hart said should be counted and could potentially overturn Miller-Meeks' win.

There's no doubt that every single valid vote should be counted.

The problem here is that it is very likely a political party will be the one determining what ballots are legit. That shouldn't be the way it works. Just like pineapple shouldn't be on your Canadian Bacon and mushroom pizza.

Election laws should begin and end in the state that are being cast – save for the unheard of dead tie.

Rita Hart needs to let this go. Even if she finds seven more votes, there will be a crazy loud and legitimate claim that Dems stole the election. We're saturated with that. If Hart had gone to the state court review, which in all fairness could have had a Republican tilt to it, she would look better in the long run – and in two years.

It was the closest election in the nation this cycle and there's always going to be that deeper hurt when it feels like some votes weren't counted properly that could've swayed the decision. There's no guarantee that the votes break Hart's way and there's no guarantee they won't. But what will be guaranteed is more divisiveness.

This could be a chance to heal some wounds.

It's also not lost on me the hypocrisy in Republicans threatening social media companies with footprints in Iowa, that pull down posts from public officials while at the same time and sometimes even on the same day, those same Republican want to legislate what can and can't be said in state diversity trainings.

The learning curve on Republican election re-calibration bills has been very small with limiting early and absentee voting laws in Iowa. They claim it's security, but that's just window dressing. Don't use that window dressing in your bedroom or bathroom because you can see right through it.

This is an election re-calibration to remove some of the obstacles the GOP pointed to on a national scale in very, very close elections. This last cycle points to the emotion we have as a nation as to what direction we should head.

I was disappointed in President Joe Biden's treatment of a journalist this week who asked about the situation at the border and when he was planning to fix it. The President asked her if her question was serious? More of this garbage? That's a real situation and every question is serious.

But I've been overwhelmingly impressed with his ability to foster a partnership with competitors Merck and Johnson & Johnson to churn out vaccinations at an unheard of pace. Biden went from asking for 100 million doses by May to 200 million. And he's gonna get them. Let's hope we don't hiccup in the haste.

Many people have reached out to Pen City Current to help get the word out about extra vaccine openings at pharmacies around the area.

But we can, and do, update regularly the Lee County Health Department's efforts, hotline and vaccination openings. It's safe to say at this point, that a little bit of early morning energy can just about find anyone a vaccination at this point, within a week or two. Maybe quicker.

I got my first shot two weeks ago in Hamilton at the Hy-Vee there. I took my daughter just in case there was something I needed to have her to drive home for. I asked if they had extra that day. She didn't have any underlying conditions, but she was here. They said they did have extra and she got her vaccine and was scheduled for her next one.

I've heard that Hy-Vee's actually make announcements in the stores that if anyone hasn't had the vaccine, they have extra and come back to the pharmacy. If you want a vaccine, and everyone should to insulate all of us, they really are getting easier and easier to find.

I made the trip to Washington to Case Field for the first outdoor track meet of the year. The season was canceled last year. Hearing Mike Jay announce the game was as fresh a reminder of the season as the spring breeze that blew in from the southwest. Jay, from Columbus Junction, is the public address guy for the state cross country meet and state track meet in Des Moines.

Being out was good and seeing Dayton Davis hanging in midair slipping over the high jump bar, and Tate Johnson opening some eyes in the last 25 meters of the 100-meter dash, brought a smile to my masked face. You can see it in my eyes – But that's Beside the Point.
