Supervisors to get FM Marina pitch

FORT MADISON – Lee County Supervisors will get a turn to look at the proposed \$6 million Fort Madison Marina project Monday.

Supervisors will hear the presentation from Fort Madison Mayor Matt Mohrfeld as he continues to get the project in front of stakeholders.

The Fort Madison City Council approved a resolution in support of spending \$1.5 million of city funds on the project. That could trigger an equal investment from Southeast Iowa Regional Riverboat Commission for waterside improvements including four new docks, two covered and two uncovered.

Firefighters pull swamped boaters off Mississippi

FORT MADISON – Fort Madison firefighters pulled a stranded boat off the Mississippi River Sunday morning. No one was injured in the incident.

At about 10:20 am the Fort Madison Fire Department was dispatched for a report of a boat that was taking on water approximately a mile north of the Santa Fe bridge. Fire crews responded with the department’s utility truck, along with rescue boat 9481.

Upon arrival at the entrance of River-view Marina, the crew made contact with the 911 caller. The caller provided the crew with the phone number of a person on the stranded vessel. Contact was made

Trooper murdered in stand-off in Grundy Center

GRUNDY CENTER – On Friday Iowa State Patrol Sergeant Jim Smith, a 27-year-veteran of the Iowa State Patrol, was shot and killed while attempting to arrest a barricaded subject in Grundy County.

On Friday, April 9th, at approximately 7:22 p.m., Grundy Center Police attempt-

ed to conduct a traffic stop on Lang, within Grundy Center City limits. Lang fled from Grundy Center Police and he was chased to an area southeast of town. Lang pulled over on 250th Avenue, exited his vehicle and assaulted the Grundy Center Police Officer who chased him. During the assault, Lang yelled, “shoot me” mul-

tiplied times to the Officer. Lang disarmed the officer of his Taser, removed his radio and put the Officer in a chokehold.

Law enforcement responded to the area of the assault. A Grundy County Deputy arrived on scene and witnessed the Of-

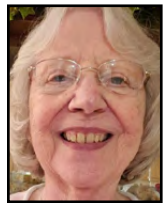

Local author to hold meet and greet for first book

It is with great pleasure I announce a book signing and “Meet the Author” for L. Kephart-Nash, better known as Linda Nash, of Ft. Madison. This gala affair will take place on Saturday, April 24th, at 1:00 p.m., at the First Christian Church in Ft. Madison, 608 10th St. Masks and social distancing will be observed. If it’s a nice day (hope, hope), we’ll meet across the street in Central Park where it will be easier to social distance and enjoy nature. Yours truly (me) will be introducing L. Kephart-Nash to the community and world, although for those of you who know her, she needs no introduction.

At 83, this is her first book. “When the Tempest Passes...and the Wicked is No More” is a smash hit. No fooling. It’s about her Norwegian grandparents’ life in SE Minnesota/NE Iowa, eking out a living on hard-scrabble land. The story is rife with silent abuse, an arranged marriage and even the possibility of murder. At the turn of the 20th Century, suffrage was a but whispered topic around the dinner table, that took second and third place to hard work, minding your own business and following the Will of God. It was a tough life where men ruled and women fell in line.

Beautifully written with breathtaking prose, and a story line that can stop you dead in your tracks, not once, not twice, but multiple times with an unfolding mystery, “When the Tempest Passes” might be the Great American Novel of the 21st Century. I say this in all seriousness. I don’t hand out compliments that easily, but L. Kephart-Nash might be a Virginia Woolf, Emily Dickinson, or Harper Lee in disguise. Sucking up her courage, she took my creative writing class

and exploded on the page. I just stood back in amazement and made sure she had free rein to write with abandon. Like writers of old, she writes everything long-hand. Her daughter does the word processing.

Here is what one of my readers had to say. “I am a retired school teach-



er...I just finished rereading ‘When the Tempest Passes’ by L. Kephart-Nash and I can’t thank you enough for connecting me to this book and author. What an amazing story along with such beautiful prose! My book club has chosen Ms. Nash’s book for discussion...I read that you are perhaps planning a meet-the-author

party for her and wanted to make sure we didn’t miss the chance to know about and attend that event.”

And another reader: “I enjoyed the book, (except I don’t know if enjoy is the word to use). It was one that really made me think and I went back to reread parts. I am passing it along to my sister. I hope the author does write more books.”

Well, yes. L. Kephart Nash has written another book. No one-book

wonder is she! “A Spacious Place” will be released soon. This makes two books in little over a year. “Prolific” doesn’t even begin to express energy of that nature.

A retired RN, moving from obstetrics to geriatrics, married to a Presbyterian Minister, and having six children, Nash has experienced the full gamut of heartbreaks and rewards of a full life. Never having written before, she writes stories that are within her, the ones that have been

begging for exposure all her life. “Raw talent” is a good descriptor of her, another is “brave,” still another, and the most important is, “Christian.”

You won’t be disappointed in L. Kephart-Nash, A.K.A, Linda Nash. Books will be available at the “Meet-and-Greet.” If we’re lucky, she’ll even read a little selection from “When the Tempest Passes.”

The commitment from the city also was required as part of a federal Community Project Fund administered as part of the American Recovery Plan through U.S. Rep. Mariannette Miller-Meeks' congressional office.

The initial price tag on the project is \$6 million, but Mohrfeld has been up front in saying the project could range to \$11 million when all facets of a multi-phase plan have been implemented.

Federal Emergency Management Agency (FEMA) funding is also coming into play in the re-dredging of the marina, which is set to begin in September. That will also require the pulling off of all current dock slips, which are set to be replaced.

The city is looking for a letter of support from the county to be used in applications for additional funding mechanisms including the congressional grant.

A multi-tiered public/private lease structure is planned to be in place for the 5-star marina with maintenance funding coming from proceeds of the brand new hospitality center that is being planned as new construction.

Wellman's goal lifts Hounds past Washington

Fort Madison rolls MP 10-0 in rain-shortened Saturday soccer tournament

FORT MADISON – It wasn't the most pleasant of nights, but the Fort Madison Bloodhounds got their first soccer win of the year on a chilly, wet night at Baxter Sports Complex.

With some other events canceled due to weather, the Hounds took to the pitch and came away with a 4-2 win over Washington to move to 1-1 on the year and 1-0 in Southeast Conference action.

Xander Wellman and Jacob Pothitakis both had two goals in the win, each with a goal in both the first and second half.

A goal into the right side of the net past a sliding keeper from Xander Wellman proved to be the winning goal at the 24:12 mark.

The Hounds opened up a 1-0 lead when Pothitakis took a ball from Williams at with 28:08 left in the first half and punched it in. Then just three minutes later Wellman scored on an assist from Mitchell Pothitakis.

On Washington's next trip down the field, the Hounds were whistled for a knock down on a Demon attack resulting in a penalty kick, which squirted by FM keeper Reiburn Turnbull with 24:11 left in the period for a 2-1 score.

No other goals were scored in the first half.

The Demons would tie things up at the 29:47 mark with an attack from Turnbull's left side. The Demon's shot the ball across the front of the net and into the net as Turnbull dove to his right to make it 2-2.

Most of the rest of the match was played on Fort

Madison's side of the field with plenty of action at midfield.

Wellman broke the tie with his shot from the left side into the right bottom of the net. Mitchell Pothitakis would miss a penalty kick to the right side and high before Jacob Pothitakis would cap the scoring on an assist Mitchell with just over four minutes left in the game.

Head Coach Kevin Wellman said the Hounds are still seeing two different styles of play with the inaugural year of a combined Fort Madison and Holy Trinity Catholic team.

"We're still working some kinks out the different styles of play and that's causing some trouble deciding when to play certain styles," he said.

"But the chemistry when we have the ball in the middle of the field is fantastic. Really good short passes amongst the midfielders. Even transition to defenders to the midfielders is really good, we're just having a bit of a disconnect getting into the attacking third of the field."

Fort Madison took 24 shots on the night to the just nine from the Demons. The Hounds had 13 shots on goal. Turnbull had two saves

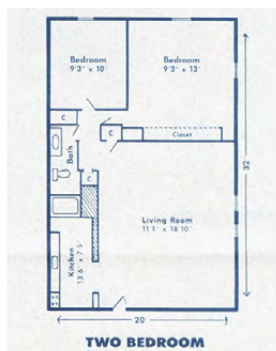
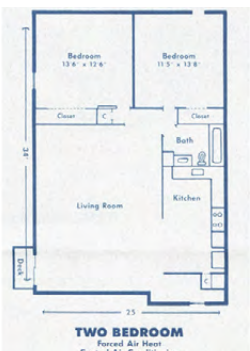

ficer recovering from the assault and Lang in the area of the Officer's patrol vehicle. The Deputy drew his weapon and gave commands to Lang to put his hands up. Lang did not comply, stating, "Come get me," and subsequently got into his vehicle and fled the area.

The Deputy pursued Lang back into Grundy Center but lost sight of him. The Deputy went to Lang's residence located at 305 G Avenue, saw Lang's vehicle parked in the driveway, and Lang walking into the residence through the garage. The Deputy requested assistance from other law enforcement officers. Responding law enforcement set up a perimeter around the house. Lang's father arrived at the house and advised law enforcement that Lang had multiple firearms inside the residence, including a .410 shotgun.

At approximately 8:55 p.m., Sgt. Smith, three additional ISP Troopers, and a Hardin County Sheriff's Deputy K-9 unit made entry into the residence through the door of the garage leading into the residence. Prior to entering the residence, Sgt. Smith and the entry team verbally identified themselves as law enforcement. They also announced that they would send in a K-9. As Sgt. Smith

and the entry team began to clear the upstairs of the residence, Sgt. Smith was hit by gunfire coming from inside the residence. After Sgt. Smith was shot, members of the entry team observed Lang emerge from the doorway holding a black pump action shotgun.

Two members of the entry team retreated into the basement while other members of the entry team pulled Sgt. Smith from the residence. Lang then barricaded himself inside the residence and refused to come out. Members of the entry team that remained in the basement stated that Lang made several statements about having shot Sgt. Smith and expressed a desire to shoot more police officers. Lang remained barricaded inside the residence for several hours.

At approximately 11 :50 p.m., an ISP Tactical Team attempted to make entry into the residence with a wheeled armored personnel carrier. During the entry, Lang shot multiple rounds at the personnel carrier. Lang was subsequently taken into custody by ISP Tactical Team members.

Trooper Smith began his career as a member of the Department of Public Safety's 19th Basic Academy in 1993. Upon graduation, he was first stationed in Fairfield - District 13, and in 1996 relocated to District 10 - Oelwein.

with the stranded boat which confirmed their location and that there were two people aboard. The rescue boat was launched from the Willow Patch boat access at 10:42 am. The crew arrived at the stranded boat at 10:53 am. Firefighters found a boat up against shore with two persons aboard. The boat had been swamped by multiple large waves prior to arrival causing it to no longer be operational.

The boat rescued was one of the team fisherman that were part of the Twisted Cat Catfish Tournament on Pool 19 of the Mississippi River.

Firefighters towed the boat, along with the persons on board, back to Riverview Marina arriving at 11:38 am.

While today's incident had a good outcome, any incident on the river can quickly become dangerous. With the summer months approaching, FMFD would like to remind the public to practice proper boater safety and to never hesitate to call for assistance on the river.

The Fort Madison Fire Department is fully equipped to handle emergencies on the water.
