County drops masks

SUPERVISORS: Vote to end mandate for masks in county buildings

FORT MADISON - Lee County Supervisors have lifted the mask mandate for people using county offices going forward.

At Monday's regular meeting of the Lee County Board of Supervisors, supervisors voted unanimously to lift the ban which requires county residents and staff to wear masks inside county office buildings.

The move doesn't preclude anyone choosing to wear a mask from being able to do so obviously, but Supervisor Gary Seyb, Jr. said it should be up to people at this point to be able to make the choice as to whether they want to wear a face covering or not.

"I'm not saying don't wear a mask. If you want to wear a mask, wear one, I'm just saying drop the mandate," Seyb said.

Lee County Health Department Administrator Michele Ross said she would like to see the county's vaccination rate, which is just over 31% now, a little higher before everyone starts dropping masks.

Supervisor Ron Fedler said he thinks the numbers is higher than that because Lee County residents could have gone

Brighton woman learns lesson trapped in pantry

Y ou know you've been in the insurance business a long time when you go to a home for an appointment, realize you've been in the home before, but with a different family. (Deja vu all over again, as Yogi Berra would say?) Such was the case for me in Brighton. It was a nice brick ranch home. We sat in the same dining room, looked out the same picture window, at the same beautiful backyard, but with different people.

The lady, 75-year old Pat Hagist, was baby sitting her nearly two-year old Great Grandson, Waylon, that day, a beautiful child. She explained that he was born with three holes in his heart, but the defect had been repaired surgically. Waylon now pushes her heavy furniture around like toys.

Pat pointed at two side-by-side doors in the kitchen. One door was to a bathroom, the other a pantry. The pantry had been a closet but her kids built shelves and made it into a pantry for her.

Last November, she was taking care of Waylon and was in the pantry getting something. Waylon, being a helpful child, shut the pantry door. No problem, except there was no door handle on the inside of the pantry door. Fortunately, the pantry had a light. Pat kept her cool. She spoke to Waylon through the door and tried to get him to open it. Nothing doing. He just gurgled.

Pat is a resourceful woman, and tried to fashion a screwdriver out of a poptop can lid. Attempting to turn the door handle with the crude tool, all she managed to do was knock the door handle off the other side of the door. She bent down and looked through the hole trying to see what Waylon was up to. But he was too short to see the top of his head.

She took a heavy can and tried to beat the door open. If she broke the door, she would replace it. The door wouldn't budge.

What to do? The hinges to the door were on the other side. Drat. And she had left her cell phone in the kitchen. Waylon was in the house all by himself! But she could hear him on the other side



of the door, jabbering. She talked to him in a soothing voice, and he actually laid down on the carpeted kitchen floor and went to sleep on the other side of the door. She could hear him breathing.

Her kids wouldn't be home for some time. They had gone to Menards in Burlington to get her a new vanity for her bathroom. She had no choice, she would have to wait it out. The pantry was so small, she could hardly sit down on the floor.

After about two hours, Waylon woke up from his nap, and she shoved saltine crackers under the door for him so he would have something to eat. She could hear the Brighton town siren go off indicating it was noon. She had been in the pantry three hours!

Finally, she could hear and feel the vibration of the garage door opening. Her son was home. She hollered, "I need some help here!"

He hollered back, "I need some help here unloading this vanity!"

But she was rescued—a 75-year old woman finally coming out of the closet, she joked.

There is now a door handle on both sides of the pantry door. Her kids have instructed her to always have her cellphone on her, and there is a miniature tool kit in the pantry. They discussed getting her a life-alert line, and as her insurance agent, I was able to show her how her insurance would provide one, no charge.

Were there some personal issues she had to take care of while she was trapped in the pantry? Only God and Pat Hagist know.

CDC says no masks required for fully vaccinated individuals

LEE COUNTY - The Centers for Disease Control and Prevention (CDC) released yesterday interim public health recommendations for people who are fully vaccinated. Those fully vaccinated no longer need to wear a mask or physically distance in any setting, except where required by federal, state, local, tribal, or territorial laws and regulations, including local business and workplace guidance. For someone to be considered fully vaccinated it would be two weeks after either their second dose of the Moderna or Pfizer vaccine or their single dose of the Johnson and Johnson vaccine. Currently, Lee County stands at 30.3% of the population being fully vaccinated.

"As a public health agency, we continue to encourage residents and visitors of the county to reduce risks of further spread of COVID-19 and to get fully vaccinated," states Michele Ross, Lee County Health Department (LCHD) Administrator. "We want Lee County to move forward with the rest of the country, and see more people become fully vaccinated." Those not fully vaccinated still pose a risk and should consider their own personal situation and risks to themselves, their family and other community members when in public settings.

LCHD is offering several COVID-19 Vaccine Clinics throughout the county: Tuesday, May 18 at the First Christian Church in Keokuk from 4:00pm-7:00pm and on Saturday, May 22 at LCHD in Fort Madison from 8:00am-Noon – both of these clinics will be a drive-thru with both the Moderna and Johnson and Johnson vaccines available. The full pop-up clinic schedule can be found at <u>www.</u> <u>leecountyhd.org</u> or on the LCHD Facebook page.

LCHD is also aware that the Pfizer is now available to those 12-years of age and older. The Pfizer vaccine requires ultra-cold storage if maintaining inventory for more than two weeks, which is something LCHD does not have. "We are currently working with our public health partners in the state to obtain Pfizer vaccine on a small scale to hold specialty clinics. We ask people to continue to watch our facebook page and the media for when we announce those clinic dates in the near future." added Ross.

In the meantime, for those who are not fully vaccinated LCHD encourages everyone to reduce risks of exposure and spread of COVID-19 and to continue following prevention mitigation strategies – wear a mask when in public, stay 6-feet apart, wash hands frequently, stay home when ill, and schedule your COVID-19 vaccine appointment. We can do this Lee County!

"I would like the public to know that those who are not fully vaccinated should continue to use those personal protective measures we've been promoting all along," she said. "And those vaccinated but immuno-compromised should consult with health care provider."

Ross said the Centers for Disease Control updated guidance last week loosening recommendations for face coverings at outdoor events and certain indoor events.

"We still need to work together protecting everyone," she said. "The CDC did come out with these recommendations. It was a little quick I think and without a little warning that it was coming out. Local public health is working with the state to see how we should continue working with communities based on our numbers that we are still keeping an eye on."

Lee County Recorded Nancy Booten said she was still "a little leery". Booten's office is in the north Lee County office building.

"I would go with what you say, but I'm still going to wear my mask," Booten said.

Lee County Treasurer Chris Spann, who has offices in both the north and south Lee County office buildings said she won't be wearing her mask all the time.

Ross said those who've been vaccinated should feel a little more confident, but there is still concern for exposure.

"I'd like to see (vaccination rates) higher before people are just feeling they are just fine," Ross said.

"Those vaccinated should feel a little bit more comfortable, but my concern is if businesses start dropping mask (requirements), those that aren't vaccinated are going to be at risk of possibly being exposed. So make good decisions and choices for yourself.

"It's important for people to realize that even though we might be coming out on the other side of this, we do have to stay vigilant."

She said there isn't a shortage of vaccines so anyone 16 and over who wants a vaccine locally can get one.

"The problems is there is hesitancy on some peoples' part to take the vaccine. I would encourage those hesitant or with concerns to talk with their health care providers or local health department. These are effective and that's why CDC is changing recommendations," Ross said.

Lee County Auditor Denise Fraise said the plexiglass barriers that were put up at the outset of the pandemic will probably stay up permanently.

CDC needs to update guidance to allow for children summer camps

m T}$ his year, due to unnecessary guidelines restrict-

ing outdoor activities, many children will be stuck inside when they should be outdoors in the sunlight playing, learning new skills, making friends, and enjoying their childhoods.

This is not only important for their mental health but also their physical health and enhancing their immune system. Attending summer camps is a huge part of this growth.

Earlier this week, the New York Times reported that the CDC had "hugely exaggerated" their guidelines by saying that less than 10% of COVID-19 transmission occurs outdoors and that the actual estimate of outdoor transmission is somewhere between 0.1% to 1%.

We have known for quite a long time that the risk of transmitting COVID-19 outside is small. And in Iowa, there was not a requirement to wear masks outdoors; however, physical separation and maintaining small group size was encouraged.

Iowa is home to several great summer camps including Forest Lake Baptist Camp in my home county; Hertko Hollow, a camp for children with diabetes; and Camp Courageous, a camp specifically for children with disabilities.

Due to shelter-at-home orders and school closures, the numbers of youth depression, anxiety, attempted suicides, suicide, increased drug use and hospitalizations have continued to increase despite the decrease in new COVID cases, hospitalizations, and mortality rates. A staggering report from the CDC found from March to October 2020, mental health-related emergency department visits from adolescents had

increased 31% from the same time in 2019.

As a doctor, former President of the Iowa Medical Society, and former Director of the Iowa Department of Public Health, I have addressed the severity of COVID-19 and have been a strong
