FORT MADISON - Despite the radiant light of the beautiful face above...our world is darker forever.


After a two-year battle with pulmonary hypertension, an idiopathic siege, that served side-by-side with the debilitation of Type 1 diabetes, our youngest daughter Kelsey was taken from us at 6 a.m. Thursday morning.

We are blessed to have a publication in which we provide news and information to North Lee County. But as a family business that people have come to rely on for the past four years, we have to sometimes be transparent in why you didn't get your product.

This sassy wonder brought joy to Fort Madison School teachers, but never really fit into the mold of the high school peer. She left high school early to start her education toward becoming a forensic psychologist. Kelsey made the Dean's List at the University of Iowa this year.

Our morning was horrific as we told her it was OK to let go. Lee and I have been twisted and torn. Our oldest daughter Taylor couldn't get back fast enough to say "Good Bye" and I'm a little mad about that. She said her good byes in private to her only sister through an open window at University of Iowa Hospitals and Clinic's Decedent Care.

Give your children an extra hug... an extra look... and an extra kiss today and think of them. Running off to work... to school... to play, and remember that there is no doubt – "Every day is a treasure.... and today, our Kelsey is your key." We love you all.... we'll be back..



JAN. 10, 2020: Carbon monoxide to blame in Denmark woman's death

DENMARK - Area law enforcement suspect carbon monoxide poisoning may have caused the death of a Denmark woman and sent her husband to the hospital early Thursday morning.

Denmark Fire & Rescue personnel along with Lee County EMS and the Lee County Sheriff's Dept. were called to the

1400 block of 295th Avenue just north of Hwy. 16 on the west side of Denmark where two adults were found in a home.

Rescue crews pulled the victims from the building at around 7:45 a.m. and began ventilating the home.

Joan Lee Stevenson Pumphrey Walker, 87, of Denmark died as a result of the incident. Her husband Randall Walker was taken to an area hospital. No condition report on him

Lee County Sheriff Stacy Weber said findings won't be confirmed until toxicology reports are returned.

"Our office suspects this is possibly carbon monoxide poisoning and our thoughts and prayers are with the family," Weber said Friday.

Area man tazed after chase through Lee County

LEE COUNTY - An area man was tased and taken into custody after being stopped by area law enforcement Monday afternoon.

The name and age of the individual

has not been released, but Lee County Sheriff's deputies along with Iowa Motor Vehicle Enforcement, Iowa State Patrol and West Point Police scrambled to capture a man who allegedly rammed a vehicle in the 1800 block of 345th Avenue near Wever, and then got out and punctured the tires of the vehicle.

A chased then ensued westbound on Highway 16 through Denmark at speeds betweeen 60-80 mph. Authorities deployed stop sticks in his path and punctured the right front tire.

The suspect continued on the tire and made a northbound turn on 265th Avenue where the vehicle became disabled and pulled off the road.



Area braces for winter storm

LEE COUNTY – A potential major winter storm is brewing for southeast Iowa, and area officials are keeping an eye to movements in the storm.

Both Lee County and Fort Madison officials have regular plans in place to react to the storm, including having road personnel on call depending on what type of precipitation hits the area.

According to the National Weather Service at 12:30 p.m. Thursday, a winter storm watch is in effect for southeast Iowa including Lee County. The NWS has also issued a wind advisory until 6 p.m. Thursday for the immediate area.

Winds from the south are expected to be between 15 and 30 mph with gusts up to 45 mph, which could cause limbs to fall, unsecured objects to blow around, and possible power outages.

The current forecast is calling for one to two inches of rain Friday that could eventually turn to sleet and freezing rain

making travel very difficult. Saturday morning the ice is expected to change to all snow ending Saturday night. The highest potential for freezing rain and sleet is extreme southeast Iowa, west central Illinois, and northeast Missouri.

The NWS report indicated that significant ice and snow accumulations are possible with blowing snow making travel difficult. According to mapping from the NWS at 3:30 a.m. Thursday, the area between Burlington, Fort Madison and Keokuk could see as much as 8" of snow before Sunday morning. But the report also says confidence is low on the track of the storm.

Fort Madison City Manager David Varley, who's overseeing the Public Works Department ahead of the start of Mark Bousselot on Jan. 20, said the city is watching the situation.

"We're keeping a sharp eye on it. If temps drop we'll have guys ready on call and if hits the way they're saying it might, we'll be out on the streets," Varley said.

He said the city doesn't pre-treat for ice, but we'll quickly respond to ice conditions by getting sand trucks on the streets.

FM YMCA takes over Donnellson daycares

DONNELLSON – The Fort Madison YMCA will be taking over operations of two day care centers in Donnellson.

The Raisin' Em Up Early Learning Center in Donnellson, and Raisin' Em On Up, also in Donnellson will begin operations under the Fort Madison YMCA on March 30.

Fort Madison YMCA director Ryan Wilson said the YMCA only began looking at purchasing the day care providers on Jan. 16 of this year.

"We had a board meeting on the 16th and I had actually received a call that they were for sale earlier that day," Wilson said Monday.

"We didn't want to rush

into anything. So we put a committee together to hash it out to make sure it makes sense financially and fits the mission. Then I reached out to the owner and began discussions."

Wilson said he took several YMCA board members out to tour the facilities and has spoken with staff on site.

The facilities came under fire from the Iowa Department of Human Services through most of 2019, and on June 13 had 15 complaints filed against the facilities and owner Sarah Tweedy after unannounced visits were conducted in April and June. Tweedy appealed the complaints and the situation was working it's way through the DHS administrative process at the time of the sale.

At one point DHS

officials started a 10-day revocation timeline against Tweedy, but the appeal delayed the license revocation

In August, Laura Mc-Dowell, a site supervisor for the daycares, was charged with child endangerment after an incident at the facility resulted in the death of a child in December of 2018. McDowell has pleaded not guilty in that case and pretrial conference has been set for Feb. 14, with a pre-trial motions deadline set for March 10.

Wilson said he's spoken with the Department of Human Services and the facilities will have a clean slate under the YMCA's ownership, and the state is not requiring any changes to take place after the sale.

Wilson said additional one-on-ones are scheduled with current staff, but he said plans are to keep the current staffing, hours, and rates at least for the first 90 days.

"If we need to make any changes to we may look at that at the beginning of the next school year," he said.

Once ownership changes hands the facilities will be tentatively be called the Fort Madison YMCA Early Learning Center, and the Fort Madison YMCA Learning Center for the older children.

Wilson said initial reactions to the YMCA taking over has been good.

"We've heard nothing but great things from the community about us taking over," he said.

He said there is room for additional children at the facilities. With the unknown future of the centers as DHS officials considered the appeal, families have taken their children to other places.

FORT MADISON – An overnight break in at Jim Baier Ford in Fort Madison has police looking for at least four vehicles.

According to owner Jamie Baier the suspects broke into the business on the west end of Fort Madison sometime overnight and drove two vehicles off the showroom floor, including a 2020 Dodge Charger Hellcat Daytona, one of only 501 built.

The suspects also took a 2020 orange Ford Mustang off the floor.

They left a 2020 Silver Jeep on the floor.

"Maybe they didn't know how to drive stick," Baier said from the dealership Monday morning.

Fort Madison Police are also looking for a 2019 black Dodge Challenger and a 2015 white Dodge Challenger taken from the lot.

Baier said the suspects smashed the key box in the sales bullpen that holds the keys and drove the vehicles right out the front door.

According to Fort Madison Police Chief Mark Rohloff, the method of operation has the marks of a professional ring that has been working in the Midwest and indicated an investigator has been called to the scene.

Baier said the dealership doesn't have showroom alarms because he's never had anything like this happen. He did have camera footage, but that was taken as well. Baier said the suspects also got away with dealer plates.

"I'm sure they put these plates on. But these cars aren't hard to see."

Anyone with information or observing the vehicles is encouraged to contact the Fort Madison Police Department.

Jim Baier staff are still completing a total inventory of the dealership.

LEE COUNTY – The Lee County Conagra Brands facility announced today that they are expanding their facilities, investing \$31,900,000 and adding approximately 91 jobs. The Lee County facility currently employs approximately 450 individuals.

To help facilitate this expansion and creation of jobs, the Iowa Economic Development Authority (IEDA) board has awarded Conagra \$1.2 million over five years as part of the High Quality Jobs tax credit program. In order to qualify for this program, the jobs must pay a minimum of \$17.09 per hour at the beginning of the project and at least \$20.51 once the project is completed.

"Conagra has been a great partner to the community," commented Lee County EDG Project Director Dana Millard. "We are excited about the announcement of this project and bringing additional high paying careers to Lee County," Millard said.

The project will bring the production of canned beans to the Fort Madison facility. The expansion involves a significant investment of machinery and equipment however they do not plan to expand the physical footprint of the building. Equipment installation is scheduled to begin at the end of July.

"We are excited to expand production at our facility," said the plant's manager, Bryan Langerud. "We continue to focus on the growth of our business and are pleased to create more opportunities in the Fort Madison area," he said.

The plant has been part of the community since 1972 when it was opened by the Dial Corporation. In 2011, two additional lines were added to the plant to produce Birds Eye.

State, federal grants kickstart Sheriff's GHOST team

LEE COUNTY – A federal and state supported grant has put a Lee County Strike Team on the ground rooting out habitual drug and gun offenders.

According to Lee County Sheriff Stacy Weber, the Lee County Sheriff's Office applied for and received a grant for overtime costs associated with the Guns & Habitual Offenders Strike Team (G.H.O.S.T) to be formed to combat certain repeat offenders in the county.

This unit was formed under a memorandum of understanding with both Keokuk and Fort Madison police departments. The unit was awarded nearly \$26,000 in funding to pay for officers from all three agencies to work collectively to combat repeat offenders who are determined to deal drugs, commit felonies, and carry illegal firearms.

On Tuesday this unit officially hit the streets. Officers were able to identify and arrest three different felony level wanted subjects and one misdemeanor level subject. Methamphetamine was also seized and one house was searched.

The focus of this unit is to seek out repeat offenders who continue to be armed illegally while violating Iowa laws. This unit will work with the Lee County Narcotics Task Force to help disrupt organized crime and dismantle criminal organizations.

The unit consists of two deputies, one Fort Madison police officer, and the Keokuk Police Department has not made an assignment at the time of this release.

Any additional comments and news releases will come from either Commander Donaldson of the LCNTF, the Lee County Sheriff, of the chief of the participating agency.

This funding is made possible by a grant provided by the Governor's Office of Drug Control Policy and the United States Attorney's Office –Southern District of Iowa.

City starts work on PORT Connector trail

FORT MADISON – The first meeting of the newly structured Fort Madison City Council was highlighted by a move to put the construction of the PORT Connector Trail to Rodeo Park in action.

The Community Health Foundation, a joint venture of Great River Health System-Fort Madison Community Hospital, pledged \$1.5 million to the project this summer.

The city serves as the pass-through for the money to get the work done. At Tuesday's regular city council meeting, the council voted 6-0 to approve a professional services agreement for \$214,000 with HR Green of Cedar Rapids for design and construction administration services for three segments of the trail.

Segment 1 will be built on the west side of 15th Street from Avenue B to Rodeo Park. Segment 2 will be constructed along the north side of Avenue B from the 15th Street to Fort Madison High School. A third segment is planned along 15th Street from Avenue H to Avenue G.

The City has placed segments 1 and 2 as priorities

over segment 3.

Former Public Works Director Larry Driscoll was on hand to speak on the issue along with Tim Cutsforth of HR Green and Angie Budnik representing the Community Health Foundation.

"This is another example of the wonderful work the PORT committee does," said City Manager David Varley.


"It's a very ambitious group and I haven't seen another group that can match the energy it has and the success it has had in raising funds. Their work has been phenomenol."

Driscoll said segment one has to be done in 2020, as part of a commitment to the foundation as part of the grant. He also said the foundation reserves the right to name the trail as part of the donation.

City watching Humphrey building closely

FORT MADISON - The city of Fort Madison is keeping a close eye on progress of a building that is structurally deficient in the middle of downtown.

Activity has been seen at the building, which according to the Lee County Recorder's information is owned by Bryan Humphrey and is located at the corner of 8th Street and Avenue G. City officials cordoned off 8th Street south of Avenue G to the alley and in front of the building more than three months ago.

At Tuesday's regular city council meeting, councilman Mark Lair asked for an update on the progress of the building and the barricaded streets.

"I've been getting a lot of questions from the downtown area because of a certain building that's in disrepair and taking a lot of parking spaces from retailers. Do we know where we're at with that," Lair asked.

Mohrfeld said he was in a staff meeting on Friday and told city staff this can't go on.

"This cannot be the face of our community. We can't be held hostage by one irresponsible property owner.

It's not right. We have to do everything we can."

Mohrfeld said city Building Director Doug Krogmeier was working hard on the situation, but he said there is a mitigation plan in place and city officials only know of some of that progress.

"Is it moving as fast as we want, No. But we will know when the building is stabilized," the mayor said.

Mohrfeld said work is happening on the building but city officials don't know the timeline of the internal repairs to stabilize the building. He said it will be joint effort to expedite the mitigation.

"It's just not acceptable that that's what you see when you turn into our city," Mohrfeld said.


"It's one thing when it's a misfortune, but it's another when you start messing with other peoples' livelihood."

Lair said the people who have contacted him have retail businesses and have indicated they are missing out on up to nine parking spaces.

But Mohrfeld indicated the city will not pull the barricades until staff is confident the structure is safe.

"Be there no doubt, it is our responsibility to safeguard the public area," he said.

"It's tough situation...a tough situation."



"I've been to state the past two years so that experience helps," he said. "I just kept thinking that this was my last high school event so I wanted to focus on that."

Having Olympic-bound Frazier several lanes down in his heat in the 100 breaststroke didn't intimidate Mohrfeld.

"He isn't within reach. He's in USA Swimming with me and I've seen at him at other events, so I don't focus on him, I just go and try to compete with everyone else."

Mohrfeld said his future plans include swimming and he said he still has YMCA state and regionals to focus on in Iowa. He's also involved with the USA Futures Championships and that usually requires some travel

The HTC senior competed at the Speedo™ Championships held in Minneapolis last year and had times good enough to qualify for the USA Futures events.

"That's pretty serious there. They have some really fast swimmers and they divide the whole country into four sections."

Mohrfeld also competed in 200 meter freestyle and finished 21st with a time of 1:47.83.

The Burlington team of Wyatt Hellman, Colby Geiger, Taden Jameson, and Mohrfeld took 17th in the 200 meter freestyle relay, one position out of the points.

FORT MADISON – The flooding of 2019 took a toll on the Old Fort as far as numbers, but the added American Cruise Lines traffic helped offset some of the loss.

Dr. Eugene Watkins, Site Manager of the Old Fort said a fundraising effort is currently underway through Friends of the Old Fort, which operates under the North Lee County Historical Society's 501c3 arm.

Watkins said funds are needed to help replace some of the interpretive items at the fort.

"At this point, the main part of the fundraising is to replace those things that are wearing out," Watkins said Wednesday afternoon.

"The fort is close to 30 years old and a lot of the equipment and clothing is just getting old and is need of replacement."

Other items that will have to replaced in the near future include firearms and trade goods that add to the factory display at the fort.

The historical society has set an immediate fundraising goal of \$10,000.

"Of course, we'd take more than that and can certainly use more than that, but at this point we're trying to raise enough money for replacement of things wearing out, but we will also need to start looking at getting materials for additional repairs."

Watkins said the flooding kept numbers down in the early part of the season, but the cruise lines helped the fort rebound as far as attendance.

City initiates court action on crumbling Humphrey building 3,622 views, 739 engagements

FORT MADISON – Fort Madison Mayor Matt Mohrfeld announced Friday that the city has initiated court proceedings against the owner of a building in downtown Fort Madison.

Mohrfeld said the Humphrey building on the corner of Avenue G and 8th Street is a public safety and nuisance issue and is looking for judicial intervention.

According to Lee County records, the building is owned by Bryan J. Humphrey, a former practicing attorney in Fort Madison.

"Regarding the Humphrey Building located at 732 Avenue G, the Mayor and City staff are working diligently to resolve the public safety and nuisance issues," Mohrfeld wrote in an email to the Pen City Current Friday morning.

"We hope to have a trial date before the Lee County District Court in the next ninety days."

He said the city will continue to work with the owner to resolve the issues, but it asking the court for assistance during the process.

"If the conditions are not abated voluntarily before trial, the City will seek a court order requiring the issues to be rectified and authorizing the City to rectify them if the defendant does not comply with the order."

Portions of 8th Street between Avenue G and Avenue H were cordoned off last fall when structural defects were observed that could jeopardize public safety.

In November, city officials expanded the barricade to include an entire half block from Avenue G to the alley south. About a week later settling occurred causing brick facing to fall to the sidewalk inside the barricades.

Work has been done to shore up the exterior of the building and city officials said plans were submitted to shore up the interior of the structure, but Mohrfeld said at a city council meeting two weeks ago that the city wasn't aware of how that work was progressing.

County Recorder says offices need better security 3,469 views, 723 engagements

MONTROSE – Lee County Recorder Nancy Booten wants the county supervisors to do something about security in Fort Madison.

And she wants it now.

After Tuesday's regular Lee County Board of Supervisors meeting, Booten told supervisors that in addition to her department holding active attacker training last week, police chased two men from the building Monday

She said her staff is understandably concerned about their safety.

"We've heard for years, 'let's do something about safety', 'what's a life worth'. Well they don't feel like they're worth anything. They really don't because nothing's been done," Booten said.

She said recently there were two customers that had made the staff nervous and warranted a call to law enforcement. After investigating footage it was determined the two had arrest records and were later arrested for theft the same evening they were in the North Lee County offices.

Booten said her department is first in the door and the height of the counter makes her staff and herself very susceptible to harm if something were to happen. "You hear all the time it can't happen here... we heard it can't happen here, well it happened at (Scotts)," She said. "We want something done. We want a door and some teller windows."

She said she didn't think it was very expensive for the improvements, and anything that could cause a delay to someone who wants to do harm could save a life.

Booten said the south Lee County offices were given security upgrades but nothing has happened in North Lee County aside from some occassional deputy presence.

"The state doesn't give us a dime, but we're protecting them. Our staff doesn't feel like we're protecting us," she said.

"If I have to take it out of my budget, since we're talking about budgets... whatever. I just think we need to do something and we need to do it now."

Supervisor Gary Folluo said there should be a hallway at North Lee County similar to what Keokuk has.

"And you should be behind a wall of glass," Folluo said.

Supervisor Matt Pflug said Booten was making valid points.

"The state doesn't give us anything and, again, we kick this can around a lot. I know it all takes money but it's a life," Pflug said. "We have to do something, you're exactly right."


tion, and was struck by a vehicle driven by Richard Gary Scott, 55, of Fort Madison.

FMCSD board puts PPEL levy in front of voters 3,144 views, 303 engagements

FORT MADISON – Local school officials have taken the next step in trying to get district facilities upgraded over the next 10 years.

The district voted unanimously at a workshop Monday evening to put a voted Physical Plant and Equipment Levy (PPEL) on a March 30th special ballot.

The move would generate about \$1 million

per year, according to district business manager Sandy Elmore. Taxpayers would see a \$1.34 levy per \$1,000 of equalized assessed valuation on their tax bill.

But Elmore said even with conservative estimations of about a 1.5% allowable growth from the Iowa legislature this year, the district's tax asking would be in the range from static at \$12.86/\$1,000 EAV to possibly a couple cents lower.

WP Council kicks around levy bump

WEST POINT – Taxpayers in West Point could see a substantial bump in their property tax rates this year.

At Monday's regular meeting of the West Point City Council, the council voted 5-0 to set a public hearing at a special Feb. 24 meeting to set the levy.

Because the levy increase is more than 2%, state law requires a special hearing for the levy to allow taxpayers to hear what the council is planning to do with the money.

The Iowa legislature put a new law on the books this year that places a 2% soft cap on property tax revenue growth on governmental bodies.

West Point officials are projecting a 7.44% increase for fiscal year 2020-21. In 2019-20 the district taxed residents at 7.31/\$1,000 of assessed valuation generating \$242,000. If the city held at that amount for the next fiscal year it would have created a levy of \$7.13/\$1,000 due to the city's taxable valuation increasing \$844,000.

However, City Administrator Dennis McGregor said the city is looking at some relatively steep insurance increases across the board. The city is also going to lease space for the West Point Police Department, which currently operates out of the West Point Fire Station.

The additional revenues needs are projected to be \$260,000, which would required a levy rate of \$7.66/\$1,000, which is a 7.44% increase. After the hearing, the city would then hold another hearing for the budget approval which would require a supermajority of 4 of the 5 councilman.

Along with the 2% soft cap, the new law requires the supermajority approval of the levy increase.

The new levy would still be .54 under the state's general fund property tax cap of \$8.10.





Lee County EMS director says group needs more funds

MONTROSE – Bill Young, the director of the Lee County Emergency Medical Services, asked the Lee County Board of Supervisors for additional support Tuesday morning.

After the board's regular meeting, Young told the board Lee County EMS operated with a loss in 2019 and would need additional support to offset Medicare and Medicaid write-offs totaling almost \$500,000 of a total \$619,000 in charges.

Young said the reimbursement rates are the biggest sticking points in his operations.

"You can see where it makes it very difficult to purchase equipment, maintain equipment, pay bills." Young said

Supervisor Matt Pflug asked how Young continues to offer services with those types of reimbursements.

When Young rattled off the numbers, several board members muttered that was ridiculous and board Chairman Ron Fedler, who was voted in as chair last week, said Young had his support.

"I'm just going to be very honest with you. It's very stressful," Young said. "EMS is my compassion but it's what I was meant to do, I believe. So I'm gonna figure it out."

Budget Director Cindy Renstrom said the county contributed \$429,624 to the service last year. Young said this year he's requesting \$500,000 to help offset some of the services losses.

He said there is gap funding from the federal government and through the state as well, but he will not be able to see any of that funding as a private service provider.

"The Board of Supervisors should do what we we can to help you continue your services," Fedler said. "I don't think we have a choice."

Young said EMS has already taken steps to curtail expenses including not having a standby ambulance in the rotation. The standby vehicles typically move to a central county point when two ambulances are in the same area.

"We've stopped doing that and haven't really had any issues," Young said.

Young said the future of the service will probably include a non-profit status to help take advantage of some additional funding and resources.

Young said it's been almost 17 years since he's asked the board for an increase in funding. He said he was told by several past supervisors to not ask for a raise.
