# **Arrests made in armed burglary**

### FRIDAY: Incident remains under investigation, more arrests possible

FORT MADISON - An 18-year-old Argyle man and 17-year-old juvenile from Fort Madison are in custody following an armed burglary that took place in the 1900 block of Avenue F Friday afternoon.

According to reports, at 3:17 p.m. Friday, officers were dispatched to a residence in the 1900 block Avenue F for a burglary-in-progress call. Reportedly the victim had returned to his residence and surprised the suspects in the act of looting his home.

A struggle ensued after one of the perpetrators produced



a handgun. The suspect was successfully disarmed by the homeowner, and fled the scene with his accomplices. The victim sustained a minor injury and was later treated at the hospital and released.

The principal suspects, as well as additional involved juveniles, were located shortly afterward in the area of burglary.

Charged at the time were Hunter J. West, age 18, of Argyle. West was charged with burglary in the 1st Degree, and

## **COUNTY NEWS Supervisors** haggle over levyrate

FORT MADISON - Lee County Supervisors had a healthy exchange Monday over a proposed increase to the general supplemental levy to offset recommended increases in county wages.

County Budget Director Cindy Renstrom, during a workshop following the board's regular meeting, proposed increasing the general supplemental levy portion of the county budget just over 9% for the coming year to 11.21%.

The state allows for a 2% allowable growth without a special vote of the supervisors, anything over that threshold would require a super-majority vote, or four of five supervisors voting in favor of the increase.

## Bump in levy wouldn't increase county's overall rate

#### LEVY - Continued from Page 1

A 2% increase would only have generated an additional \$40,000 in the supplemental fund, so Renstrom proposed adding \$1 million to absorb the pay increases and create some carry over fund balance.

"I plugged in an extra million to get general supplemental back up so the percentage increase is 11.21% from 2% this year," Renstrom said.

That figure generates a total county levy rate of \$10.355/\$1,000 of assessed valuation for the upcoming fiscal year beginning July 1. She said that rate, even with the increase, is still less than this year's levy of \$10.702.

With county valuation projections up more than \$40 million for the next fiscal year, taxpayers could still see an increase in their property tax bill, but the county's portion of the levy would go down, even if the 9% increase is approved.

Supervisor Garry Seyb said that was an important distinction to make to county residents.

"We're moving money in the budget, but it's not increasing our taxes to the taxpayer. It's increasing the supplemental (budget) so we can pay our bills in between the time the fiscal year ends and the time taxes start coming in," Seyb said.

"So the end result to the taxpayer is no tax increase. Fedler was quick to point out that taxes could still go up based on individual property valuations increasing.

"That is unless the assessed value of their property goes up. If that goes up, the levy can be the same but the tax they pay will actually increase," Fedler said.

Seyb responded that the county doesn't set the valuations and can't control what the state assessors do.

Renstrom said what's helped this year is the elimination of the mental health levy which was .88/\$1,000.

"So if we drop that and raise the supplemental to get

some carry over, that would be a good time to do more than 2%.," she said.

She said giving a proposed 10% to the general staff and 45% to the sheriff will help with retention as counties around Lee County raise their pay structures.

Supervisors Ron Fedler and chairman Matt Pflug expressed hesitancy with the increases.

"First of all, it's going to open a can of worms one way or another, I don't care how you look at it," Pflug said.

"Regardless of what this board decides, and it's your decision, but I know the feedback I've gotten from the 40 or 50 people I've ran into or talked to on the phone. They're not happy."

Pflug said Governor Kim Reynolds was irresponsible in putting the burden on counties to absorb the impact of the Back the Blue law that spelled out how county compensation boards were to calculate recommended sheriff wage increases across the state.

"We fight every year to hold the line on taxes, which is what were elected to do, and all of a sudden this comes at us," he said.

Washington County just raised pay across the board 20% and added 35% to the sheriff's wages structure.

Pflug said Lee County is not Washington County.

Supervisor Garry Seyb, Jr., said he was confused by the board's stance on moving the funds around in the budget.

He said valuations are going up, so people's property is worth more and the county has more money through those valuations.

"It's up to us to use that funding the best way we see fit and not artificially raise taxes. Just moving the taxes does not increase anyone's taxes, its just being good stewards of the money," Seyb said.

Seyb also pushed back on Pflug saying Lee County is influenced by what Washington or Van Buren or Henry county is doing.

"If people here can go back to Washington County and receive a \$2 or \$3 raise per hour just like that...?," Seyb said.

"They, in essence, become a free agent now." Fedler asked Seyb what was the amount of levy increase in those counties was.

Seyb said he didn't know that and Pflug said that was information he should have if he's going to compare counties.

"Are we increasing taxes, yes or no? Yes or no? If we were to approve this today are we increasing taxes? Yes or No, I'm the new guy on the board. Tell me because what I heard was \$10.70 and \$10.35. That is .35 less than \$10.70. I'm a simple guy and that's simple math," Seyb said.

Pflug said now you have a county engineer or a county attorney making less than the sheriff and the bargaining units are going to come to the table and they won't be sitting on their hands.

# EMS Director looking into incentives for staff

several recent incidents where fire departments were told an ambulance wouldn't be able to respond, or ambulances weren't running fully staffed.

"I don't know how we track that, but I've done some research myself and they've told us that, they've told Keokuk that, and I believe they've told Jackson Township that," Herren said.

"I think we need to see how many ambulances are available in the county during a 24-hour period. And how many times we're supposed to be a paramedic service, and how many times we're sending out an ambulance with two EMTPs on it. Those are things we need to track, too, because we are running into that."

Herren also asked that the committee monitor service times. Committee chairman Jim Steffen said an overview of response teams means very little in terms of quality metrics because LeeComm doesn't use a priority dispatch.

"Its very hard to look at a flat response time. But if the county wants to track that, I'm perfectly fine with it," Steffen said.

Herren said he was puzzled by that response because in his experience everything has always been about response time in medical calls.

Lee County Ambulance Director Dennis Cosby said staffing issues have forced the county to run shifts with just two ambulances at times. He said transfers from both county hospitals have also put pressure on the system, and at times has had the county declining transfer requests because there is insufficient staffing to back up the transferring staff.

The committee discussed possible mandatory on-call shifts that would have to be paid, but Steffen said staff is working 24 hours on and 48 hours off and likely would not respond well to mandates that they be home to back up in the event of transfers.

Cosby said the county had 34 transfers over the last 10 days for just over three per day. If those transfers are to Iowa City or Quincy, those are three to four hour trips at a minimum, which leaves the county with two ambulances in service.

Herren said some days you may have to mandate staff come in to cover the service, as is the case in the paid fire departments.

Steffen said there's no way to mandate staff to come in and cover transfers, when the county is doing three to four a day.

"Once you have a day off, you can't mandate someone come in to put in five or six hours just for a transfer. They will revolt, they will flat out revolt. I know paramedics and it won't work," Steffen said.

Cosby said he's looked at multiple ways to incentivize, and staffing is to the point that most will generally will step up and fill overtime shifts.

"But mandating someone to come in on a day off because we have a transfer would be very difficult," Cosby said.

Steffen said incentivizing the coverage could work, calling it the 'carrot rather than the stick'.

The lack of the third ambulance in service is a concern of Herren's.

"I just don't think we have enough rigs. I would imagine that most of the time there are only two rigs covering the whole county and that affects response times. I think response times are something you just have to look at. I was puzzled by their response to that," Herren said.

Herren, along with Keokuk Fire Chief Gabe Rose, put together a proposal to run

the service when it became apparent the private ownership wasn't going to continue. The original steering committee went with the recommendation for the county to take over the service, rather than the fire department's picking up the operations.

Cosby said the staff has had 12 people with COVID in January and he said once in a while they have to staff a Basic Life Support truck.

"I think we've done that twice and then there's been a few hours here and there we didn't have enough to staff three trucks so we went down to two ambulances," he said.

In other action, the panel got an update on progress of the ambulance service moving to a professional billing service as outstanding billing approaches half a million dollars.

The County is currently contracting with Burlington Fire Department at a rate of 6% of billables. According to county figures, the county currently has \$450,073 outstanding in service bills when Medicare billing is figured in. Medicare pays at 85% of billable services. However, the panel was aware that the county would have to fund the service at the outset.

But Cosby said he's getting concerned about the time span of the billing.

"We're still not really billing through them (what does THAT mean?!) and we're at about eight months and I don't want to run out of time and have to write off revenue because of the way it's billed," he said.

Steffen asked if the county could take on the billing in-house as was discussed during the transition.

"Have we looked at doing our own billing?" he said. "Our initial thoughts were we would use a billing company and then after a while revisit when we wanted to move to in-house billing using public health as the base, and then compare the cost of that."

Cosby said he favors moving toward the professional company who can also help with reporting when the county is eligible for Ground Emergency Medical Transport subsidies from the Iowa Department of Human Services. The county has already approved moving to a professional billing company. Cosby said he's waiting on guidance from Lee County Attorney.

"At this point, we need to look at a professional billing company. This would be a much, much better system. If a couple years from now, we want to bring billing back in-house I'm not saying we couldn't look at that," Cosby said.

"But I think we stand to lose a lot of revenue if we don't use someone that's able to keep up with these things. Rules change continuously and it's very difficult to keep up."

The county would have a 90-day out on the current contract.

Despite the billing and staffing issues, Steffen said at the end of the meeting that the service is running as well as can be expected at this point in the county's ownership.
