Hull wants action on 180th St.

IMPROVEMENTS: County has been trying to get IFC, IDOT officials to act on road just north of fertilizer plant

LEE COUNTY - County Engineer Ben Hull said an effort to get 180th Street north along the Iowa Fertilizer Company property up to standard has to move forward this year.

At Monday's regular meeting of the Lee County Board of Supervisors, Hull told the board this is the third conversation he's had with state Department of Transportation officials and IFC officials about getting the roadway improved.

The stretch of roadway was a gravel road when IFC first came to Lee County. The company improved the roadway at their cost during construction of the plant, but Hull said

it is not sloped correctly nor built to withstand the traffic flow. The county has a weight limit of 10,000 lbs. on the roadway and Hull said it is not holding up well.

Hull said county crews dumped a maintenance truck on the road last winter.

"It's not sloped correctly so there's no chance for vehicles that leave the roadway to stay upright. We experienced that ourselves last year with one of our own trucks," Hull said.

Supervisor Garry Seyb said personnel changes have muddied the conversations of the past several years. Hull agreed saying most of

the people he is talking with now are new to the conversation about the

Another meeting to try and iron out the improvements was held Monday afternoon.

"This has to be the last time we try to hold conversations about that roadway. This is the third time since I've been the engineer that we've

READING PROGRAMS

City library throttles up summer reading

FORT MADISON – If you enjoy a book on the back patio or the porch swing, then the Fort Madison Public Library wants to reward you for your time escaping, even if you listen to audio books.

The library's summer reading program kicks off May 31, but Fort Madison Public Library director Sarah Clendineng said there's plenty more planned for the summer.

Clendineng spoke at Fort Madison Kiwanis' Monday lunch meeting and said the library is making it easier than ever to get rewarded for reading, including the yearlong Beanstack tracking app.

The app requires a simple registration

with a username and password on Beanstack Tracker by Zoobean, however you don't need to use the app if you don't have the tech or the gumption to stay connected.

"If you don't want to do that app or tracking we have ways of doing it for you. We're not going to force anyone to use that especially since there may still be people who don't have a phone that can do that or a computer at home," Clendineng said.

She said you can track reading minutes at home and then claim prizes all at once. You can present your minutes read to library staff for prizes.

Registration for the summer reading program begins May 31 and the first 50 kids to register will receive a velvet coloring poster, reading record, crayons, and a lanyard to hold buttons that are being offered this year.

"For the kids and teens, we're doing something a little different this year. We're going to be handing out buttons. So for every 120 minutes you read, you get a button. If you attend at least one activity a week, you get a button and then once you collect enough buttons, you can claim prizes," she said.

For little readers, stickers will be handed out instead of buttons, and those can be



Aaron Salter Jr., 55, was on duty at the security job that supplemented his retirement income. Ruth Whitfield, 86, was buying groceries. Celestine Chaney, 65, stopped in for strawberries for the shortcake she and her sister were eager to enjoy.

But their plans went awry Saturday afternoon. Salter's work shift ended sooner than he expected. Whitfield didn't make it through her grocery list. And thoughts of strawberry shortcake evaporated in a flash for Chaney.

The three were slaughtered along with seven other people at a Tops supermarket in Buffalo, N.Y. Just like the 20 students, all 6 and 7 years old, and six employees who were massacred at Sandy Hook Elementary School



in 2012. Just like the 60 people who were gunned down at a music festival in Las Vegas in 2017. If only our

Hounds end regular season with win FM golfers fail to

FORT MADISON – Fort Madison's boys soccer team learned more from a loss than a win heading into the Class 2A substate tournament.

Monday's 5-0 win over Mediapolis at the Baxter Sports Complex closed the regular season for the Bloodhounds (12-5), who open the postseason at home against Mount Pleasant on Tuesday night.

Mitchell Pothitakis had three goals and Leif Boeding and Payton Lambert scored once for the Bloodhounds, who took advantage of Mediapolis (10-6) playing one player down after a red card nine minutes into the match.

That made it difficult for coach Kevin Wellman to identify what went right for the Bloodhounds just two days after a 3-0 loss to Newton.

"It's hard to tell for sure — they played a man down basically the whole game," Wellman said. "We played better than we played at Newton, but you never know. Was that because we weren't pressured as much because (Mediapolis) had 10 (players), so we had more time to play a better ball? I'm not sure.

"At Newton, we played with enough hustle, I feel like. But here we played with more. So that's definitely part of it"

Boeding gave Fort Madison a 1-0 lead less than a minute after Mediapolis' Jack Myers picked up the red card. Pothitakis made it a 2-0 game after his goal with 14:51 to play in the first half, one that bounced off the right post and into the net.

Pothitakis then scored his next two goals in the first 23 seconds of the second half. Lambert closed the scoring with a goal with 2:59 to play.

Now the Bloodhounds head into the postseason with their first match at home. The substate semifinal is also scheduled for the Baxter Sports Complex, with the final set for Pella High School, a stadium that has artificial turf.

That made Saturday's match against Newton, which plays on artificial turf, so important.

"The road to state is on Pella's turf field," Wellman said. "That was part of the reason we went to Newton, at the time of the year we went there, to get on turf and to play a team that is a top-notch team. They were good. They beat us in the air, their throw-ins and their corner kicks, and that identified something we needed to work on. Yes, it was very beneficial, even though we lost, to give us an idea of what we still have to work on. And it was obvious what we still have to work on."

The Bloodhounds swept through Southeast Conference play even though they lost two of their top goal scorers, Jacob Pothitakis and Xander Wellman, to season-ending knee injuries.

FORT MADISON – Tyler Wade shot a 9-over 81 at Sheaffer Memorial Golf Course Wednesday, but failed to qualify for districts on May 16.

The top four individual golfers and top two teams including ties were able to advance to the district meet at Vinton-Shellsburg's Wildcat Golf Course.

Wade shot a 4-over 39 on the back nine including a birdie on the par 5 18, but ran a 42 on the front nine for the 81.

Brady Wade shot a 42-42 84 for the second best score for the Bloodhounds who finished 6th overall with 351 figuring in the team's top four scorers.

Fort Madison's other top two scorers were Brennan Ulik and Emmett Kruse, who both shot 93s for the Hounds. Aiden Pennock shot a 94 and Jordan Simpson carded a 106.

Fort Madison 4×800 tallied a personal best with Addison Rump, Ellie Huebner, Caralena Crooks and Avery Rump running an 11:17.20, blowing away their season best time by 24 seconds. The time was good enough for fifth place. The Distance Medley team of Dayonna Davis, Huebner, Dynasty Bell and Avery Rump finished third with a 4:45.49.

The 4×400 relay team of Smith, Davis, Crooks and Bell was 6th overall with a 4:42.95. Addison Rump placed 10th in the 1500 with a 5:43.64, her best time of the year.

The Hounds only were able to compete in four events during the year due to rain cancelling three others.

Fort Madison scored 15 points on the day.

County approves purchase to replace gravel dump semi

tried to work this out."

He said the county has the authority under the original road haul agreement on the stretch of roadway to mandate it be put back to its original condition, which is gravel without any shoulders.

"Nobody wants that," he said. "But we have to get the stretch up to standard." Hull said the state DOT at one point was interested in possibly putting an acceleration lane on the northbound lane on a right-hand turn out of the facility west bound. He said now DOT officials have changed and they too are new to the conversation and he feels like the county keeps going back to square one.

Hull said he's hoping the DOT revisits the acceleration lane as it would allow for easier transition onto Hwy. 61 northbound out of the facility.

The Biden Administration's Infrastructure and Investment Jobs Act has money available on a competitive basis for projects to improve transportation models across the country. Hull said this project could be eligible for some of those funds if a consensus can be reached quickly on improving the road.

Hull also said the road is critical to access to the area, when flooding occurs. In other action, supervisors:

- appointed Bob Conlee to the county Civil Service Commission.
- reappointed Todd Shields and Lonnie Glascock to the Veteran's Affairs Commission.
- approved the purchase of a tandem axle belly dump semi-trailer after a collision last month damaged the county's current gravel hauler. The city received \$33,000 in insurance proceeds after the collision and approved the purchase at \$48,554.

Nation's leaders having poor response to weekend shootings

as and her decision to compete for the Quakers or NFL quarterback Colin Kaepernick and his decision to kneel during the national anthem.

Of course, it is easier for politicians to talk about trans-sexual athletes and to look for ways to score cheap political points. It takes time, and it opens a politician up to potential criticism, to do the difficult work of finding ways to reduce gun violence.

It is more difficult to muster the political courage to explore possible changes in laws that now allow anyone to assemble enough weaponry, body armor and high-capacity ammo magazines to outfit an army platoon.

While politicians solemnly offer their thoughts and prayers, these officials prefer to talk about the sanctity of the Second Amendment's "right to bear arms" than explain how unfettered access to weapons of war squares with the "life, liberty and the pursuit of happiness" promise our founding fathers laid out in the Declaration of Independence.

Too few of our leaders seem to be giving much thought to how we are supposed to guard against tragedies like the one on Saturday and the relentless carnage guns are causing across our nation.

With public outrage boiling and the optics of the Buffalo tragedy so shocking, even some supporters of guns and people's right to bear arms were keeping their "thoughts and prayers" to themselves over the weekend — because, I am sure, they realize their statements ring hollow to many of us.

The paralysis associated with our nation's response to gun violence is downright depressing. These senseless deaths are ruining families, leaving far too many people living in fear, and enraging so many.

People are enraged, because each time one of these tragedies occurs, too many of our leaders just appear to be marking time until journalists and the public turn their attention to another story.

People are angry, because too many leaders just shrug when they are asked why going to a grocery store has to be a life-and-death choice. These leaders are content to talk about the importance of better mental health services until the news crews get enough quotes and move on, and then our leaders return to their governing paralysis.

People are incensed because "pro-life" seems to have taken a backseat to pro-gun. The National Rifle Association and Second Amendment absolutists wrap themselves in the words "right of the people to keep and bear arms" and skip over the other part about "a well regulated militia."

The "solution," in their view, is more guns.


Supreme Court Justice Samuel Alito has recently been in the news with his reminder about the importance of what is not said in the Constitution. Although he was writing about abortion, I am sure he would want to remind us, too, that there is no language in the Second Amendment that mentions unfettered access to high-capacity ammo magazines or weapons that can fire as rapidly as a shooter can pull the trigger.

Yes, there is no magic solution that will end all mass killings. It is foolish to expect 100 percent perfection from every step that is proposed.

And it is even more foolish to do nothing, knowing full well that within a week or two the tragedy of another mass killing will visit another community after another deranged person decides to settle some perceived score by gunning down innocent people who are shopping for strawberries, sitting in a classroom, or enjoying a concert.

How much longer must we wait before our "leaders" actually lead on this problem?
