

FORT MADISON – A man known to most for his comfort food and cold beer now has a hefty stake in real estate in Fort Madison.

Chase Gibb, the owner of the Buffalo61 Bar and Grille in Fort Madison purchased School House Apartments in the 1800 block of Avenue F from Todd Schneider several weeks

Gibb said he and Schneider came to terms fairly quickly on a \$2.2 million purchase agreement.

He closed on some Burlington properties at the year's end, but had been talking with Schneider about the Fort Madison apartments since October on a tip from a real estate agent.

"It's an impressive building, but it wasn't a traditional real estate transaction because there were so many grants and tax credits involved in how Schneider funded the project,"

Schneider used historic tax credits to refurbish the former

# **Support now** needed for Middle East veterans

In restaurants or public places he sits in a corner with his back to the wall, close to a window, where he can see the door in case he needs to escape. He does not carry a weapon because he knows he would use it. His name is Patrick James Hogan. His many friends call him PJ. He's 75 years young, from Ft. Madison and a Vietnam Veteran.

He grew up on a farm southeast of Niota, IL. When he received his draft notice in 1966, being a "draft dodger," he joined the Marines (Ha!). He doesn't know if Vietnam was right or wrong. He enlisted to fulfill his military obligation and serve his country. That's it.

The Marines put him into Aviation. There was a sign-up sheet for door gunners. PJ put his name on it. However, on leave, he read in the Ft. Madison's Daily Democrat about one of his friends who was a door gunner and was killed. Back on base, there was a second sign-up sheet for door gunners. If you put your name on it the second time, you would be a door gunner. PJ did not put his name there a second time, and he's glad he didn't. Of the 40 who did, only seven came back alive. His friend may have saved his life.

PJ was put into hydraulics and pneumatics. When he arrived in Da Nang there was a rocket attack. It scared him badly. But there were so many rocket attacks, they became more of a nuisance.

He almost shot a South Vietnamese citizen. The citizen had scaled the fence on the perimeter of the base and was stepping off the distance to one of the buildings. PJ ordered him to stop. The Vietnamese was scared because he knew PJ was scared. The citizen was taken away and questioned. The



## Lack of decompression hitting veterans

next day he was back on base raking sand. PJ saw other South Vietnamese citizens stepping off distances to buildings. One of those buildings was hit by a rocket. The South Vietnamese were selling coordinates to the enemy.

PJ occasionally saw a truck roll by with two-maybethree aluminum caskets with dead soldiers. A couple of times there were two trucks full of caskets. The building was near by where the caskets were stored. He could smell formaldehyde. He got used to that also.

He's the only Marine you will ever meet who never rode in a helicopter. He saw a helicopter come in once laden with bodies. The helicopter caught on a trip wire, crashed and rolled up like a cigar. There were bodies everywhere.

PJ didn't realize how much stress he was under until he went home on leave. He was standing beside his brother who was 13 years older than him. In the mirror, PJ looked to be 10 years older than his brother.

Back on base, a friend told him to look over toward China Beach—the most beautiful beach in the world, according to PJ. There was a bright colored explosion, the sound wave hit them, they could see the rocket going up, and then it disappeared. That was when the rocket was coming right at them. "Incoming!"

Back home after discharge, PJ was not accepted into organizations like the VFW because WW II vets didn't consider him a "real veteran." Now they want him because the WW II Vets are dying off. PJ says, "Nope."


He spent 30 days in a drug and alcohol treatment center in Burlington. He's been sober over 30 years now. He was happily married, but his wife died. Like many Vietnam Veterans, PJ is reclusive. He lives in town, but there is a chain link fence on both sides of his house.

58,000 soldiers died in Vietnam, and more died by suicide after the war. It's worse for returning Middle East Veterans. 22 are now dying per day, by suicide! PJ feels it is because of a lack of decompression time for returning veterans. They're in a war zone one day, 48 hours later they're on the street and supposed to be functioning normal. It is not the Vietnam Vet that needs help and support now, PJ says, it is the Middle East Veterans.

Vietnam Veteran's Day is Tuesday, March 29, (the date of withdrawal from Vietnam). Support and honor your veteran whether they be SE Asia Veterans, Middle East or wherever. Don't pamper them. Respect them.

#### Letter to the Editor - Reichman needs to explain voucher data

Dear Editor -

Education is a hot topic in Iowa. The idea of taking up to 50% of per student income away from public schools and awarding it to private entities is not a popular opinion.

The Legislature had the opportunity to truly invest in the Iowa Public School system this year, instead they chose to award corporations with tax breaks. Then to really emphasize their distaste for our public educators they are reframing the concept of vouchers to 'educational savings accounts' thinking it will soften the blow. We are not fooled!

Thankfully the attempts

to criminalize librarians and placing cameras in classrooms has already been defeated. I cringe at what else might be in store for our schools if change is not made, not just locally but across the state.

Let's talk a bit more about education. Today at the Legislative Luncheon, when Senator Reichman was asked about the education initiatives, aka vouchers, coming out of the Republican held legislature he proceeded to cite the alleged 755 kids who dropped out of the Des Moines public school system. I am sure you are just as confused as I was. I believe he was trying to imply that a voucher aka educational savings

account, would somehow solve that dilemma for the Des Moines Public School (DMPS)system. Although, I am not sure how.

As a side note the DMPS

reports the dropout rate has hit an all-time low at just 3.38%. So is it a problem or not? Again an explanation will be required as to how the vouchers are supposed to make this number lower. Beside educational research indicates when you remove socioeconomic factors "There was also no evidence to suggest that low-income children or children enrolled in urban schools benefited more from private

By the way, the the combined drop out rate for

school enrollment".

Fort Madison and Keokuk public schools (https://educateiowa.gov/sites/files/ed/ documents/DR712 2021 District.xlsx) is 6.1%. A targeted approach would benefit Lee County more then worrying about vouchers. Perhaps investing in our schools with more teachers, teacher assistants, social workers and mental health support would make a significant impact for our youth and reduce this alarming number. By investing I mean funding. We cannot expect miracles out of educators who are underfunded and understaffed.

**Central Lee 6th in B Division:** Eschman third in 100-meter dash and long jump for Hawks

WEST BURLINGTON – The Fort Madison Bloodhounds took 3rd place in the A Division at the annual Falcon Relays.

Fort Madison got first place finishes from Mikey DiPrima in the high jump at 5'8", John Cottrell in the 1600-meter run, the 800 sprint medley relay team, and Macayden Rhoer in the 400 hurdles.

Cottrell edged Mt. Pleasant's Nathan McWilliams in the 1600 with a 5:19.12 just .7 seconds ahead of the Panther. The Hounds' Hayden Wolfe took fifth place in the event at 5:32.91.

The Sprint Medley team of Tate Settles, Tate Johnson, Hayden Segoviano, and Andrew Schaefer was a full 2.5 seconds in front at 1:40.31. Washington was second at 1:42.87. The Hounds' time was the fastest in both divisions. New London's Boden Pickle, Joel Lacy, Reean Seberg, and Rylan Martin ran a 1:41.15.

In the Distance Medley, Fort Madison's Teague Smith, Lamar Dayton, Dane Butler, and Cottrell took second place with a 4:04.82 behind Washington's 4:00.79. New London's Seberg, Jordan Sharp, Kade Benjamin, and Alex Julian had the fastest time of the day at 4:00.47.

Rhoer's 1:01.48 was tops in Division A 400 hurdles, a full 3.6 seconds in front of West Burlington-Notre Dame's Gediyon Boal's 1:05.04. Winfield-Mt. Union's Gabriel Hemsworth had the fastest time of the day at 1:01.29.

Johnson had the second fastest 100 meter dash with an 11.31 behind Washington's Elijah Morris' 11.19. Settles had the second fastest Bloodhound run at 12.18, good enough for eighth place overall.



student at Central Lee High School and active 4H Club member, shared her childhood and recent memories at Denning Conservation Area. She was concerned that the park was going to be removed. Mellissa Peitz, a Lee County citizen, spoke on the recent article about the LCCB's plan to continue forward with the demolition with the house and outbuildings on the north

side of the property. She felt her and others voices were not heard in a previous Board meeting. She also shared her concern about the Board's meeting time of 4 p.m. and about the LCCB's lack of knowledge of the Eleanor Denning Trust and how the Board intends to use these funds.

Gail Thompson, mayor of Houghton, asked what happed to Eleanor Denning's memorial donations. Huebner responded that she looked into this and the total was less than \$500 and was put into the conservation fund for future maintenance for the Denning Property- the same for the approximately \$17,000 received from the Denning estate. Thompson also asked what happened to items from the barns, such as antique tools and wagons. The Board responded that the current renter/EIeanor's former caretaker took ownership of many of those items and was given a lengthy amount of time to remove what he wished to keep. The LCC staff recently removed the two wagons, so they would not be a part of the demo.

Kennedy Wellman, a Central Lee Student, stated that she was new to this issue and asked why this was happening. The Board explained the

issue and that the playground was never slated for removal. This was a misunderstanding. The playground would only be removed after its lifetime was met (many years from now).

Huebner swore that no one currently or formerly on the LCC Board or staff knew of the recently signed over Denning Trust for the maintenance of the playground because a private citizen was the trustee and signed it over to the LCC during Huebner's first few weeks of employment.

Diana LeGrand called in with her concerns about the Denning property and the usage of the money from the farm rent.

The Board thanked everyone for their input.

Agreement with the IDNR before fully understanding the recently signed over Eleanor Denning Trust. The Board is not ready to go with the suggested verbiage change from the IDNR.

Pollpeter asked Huebner if all of the financial information on the Eleanor Denning trust had been turned over to her yet. Huebner stated that not all of this information has been received yet. She has been with working with the county attorney on this matter. She will release a press release once she had a full understanding of these finances.

8.Discuss and Take Possible Action on Denning Barns

Pollpeter clarified that this discussion would be about the two barns on the north side of the Denning Property. Huebner asked if the Board had a chance to review the letter from NRC. She also spoke on the importance of LCC's good relationship with the NRC and

IDNR

Patrick shared a statement about the in-depth research he had done on the Denning Property to get a better understanding of what the Denning's true intentions with this property, which gave him a greater perspective. He concluded that the Denning's would have liked the north side of the property to be returned to wildlife habitat for hunting and for the South side to be for the park. After spending hours researching the barns and receiving expert input on them, he found that the barns had no value other than sentimental, and to take them down rebuild one of the barns could cost \$30,000-\$100,000. He also believes the DNR is not going against Eleanor's wishes by tearing down the barns because she wanted this side of the property to be returned to wildlife habitat for hunting and left no fund dedicated to the barns maintenance. He reiterated that while every has their own opinions on what they believe Eleanor would have wanted, he took it as his responsibility to research the facts to higher standard, rather than just running on opinions. Patrick apologized for acting impulsively due to his love of old barns, without doing justice to Eleanor and trying to understand what her bigger picture was.

Alton and Pollpeter thanked Patrick for sharing his statement.

Huebner stated that to have another organization in to remove and rebuild the barns would be a large liability to the county according to the county attorney.

Citizens restated concerns about a lack of maintenance on the Denning Property and where the funds for the farm rental goes.

Huebner stated these funds are put into the LCCB trust fund, which goes into maintaining the Denning Property, including the demo work currently being completed, and other conservation areas.

Huebner also stated the LCCB has no intention of removing the playground Denning and never would have until the playground met its lifetime. The LCC staff are coming up with a volunteer and better maintenance plan for Denning beginning this spring.

Alton stated that now that the Board has full clarity on this property. They wish to put in the work to improve the barn on the south side of the property.

The current contract with C.C.S. of Keokuk would be the cheapest option to remove the barns. The Board had a discussion on whether this would be the right path to move forward on. Moore asked the public if they would be able to come up with the funding to take down and rebuild the barns. The members of the public did not feel confident that they could.

Pollpeter motioned to continue with the Denning demolition contract with

C.C.S. to remove the two barns on the north side of the property.



# City's growth attracted real estate investment

Fort Madison Middle School, as well as took advantage of some energy credits when he had solar panels installed on the roof of the building and the carports to help offset utility costs.

"There were a lot of hoops we had to jump through with the Iowa Economic Development Authority because there are still five years of regulations and rules I have to follow as far as renting the apartments to people who meet income thresholds," Gibb said.

Gibb said he has property managers who handle the day-to-day operations and considers himself more of an investor.

"I started investing in real estate about 10 years ago. I didn't discuss it a lot because it's passive income for me. I'm a big believer in diversifying investments. And what I've learned over time is, and I love the restaurant business, but you have to be very hands on in that game and I can do that now," he said.

"But in 10 years I don't know if that's something I'll still want to be as heavily involved in."

Gibb said real estate was more of a hobby in the past and was fun, but now he can take the returns on that initial hobby, and become more ingrained in the market

He said right now he has about 90 apartments in Fort Madison and Burlington and has other opportunities in the works, especially in Fort Madison.

"I read all the time and pay attention to what's going on in Fort Madison, even though I live in Burlington," he said.

"I've been impressed with the way the city of Fort Madison is trying to grow. The marina, the projects downtown, and the mayor saying he wants to bring 1,000 people to grow the population. When you see other people locally investing in their community like that, it makes you feel safe investing in that community, too."

Gibb said the School House Apartments are fully leased with a waiting list. But he doesn't know what he will do with the gym.

He said he may let it sit for a while, but he wants to look at possibilities with other groups in the community that could use the facility.

'The floor's still good, everything's in good shape and there's some historical tax credits that might be available to develop this for the community," he said.

"I could just rip everything out and build storage units for the tenants. I could do that. But these chairs are still comfortable, the stage is in good shape. I just think there's a use for this, I'm just not sure what that looks like yet. I don't need to make money off this, but what could I do to help with Fort Madison's growth plans."

He said groups like Old Fort Players could be someone he would like to connect with, or non-profits to use the large space.

"Here you go. Keep it nice, do something nice with it, and I will lease it to you for \$1 a year as long as you don't disturb a tenant."

He said there will be some improvements made to the exterior and some clean up.

Gibb said he'd like to improve on the exterior lighting and would like to eventually put some garages on the property, but wants the construction to fit the historical character of the building. He may pull the tennis courts and basketball courts out to add the space for garages.

"I don't want to create an eyesore so we'll want to keep it looking nice for the neighbors."

He also said he wants to offer occasional tours of the tunnels in the basement. There is a series of low tunnels that move through the basements and around the base of the building that a lot of people haven't been able to experience yet.

"Everybody wants to see the tunnels. I've heard the stories. It's really kind of neat and there's still a lot of stuff stored down there."

But with the apartments completely leased out and a waiting list for additional tenants, Gibb is turning his sights on additional real estate ventures in the community, and what that looks like only he knows.

#### IDPH, DHS close to merging operations

DES MOINES – The Iowa Departments of Public Health (IDPH) and Human Services (DHS) are one step closer to becoming a single agency. Today the Departments released the final change package and functional organizational chart. This serves as the roadmap to bring together both agencies under a single leadership structure. The goal of this work is to strengthen coordination amongst existing services and provide more comprehensive services to all Iowans. This will also allow us to gain efficiencies and better leverage resources to reinvest in our system. There are no plans for layoffs or to discontinue existing programs or services.

This work is the culmination of nearly two years of meetings with IDPH and DHS staff, local public health, community partners, stakeholders, and the public to gather feedback on how to establish a unified health and human services agency to better support all Iowans. These conversations resulted in a prioritized set of recommendations on how the agencies can work together to align programs and services. These recommendations are outlined in the final change package published today here.

This includes a functional organizational chart that outlines the major functions of the combined agency. Leveraging the resources, tools, and specialized expertise in both departments will allow us to better focus on overall population health and community wellbeing for all Iowans. The goal is to establish a true health and human services system that address the full continuum from prevention to intervention.
