PRIMARIES: Finkenauer goes down in Democratic primary voting



MITCHELL

DES MOINES – Iowa Rep. Joe Mitchell (R-Wayland) was ousted in Tuesday's primary voting for State Rep. District 87.

Mitchell, whose district has changed for the upcoming term due to state redistricting, is serving his second term representing southeast Iowa, including northwest Lee County.

The new 87th district no longer includes Lee County. The only other local race contested was for the new

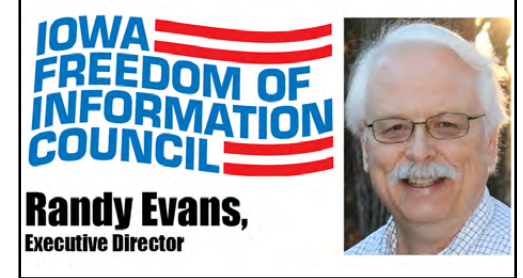
State Representative for District 99 where TJ Widbin lost in his first ever attempt for elected office. Widbin was defeated by Matthew Rinker 728 to 595. The new district includes northeastern Lee County.

Martin Graber ran unopposed on the Republican ticket and garnered 931 votes with just three write-ins.

At the federal level, Michael Franken ousted Abby Finkenauer for the Democratic challenger to Charles

Complexities of debate shouldn't deter progress

Middle ground seems to have disappeared in the United States, and that's unfortunate.

These days, there's no appetite for the give-and-take that leads to compromise. Regardless of the side you are on, it's pretty much "my way or the highway."

Speaking of highways, in 1973, Congress and President Richard Nixon enacted a nationwide 55 mph speed limit in response to the oil embargo by Middle East petroleum producers. Lead-footed Iowa drivers, frustrated after zooming along at 75 mph on Interstate highways, got nowhere with their objections the new speed limit interfered with their constitutionally articulated right to "secure the blessings of liberty" by driving faster.

A generation before, it was the same following the attack on Pearl Harbor. The federal government instituted a 35 mph "victory speed limit." There were some who disregarded the new limit, of course, but most Americans willingly went along with the inconvenience — because they accepted assurances the lower speed limit was accomplishing a greater good for the American public.

Today, however, anyone making "the greater good" arguments about any limitations on guns is going to get a response similar to what occurs when you knock down a hornets' nest. I know, because I was "stung" several times last week in conversations with some readers around Iowa and from points beyond who see no wiggle room, and no value in compromise, on issues relating to guns and the Second Amendment.

No wiggle room for more comprehensive background checks — to include people who buy guns from private sellers

New sports facility is part of 2023 GRE improvements

BURLINGTON – The Courts, a long-awaited indoor basketball, volleyball and pickleball court facility, celebrated a ground-breaking ceremony on Wednesday morning.

The ceremonial 'first dig' followed brief comments by Dr. Michael Ash, President of Southeastern Community College; Matt Shinn, Director of City Hope of Burlington; and Randy Winegard, on behalf of the Winegard

Foundation and Winegard Trust, all individuals and organizations who helped make the project possible.

The Courts were first conceived in 2011 after the 'Imagine Campaign' received more than 3,500 ideas on how to improve the Burlington area. In conjunction with the completion of the FunCity Turf in 2019, The Courts will be the second and final phase of the project aimed to increase sports

tourism, health, fitness, and athletic activities in the area.

The Courts will be built in the southeast parking lot of FunCity Resort, between the Winegard building and east wing of the newly renovated FunCity Resort Hotel. Once complete, it will feature three collegiate-sized basketball courts and five pickleball courts, all

Hounds sweep Demons in extra innings

WILLIAMS: Landes Williams leads Hounds on the mound and at plate

FORT MADISON – The Fort Madison Bloodhounds moved to 7-2 on the year after a Monday sweep of Washington at home in Southeast Conference baseball action.

Landes Williams went 3-for-4 at the plate with an RBI including two doubles, while going eight innings on the mound, fanning nine in the Bloodhounds' 2-1 win in the opener.

Fort Madison trailed 1-0 going into the bottom of the seventh. Van Buren scored in the third when Isaac Vetter scored on a passed ball with two outs. Williams kept things close over the next four innings allowing just two hits through the seventh.

In the bottom half of the seventh, senior Matt Hopper reached on an error. Courtesy runner Brennan Ulik would come around to score when Williams laced an RBI two-out double to center after fouling off six pitches in a 12-pitch at-bat. The RBI tied the game at 1-1.

A ground out would end the seventh. Hopper would get the Demons 3-up, 3-down in the top of the 8th to set up an extra-inning win for the Hounds.

Reiburn Turnbull doubled to lead off the bottom half. Following a Tate Johnson strike out, Tanner Settles ground out moving Turnbull to third. Aidan Pennock would draw a walk and then Hopper would single to center, plating Turnbull with the game winner.

Kane Williams had the other hit for Fort Madison in the win. Williams is now hitting .406 on the year just .15 ahead of his brother Landes.

The Hounds rolled in the night cap behind the pitching of Pennock, Hopper, and freshman Luke Hellige.



Kane Williams went 3 for 5 with 2 RBIs and a run scored. Turnbull went 2 for 4 with 3 RBIs and two runs scored in the onslaught. Tanner Settles was 3 for 4 with 3 RBIs and two runs scored.

Washington jumped out to a 3-0 lead in the top of the first inning, but the Hounds responded with two in the bottom half. The Demons would add a run in the top half of the second to make it 4-2 after two.

Fort Madison would erupt for six runs in the bottom of the third, highlighted by Settles' two-run single. The Hounds would put up four more in the bottom of the fourth as Pennock locked down the Demons to give the Hounds a 12-4 lead after four.

Washington would add two in the top of the fifth to cut the lead to 12-6 on Zeke Slagel's double off Hellige. Hellige would get the next batter and then retire the side in order in the top of the sixth.

Fort Madison would add four in the bottom of the sixth to invoke the 10-run rule. Cayden Barnes, Kane Williams, and Turnbull all had RBI singles in the frame. Tate Johnson would work a walk on four straight pitches to force in Landes Williams from third for the game winner.

Fort Madison (7-2, 4-1) hosts Mediapolis for a non-conference matchup Wednesday night in a single game 7 p.m. start.

Grassley, who was chosen as the Republican candidate for six more years. Franken won by 20,900. Grassley won his primary by 91,500.

Christina Bohannon, running unopposed to be the Democratic challenger to Marianne Miller-Meeks for the new District 1 U.S. Representative seat in Iowa, garnered 37,267, while Miller-Meeks received 40,833.

Governor Kim Reynolds got 184,866 votes, while Democratic challenger Deirdra DeJear garnered 145,316.

Iowa Secretary of State Paul Pate said more than 356,000 registered Iowans voted in Tuesday's election, or about 16.5% of all registered voters. More

than 73,000 of those votes were cast absentee, the second highest total for a primary election in the state's history.

The unofficial turnout by political party was 195,355 Republicans and 156,589 Democrats.

Secretary Pate extends his thanks to Iowa voters, poll workers, and county election officials for ensuring a clean, smooth primary election process.

"I think it went fantastic," Secretary Pate said. "I've got to compliment all the voters and our unsung heroes, those poll workers. They came through with flying colors. We saw thousands of Iowans coming out to have their voice heard and democracy in action."

Miller-Meeks bill chases unspent ARPA funds

WASHINGTON, D.C.— On Wednesday, Rep. Marianne Miller-Meeks (IA-02), a member of the House Education and Labor Committee, introduced the Securing Our Schools Act. This legislation would clarify that states have the flexibility to utilize unused State and Local Fiscal Recovery Funds to be made available for school security measures.

"We need to give schools more resources to keep our students safe. There are currently billions of dollars sitting unused in states around the country," said Miller-Meeks. "Clarifying states have the flexibility to use relief money to increase security is a commonsense step that would see immediate results. I hope that Congress can act to keep our students safe and responsibly use taxpayer dollars."

indoors. Additionally, this space will be able to host volleyball games, racquet-sports, wrestling, events, and other community activities.

Leading the charge on fundraising and design is a group of community and business leaders from Great River Entertainment, Southeastern Community College, Winegard Company, the Greater Burlington Partnership, Great River Health Systems, and many others. Like the FunCity Turf, The Courts will be managed by the Greater Burlington Area Sports Facilities – a non-profit led by President of the Board Michael Ash, who also serves as the President of Southeastern Community College.

Other companies involved with the project are Studio

483, an architecture and design firm out of Davenport; Conceptual Designs Inc., a commercial interior design firm out of Bettendorf; and Build to Suit Inc., a construction company out of Bettendorf. Once complete, the Courts will be managed by Andrew Ryerson, who is the current general manager of the FunCity Turf.

To date The Courts project has raised \$6.1 million and is tentatively scheduled to be completed May 2023. Prior to the opening of The Courts, FunCity plans to re-open Ballocity, a new indoor water feature, and the new Ninja Extreme course in early 2023.

In addition, a new Court Side activity space, featuring concessions, arcade games, video screens, and more – will also open in 2023.

Ames shooter was charged two days before killing two

and would-be buyers whose transactions are allowed to go through if the FBI background check is not finished within three days.

No compromise on raising the age for purchasing any firearm to 21, from the current 18. No wiggle room for stopping the sale of large-capacity ammo clips and magazines to private purchasers and limiting those transactions to military and law enforcement buyers. No compromise for ending what is called the “boyfriend loophole” — which allows guns to be taken from people who have been convicted of domestic violence against a spouse or someone they live with or with whom they have a child. But the law does not apply to stalkers, nor does it apply to a current or former dating partner. And no wiggle room for restricting the sale of body armor only to military and law enforcement buyers.

That last no-compromise point came home to Iowa after an 18-year-old gunman, protected by body armor made in our state, killed 10 people with a semi-automatic rifle at a Buffalo, N.Y., supermarket on May 14.

The victims included security guard Aaron Salter, the first armed person to confront the gunman. But Salter’s shots were ineffective against the gunman’s body armor. The Buffalo News reported the gunman bought two protective plates from RMA Armament, whose offices and factory are in Centerville. The company website shows the retail price for two armor plates like the gunman purchased was \$640. If the 18-year-old had any concerns about the effectiveness of those armor plates, the company’s website dispels anxieties. The newspaper reported RMA says the plates can stop bullets fired by M16 automatic rifles used by the military and by AR-15 semi-automatic rifles like one the killer used. Most states allow private citizens to purchase body armor, although some require the purchases to be made in person, rather than online. Following the Buffalo killings, New York state lawmakers began work on legislation to prohibit body armor sales to private buyers.

The “boyfriend loophole” came into the spotlight following the shooting deaths last week of two Iowa State University students, Eden Montang and Vivian Flores, in the parking lot of an Ames church. Their killer, Johnathan Whitlatch of Boone, shot and killed himself seconds later.

Montang and Whitlatch had dated but had recently broken up. But two days before the killings, he was charged with harassment and impersonating a public figure in relation to the breakup.

In 2017, he was accused of domestic abuse by a woman in Wapello County, but that case was settled when a judge ordered him to undergo anger management coun-

seling. Last October, Whitlatch was charged with sexually assaulting a woman at a Cedar Falls bar. His trial was scheduled to begin next month.

Because he had not been convicted of a crime, he was allowed to purchase the 9 mm pistol used in the killings and an AR-15 semi-automatic rifle that was in his apartment.

Lawmakers have resisted pressure to close the boyfriend loophole. The National Rifle Association has objected, arguing that confiscating the guns of these people would be ripe for abuse.

Those same slippery-slope concerns were expressed by one reader who feared what some see as common-sense, middle-ground attempts to reduce gun violence would eventually lead liberals in government to confiscate everyone’s firearms.

Be assured the federal government is not going to sweep in and start seizing everyone’s firearms. The U.S. Supreme Court has ruled the Second Amendment protects an individual’s right to own guns.

But Justice Antonin Scalia, who wrote the landmark “Heller” gun decision in 2008, added an important qualifier that often is overlooked: “Like most rights, the right secured by the Second Amendment is not unlimited. ... The right was not a right to keep and carry any weapon whatsoever in any manner whatsoever and for whatever purpose.” The middle ground in reducing the misery from gun deaths will not totally wipe away the problem. But a growing number of people are ready for changes that would, at least, slow the rapidly growing string of unnecessary tragedies with steps like I mentioned above.

Tanner Krause, CEO of the Kum & Go convenience stores, wrote in a recent Des Moines Register column: “We should not let the complexity of a problem get in the way of making progress.”

Biden forgives \$5.8 billion in student debt

DES MOINES — Iowa Attorney General Tom Miller commends the U.S. Department of Education’s actions to cancel \$5.8 billion in student loan balances for students who attended Corinthian Colleges, a defunct for-profit college chain.

“This will provide long-needed relief for student loan borrowers in Iowa and across the nation,” Miller said. “Our office has been working with other attorneys general to get this relief for more than seven years, and we are proud to see those efforts lead to this outcome.”

The Biden administration’s announcement last week means more than 560,000 borrowers will have their federal student loan balances discharged. In Iowa, more than 500 students were eligible for debt cancellation when the school closed in 2015.

Miller led a multistate investigation into Corinthian before its collapse. The investigation found that the school lied to students about future job prospects, falsified data on graduate success, and wrongly claimed students could transfer credits to other colleges.

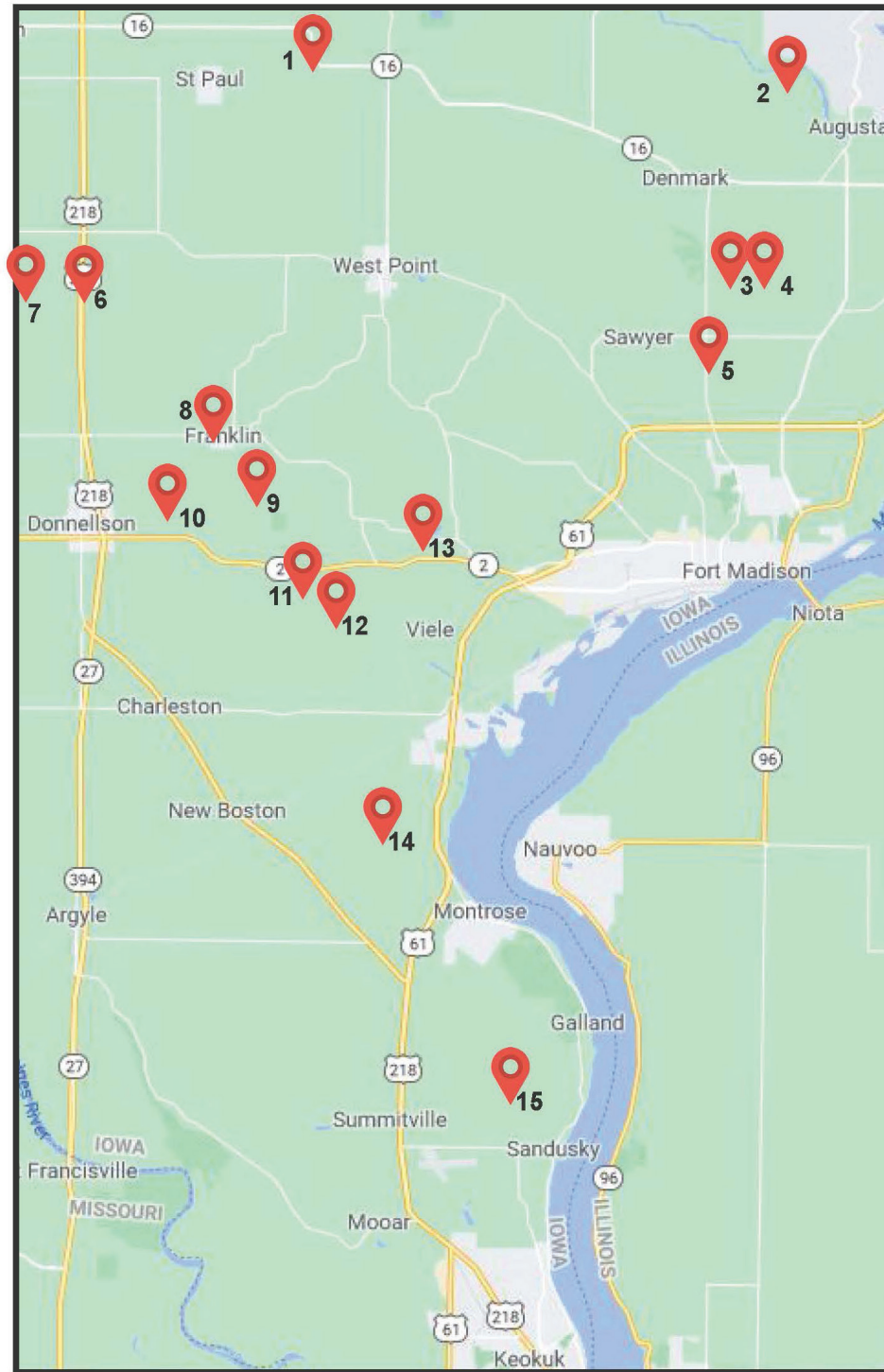
