LEE COUNTY - The winter weather that hit the area Thursday afternoon was to blame in many of the seven accidents that were reported between just noon and 5

The most serious accident took place at the intersection of 255th Street and Hwy. 27 when a semi-trailer and pickup truck collided at the intersection.

The driver of the semi was taken to area hospitals by Lee County EMS in serious condition. The driver of the pickup was reportedly uninjured.

## Davis convicted on homicide charges in Horns' deaths

LEE COUNTY - A Donnellson man has been found guilty of two counts of homicide in the deaths of Michael and Linda Horn, also of Donnellson.

On Friday, February 18, 2022 Chad

Ray Davis, 55, pleaded guilty as charged to two Counts of Homicide by Vehicle While Operating Under the Influence, both Class B Felonies under Iowa law.

Davis now faces sentencing on the convictions, which are each punishable by up to 25 years in prison, for his involvement in the traffic accident on Highway 2, east of Donnellson on August 4, 2020. According to reports from the accident, Davis was driving a pickup truck and struck the Horns from behind. Michael Horn was driving a

# Miller starts inquiry into fertilizer prices

Iowa Fertilizer Co. gets letter from AG looking for information

LEE COUNTY - Iowa Attorney General Tom Miller announced Thursday that he's launching an inquiry into what he called "unprecedented" increases in fertilizer costs in the state.

Miller is working in conjunction with eight other states and some agriculture economists as well as representatives from

some of the world's largest fertilizer companies for a closer look at why prices have spiked.

"Farmers saw higher-than-average prices for corn and soybeans last year, but any profits will be eaten

by increased fertilizer prices," Miller said. Miller, who's currently serving as the president of the National Association of Attorney Generals, declined to name the other eight states in the collaboration.

He said a robust debate and public discussion will be key in helping the inquiry along.

"We think this is really important for our ag community. The price increases I've described were just astronomical, so we approach this from that point of view," Miller said Thursday.

"We think public discussion of this is very much a part of what we think will be helpful to get to some resolution.

Miller said since January 2021, anhydrous ammonia has increased 315%. Urea has increased by 214%, liquid nitrogen by 290%, monoammonium phosphate (MAP) by 171%, and potash by 213%, according to the most recent data supplied by USDA's Agricultural Marketing Services.

"These sudden and significant price

#### Miller-Meeks leads effort for COVID cocktail

WASHINGTON, D.C.—Last Week, Reps. Mariannette Miller-Meeks (IA-02), Bill Foster (IL-11), Mark Green (TN-07), and Kim Schrier (WA-08) led a bipartisan group of eight Members of Congress in calling for greater federal efforts to research and develop COVID-19 combination therapies, or drug "cocktails".

In a letter to Department of Health and Human Services Secretary Xavier Becerra, National Institute of Allergies and Infectious Diseases Director Dr. Anthony Fauci, and National Institutes of Health Acting Director Dr. Lawrence Tabak, the Members wrote:

"Decades of experience combating HIV and

other viruses have shown that combination therapy, or 'cocktails' of multiple therapeutics, is frequently the most effective way to combat viruses. [...]

"However, the pharmaceutical companies that developed [the existing COVID-19 treatments] do not have a natural commercial incentive to formulate and test therapeutic cocktails. Similarly, generic drugs that are off patent do not have a natural advocate for inclusion into cocktails. Therefore, it is necessary for the federal government to aggressively step in and run – or at the very least, fund – these trials."



motorcycle with Linda seated behind him as a passenger on the vehicle.

Sentencing is set for April 15, 2022. If ordered concurrent, Davis will be sentenced to up to 25 years within the Iowa Department of Corrections. If ordered consecutive he could face a 50-year indeterminate sentence.

He remains in custody at the Lee County Correctional Center pending sentencing.

The Iowa State Patrol and the Lee County Sheriff's Department were the responding and investigating agencies.

The matter is being prosecuted by Lee County Attorney Ross Braden.

# Icy roads lead to mishaps

Lee County Sheriff deputies were on scene for more than three hours as the vehicles were removed. Traffic was closed to the northbound side of the highway and rerouted down 255th Street.

Lee County Sheriff Stacy Weber said rain was falling in the county with temperatures near 24 degrees and many roads in the county started icing over.

While deputies were handling the collision at 255th Street, another vehicle lost control about a mile south of that accident and entered the ditch. Minor injuries were reported in that accident.

Another accident at 303rd Avenue and near 313th Avenue resulted in a Ford Explorer rolling after losing control on the 100% ice-covered roadway. No information on the driver's condition was available at press time.

Fort Madison police responded to a possible rollover on 2nd Street just as the weather started, but no injuries were reported at that scene.

Two other two-car collisions also happened in that time span. The first was in Donnellson with no injuries and the second was at the intersection of Avenue D and 18th Street, with no injuries.

The icy road conditions also prompted the postponement of the Fort Madison Bloodhounds Substate semifinal game with Clear Creek-Amana. That game will be made up at 7 p.m. Friday in Fort Madison.

The National Weather Service issued a winter weather advisory for the Fort Madison area until 3 a.m. Friday morning with up to 3 inches of snow possible.

# Fertilizer prices could be legal, but not justified

increases warrant an analysis into the underlying causes," Miller said. "We are not looking at any legal theory or from an enforcement point of view at this time. We want to know, to the extent possible, why this happened, what were the basic factors that caused the price increase, and whether the increases can be explained by supply and demand."

Miller said it's possible the increases could be legal, but not justified and not right, and the inquiry should help shed light on the pricing structures.

"That's the approach we're taking." he said. "It's different than usual, but the right approach."

He said the state's corn growers brought the issue to his attention.

Twelve years ago, the AGs office did a similar inquiry into the unsubstantiated increase in natural gas prices.

"We had an economist do a study and the increases there had no correlation to supply and demand. Over time the prices did decrease."

Miller also referenced a Texas A&M study that showed since 1970, increase in crop returns for farmers tend to coincide with even higher increases in fertilizer expenditures.

"The data suggest that manufacturers are taking advantage of higher farm incomes to increase their returns, but we need more information," Miller said.

U.S. Sec. of Agriculture and former Iowa Governor Tom Vilsack has also spoken with Miller about the issue and will be looking at activity at the federal level.

Letters were sent from Miller's office to five fertilizer companies, including OCI N.V., the owner of Iowa Fertilizer Company in Wever.

Miller said a price increase was expected, but he wants to get more information on the degree to which it occurred.

"We'll be looking at this backward and forward," he said.

He has also discussed the issue with the leaders of the Iowa Soybean Association.

"Farmers have faced rising input costs in recent years, including price increases in fuel, feed, seed, and fertilizer. While weather and other external factors have contributed to these rising costs, production limitations and concentration are a cause for concern. USDA is working to address these types of challenges in other parts of the supply chain through its \$4 billion Build Back Better Initiative, with a quarter of that already dedicated to meat and poultry processing capacity," Secretary Vilsack said. "We welcome the market study announced today and look forward to working with the Attorney General's office on this effort. Farmers deserve transparency in the marketplace and to have confidence that their input costs are fair and equitable.

"The fertilizer increases could hit the pocketbooks of all consumers in the form of higher food prices," Miller said. "I hope to use my presidency to draw attention to this crisis."






