GRRWA to bump rates

MORE THAN DOUBLE Governments could see charges go up over 200% in July

BY CHUCK VANDENBERG

LEE COUNTY - Many governmental agencies could be looking at steep price increases from Great River Regional Waste Authority.

The City of West Point will be the first to tackle the hikes publicly as the issue is on their agenda for Monday night's meeting.

According to information in the West Point City Council packet, GRRWA is asking to more than double the rates charged to the city for waste management services.

The city is currently paying GRRWA \$432 per month or \$5,184 annually for city residents to have access to the company's waste management.

However GRRWA officials have recalculated rates based on 2020 census data, according to City Administrator Dennis McGregor.

That rate is projected to result in an increase to \$992 per month or \$11,904 annually, an increase of 230% over

GRWWA has also informed Lee County that their rates

Bloodhounds send three wrestlers to Wells Fargo

IOWA CITY - The Fort Madison Bloodhounds had a shot at two titles at Saturday's Class 3A state wrestling qualifier at Iowa City High. That quickly turned into the Bloodhounds having wrestlers competing for 2nd place in

eight of 10 wrestle back classes.

Ike Thacher (195), Jakob McGowan (170) and Daniel Sokolik (220) all won in true 2nd place matches to advance to this week's Iowa High School Athletic Association State Wrestling Tournament at Wells Fargo Arena. The tournament starts on Wednesday

Thacher was 30 seconds from being

eliminated in his wrestle back at 195 trailing 17-5 against Liberty's Ethan Armstrong. Armstrong led 13-4 going into the final period. He scored a takedown at 35 seconds into the period for a 15-4 lead, but Thacher escaped a half a minute later. Armstrong would score two

More than just wage bumps at issue in new law

Lee County is in a fish bowl when it comes to the Back the Blue law.

In the past several days Lee County Sheriff Stacy Weber has been in several of the state's largest newspapers talking about the impact of the legislation on law enforcement as well as the impact on county budgets.

From all the chatter through those media outlets it would appear that the Lee County Board of Supervisors recent nod to a 45% increase for the sheriff and his administration may have been the largest single increase in the state as a result of the legislation.

I like to put things in nutshells. It keeps the word count low, and is supposed to simplify the issues. To that end, the Back the Blue law requires county compensation boards to take a median average look at salaries across the state for administrative law enforcement positions including everything from police chiefs with cities of comparable size to counties, to Iowa State Patrol administrative salaries, to Iowa DCI administrative salaries.

The intent of the law was to protect law enforcement to a higher degree from backlash in going about their daily routines of protecting the citizenry. On the back end of the bill came the salary mitigation.

It quickly became the focal point of legislation as counties, specifically in rural areas where budgets are a bit more depressed in reflection of those economies, began to see the impact of the law on salary recommendations.

Boards of Supervisors can brush aside a lofty pay increase recommendation for elected officials, but they are required by law to make any adjustments across the board. In the case of Lee County, the compensation board recommended a 45% increase to the sheriff's salary, which ties by county code

to the Chief Deputy, the department Captain, and the Jail Administrator.

The board also recommended a 10% across-the-board increase for all other elected officials. In brushing aside a 45% increase for one elected official, the board is handcuffed to a degree because any adjustment to the one compensation board recommendation has to be applied to other elected officials equally.

If they cut the sheriff's recommended increase in half, they would have to cut all the other elected officials in half

The weird twist in Lee County came when the item was placed on the board's agenda at the Jan. 31 meeting. Typically the board would vote, as part of the budget process, on the comp. board's recommendation, which only applies to elected officials' salaries.

But the agenda was listed as "discussion and possible action on employee wages. Supervisor Ron Fedler motioned to accept a 50% reduction in the comp board recommendation. That would have set a 22.5% increase for the sheriff and a 5% increase for the other elected officials. Salaries in those departments would have been negotiated as part of the regular budgeting process.

But since the agenda item listed specifically employee wages, and Fedler's motion failed by a 3-2 vote, Supervisor Garry Seyb motioned to approve a 45% increase for the sheriff and a 10% increase for all other employees, and that motion passed 3-2 with Fedler and Board Chairman Matt Pflug voting in opposition to the increas-

The raise amounted to a roughly \$45,000 increase for Weber, making him the highest paid employee in the county. That's a tough one to swallow in rural southeast Iowa and was a tough, long debate for supervisors. Pflug flat out said no one deserves that kind of a raise in any sector, despite his documented support for the sheriff's

department and Lee County Jail.

There's a couple things at work here that most people don't choose to, or haven't yet had the inclination to, think

Lee County is being outpaced by other counties, even rural counties, in salary comparisons across the board. That's a result of past boards ignoring the recommendations of compensation boards that due the diligence in making recommendations. It's also a byproduct of a sluggish economy.

But there's the other side that we don't think about. On Thursday, four sheriff's deputies including Lee County Sheriff Stacy Weber had to take down two armed robbers out of Des Moines. One at gunpoint at the Denmark JetStop.

I think writing for all to see and digest takes a little bravery, but it's a physically safe bravery. I wouldn't want to be the first one through the door. Don't get me wrong, there are people in the county that would do that, I'm just not one of them, and when my tax dollars go to pay those that do, I'm fine with that.

It's not the salaries that concern me, it's the vote. We have two local legislators who confessed to not having all the information at hand before voting on Back the Blue. So the power of that caucus or the lack of diligence needs to be pointed out here.

In lieu of that, the GOP leadership sneaked in language at the end, that not even their own party was familiar with. Either way, that kind of win-at-all-cost politics is a bigger issue than getting Lee County's elected officials salaries on par with the rest of the state.

That's something we all should be thinking about when we go to the polls again – But that's Beside the Point.



Assumption too tall an order for Lady Hawks

Central Lee can't catch up to Knights early runs

DONNELLSON — The height disadvantage was well known even before Central Lee played Davenport Assumption in Saturday's Class 3A regional quarterfinal. The Hawks' tallest players were Macy and Maura Watkins at 5-foot-7. The Knights countered with junior Ava Schubert at 6-1, and three other starters who were 5-9.

It explains why Assumption dominated inside early and often on the way to a 60-43 win that ended the Hawks' season.

Assumption (13-9), which advanced to play West Liberty in Wednesday's semifinal, used its height advantage to take control of the game early. The Knights led 13-5 at the end of the first quarter, then opened the second quarter with a 15-2 run on the way to a 35-14 halftime lead.

"It was just about keeping our energy up," said Schubert, who led Assumption with 20 points. "It's high on our list to put the game away early, no matter who we play. That's what we did tonight. So it was nice."

The Knights played their strength to near perfection.

"We expected that they would be a smaller team," Schubert said. "But we didn't want to take them lightly, at all. We wanted to play with the same intensity we

"Our focus was to play our game," said Assumption assistant coach Samantha Johannsen, acting head coach in the place of Jake Timm, who is out with an

"And that's what I'm going to keep harping on

them throughout the postseason — playing to our strengths."

Johannsen said the 50-40 regular-season finale win over Davenport Central provided some of the momen-

"We played with a lot of intensity in that game, and we wanted to keep that up," she said.

Schubert was especially effective right away.

"Ava got great position and was able to finish around the rim," Johannsen said. "And we kept going at her

And then when the Knights hit four first-half 3-pointers, the Hawks (13-9) couldn't find any sort of defensive answer.

"They're a good team," Central Lee coach Jay Baldwin said. "They took advantage of their height, and then they started making threes, and we had to pick

The Hawks lost point guard Mikayla Morrison early in the game. Morrison had been bothered by back pain all week and when it flared up on her in the first quarter, she had to leave the game.

"Bless her heart," Baldwin said. "She really tried to go. Basically her practices all week were her getting her back iced down. She tried to go and just couldn't."

Assumption led by as much as 30 points in the second half before the Hawks rallied.

Alivia Myhre scored 20 points, 15 in the second half, as Central Lee tried to crawl back in the game.

"We told (Alivia) she had to take over," Baldwin said.

Macy Watkins added 10 points for Central Lee. Baldwin liked how the Hawks had progressed all

"I'm proud of these kids," he said. "They just kept working hard and getting better. And you could see that at the end of the season."

Landfill rates could more than double

will go up beginning in July.

According to Lee County Budget Director Cindy Renstrom, the county has been notified that its rate will increase from \$54,696 annually to \$140,184 per year, an increase of 256% over current rates.

In a letter to West Point officials, GRRWA General Manager Austin Banks pointed to growth of communities and thusly, the landfill, as to the reason behind the increases.

"As our communities continue to grow and generate waste, the GRR-WA must also expand and be forward thinking in our planning. Our service to the planning area must meet those needs along with compliance of state and federal regulations through the EPA and DNR," Banks wrote.

He said the current landfill is utilizing a cell with 4.5 years of airspace, and a new cell will be ready by 2025 to provide an extra five years of airspace. The authority also has plans

to build another cell in 2030 to give an extra eight years of airspace, with additional footprints for other new cells.

Banks also indicated that the EPA could very soon require a methane gas collection system due to the amount of waste being stored.

"Accordingly, the GRRWA must reassess the fees charged to members of the planning area," he wrote.

Currently GRRWA charges \$44 per ton of waste at regular rates and \$36 per ton for contracted rates, with a household rate of \$1.

Beginning July 2022, the new regular rate would be \$45.50 per ton and the contracted rate would go up 113% to \$40.50 per ton. The household rate would increase from \$1 to \$2.50.

Lee County hasn't publicly discussed the rate increase, but Fort Madison officials have indicated they will likely see an increase in fees, as well





McGowan, Thacher, Sokolik punch tickets for state

more points getting control of Thacher with 33 seconds left in the match and the 17-5 lead.

The Bloodhound worked another escape with 21 seconds left and the two scrambled to their feet where Thacher executed what amounted to a hip toss and landed on top of Armstrong with 13 seconds left in the match and was able to register the pin with 7 seconds on the clock.

"I wasn't really looking to score at that point. I knew time was running down and I needed to hit something big," Thacher said.

"I was getting back to the circle quick, and he was taking a little longer so I knew I could get it done if I tried," Thacher said. "I hit a lat drop. He was tired and I just got him over and under and just threw him as hard as I could.

"This means a lot to me. It's something I've been wanting to do since I started wrestling in the room when I was a little kid looking at all the other people who placed on that wall."

Sokolik said getting to watch the final seconds of Thacher's match inspired him in his wrestle back match.

The junior took on Diego Cortez of Bettendorf in the 2nd-place match and the two were tied after Cortes scored the first take down 24 seconds into the match.

Sokolik worked a reversal right at the end of the period to tie things up, and then from a standing start to the second two-minute period, Sokolik got the take down 15 seconds in and turned the move into pin seven seconds later

"He took me down in the beginning and I was fighting on my belly a little bit. I just kept working it and went from a power half to a half and was able to get him down.

Sokolik said he wasn't thinking too much about the Hounds 0-4 start in the 2nd-place matches.

"I wasn't really thinking about that, but the thing that motivated me for this match was watching Ike pin that kid down at the end. That made me really happy watching him win and then watching (Jakob) win. It just motivated me to go."

The Hound knocked off Burlington's Julien Perez-Hall for the second time in two weeks to get into the championship side of the bracket.

McGowan was wrestling this year for the first time since his sophomore year after suffering a knee injury. He said getting to state was his goal going into the season.

His 2nd-place match with DeAvion Parker of Betten-

Freshman Logan Pennock probably had the biggest heartbreaker of the night when he couldn't get a two-point control award as time expired in his wrestle back with Ottumwa senior Corbin Grace.

Pennock had control of the match through the first two periods and had worked a 7-3 lead keeping Grace wrapped up most of the match, but Grace was awarded five points for two near falls in the final 70 seconds to take an 8-7 lead.

In the final 10 seconds, Pennock was able to get out of Grace's control and ended up getting Grace on the mat underneath him. Pennock was laying on Grace with his back and had pushed Grace out of position, but was awarded no points for an escape or reversal as time expired.

Pennock won his first round match and then lost to eventual champion Cael Seaton of Iowa City High, by fall before downing Liberty's Gabe Avalos in trying to get back to the 2nd-place match.

Fort Madison placed third at the meet with 167 points behind Bettendorf and Pleasant Valley.

Emmett Kruse took 5th place at 126 lbs. Henry Wiseman took the 6th place at 138 lbs and Joe Hartman took 6th at 182. Aiden Pennock took 3rd at 145, just missing a shot at a wrestle back. Arnett, just a freshman took 3rd at 285 falling in his wrestle back match to Burlington's Julius Harris (31-3) in a very respectable 3-0 decision.
