## Mayor to host public update of marina June 2

FORT MADISON – Fort Madison Mayor Matt Mohrfeld is making good on his commitment to share a beverage with the public at the riverfront to highlight progress on the city's new marina project.

Mohrfeld had originally planned an April 1 viewing of the marina, but that date was pushed into May due to the increased difficulties and unforeseen delays around river

dredging.

In a release issued Wednesday, the committee in charge of marketing for the project, invited the community for an update on the project and a sneak peek at the work being done.

“Three of of the docks are currently on location. The two uncovered slips should be usable by the July 1st goal date, with parking

also available at that time for slip renters. The covered dock should become available for use by late July.

We are also excited to announce a public celebration event on Thursday, June 2nd, from 5 p.m. to 7 p.m. at the Fort Riverview Pavilion in Fort Madison, where residents can enjoy a complimentary beverage and a Marina update from Mayor Matt Mohrfeld.”

## Accident sends one to hospital

LEE COUNTY – A two-vehicle accident in central Lee County resulted in an area woman being airlifted to a nearby hospital.

According to the Lee County Sheriff's office, rescue personnel were called to the intersection of Ambrosia Lane and Hwy. 218 just before 8 a.m. where a vehicle had collided with another vehicle at the intersection.

According to reports, the vehicle driven by a student heading to Central Lee schools collided with the rear end of a vehicle carrying a group of women from Des Moines County heading to Nashville.

One of the women in the vehicle was transported by Air Evac from near the scene to a nearby hospital. Her condition was unknown as of this posting.

The accident remains under investigation by Lee County Sheriff's Department.

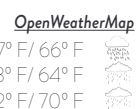

# HTC kids donate \$700 to K9s

while Warosh showcased Fort Madison's newly acquired Norik.

Maag and Warosh took turns talking about the relationship they have with their animals including training, care, and deployment.

Maag said having the dog in his care is one of the most rewarding experiences of his career in law enforcement. He told the students that handlers have the dogs with 24 hours a day, seven days a week, and they become part of their families.

Kion had recently been deployed in a search and rescue in the timber near Farmington and had gotten rescue personnel within 100 yards of where the person was found, but got a foreign object lodged in his paw and had to be taken from the scene for medical treatment. Had it not been for the injury, Maag said Kion would likely have found the subject.

Kion and Gunner are both animals with the Lee County Sheriff's Office and have been part of the department for close to two years. The animals have transitioned through a couple different handlers as is needed when deputies leave the department. Kion is actually the third K9 officer with Lee County. One of the first K9s was Alex, who struggled with some commands during encounter drills. He is now working drug detection for the Transportation Security Administration.

Warosh said having Norik in the mix with the FMPD

has helped provide additional resources for the department.

He said previously the department would have to rely on Lee County for a K9 presence and that was dependent upon availability and staffing. Now the city can deploy their own K9 officer.

Maag said control of the animals in tense situations is critical. During a bite demonstration, Maag monitored Kion's attack on Warosh's arm guard and gave a command to get the animal to release.

"If he hangs on and continues to bite, they can cost the department millions, so we have to be in total control. If he bites outside of a command, that can cost us millions, so these dogs have to respond," he said.

Maag said he gives commands in three different languages.

"I like to mix them up when we train that way no one can pick up on the commands and potentially give one when we're on the job," Maag said.

Norik has been on the job for about two months. His training was a bit different from what the county deputies encountered. Warosh was actually trained to handle a dog that had already been trained for law enforcement duty. Previous training involved an officer getting with an untrained animal and the two trained together.

Both K9 operations are being funded privately through donations to county and city K9 programs. Donations can be made by contacting the Lee County K9 Association at 319-470-2327 or the Fort Madison Police Department at 319-372-2525.

# Davenport North snaps Lady Hounds' 8-game streak

**REGULAR SEASON FINALE:** FM falls 1-0 on late goal by North; post-season work starts next week

FORT MADISON – Fort Madison's girls soccer team gets some time to prepare for the postseason. And rest.

The Bloodhounds finished a long, hot week with a 1-0 loss to Davenport North on Thursday at the Baxter Sports Complex.

The loss in the regular-season finale snapped

Fort Madison's eight-match winning streak.

Now it's on to the postseason for the Bloodhounds (11-3), who play host to Keokuk in a Class 2A regional quarterfinal on May 20.

It had been a busy week for Fort Madison, which defeated Mount Pleasant in double overtime on Monday and then shut out Mediapolis on Tuesday. That's a lot of soccer on a week when temperatures were in the 90s.

"It showed," Fort Madison coach Carrie Burken said. "But fortunately we have a whole week to prepare for the next game, which is good."

Playing North (4-9) was a good lesson for the Bloodhounds who, if they win their first game of the postseason, would get Clear Creek Amana in the semifinals and a possible matchup with fifth-

ranked Cedar Rapids Xavier in the regional final.

"The No. 1 thing that our girls talked about at halftime was, 'Wow, they're really good at connecting passes,'" Burken said. "I'm like, 'That's how it is when you play against the bigger schools.' I hope they saw that we can connect passes, we can do similar things."

"Three games in this heat in one week is tough. But, honestly, I thought we played really, really well. I thought we connected passes well. Our defense played really well."

The lone goal came with 5:33 remaining in the match, when North's Sophia Allardyce was able to get a shot past Fort Madison keeper Taylor Johnson. Johnson hadn't surrendered a goal since midway through the second half of the win over Mount Pleasant.

"Taylor did a really good job," Burken said. "Honestly, that's just tough to be in that position on that goal. I know she's mad at herself, but she played really well."

Fort Madison's best chance to score came in the final seconds of the first half, when Natalie Randolph's shot was stopped by North keeper Emma Jouran.

"Their keeper made a great play there," Burken said. "If she doesn't hold on to the ball, we had people in position for the rebound."

The Bloodhounds will get Friday off, then start preparing on Monday for the postseason.

"They need time to heal and recover," Burken said. "Next week, it's about improving on the things we need to work on — connecting on passes, getting quick touches. Because against better teams, you have to move the ball more quickly. Otherwise, they'll pounce on it."

"The competition we see day in and day out isn't like we're going to see from the bigger schools. So we have to be ready."

# Bloodhounds send at least eight to state track meet

**4x100, 4x200 boys advance:** Senior Tate Johnson comes from behind in three different races to give FM titles

MT. PLEASANT – Fort Madison senior Tate Johnson doesn't like running with someone in front of him.

But in the three times it happened Thursday night at the district state qualifier in Mt. Pleasant, Johnson bolted and brought home titles for the Fort Madison Bloodhounds.

Johnson will join at least seven other Bloodhounds at the IHSAA State Track meet beginning Thursday at Drake.

Sophomores Lexi Whaley and Aija Jenkins kick-started things with 2nd-place finishes in the shot put and high jump. Whaley threw a 33-11.5 in the shot and Jenkins ratcheted up her best leap of the year clearing 5-2.

Then senior Mikey DiPrima found an extra spring in the gears and cleared 6-1 for the first time all year to take the top spot in the high jump outlasting Washington's Kasen Bailey and Ethan Patterson, who couldn't clear the 6-1 bar.

DiPrima also jumped 20-0.25 in the long jump and that will be on the bubble for the top 24 leaps in the state when official qualifiers for the state meet are released tomorrow at around noon.

Last year DiPrima qualified in the long jump, but not the high jump. He said clearing the bar at 6-1 for the first time was like his long jump last year.

"It's just finding it when I need it," DiPrima said. "I cleared the 6-foot bar on the first try and I was hoping the Washington kids wouldn't make it so I didn't have to do more. But they gave me the fight I wanted."

Then Johnson became the fourth Bloodhound to qualify in an individual meet when he caught and passed a speedy Jack Riley from West Burlington in a slight headwind out of the southwest to take the 100-meter dash at 11.38, just a tick ahead of Riley at 11.41.

"I had a pretty bad start – so once again, I just had to chase a guy down. I hate seeing someone in front of me," Johnson said.

But Johnson would come from behind two more times in the 4x200 and 4x100 anchoring both district champion four-somes.

Johnson ran with Julian Dear, Tate Settles, and Hayden Segoviano in that order, in both the 200 and 100 relay events. In the 200, the Hounds were running six in their heat when Settles handed to Segoviano to start the third leg. Segoviano made up some ground handing the baton to Johnson with two runners in front.

Johnson took the baton and, with the Panthers' home announcer calling the horserace between West Burlington's Riley and Davenport Assumption's Angelo Jackson running 1 and 2, Johnson pulled up in the first 100 and blew past both runners almost quicker than the announcer could change up the call, giving the Hounds the win by close to a full second at 1:31.90.

Johnson, who's only run in the 4x200 three times this year said it's different because typically he doesn't see runners in front of him.

"Normally there's someone ahead of me in the 4x200 so my mentality is I'm not going to let that guy beat me. I tried to get to them as early as possible and then hold on," he said.

"He ran a low 21 split – Oh my gosh. He's just fast ... there's just no other way to describe it," said Head Coach Mike Schneider.

"I thought we might get one of the automatics, and I'm like 2nd place – okay that's awesome, but then Tate just kept closing on him."

In the 4x100, only one second separated the top five teams with Fort Madison winning over West Burlington by .05 seconds as Johnson once again caught Riley from behind.

Fort Madison came into the meet seeded 4th in the 4x100 but Schneider said it was anybody's race to win.

"You can't worry about seedings, it's just whoever runs the best race tonight... the cleanest race... and I thought we did that."

Johnson said the Hounds hadn't beaten West Burlington all year and they will see them again at state.

"We haven't beaten those guys all year (West Burlington) but we wanted to do that in districts and I guess we'll see

line) and the Mississippi River. Also includes the following portions of Fort Madison Township, Census Blocks: 191114911002037, 191114901005009, and 191114901005014; and the following portions of Jefferson Township, Census Blocks 191114902002072, 191114902002073, and 191114902002074.

Section 4. The City Council of the City of Fort Madison does hereby amend Title 1, Administration, Chapter 16, "Wards; Precincts" by deleting Title 1, Chapter 16, Section 3, Precincts Established, in its entirety and replacing it with new Section 3, to read in full as follows:

The city is hereby divided into six (6) precincts as follows:

- A. The 1st Ward shall consist of Precinct 1.
- B. The 2nd Ward shall consist of Precinct 2.
- C. The 3rd Ward shall consist of Precinct 3.
- D. The 4th Ward shall consist of Precincts 4 and 4A.
- E. The 5th Ward shall consist of Precinct 5.

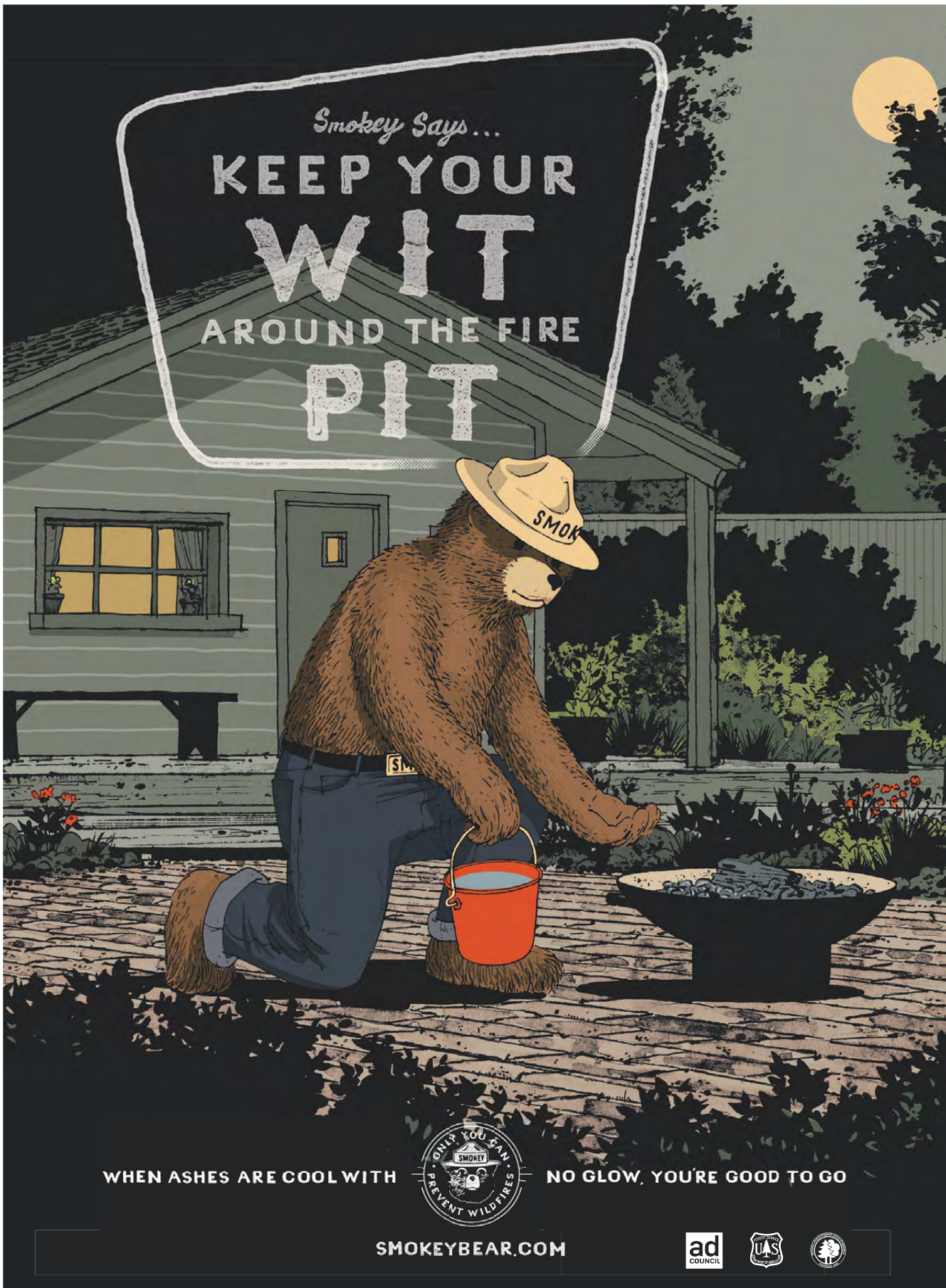
Section 5. All ordinances or parts of ordinances in conflict herewith, are, to the extent of such conflict, hereby repealed.

them again at state," Johnson said.

Dear said he had no doubt the Hounds were going to surprise everyone and win it outright.

"I knew going into it that we were going to win - 100%. It's always great to have Tate as your anchor for everything, but I knew we were going to win."

Fort Madison got another state qualifier in the 400 hurdles when Raquel Schneider gave Fairfield's Kelsey Pacha, who had the fastest time in the district coming into the event by about four seconds, all she wanted.

And if not for a stutter at the final hurdle, could have knocked off the top seed.

Schneider finished with a 1:08.79, her fastest time of the year, and was in a dead heat with Pacha at the final
