KEOKUK - Keokuk police were called to the Elks Fairview Golf Club Sunday morning during the final round of the Keokuk City Tournament.

A single-engine crop duster that was trying to reach Keokuk's airport with a engine trouble had to put the plane down in the city and found an open fairway at the golf

Keokuk Police are not releasing the name of the pilot who landed the plane without injury on the Hole No. 4. Golfers

at the tourney said the no one was on the fourth hole at the time, but were on Holes 3 and 5. The plane landed on the east side of the fairway and headed west where it had to jump over a dip in the fairway and then can landed hard and spun to a stop before the green.

The Federal Aviation Administration is enroute the site to complete an investigation, according to Keokuk Police.

Unofficial reports indicate the pilot is from Australia and was flying in from Missouri.

No golfers were injured, however many saw and heard the plane right over head as it came in. The tournament continued as police taped off the scene

# U.S. District court orders pipeline shut down

LEE COUNTY - A U.S District court ordered this week, that the company that owns and operates the Dakota Access Pipeline that runs, in part, through Lee County, to stop flow and empty the

The long running legal battle between property owners, carried legally by two Sioux Indian tribes, Standing Rock Sioux Tribe and Cheyenne River Sioux Tribes, and the company and U.S. Army Corps of Engineers, has had more than 10 legal opinions from the U.S. District Court for the District of Columbia.

That Court ordered the flow of oil

from the pipeline but shut down, and the pipeline be emptied within 30 days, by Aug. 5 and that the easement given by the U.S. Army Corp of Engineers, specifically to build the pipeline under Lake Oahe in North Dakota, is vacated.

The court said the Corp of Engineers

# **Teammates** remember Ellison 20 years later

 $oldsymbol{1}$  found out from Holly Howard Friday afternoon that a group of girls were gonna smack a softball around under the lights at Central Lee High School following senior night for the Lady Hawks.

Howard said she was teammates with Amanda Jo Ellison, who was killed tragically on the morning of July 10, 2000. The teammates were getting together for the first time in eight years to honor their fallen teammate. Something they had done several times since

Ellison was driving a 1989 Dodge Spirit on Hwy 218, north of the Salem Stub, when the vehicle collided head-on with a pick up truck driven by Jean Frueh, then 46, from Donnell-

Ellison was pronounced dead at the scene. Writing those words are gut-wrenching. We know how Amanda's mother Mary Ellison feels. I thought hard about going out to the memorial game, but the Lady Hawks were playing Fort Madison in Central Lee's regular season finale. After some deliberation, I decided to head out to the games.

On the way out, an SUV rolled on West Point Road and AirEvac was on the scene. Early investigation indicates the victim wasn't seat-belted and was ejected from the vehicle. A somber irony on the day's events.

After the Lady Hawks swept the doubleheader, I was walking over to interview Bloodhound Dalyn Wondra, who had homered in the second game. I was met on the way by two different Central Lee parents who offered condolences for the loss of our 20-year-old daughter earlier this year.



# Central Lee girls take Lee County "championship"

DONNELLSON – Central Lee head coach Tiffany Woodruff was all smiles as she proclaimed her Lady Hawks Lee County "champions" Friday night.

"I call it the Lee County Championship. We beat Keokuk and Fort Madison so there we go. Lee County Championship right there," she said Friday after the Hawks swept a doubleheader with Fort Madison at home 8-3, 9-8.

The nightcap was a thriller under the lights.

Meghan Hopp laced a line drive in the bottom of the seventh, that Fort Madison's Allyson Helmick tried to get to on the fly. The ball slipped under her glove and to the fence scoring Halo Arrowood all the way from first base to end the game.

In the previous at bat, the Lady Hawks' Daly Brisby just missed ending the regular season of her senior year with a walk-off two-run homer. Brisby was facing a 1-2 count and sent a shot about 230 feet down the left field line to an uproar for the Central Lee faithful, but the ball was ruled to have landed in foul territory. Brisby would then line out to first for the first out of the inning.

The Hawks tied the game with no outs when Zoe Eschman singled to short and moved to third on an Arrowood's bunt that was mishandled by the Fort Madison defense. As Fort Madison was resetting the defense, Eschman creeped down the third baseline and bolted for home being called safe on a bang-bang play at the plate.

Arrowood would steal second, then Hopp took a 3-1 pitch on a liner to the opposite field for the game winner.

Central got on the board in the first with two runs, the first on a squeeze bunt and the second when Hopp lined to left scoring Arrowood. They added a run in the third to go up 3-0 when Shanna Buford scored Hopp on a fielder's choice at short.

The Lady Hounds would get one back in

the fourth when Allyson Helmick would score on a passed ball with one out. But Hopp would get the next two hitters to retire the side up 3-1.

Lauryn Helmick would get out of the bottom half unscathed with Central scoring one.

Fort Madison would pick up five runs in the top of the fifth. Senior Ivy Geerdes smacked a one-out RBI single to center scoring Kylee Cashman from second. Following a strike out second out, Neeley Rehm hit a rocket grounder that got through short scoring Lexi Whaley and Geerdes.

Then senior Dalyn Wondra homered for the second time this week plating two and putting the Hounds up 6-3, before a pop out to center ended things in the fourth.

Wondra said she's been trying to be more patient at the plate.

"I've been working hard trying to improve my hitting for years now. But everything is coming together now and starting to click," she said. "A big problem for me was that I was way out ahead of the ball, I've kind of learned to sit back a little more and see it in."

Central Lee would get one back with two outs in the top of the fifth. The Lady Hawks loaded the bases with no outs, but Lauryn Helmick would get Sophie Woodley on strikes in four pitches and then Central Lee's Andrea Benner grounded into a fielder's choice at third where Hopp was forced out at home.

Sophie Turner would responded with an RBI single to center, but Helmick would work a pop out to the mound for the third out leaving the bases juiced.

Fort Madison would pick up two more in the top of the sixth on an RBI single by Lexi Whaley and an RBI fielder's choice by Geerdes to second.

The Lady Hawks again responded with two outs. Helmick got the first outs on fly balls in just four pitches but then the

Buford then followed with an RBI single to left scoring Hopp to make it 8-5. Woodley would walk and Benner would double down the left field line bringing in Watkins and Buford for an 8-8 game setting up the seventh inning drama.

Hopp was 4 for 4 for the game with 2 RBI and two runs scored to lead the Lady Hawks in the second game. Eschman went 3 for 4 with two runs. Arrowood, Watkins, and Buford all had two hits in the game. Buford and Benner both had 2 RBI.

Hopp (1-2) started the game on the mound and then re-entered in the top of the 7th getting the win going 3 2/3 innings total giving up one earned run. She gave up three hits and two walks. Makayla Morrison then threw 1 2/3 giving up two earned runs on three hits and walking two while striking out one. Sophie Turner, who pitched the first game came on in relief throwing 1 2/3 giving up five earned runs on four hits, while fanning one.

Fort Fort Madison, Johnson, Rehm and Whaley all had two hits. Rehm, Geerdes and Wondra each had 2 RBI in the game. Kylee Cashman and Lauryn Helmick each had hits. Cashman scored twice.

Helmick (3-1) went the distance giving up 9 runs on 17 hits and three walks. She struck out four.

In the opener, Central jumped out to 5-0 lead through five innings, but Fort Madison would make a game up of in the sixth.

With one out, Geerdes doubled to right followed by a Wondra single moving Geerdes to third. Allyson Helmick would single up the middle scoring Geerdes and moving Wondra over to second. Rehm would move everyone over on the next atbat with a fly to deep left.

Lauryn Helmick would then hit into a fielder's choice back to pitcher Turner and Wondra was thrown out trying to score. Emily Steffensmeier would then single to right scoring two before ground out to short ended the threat.

The first three Lady Hawks would single off Helmick to start the bottom half of the sixth. Eschman's single would drive in two and she would move to second on a throw home. Arrowood would lay down a bunt and Eschman who was moving on the pitch would come all the way around to score on the fielder's choice to set the final at 8-3.

Woodruff said the sweep was important for Central Lee going into district's next week.

"It's huge just because we beat Keokuk and we wanted to win these two games so it get us back on track for West Burlington.," she said.

The Lady Hawks were shut out by the Class 3A 13th-ranked Falcons on June 25, 4-0, with West Burlington getting three in the bottom of the fifth. The two clash in the first round of Region 8 regional action on Wednesday at 7 p.m. in West Burlington.

Fort Madison travels to Class 5A 8th ranked Muscatine on Tuesday for a double header and then takes on Keokuk at home in the opening of Region 7 action at 7 p.m.

Wondra said the district performance will depend on energy the Hounds were lacking Friday.

"As a team we;re playing and meshing well. Tonight it wasn't really on though. We usually really have good energy and tonight just wasn't a very good night for us," she said.

"We'll be fine in districts if everyone brings that higher level of energy we need."

FORT MADISON -The Bloodhounds should start calling Landes Williams - The Cooler.

Not only did the sophomore take a fullon body blow at home to save a run Thursday night, but then drove in the game winner in the sixth to preserve a 5-4 win over Mediapolis to end the Hounds regular season.

In the bottom of the sixth, trailing 3-5, Williams stepped in with two outs and the bases loaded with Hounds.

Kane Williams wore a pitch with two outs and Jace Burgher beat out an infield single to third. Garrett Hannum then took a 3-0 pitch off the shoulder to load things for Williams, who may have been looking for a little revenge.

Williams got down 0-2 after fouling the first pitch straight back and then watched a called strike. The next pitch came it a touch high for a ball, and Williams fouled off the fourth offering from the Bulldogs Regan Thornburg.

Thornburg would then shoot a fastball that came in just a bit high, but Williams went after it and drilled it into the gap in left center scoring Kane Williams and Burgher for what turned out to be the game winner at

Jason Thurman would get plunked with the next pitch to load the bases. Brandon Reichelt would then work a full count, and with runners going, let a pitch go by for a called third strike to end the inning.







# Lady Hawks gather 20 years after tragedy

I didn't know who they were. But they knew me... and our tragedy. I was moved by the kindness of these strangers.

But as I rounded the outfield fence working my way back to conduct a few more interviews about the official game, and the game in Ellison's honor, I looked on the field to see a group picture being taken and noticed the scoreboard was still on.

It said the score was 7 to 7 in the 7th inning. That wasn't the score of either of the softball games, but Howard said it was in honor of Ellison, who wore number 7.

"She was our friend. She was our catcher and she was super in softball," Howard said. "That was like hand-in-hand, Amanda and softball."

Ellison's accident happened at the end of the 2020 regular season – Amanda's junior year with the Lady Hawks. Mary Ellison said there was a game that night 20 years ago that was postponed for the girls to grieve. And now in way they still grieve.

"I think it's wonderful for them to remember her," Ellison said. "It's been 20 years and I remember they had a ballgame that night that they canceled into the following week. And then that was the scoreboard in the 7th inning of that district

game. The score was 7 to 7."

Ellison sat smiling and laughing behind the home plate fence in the bleachers watching as current assistant coach Tony Arrowood took a couple swings from the 2000 team donned in black, gold, and white t-shirts with the AJE initials in a softball emblem.

"It's both painful and enjoyable," Ellison said. "They know that I love these girls and that they've kept her in their memory. But it's hard to watch, too because she's not out there."

Part of the Amanda's memorial donations went to help bring lights to the softball field – another way for the Lady Hawks to feel that Amanda is always around them.

"When we were in high school. she was all softball, softball, softball. We wanted lights when we were in school and we tried to raise money through fundraisers, but her memorial was a big part of getting these lights in place here," Howard said.

The last time the group got together to play was in 2012, but she said the ladies wanted to get together again because this was the 20th anniversary of her death.

"It's just kind of away to keep her memory alive and keep

us all connected still. It's pretty devastating when you lose someone that young."

Ellison said her daughter got a varsity letter as an eighth grader and was looking forward to getting that fifth varsity bar for her jacket.

"She wanted those five bars so bad on her jacket and just didn't quite get to the last one," Ellison said.

Central Lee Superintendent Dr. Andy Crozier said Sunday, that if Amanda didn't get that bar, "I think we can make that happen."

It's those little things that bring smiles – and tears – and keep memories alive. There's nothing more important.

I'm not overly religious but I just don't know if it can be considered a plan of God to take young people from us. Sometimes I imagine he weeps as we do at the tragedy and disease that are consequences of the creation.

What I do know is I found myself in tears in my SUV before heading home as I thought about Mary Ellison... and Amanda... and then Kelsey and my wife and the two Central Lee parents that patted my shoulder that night.

A somber day indeed.

# Pipeline ruling now goes to circuit court

did not sufficiently conduct an environmental analysis of the impact of the pipelines' construction and operation on the land and populations around the pipeline.

In the opinion, the U.S. District Court Judge James E. Boasberg wrote, "given the seriousness of the Corps' NEPA error, the impossibility of a simple fix, the fact that Dakota Access did assume much of its economic risk knowingly, and the potential harm each day the pipeline operates, the Court is forced to conclude that the flow of oil must cease."

Lee County Supervisor Chairman Ron Fedler said he heard of the potential of the ruling two weeks ago, but said the decision will not have an impact on Lee County.

"I heard of this couple weeks ago. There have been some Indian tribes fighting this for years," Fedler said.

"But it won't impact Lee County or the revenue we receive from the pipeline as I understand it. We get revenue based on the value of the pipeline not the flow going through it."

However, if the decision is upheld on appeal, it could represent the first

major operational pipeline to be forced to shutter because of environmental concerns.

According to a report in Bloomberg Law, attorneys representing Dakota Pipeline, LLC and it's partner and parent company Energy Transfer LP, are "immediately pursuing all available legal and administrative processes" to challenge the decision.

The article goes on to state that the disruption will be substantial with thousands of jobs and millions of dollars in economic impact. The Corp of Engineers is estimating 18 months to remedy the environmental study, which

would then take the issue in front of potential change in the White House, where a Joe Biden administration could refuse to reissue authorizations.

The pipeline runs from it's northwest point of Stanley, N.D. in Bakken Shale fields, southeast through the state, through northeast South Dakota, diagonally across Iowa through Lee County at the southern exit of the state, and into Patoka, in southern Illinois.

The ruling will now go to the same district's Court of Appeals to either overturn the lower court, stay the decision of the lower court, or concur with decision.


