## Pollmiller beach to open

#### **NO CHARGE:** Conservation board votes to make beach open to public at no cost

MONTROSE – Area residents will have access to the Pollmiller Beach at Pollmiller Park at no charge this year.

At Tuesday's regular meeting of the Lee County Conservation Board, the board discussed Pollmiller Park operations going forward in the hopeful wake of the coronavirus and COVID-19 illness.

The board approved opening the beach from 8 a.m. to 7 p.m. and moving from five days a week to seven days a week starting Friday at the latest, according to Lee County Conservation Director Nathan Unsworth.

Several residents encouraged the Lee County Conservation District to open the Pollmiller Park beach as the state continues to reopen sectors of the state's economy on a limited basis.

Ashley Grinnell said her family has camped at Pollmiller the last couple years every weekend.

"The beach is something we utilize every day especially during the hot weather. I think just having it at the discretion of the parent and knowing social distancing is important," Grinnell said.

Several other residents on the teleconference meeting said

## SPRUCING UP Old bank getting a grooming by CHUCK VANDENBERG PCC EDITOR

FORT MADISON – One of the joys of pedaling around the city is that it brings a different view of what else is going on that you normally don't see on the main drags.

Sunday turned up four people working on the old drive-up bank building at the corner of 11th and Avenue G.

The building has been standing vacant since the early 90s, but now is getting a new pitched roof, some paint and a new life.

Micah Stewart, who recently moved back to the area from Springfield, Illinois was mowing the lawn Sunday afternoon, in anticipation of opening Cruiser's Pet Grooming later this month, or in early July. "It's going to be more of a one-man grooming salon. We're going to start very simple, slow, and then hopefully it will grow and we'll be able to do more things. But we're just being cautious right now," Stewart said.

## SUPERVISORS County to roll out soft openings

Buildings to remain closed, but officials to serve by appointment

LEE COUNTY – County residents will be allowed back into county offices starting Monday, but by appointment only. And you have to wear a mask.

At the regular Lee County Board of Supervisor's meeting Tuesday, the board voted 5-0 to reopen county buildings June 15, but only with an appointment. Doors will remain locked and those with appointments will be allowed in if wearing a face covering.

Lee County Auditor Denise Fraise said all department heads had agreed that it was time to try the soft opening as state officials have reopened most sectors of the state economy on a limited basis.

"We're not going to just open the doors to let people flood in," Fraise said. "This will be by appointment only. I would think they may even appreciate that rather than sitting here for two hours."

County Treasurer Chris Spann said the Iowa Department of Transportation is suggesting that all counties conduct driver's license business by appointment from now on.

Supervisor Matt Pflug asked how long the county should run by appointment only.

Fraise said it was difficult to predict and left the conversation open ended.

"I have no idea. Who knows. Who knows

more information.

Stewart moved back to the area from Springfield, Illinois after the coronavirus shuttered his previous job at a veterinary clinic.

"With the whole virus thing, dog grooming wasn't considered essential business so I just decided to move everything under one roof. They had bought this building for a different reason, a BBQ or something, and it wasn't

stalling a new pitched roof on the building, while Stewart's fiance Madeline Cox and her mother repainted the lengthy planter on the properties south side.

While Stewart refreshes the building and fits it for the new venture, he's working on city permits to get the work completed and the new business open.

"I'm hoping to have a soft opening this month yet, and if we can't get it ready by then, we'll look at something in July," he said.

Aside from shoring up the roof and sprucing up the property, Stewart said location won't require intense preparation.

"Pet grooming is such a simple business. We're just leaving it with cement walls and cement floors. Painting it up a bit, but the roof is the main concern because it was leaking pretty heavily," he said.

Visitation will be held on Friday from 10 am – 11 am at the Vigen Memorial Home in Keokuk with family meeting with friends at that time.



## Little Scholars becoming Little Sprouts

WEST POINT – She wants to the be "the top dog" in early childhood education, and she's got the pedigree and passion to make it happen.

Asia Millizer, a former staffer with Head Start out of Community Action of Southeast Iowa is the new owner of the Little Scholars Preschool in West Point.

She purchased the early education center from Jill Kruse in June and is well on her way to reopening the business to service families in southeast Iowa.

Millizer was with Head Start for the past five years as an instructional coach for all Head Start and Early Head Start classrooms in four southeast Iowa counties, and said she "absolutely loved it".

"I'm very passionate about their mission, but it's always been my dream to have my own place and my own preschool. When I found out Jill was going to be closing I reached out to her... and here we are," Millizer said Tuesday.

Millizer is currently accepting registrations for acceptance into the program and is going through the proper licensing and Department of Human Services regulations to be able to open in the fall.

In the meantime, she's offering parents an incentive to check out the new brand. Information on registering can be obtained by emailing Millizer at <u>littlesproutsam@gmail.com</u> or by calling her at 319-457-1395.

Anyone registering before July 1 will have all registration fees waived and receive a 5% discount on the first three months of tuition. Anyone registering by Aug. 1 will still get the waived registration fees.

The school is located at 311 Avenue D in West Point and has been knows as the Little Scholars Preschool for about 15 years. Millizer is changing the name per a recommendation from DHS to avoid any overlaps. When the school opens in the fall it will be called Little Sprouts Preschool.

Millizer said the name is similar because she wants people to know that Little Scholars was a high quality early education program, and she plans on continuing that tradition in a county where high quality child care is in demand

"Lee County has a real need for child care and quality programming and Little Scholars has a history of providing that," she said.

"I looked at other options and nothing really struck me as something I wanted to take a chance with, but Little Scholars came along and it seemed like a good fit. We're very excited."

She said Kruse and her staff have been wonderful in the transition and she couldn't imagine the transition without their help.

"They've been absolutely wonderful to work with. They've been readily available and helped with communication between families and myself."

Millizer said she has already been looking for asso-

ciates to hire to keep the ratio of staff to students very small.

"We will follow DHS licensing guidelines for classroom ratios. We're probably going to hire two associates no matter what, just because smaller ratios are are always better," she said.

Kruse was forced to close the center following the governor's declarations around the coronavirus outbreak. Millizer was then made aware of Kruse's decision to not reopen the center after 15 years serving families in southeast Iowa.

The preschool will be program during the regular school year, but Millizer said she is already in the process of surveying families to see if there are other needs. She said a summer enrichment program is not out of the question at this point.

"The sky's the limit. Lee County has a lot of opportunity and need and spots are filling up. All people need to do is contact me through Facebook or my email address and I can get them a form," Millizer said.

"I'm so passionate about early childhood and I'm determined to make this a success. Little Scholars has a reputation of high quality Montesorri Curriculum and other enrichment activities and we're going to continue that. Were gonna be top dogs in early childhood."

Kruse said she was forced to close on Friday the 13th of all days in March.

"It was kind of a shock. I still had planned on reopening even though I knew my lead teacher was going to retire," Kruse said. "But as this COVID hit, I started to think maybe this is the time for a new chapter in my life and I didn't know what it would look like in the fall."

Kruse said she applied for state grants for gap funding, but was declined for any of the state grants and didn't really understand that, but said the decision was one she was comfortable with.

She said Millizer contacted her initially through Facebook and the two hit it off.

"She's going to have no problem taking over the preschool. It's a Montesorri based program so she'll get certified for that and should be done by spring."

#### Supervisors push public ambulance issue

County EMS, but the contract contains language that allows the county to purchase the service from the company and make it public owned.

Supervisor Chairman Ron Fedler said both the county and the ambulance service would provide independent appraisers to assess the value of Lee County EMS equipment and facilities in the event the county purchased that equipment as part of the take over. But he said there was no obligation that would require the county to purchase company equipment.

Fraise, County Budget Director Cindy Renstrom, Supervisor Rick Larkin, Fedler, and Lee County Attorney Ross Braden met with Lee County Ambulance Director Bill Young and presented the proposed extension more than a week ago.

Fedler said input was also received from Dr. Phillip Caropreso of Keokuk, and Bryor McMillen, a county volunteer firefighter and reserve sheriff's deputy.

"I still haven't heard back from the ambulance service on the proposed contract," Fedler said. "I've been talking with Ross and Denise, and I don't want to wait til the end of the month to have that contract done for the next fiscal year."

The new contract would take effect July 1.

Fedler said it would take six to nine months to get everything in order and he didn't want the county to find itself in the same situation it has this year.

Larkin said it was important for all the supervisors to be on the same page.

"We wanted to proceed with having a public-owned ambulance service... that's why we're bringing it forward right now," he said.

In other action, the board:

• voted 5-0, to approved hiring Southeast Iowa Regional Planning Commission to handle county floodplain administration at a cost of \$13,000 per year for the first year.

• voted 5-0 to approve a contract for the repair of two boilers in the South Lee County Courthouse.

• voted 5-0, to approve new confidentiality and segregation of duties policies.

• voted 5-0 to accept the canvass of the June 2 primary election results.





#### Pollmiller beach could be open Thursday

they too favored having the beach open under the discretion of parents.

Unsworth said it's important to look at the Pollmiller Park operations for a standpoint of public safety and not just financially.

The district would normally charge \$1 per person to use the beach and would average 100 to 150 people per day, with heavy usage at 250 people.

Obviously, we have some people ready to use

our beach and we want to provide that, but I'm trying to strike a balance here with facilitating usage while trying to keep people comfortable with guidelines.

Board member Liza Alton said the safety of staff and patrons has to be at the forefront of the decision to open.

"Anytime we have someone taking cash or counting people we put them at risk. I think we should just open with no admission, leave it to the discretion of the users and post guidelines for safety," she said.

"I don't think we should sell snacks to help keep things sanitized. We don't rent kayaks, canoes or life jackets at this time. It would be a lot of work to keep those things clean."

Unsworth said he wasn't sure what the best answer is, but said everyone knows this year that things are going to be different.

Board member Kritter Hayes, said the people that have commenting have all been practicing social distancing and safety measures for several months.

"If people get too close, they start to get away from each other. If it's easier to not charge money and better for personal safety, let's go that way and open it up. I think it's a great thing for everybody," Hayes said.
