### PEACEFUL PROTEST:

 About 40 march on Keokuk PD to protest racism, Floyd death

KEOKUK – A small black child gave a high-five to a Keokuk Police officer to wrap up a peaceful protest Monday night that ended in front of the Keokuk Police Department.

The march was organized by Davion McGhee of Keokuk and included about 40 men, women and children, black and white. It ended the way it started, unlike many episodes of violence in the nation over the past week, with handshakes and high fives between protestors and law enforcement.

McGhee said she insisted that the march be peaceful in protest, because racism continues to tilt the balance of justice in America.

“We want everyone to go home safe and sound,” McGhee said as members of the protest chanted “No Justice – No Peace, No racist police”

“I’ve lived here for four years with my family and we’re trying to start a new life. And ever since we’ve been here we’ve encountered racist people, including police officers, and for what, just the color of our skin?” I just thought we needed to be heard.”

### AMBULANCE SERVICE

## New deal gives county option for purchase

FORT MADISON – Lee County Supervisors Chairman Ron Fedler said Tuesday there is room in a tentative deal for ambulance service, for the county to take over within the next fiscal year.

Fedler told the board at Tuesday’s regular meeting that a new contract has been agreed to in principal, but the investor group that owns Lee County EMS Ambulance Inc., still has to approve the proposed contract.

A group consisting of Fedler, Supervisor Rick Larkin, Lee County Auditor Denise Fraise, Lee County Budget Director Cindy Renstrom, Lee County Attorney Ross Braden, and Bill Young of Lee County EMS, met Monday to hash out the details of a one-year extension starting July 1.

“It was a very, very good meeting. There was no controversy,” Fedler said. “Bill has to bring it to his board of investors for approval. Barring any problems we should have a contract for the board very shortly.”

Fedler said the contract would pay the service \$75,000 a month with language that would allow the county to take over during the contract or when it expires on June 30, 2021.

Supervisor Gary Folluo asked what Fedler meant by “taking over”.

Fedler said language in the proposal would allow the county to, at some point, take over the service and make it a Lee County-run service. He said the contract pays Lee County EMS monthly so if the county took over in six months, the ambulance service would only get funding through that point.

“That’s a provision in the contract,” Fedler said. “It also said if that would happen at the end of December, which would be six months, the amount we agreed to – they would just get half of that.”

Fedler said he was very pleased with the cooperation between all the parties and

## City moves forward with marina plans

FORT MADISON – The Fort Madison riverfront marina and docks will get some needed repairs, but it will take three years to get done.

At Tuesday’s regular meeting of the Fort Madison City Council, which for the first time had all council members in regular attendance since the coronavirus pandemic hit, the council voted 7-0 to move forward with repairs.

City Public Works Director Mark Boussetot gave a presentation to the

council about the needed repairs compared to the budgeted revenue and expenses associated with the marina and docks.

The Federal Emergency Management Agency is putting up 85% of the costs of repairs, but the city still will be saddled with about \$87,000 worth of costs.

Repairs include roadway repairs to the retaining walls in the dock area, dredging the marina, and removing debris. Most of the repairs are associat-

ed with flooding and therefore trigger FEMA assistance.

Despite eventually voting to move forward with the repairs but space them out over “several” years, most of the council wanted to see a more comprehensive plan to take advantage of the marina.

“We have a beautiful downtown and it’s a shame not to see us have a marina,” said Councilwoman Rebecca Bowker.

Councilman Rusty Andrews said he

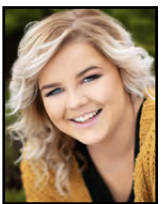

# Treasury to deal with stimulus debit cards

DES MOINES - After discussions with officials at the U.S. Treasury, the Iowa Attorney General's Office reports that several problems with Economic Impact Payment debit cards should be resolved.

Nearly 4 million Americans have received their stimulus payments by prepaid debit card, instead of by paper check or direct deposit. The debit cards have created much confusion, and the Attorney General's Office has heard from about 200 Iowans with questions and concerns regarding potential fraud, customer service, access, fees and other problems with the cards.

"While we appreciate that prepaid debit cards are secure, we are concerned that this confusion could be exploited by scammers and result in financial harm to those an Economic Impact Payment was intended to help," Attorney General Tom Miller said. "We're pleased that the U.S. Treasury is addressing our concerns."

Many consumers believed their card to be fraudulent or a solicitation and discarded it. They later had difficulty getting a new card without the card number.

The U.S. Treasury has waived the \$7.50 replacement fee for the first replaced card, and it has changed the phone system to help recipients reach a live customer service representative. Consumers should call 800-240-8100, press "2" when prompted to report a lost or

stolen card, and enter the last six digits of their Social Security number.

Representatives from the offices of the Iowa and Nebraska attorneys general and the National Association of Attorneys General spoke with U.S. Treasury officials on Monday. The Treasury officials said they have taken the following measures:

- increased the daily limit for cash withdrawals from \$1,000 to \$2,500, which should cover most consumers;
- allowed recipients to transfer all of the money from their EIP card to a bank account for free;
- verified that cards issued with an incorrect last name (such as a spouse's name) are still valid.

The Treasury officials said they will work with Meta-Bank to update the [Epicard.com](http://Epicard.com) website to address the above issues. They also promised to answer any further questions from attorneys general in a timely manner.

The Treasury indicated that nearly all of the cards have been mailed out.

# Some businesses close in anticipation of vandalism

McGhee said she was in Wal-Mart in Keokuk earlier in the afternoon and heard that they were thinking of closing due to rioting.

She said she went up to store employees and told them the protest she was organizing was going to be a peaceful protest. Wal-Marts around the region closed up stores early and piled pallets in front of doors as unsubstantiated rumors of widespread vandalism were being planned in the area.

Hy-Vee's in Fort Madison and Keokuk closed at 8 p.m., In Fort Madison, Walgreens' also closed at 8 p.m. and McDonalds was closed early.

"I stopped and told them that there wasn't going to be any riot at all. That it was a peaceful protest. We came down here for George Floyd because that was injustice, and he still needs justice."

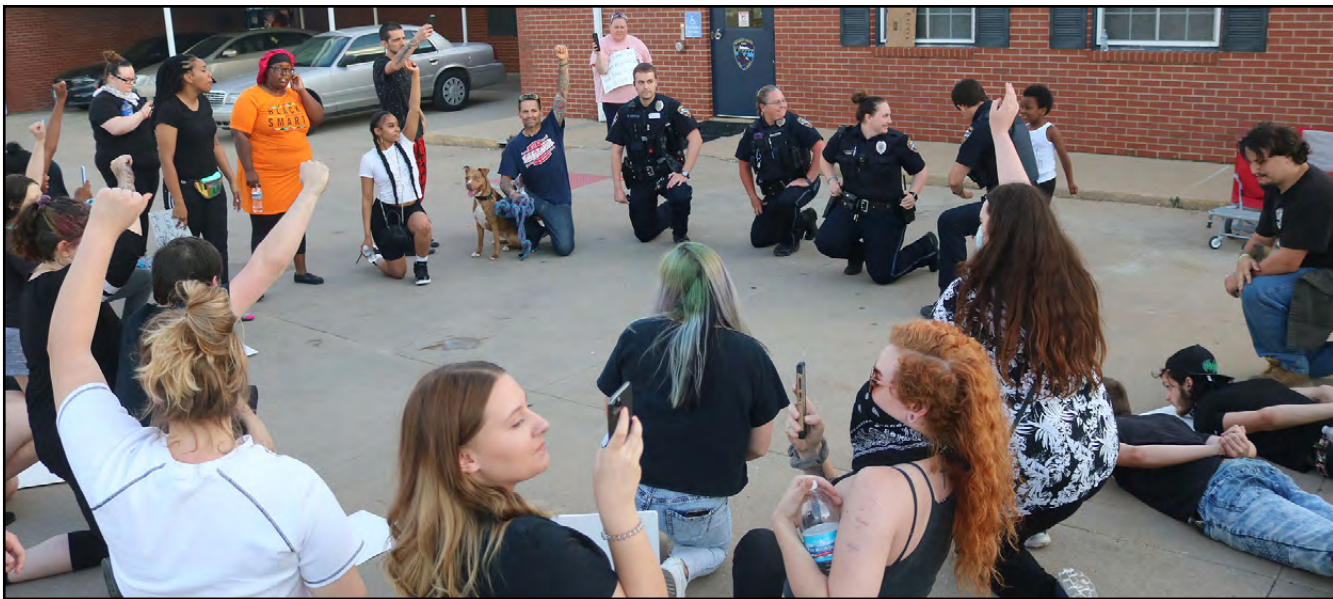
Floyd died May 25 as a result of a injuries sustained after Minneapolis police officer Derek Chauvin, pinned him to the ground and held his knee to Floyd's neck for more than eight minutes. Floyd was accused of trying to pass a fake \$20 bill at a nearby market.

A coroner's report out of Hennipen County in Minnesota showed the 46-year old from St. Louis died of cardiac arrest complicated by neck compression. The report also noted other underlying health conditions, fentanyl intoxication, and recent meth use.

Chauvin is being charged with 3rd-degree murder and manslaughter. He, along with three other officers at the scene were fired after an investigation by the Minneapolis Police Department.

McGhee said the march was different than the rioting that is dominating national news cycles.

"What do you see here? We are laughing, smiling and having a good time. You don't hear anything about us breaking anything," she said. "What they are doing is rioting, this is a protest and this is just so we can be

heard."

Keokuk Police Officer Scott Kindig was one of eight officers from the department to come out and greet the protesters. Several of the officers kneeled with the group while a couple protestors laid on the ground with their hands behind their backs representative of Floyd's arrest.

Kindig said the Floyd incident was handled wrong, but the group in front of him was handling things right.

"We support this group 100%," Kindig said as the protest wound down. "I'm just glad they handled it the way they did. They're doing it right. The way things were handled with that man was just wrong."

Officers stayed outside shaking hands and talking with protestors following the event.

Sophie Ravenscraft, a 20-year-old in the protest from Lomax, Ill., said she was there supporting her friends.

"I have a lot of African-American friends and I'm just tired of them feeling so oppressed from a judicial system that is totally warped," she said.

"I don't think the current state of government and the

system is correct or just. And I think coming out here and showing support for not only them, but the whole group is very important.

Ravenscraft said the Keokuk Police officers and several sheriff's deputies were on scene during the march, but they were very polite.

"There was only an intention here to keep this peaceful. It proves the point. It does no good to be violent towards people at this point."

# County to repair J50, J72 bridges

said not having to renegotiate contracts yearly will help solidify the service for the county. He also told the board that Lee County EMS Ambulance is confident they can provide the service for the entire year if the county needs it.

Supervisor Rich Harlow said he'd read in local news outlets that Keokuk Fire Department was still looking into possibly providing transfer service.

Fedler said he believed that one service in the county was the best option for residents, but he couldn't do anything about what the cities were planning.

Fort Madison Fire Chief Joey Herren told Fort Madison's City Council two weeks ago, that he wants to continue to look at options for a city run service, with the unknown status of the county service going forward and considering what the legislature is going to do with possibly making ambulance services legally essential in the state. That move would open up taxing districts to put up a levy to pay for the service.

Fort Madison, did however, back off a move in May to rezone space behind the fire department for private investment on property that would have provided space for equipment as well as living quarters for ambulance personnel on duty.

"I can't control what the cities do and they have a right to do that," Fedler said. "But I think it would be to everyone's benefit to have one ambulance service for the county."

Fedler said he would like to get a copy of the contract in the hands of the other four supervisors before the next meeting so they have time to go over

the details before putting it up for a vote. He said the deal is "eight or nine pages" long.

In other action, the board:

- approved 4-0 to approve a contract to repair two bridges in the county for a total of \$390,668.

The project consists of a repair and overlay on the J50 bridge over Lost Creek in Green Bay Township, and the J72 bridge over Sugar Creek in Des Moines Township.

- approved a resolution for two-years of tax abatements in support of a housing development application by to L and W Land Development for Meadow Brook Condominiums near West Point.

# City may ask for help with marina

agreed with Bowker and the city needs to get aggressive about getting the marina up and flourishing.

"I wanna see more conversation about how we promote it. How do we make this a lot easier," Councilman Rusty Andrews said.

Mayor Matt Mohrfeld said making the improvements makes sense only if the city plans to keep moving toward a sustainable project down the road. He also said they may need professional assistance in creating a sustainable path forward.

"We can all be blessed with good intention and good vision, but we have to translate that into some form of reality. I'm going to suggest if we do this, we bring in professional help," said Mayor Matt Mohrfeld.

Councilman Chad Cangas said that has to be the direction the city goes, but if they can't make a go of it, they have to be prepared to wash their hands of it.

"I don't think anybody here disagrees, if there is a way forward for the marina, that's our goal. That's the direction we're looking at. But we have to at least discuss the fact that we may have to wash our hands of it if we can't make it go. But I think everyone here has their eyes on the prize," Cangas said.

Mohrfeld said prior discussions on marina plans included seven figure city investments with business plans that were in the region of \$5 million.

Councilwoman Rebecca Bowker said the city needs to put effort back into marketing the property to inves-

tors and not rely on past failures to undermine future success.

"Just because something didn't work then doesn't mean it can't work in the future. With the right contacts, the right energy, and the right positive thinking, I would think we could overcome some of these objections we've heard in the past," she said.

City Manager David Varley said he's had interest from outside parties, but all those inquiries fell flat and he doesn't know what else the city can offer interested parties.

Mohrfeld said he was going to keep putting the issue on the agenda until a plan is hashed out.

Councilwoman Rebecca Bowker said a small committee with forward-thinking ideas should usher in options for the city to consider.

In other action, the council:

- voted 6-0, to approve a resolution in support of a workforce housing tax credit application from Green Oak Development to begin building homes in Fort Madison.

- voted 7-0 to approve a resolution to waive subdivision requirements for property in the 2700 block of 220th Street within the city's two mile territorial jurisdiction.

- voted 7-0 to approve a joint agreement for the creation of a Southeast Iowa Safety Group. The agreement is a three-year commitment.

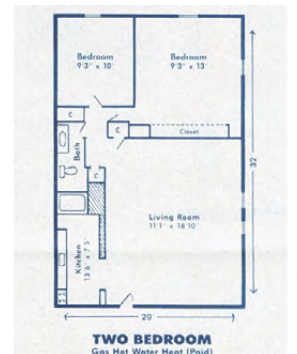
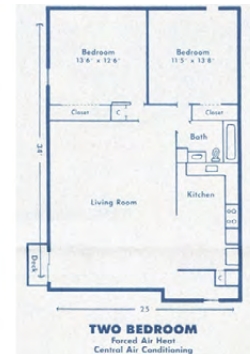

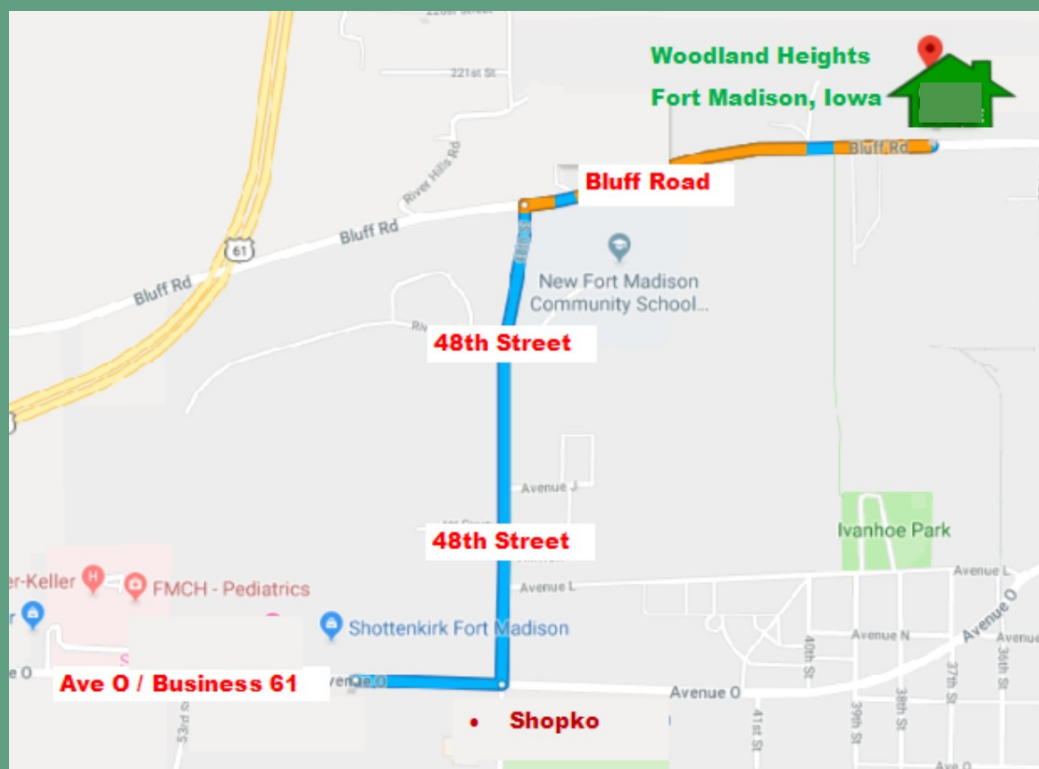
