Chief visits cut by Amtrak

OCTOBER 1: Official says reductions will start Oct. 1 but daily runs will resume when ridership returns

FORT MADISON – As Iowa Bridge and Culvert literally makes its way to Fort Madison to start construction on the new Amtrak platform at the city depot, Amtrak officials are releasing cuts to it's Southwest Chief stops in Fort Madison.

The cuts are being labeled as temporary cuts due to decreased ridership on the heels of the COVID outbreak and Mayor Matt Mohrfeld said Thursday morning he believes they will be temporary.

"I have all confidence that ridership is going to come back up," Mohrfeld said.

"The depot – BNSF still wants it out of their rail yard and they are fully committed. Does it mean less trains for a while, yeah?"

Amtrak currently runs the Southwest Chief daily between Chicago and Los Angeles, including stops in Fort Madison to and from. It also runs the California

Zephyr from Chicago to San Francisco with stops in Burlington. Both of those routes will be reduced to three stops per week beginning Oct. 1. Nine more other long-distance routes are also being cut to three days per week.

In addition, according to a report in the Washington Post on Tuesday, Amtrak may be looking for an extra infusion of \$1.5 billion in federal funding to stay afloat.

Marc Magliari, a spokesman for

Amtrak, said ridership was on trajectory in the fall and winter to beat record numbers seen during the last fiscal year. But the COVID outbreak sent ridership plummeting in March and April to about 10% of normal.

"This is just a temporary change," Magliari told Pen City Current Thursday. "Certainly a lot of people have scaled back their travel. We have Congressional

REGISTRY SWEEP

Sex offender sweep lands one in jail, warrants issued

LEE COUNTY – A sweep of more than 70 registered sex offenders has landed one in jail, and has local law enforcement looking for three additional offenders with active arrest warrants.

The sweep, coordinated by the Lee County Sheriff's Department in conjunction with area police departments and state officials, took place on Wednesday for the most part. But additional investigation continues.

Lee County Sheriff's Deputy Steve Sproul coordinates the department's activity for Lee County residents listed on the Iowa Sex Offender Registry.

He said there are currently 75 residents in Lee County who are active on the registry.

"We didn't make contact with about 35% of them and we did all this in the morning hours from 8 a.m. to noon," Sproul said.

"For the most part these guys are fairly compliant. We left hang-

Reduced runs unwelcome news for city

funding through Sept. 30, but after that we thought it was prudent to reduce capacity until demand is back up.”

In a statement emailed Thursday morning Magliari wrote that the passenger rail system’s goal is to restore service as soon as demand warrant, hopefully by next summer.

“Due to the long-term impact of Covid-19 on ridership, Amtrak has made the decision to operate with reduced capacity through FY21. As we have already made adjustments to our Northeast Corridor (NEC) and state-supported services, the next adjustment is with our long-distance trains, which we plan to reduce to three days per week, beginning October 1, 2020. Our goal is to restore daily service on these routes as demand warrants, potentially by the summer of 2021,” he wrote.

The statement also said Amtrak expects a 20% reduction in staff and is offering a voluntary incentive package as a first step in adjusting its workforce.

The city is in the final stages of relocating the Amtrak Depot to Riverview Park. Mohrfeld said crews should be in town yet this week or the beginning of next week to start that project.

City Manager David Varley said the announcement was unwelcome news.

“It’s not news we take lightly and nothing we were hoping for,” he said. They would not guarantee would always be a stop, but they gave us verbal guarantees that the Southwest Chief would continue to run. But they couldn’t give us anything in writing.”

Varley said about \$2.8 million has been spent in preparing the historical museum and depot property for the eventual relocation of the depot. The city’s contribution to the project, including the new platform construction is right around \$900,000.

“You know this whole thing from day 1 has been a gamble and Amtrak has been in trouble. They’ve been going to Congress about cutting service on long distance trains,” Varley said.

“But there’s a strong group of rural representatives and groups advocating to not cut back on those as in some places it’s one of the few methods of transportation that people in sparsely populated states have.”

He said data indicated the number of people getting off trains in Fort Madison and was averaging about 17 people per day and has dwindled more in since the pandemic.

Jobless numbers continue to fall

DES MOINES - The number of initial claims in Iowa, filed between Sunday, June 7, and Saturday, June 13, was 9,516. There were 8,717 initial claims by individuals who work and live in Iowa, and 799 claims by individuals who work in Iowa and live in another state.

The number of continuing weekly unemployment claims for June 7-13 was 154,752, down 3,516 from the previous week. The U.S. Department of Labor provided updates to last week’s number of initial and continuing claims made between May 31-June 6, which amounts to 9,488 initial claims and 158,268 continuing claims. Iowa Workforce Development relies upon the weekly data released by the U.S. Department of Labor to report its numbers and as such, adopts the revisions to the previously published data.

Unemployment insurance benefit payments totaled \$37,966,993.80 for the week of June 7- June 13. The following industries had the most claims:

Manufacturing (2,160)

Industry Not Available - Self-employed, Independent Contractors, etc. (1,408)

Health Care & Social Assistance (840)

Accommodation & Food Services (649)

Retail Trade (602)

A total of \$94,729,200 in Federal Pandemic Unemployment Compensation (FPUC) benefits was paid during the week of June 7-13, 2020. Since April 4, 2020, a total of \$960,705,000 in FPUC benefits has been paid.

A total of \$6,201,822 was paid in Pandemic Unemployment Assistance (PUA) benefits during the week of June 7-13, 2020.

A total of \$3,407,076.16 in benefits has been paid in Pandemic Emergency Unemployment Compensation (PEUC) benefits for the week of June 7-13, 2020. Since May 27, 2020, a total of \$14,669,608.14 in PEUC benefits have been paid.

Bass, blue gill heating up was local waters clear up

DES MOINES - The following is the weekly southeast Iowa fishing report provided by the Iowa Department of Natural Resources

Big Hollow Lake

Water temperatures are in the upper 70's. Water clarity is good. Duckweed on top of the water will cause some hassles, but not too bad. Largemouth Bass - Good: Early and late in the day bite are best. Work some soft plastics around the big brush piles in 6-8 feet of water. Bluegill - Excellent: Bluegill fishing was good over the weekend with lots of nice fish out in 3 to 4 feet of water on the spawning beds.

Iowa River (Columbus Junction to Mississippi River)
The Iowa River at Wapello is still running at bank full level.

Lake Belva Deer

The lake has settled back down after last week's heavy rains. Water temperature is in the mid to upper 70's. Largemouth Bass - Good: Work the flooded timber and around the mounds at the upper end of the lake. Bluegill - Good: Work the edges of the weed beds.

Lake Darling

Water level is still a little high, but water clarity is back to about 3-4 feet. Water temperature had cooled to 77 degrees on Wednesday morning (6/17). Largemouth Bass - Good: Anglers are catching nice bass on topwater baits early and late in the day. Bluegill - Good: The return of better water conditions improved bluegill fishing. Channel Catfish - Good: Work just out of the the weirs in the in-lake silt dams to catch nice catfish as they wait for the high water to wash food by them.

Lost Grove Lake

Water temperatures are in the mid to upper 70's. The

aquatic vegetation is thick this year, but should start to die back some with the hot weather. Largemouth Bass - Good: Work the outer edge of the weed beds or use weedless top water baits like scum frogs or moss bosses to get them out of the pockets. Bluegill - Good: Bluegills are on nests; work the edges of the weed beds and any holes you can find in them. Some bluegills have finished spawning; find them in the flooded timber out in deeper water.

Skunk River (Rose Hill to Coppock)

The Skunk River dropped several feet this week; just a little over half bank full now.

Central Park Lake

Largemouth Bass - Fair: Most fish are 12-13 inches. Bluegill - Fair: Most fish are smaller, up to 7 inches.

Coralville Reservoir

The lake level is 696.3 feet on 6/18 (normal summer pool is 683 feet) and is predicted to start slowly falling. Water temperatures are in the mid-70's. Channel Catfish - Fair: Use cut bait in the channel or live bait along rock banks for spawning fish. White Crappie - Slow: Try minnows or jigs around brush piles or along steeper rock banks.

Diamond Lake

All facilities are open. Black Crappie - Fair: Most fish are 8-12 feet down in deeper water around brush or suspended in open water. Try small jigs for these 8-9 inch fish. Bluegill - Good: Use small jigs or worms in the shallows as they are spawning. Many fish are 7-8 inches. Channel Catfish - Good: Try stinkbait or crawlers. After rain events has been best.

Iowa Lake (Iowa Co.)

Water temperature is around 75 degrees. The shoreline is heavily vegetated with aquatic plants. Bluegill - Fair: Look for pockets in the weeds for bedding fish. Largemouth Bass - Fair: Try a weedless frog fished in weed lines or over the weeds. Black Crappie - Fair: Target weed lines or drift open water with jigs. Most fish are 9-11 inches. Channel Catfish - Fair: Fish are moving shallower to spawn.

Lake Macbride

Water temperatures are around 75 degrees. The 10 hp outboard maximum limit is in effect. Black Crappie - Slow: Fish are moving back out to summer areas over brush stumps or rock piles. Wiper (Hybrid Striped Bass) - Fair: Look for surface activity towards sunset; try plastics or topwater baits. Walleye - Fair: A lot of small fish are being caught with bigger ones mixed in. Troll crankbaits and live bait rigs in 7-13 feet of water. Largemouth Bass - Fair: Target shallow cover for post-spawn fish. Channel Catfish - Fair: Typical baits are working. Fish will start to move to shallow rock to spawn.

Otter Creek Lake

Docks are in; the bathroom at the ramp is open. The fish cleaning station is open. Bluegill - Good. Yellow Bass - Good.

Pleasant Creek Lake

Walleye - Slow: Use crawlers or plastics fished towards evening. Bluegill - Fair: Some fish are being seen moving shallower. Try small worms or jigs in warmer water areas. Black Crappie - Slow: Some fish are being caught on jigs or minnows in the brush or suspended in the mouths of bays. Keep moving until you find the right area. Fish up to 12 inches are reported. Wiper (Hybrid Striped Bass) - Slow: Target windblown areas. Channel Catfish - Fair: Try chicken livers and stinkbait.




ers on their door knobs and by the time I got back I already had a couple phone calls from people who wanted to know what was going on," Sproul said.

The department hadn't done a sweep in about two years, and Wray said the results were similar this year.

"Six of them had active warrants, and of those we believe two of them were not in the area and have moved away," he said.

"We made one arrest yesterday of one registered sex offenders. We are actively investigation the whereabouts of the remaining three and we do believe they are still in the area. We'll have them picked up in the very near future."

He said violations can include a wide variety of

events and the sweep typically involves a questionnaire and everyone is asked the same questions.

"I always tell them we're not singling anyone out here, and everyone is asked the same questions. Obviously some follow ups are needed," Wray said.

"But we're just confirming if they are home or not, if someone is there who knows them and where they are; if children are in the home, and identifiers on social media accounts or email addresses that aren't listed with Dep. Sproul."

Sproul said the registry is three-tiered with third tier requiring the most attention. He said those individuals have to report in quarterly. Tier-two offenders must report twice a year and tier-one was check in yearly with Sproul.

The sweep included assistance from the Keokuk and Fort Madison police departments, West Point/

Donnellson police departments and Montrose Police Departments, the Lee County G.H.O.S.T. strike force and the state DCI. Two years ago the U.S. Marshals office was involved.

The sweep was funded through a G.H.O.S.T. grant and included no overtime expenses," Wray said.

Sproul said one investigation turned up information on an offender who was out on a pre-trial release, who committed another violation while he was on the release.

"Our main goal is to look for liars. Who's telling us where they're living and if it's true or not," Sproul said.

He said doing the sweep once a year is important but two times a year would send a message that Lee County is keeping very close track of where they are and what they are doing.

DHS launches mandatory reporter portal

DES MOINES - The Iowa Department of Human Services (DHS) is launching a new Mandatory Reporter training platform via their website later this month.

"Our current platform has seen technical difficulties, making it challenging for those who need to complete this essential training. We are listening and recognize that this has been frustrating. We anticipate the new platform will resolve these issues, ensuring timely execution of the training process," said Adult, Children and Family Services Division Administrator Janee Harvey.

It is important to note that as this update occurs, the Child Abuse Mandatory Reporter Training and Dependent Adult Abuse Mandatory Reporter Train-

ing will not be available from June 19, 2020, until June 29, 2020. Newly hired mandatory reporters have six months from their hire date to complete the training and become certified. Those who need to complete training(s), must do so prior to June 19, 2020. Training information can be accessed here.

Current mandatory reporter certificates and training histories will be transferred to the new platform. Nonetheless, DHS encourages current users to save a copy of their certificates. This can be done by accessing their account online and printing or saving certificate as a PDF before June 19, 2020.

DHS anticipates the new mandatory reporter portal will be available to the public again on June 29, 2020.




