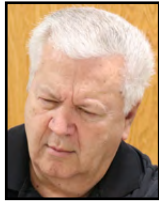
## Fedler holds, Reichman wins

**GREENFIELD TO FACE ERNST:** Lee County GOP favors Schilling over Miller-Meeks

LEE COUNTY – Jeff Reichman got his first political victory of his career Tuesday night, while Supervisor Ron Fedler seems to have held onto his seat as a county supervisor for four more years.

Reichman rolled over Nancy Amos of Mt. Pleasant with 73% of the vote 3,283-1,170 for the Republican nomination for the state's 42nd District Senate seat. Reichman now will face incumbent Democrat Rich Taylor, also of Mt. Pleasant, in the general election Tuesday, Nov. 3, 2020.

Reichman said despite the lopsided win he was hovered over results most of the night Tuesday.

"It was decisive, but I will say we were cautiously optimistic going into Tuesday," he said.

"I knew I would carry Lee County and would have that backing, but I really didn't know for sure about Henry

## City to move on marina repairs

FORT MADISON – The Fort Madison riverfront marina and docks will get some needed repairs, but it will take three years to get done.

At Tuesday's regular meeting of the Fort Madison City Council, which for the first time had all council members in regular attendance since the coronavirus pandemic hit, the council voted 7-0 to move forward with repairs.

City Public Works Director Mark Boussetot gave a presentation to the council about the needed repairs compared to the budgeted revenue and expenses associated with the marina and docks.

The Federal Emergency Management Agency is putting up 85% of the costs of repairs, but the city still will be saddled with about \$87,000 worth of costs.

Repairs include roadway repairs to the retaining walls in the dock area, dredging the marina, and removing debris. Most of the repairs are associated with flooding and therefore trigger FEMA assistance.

Despite eventually voting to move forward with the repairs but space them out over "several" years, most of the council wanted to see a more comprehensive plan to take advantage of the marina.

"We have a beautiful downtown and it's a shame not to see us have a marina," said Councilwoman Rebecca Bowker.

Councilman Rusty Andrews said he agreed with Bowker and the city needs to get aggressive about getting the marina up and flourishing.

"I wanna see more conversation about

## HTC puts 1st varsity team on field in 8 years

WEST POINT – It's been close to eight years, but HTC's blue and silver uniforms will be back on the varsity softball field this summer.

Not only is 1st year head coach Loren Menke dealing with the extra hurdles of the coronavirus, but putting together a varsity squad for the first time since 2012, has had just a few challenges.

Menke led the Crusaders to a 10-5 record last year playing a junior varsity/junior high school schedule. He said going into this year hasn't been too much different other than working more with the Iowa High School Girls' Athletic Union and navigating the coronavirus.

"I took all the girls temperatures here. I guess you don't have to and I asked them to

do it before they came, but I have a thermometer here so we get double coverage. The last thing we want is for anyone to get sick or spread it around, or even shut it

## City firefighters handle two Tuesday night fires

FORT MADISON – Fort Madison Fire Chief Joey Herren barely got in the door after Tuesday Fort Madison City Council meeting before being called to

not one, but two fires at about 9 p.m. The first fire broke out after what Herren called a "hot load" was dumped at the Great River Regional Waste Authority landfill on the city's northeast side.

"That would be what we call a hot

load coming in from one of the trash trucks. They get those every once in a while. It's pretty rare, but that's what happened," Herren told Pen City Current Wednesday morning.

# Four win NPR podcast award out of English project

FORT MADISON – A senior English project turned into something a bit more for four Fort Madison High School students.

Sara Ljungkull's English 4 second trimester class was charged with creating a podcast as their final project, and one of those projects was submitted and selected by National Public Radio as one of the top high school podcasts in the country.

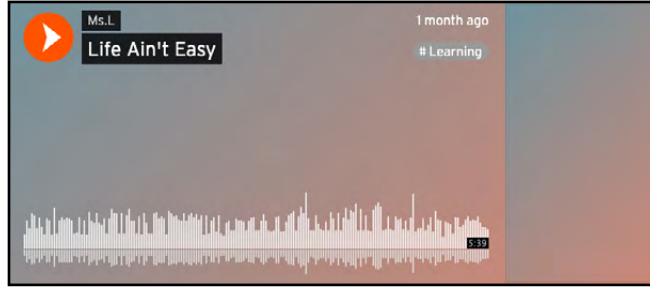
National Public Radio received more than 2,300

podcast submissions from more than 10,000 students representing all 48 states and Washington D.C.

The submission that was sent to NPR from Fort Madison was created by seniors Chris Kistner, Chris McMillan, Jarrett Settles and Ethan Wilkins and focused on two of the students' experiences with mental illness in their homes.

Settles interviewed Kistner and McMillan for the piece while Wilkins did the technical producing and polishing.

Their project was selected for an honorable



mention by the NPR selection committee.

Ljungkull said she had a list of categories for the students to pick from, but this group came up with a topic of their own based on their personal experiences.

"When I heard their stories it was just heart-wrenching. I've done some producing

and written plays so I kind of new what NPR would be looking for and one of those things was would they be moved by it," Ljungkull said.

"We shared it with the other students and everyone was just blown away by what these boys had to experience."

Kistner said talking about how mental health issues has impacted his family has gotten easier. He said now it isn't an issue of who he's talking to, he just hopes his conversations help other people.

"If it was like a couple years ago when it first

happened it would have been difficult, but over the years, I've come to face it and let it out and hopefully if I can help people with what I went through," Kistner said.

"But it's still awfully hard to get out."

Kistner had a brother who was diagnosed with bipolar disease and his family has had to navigate that path over the past several years. The link to the winning podcast is embedded and active below.

Kistner said he was surprised that Ljungkull wanted to submit their project.

"Honestly, yeah. We were just doing it as a project and she really liked it," he said. "Then she said all the other classes listened to it and

they liked it, so she said she was going to put it in the competition. When she showed us we were picked, I couldn't believe it."

Ljungkull said she had an idea the boys' effort has a chance of winning.

"I was so pleased and so proud," she said. "One of the ways to teach now is project-based learning. That is when you actually let the students teach themselves, and they truly excelled. It's just wonderful tool for these kids."

Settles said the best part of the whole project was learning about the other students' personal stories.

The podcast has a chance of being played on NPR broadcasts, but only a handful of the students programs will be played, with the top award winners in each category getting air time.

## City wants bigger plans for marina with repair spend

how we promote it. How do we make this a lot easier," Councilman Rusty Andrews said.

Mayor Matt Mohrfeld said making the improvements makes sense only if the city plans to keep moving toward a sustainable project down the road. He also said they may need professional assistance in creating a sustainable path forward.

"We can all be blessed with good intention and good vision, but we have to translate that into some form of reality. I'm going to suggest if we do this, we bring in professional help," said Mayor Matt Mohrfeld.

Councilman Chad Cangas said that has to be the direction the city goes, but if they can't make a go of it, they have to be prepared to wash their hands of it.

"I don't think anybody here disagrees, if there is a way forward for the marina, that's our goal. That's the direction we're looking at. But we have to at least discuss the fact that we may have to wash our hands of it if we can't make it go. But I think everyone here has their eyes on the prize," Cangas said.

Mohrfeld said prior discussions on marina plans included seven figure city investments with business plans that were in the region of \$5 million.

Councilwoman Rebecca Bowker said the city needs to put effort back into marketing the property to investors and not rely on past failures to undermine future success.

"Just because something didn't work then doesn't mean it can't work in the future. With the right contacts, the right energy, and the right positive thinking, I would think we could overcome some of these objections we've heard in the past," she said.

City Manager David Varley said he's had interest from outside parties, but all those inquiries fell flat and he doesn't know what else the city can offer interested parties.

Mohrfeld said he was going to keep putting the issue on the agenda until a plan is hashed out.

Councilwoman Rebecca Bowker said a small committee with forward-thinking ideas should usher in options for the city to consider.

In other action, the council:

- voted 6-0, to approve a resolution in support of a workforce housing tax credit application from Green Oak Development to begin building homes in Fort Madison.

- voted 7-0 to approve a resolution to waive subdivision requirements for property in the 2700 block of 220th Street within the city's two mile territorial jurisdiction.

- voted 7-0 to approve a joint agreement for the creation of a Southeast Iowa Safety Group. The agreement is a three-year commitment.

# Bad radio signal made fire command more difficult

"Sometimes it might a chemical, or something was smoldering when they dumped the load."

He said landfill officials had found a similar spot earlier in the day, but were able to bury it and cut the area off, but they think this fire was from one of the last loads of the day.

Mutual aid was brought in from Denmark and Wever fire and rescue units to help tank water up to the site.

About three minutes after the page for the landfill fire, firefighters were paged to possible structure fire on Old Denmark Hill. That fire turned out to be from a candle that was left burning that smoldered and caught fire.

However that fire was contained to one room. Firefighters broke in a window on the building's north side and quickly extinguished the fire. Herren said there was minimal fire and smoke damage.

With the two fires being battled with separate command structures, Herren said communication was critical, but radio signals were shoddy and impeded the process. "We were talking about it this morning again, and I joked we should have just thrown the radios into the fire. That's how bad it was. They were no good," Herren said.

Scanner chatter indicated firefighters from all three departments were having trouble communicating from the top of the landfill pile where the fire was located to the base near the entry way.

"That's a single path up there and I've got command and running tankers up and down and they couldn't hear me from the top of that pile to the base of the hill," Herren said.

But he said aside from the radios, he was very happy with how the department handled the two fires simultaneously.

"Everything else went like clockwork. I was very happy with how we handled both of those at the same time."

Herren is part of a committee that is researching and advocating for a transition to a digital radio system in Lee County. The system carries a \$7 million price tag and would be paid for with an assessment through the county's Emergency Management Services levy allowance. That would be a tax assessed to all county property owners commercial and private.

Two weekends ago, the Lee County Sheriff's Department was part of two separate searches for residents in the county near the southern part of the county on the Des Moines River.

Sheriff Stacy Weber said he encountered multiple issues with the communications, not only internally to his deputies, but to other departments as well.

Those searches turned up the body of Jacob Pezley of Argyle and another man who was found without incident after walking to his parent's house. He had run his boat aground after falling asleep and then walked back to the home.

down. So we're trying to be cautious."

The Crusaders will lean on Mary Hellige at the mound most of the year. Girls softball rules don't limit pitching like boys rules due to the different throwing motion.

"Mary will be our No. 1 pitcher and will pitch the bulk of our season. We'll play a JV schedule, too and we have three others besides Mary that will fill in the jayvee games. They'll get some varsity time to give her a breather," Menke said. "In softball you can pitch as much as you want."

He said Hellige will also be counted on at the plate along with freshman Brooke Mueller and Kayla Box.

"Brooke was one our best hitters the past couple of years and she's just a freshman. Kayla is a really good hitter as a freshman as well, and so is Mary."

The Crusaders will certainly be one of the youngest teams as they jump back into Southeast Iowa Superconference varsity action this summer. Menke said aside from two juniors who've stepped in this year, the team will have four sophomores and seven freshman.

Raquel Schneider is one of the sophomores returning after a year away from the

game. Menke said he will be relying on her at the plate as well as Kelli Meierotto and Anna Sobczak, also sophomores this year.

"We're really young and expectation-wise my goals are to have fun and maintain a good level so we can keep doing this," he said. "We want to be as competitive as possible, but there's some really good teams around so we really don't know what to expect. I realize last year we weren't always playing the best players at other schools. So I don't really have any expectations."

HTC starts the 12-game, pandemic-shortened season on June 15 with a trip to Eldon to face Cardinal. Then the Crusaders have their first home varsity contest on Tuesday, June 16 against Central Lee. Each night is junior varsity followed by varsity with most games starting at 5:30 p.m.

Menke said getting the varsity program rolling has been quite a few years in the making, but he said numbers are still soft at the junior high levels and he wasn't able to recruit enough players to field a junior high squad.

"But we have a lot of girls playing town ball so I'm really hoping we can sustain the program," he said.

He said he expects West Burlington-Notre Dame to be at the top of the confer-

ence this year, but after that he said the conference could be wide open.

"Just from what I saw last year after junior varsity game or what I've read in the paper, West Burlington Notre Dame should be the top team in the conference, but after that everything looks pretty even," Menke said.

"I don't know what to hope for...I could can tell you what I hope for, but I really don't know."

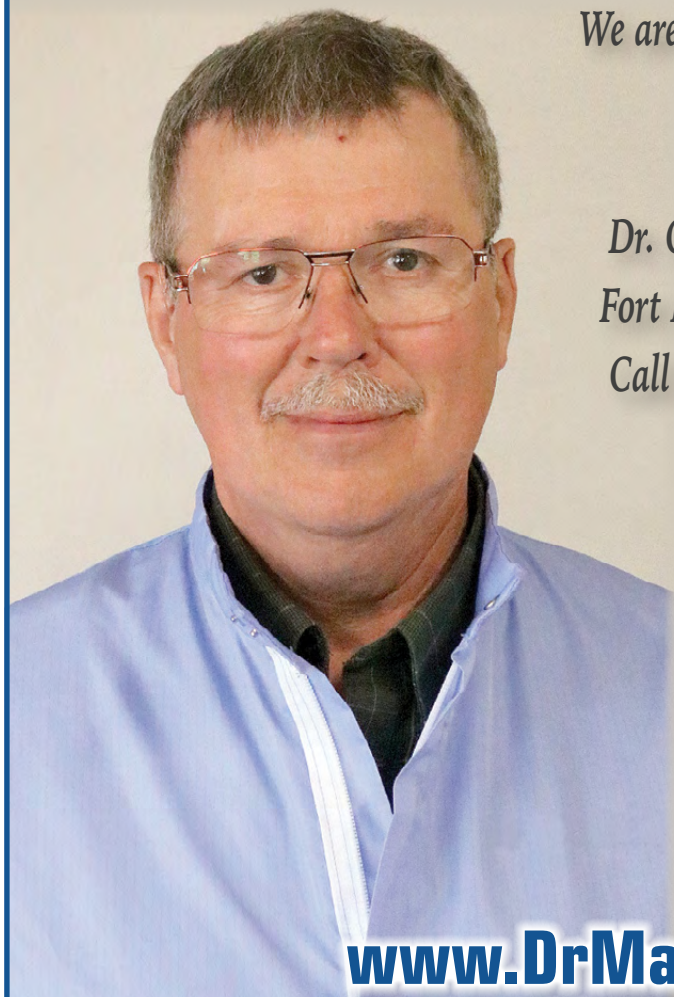

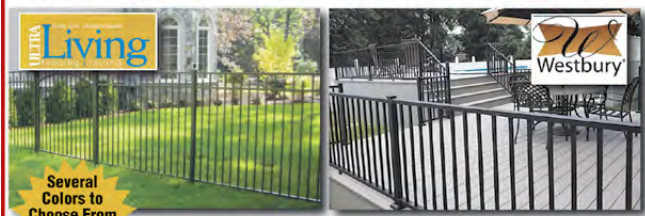

# Greenfield to take on Ernst in November

County.”

Reichman took 66% of the vote in Henry County. He won 72% in Jefferson County, 84% in Lee County, and 69% in Washington County.

In 2018, the Marine veteran lost a fairly close election to Fort Madison’s Jeff Kurtz for Dist. 83 State Representative 54% to 46%.

Reichman said this part of the state has been suffering through shrinking population and job markets and his message got through to Republican voters.

“We’ve all been through this for the last 30 years – declining population, declining job markets and the challenges that presents,” he said.

“The lack of opportunities, kids graduating and leaving and not coming back. instead of staying here and having children and grandchildren.”

He said he didn’t think the recent volatility in this country had anything to do with Tuesday’s numbers, but he said they will have an impact in the general.

He said the match-up with Taylor will go down party lines.

“He has a 100% Right to Life rating and only a 75% business rating. We’re going to be 100% pro-life and 100% pro-business,” he said. “Again, it comes back to the economy and what happened under a Democratic held county, against what could have happened with Republican control.”

Taylor is an Assistant Democratic Leader and ranking member on the Veterans Affairs Committee. He also serves on the Agriculture, Judiciary and Labor & Business Relations committees, as well as the Administration & Regulation Budget.

Ron Fedler also won with a large majority of support. Fedler took 416 of 610 total votes cast for the District 1 Supervisor seat. His opponent, Tony Keefe had 192 votes in his first run for county supervisor.

Fedler said he was pleased with the turnout despite all that is going on in the state and county currently.

“I was very pleased with what is usually a smaller

turnout during primaries. That was a larger turnout,” he said.

“I was concerned that it would be a lot closer than it was. I’m very pleased with the amount of votes I received, and I felt the district gave me a strong vote of confidence.”

Fedler is now set up for his 3rd term on the Lee County Board of Supervisors.

Fedler said he wasn’t surprised by any of the results from Tuesday’s election other than the number of voters both by absentee and at the polls.

Lee County Democrats voted overwhelmingly for Theresa Greenfield to go up against Republican U.S. Sen Joni Ernst in November. Greenfield took 52% of the votes of Democrats in Lee County and won the state primary with almost 48%. Retired United States Navy Vice Admiral Michael Franken was closest with 19% in Lee County and 25% across the state.

Fedler’s seat and the nomination for U.S. Senate were the only contested democratic races in the county.

On the Republican side, Illinois transplant Bobby Schilling won the Lee County Republicans’ support for the Iowa’s 2nd Congressional district U.S. Representative seat defeating Mariannette Miller-Meeks 811-739. However Miller-Meeks won the the state count 48% to 36% over Schilling and will face off against Wheatland farmer Rita Hart for the seat in the general election. Rep. Dave Loeb sack is retiring at the end of his term.

One of the biggest surprises of the night was the unseating of 17-year incumbent Steve King in Iowa’s 4th District in northwest Iowa. King was leading current State Sen. Randy Feenstra (IA-2nd) deep into polling, but Feenstra rallied from a 500-vote deficit to win the nomination with 46% of the district vote, compared to King’s 40%.”

It was King’s first loss in his 24-year-political career.
