FRIENDS OF THE FORT: North Lee County Historical Society helping with fundraising

FORT MADISON – The flooding of 2019 took a toll on the Old Fort as far as numbers, but the added American Cruise Lines traffic helped offset some of the loss.

Dr. Eugene Watkins, Site Manager of the Old Fort said a fundraising effort is currently underway through Friends of the Old Fort, which operates under the North Lee County Historical Society's 501c3 arm.

Watkins said funds are needed to help replace some of the interpretive items at the fort.

“At this point, the main part of the fundraising is to replace those things that are wearing out,” Watkins said

Wednesday afternoon.

“The fort is close to 30 years old and a lot of the equipment and clothing is just getting old and is need of replacement.”

Other items that will have to be replaced in the near future include firearms and trade goods that add to the factory display at the fort.

The historical society has set an immediate fundraising goal of \$10,000.

“Of course, we’d take more than that and can certainly use more than that, but at this point we’re trying to raise enough money for replacement of things wearing out,

No injuries sustained in Friday Avenue L crash

FORT MADISON – No injuries were sustained when a red Jeep plowed through a garage on the newly constructed S Curve in the 3500 block of Avenue L Friday afternoon.

According to Fort Madison Fire Chief Joey Herren, a woman, who's name was not available at press time, admitted to distracted driving

and failed to negotiate the turn and crashed into a garage on the south side of Avenue L, taking out the northwest corner of the garage and coming to rest half in and half out of the garage.

Rescue personnel were on hand to stabilize the building before removing the vehicle.

Herren said the garage suffered roughly \$10,000 damage and the Jeep is likely totaled.

Carbon monoxide may have killed Denmark woman

DENMARK - Area

law enforcement suspect carbon monoxide poisoning may have caused the death of a Denmark woman and sent her husband to the hospital early Thursday morning.

Denmark Fire & Rescue personnel along with Lee County EMS and the Lee County Sheriff's Dept. were called to the 1400 block of 295th Avenue just north of Hwy. 16 on the west side of Denmark where two adults were found in a home.

Rescue crews pulled the victims from the building at around 7:45 a.m. and began ventilat-

ing the home.

Joan Lee Stevenson Pumphrey Walker, 87, of Denmark died as a result of the incident. Her husband Randall Walker was taken to an area hospital. No condition report on him was available.

Lee County Sheriff Stacy Weber said findings won't be confirmed until toxicology reports are returned.

"Our office suspects this is possibly carbon monoxide poisoning and our thoughts and prayers are with the family," Weber said Friday.

HOLY TRINITY SPORTS Jason Thurman's 3 at buzzer in double OT sends game to third extension

HTC survives triple overtime to win at CL

DONNELSON – Holy Trinity Catholic's boys basketball team has seen its share of tight game disappointments this year.

The Crusaders (4-6) lost the season-opener to Danville in overtime – lost to Notre Dame by one point with the ball at the end – and lost by two to Cardinal in overtime earlier this week. Those go the other way and the Crusaders are over .500.

But a Friday night early start at Central Lee may have been what the Crusaders needed to get back on track.

Shooting 17 of 20 from the free throw line from the fourth quarter on... and a buzzer beater 3-ball at the end of double overtime to force a third extra period, didn't hurt as the Crusaders escaped with a 78-72 triple overtime win.

"Super proud of the guys more than anything. What I told them in the locker room that what I was most impressed with was the bench engagement," Hellige said.

"Our bench was totally in the game. Even the kids not in the game were in the game. Just a huge team win for us."

The proverbial pendulum swung a wide arc Friday with both teams holding leads as high as seven points.

The Crusaders ran out to a quick 8-0 lead, but Central Lee came firing back with some three pointers to take a 19-16 lead in the second quarter when Evan Pohren converted for the Hawks.

Central Lee would stretch the lead to 31-24 on a bucket by senior TJ Stutes, but HTC's Vasin Thurman and Chandler Rung would score five unanswered in the final 41 seconds to make to 29-31 at the half.

HTC would take the lead in the early going of the third period when senior Matt Hellige rebounded a missed Vasin Thurman shot inside and put it back for a 35-34 Crusaders advantage. Central Lee would go on an 8-3 run as HTC went 1-for-



7 from the field the rest of the quarter and trailed 42-38 at the end of three.

With 5:05 left in regulation Rung hit a 3 from the left wing and then was fouled on the next trip down from 3-point range.

The senior calmly sank all three with the Central Lee student section giving him the business to give the Crusaders a 47-43 lead with just over four minutes left in the 4th.

Central Lee would cut the

lead to one when Bronson Sargent was fouled on a bucket and completed the 3-point play. Hellige would score on HTC's next possession for a 51-48 lead with 1:53 left. But Stutes would hit another of the 20 combined 3-pointers on the night in the next possession to knot the game at 51.

Neither team would score again in the final period. The Crusaders' Quentin Schneider missed the front end of a bonus with :09 left. Central Lee got the rebound and called time out. Out of the break, Sargeant took the inbound pass with loose HTC pressure and fired up a 3-pointer that went off right at the buzzer.

The first OT session was controlled by the Hawks. HTC had one lead at 54-52 on a Blake Crabtree 3-ball, but Logan Kramer, who hadn't played since the season-opener countered with a 3-pointer at the other end.

With less than a minute left in OT, HTC trailed 58-59 after a Vasin Thurman bucket. HTC fouled Derek Denning, but the senior missed the back-end of the bonus for a 60-58 lead before Vasin Thurman scored inside with :15 left to knot it at 60. Central Lee worked the perimeter a little long and had to force up a shot that went wide right.

HTC trailed again through most of the second OT session but another three pointer from Rung cut the lead to 67-66 with about 10 seconds left. The Crusaders again fouled Denning on the inbound to stop the clock and the

Hawk hit both free throws for a 69-66 lead.

Central Lee called time out to set up the defense and came out in a 2-2-1 zone press and tried to trap Crabtree on the inbounds. The senior slipped through the trap and found a wide open Jason Thurman hanging out in the right corner. With 3 ticks left, Thurman's shot hit the back of the iron, bounced straight up, the buzzer sounded and the ball dropped through to force a 3rd OT.

"That last play we just wanted to get guys spaced out, and their press kind of got some of their guys away from the arc," Hellige said.

Thurman said the plan was to try and get the Hawks to move forward on the ball and free up some space behind.

"We wanted Quentin bringing the ball up the court and engage them and I just sat in the corner and they left me there," Thurman said.

"I knew when I saw it go up in the air off the rim I knew it was going in."

Hellige said Thurman was hot in practice during the week and was fine with him having the ball in that situation.

HTC wouldn't score a bucket in the third period, but would go 9-of-10 from the free throw line and would hold Central Lee also to just free throws. With the ball game in the balance the Hawks went 3-of-7 from the line while HTC converted 9-10.

Jason Thurman would connect on four straight free throws in the final seconds to put the game out of reach 78-72.

"We were a little flat over Christmas, but they've really picked up the intensity in practice. We felt like we should've got the win Tuesday and that slipped away from us so this is a nice win," Hellige said.

Vasin Thurman led the Crusaders with 22 points on the night. Rung had 16 and Hellige and Crabtree each had 14 points. Jason Thurman finished with eight points and Schneider had four.

For Central Lee (1-8), Stutes, Sargent and Kramer each had 16, Denning scored 13, Dylan Stuecker had nine and Pohren finished with two.

The Fort Madison City Council met in regular session at 5:30 P.M. on Tuesday, January 7, 2020, at City Hall, 811 Avenue E. Mayor Mohrfeld presided with Council Members Bowker, Morawitz, Rink, Andrews, Miller and Lair present. Council Member Cangas was absent.

On motion, Council approved the agenda. On motion, Council approved the Mayor's signature on a Professional Services Agreement with HR Green for design and construction segments of three segments of the PORT Rodeo Park (FMCH) Connector Trail.

Mohrfeld appointed Council members as liaisons to boards and commission and Rink as Mayor Pro Tem for 2020. He announced the creation of several new assignments for Council members, including Miller as the City's "Property Activist", Rink for all health and wellness matters, Bowker as the "Sustainability Coach", Andrews as the Events and Activities' liaison and Morawitz to work with the Neighborhood Watches.

At 6:54 P.M., the meeting adjourned until January 21, 2020, at 5:30 P.M.

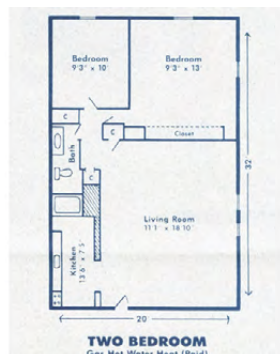
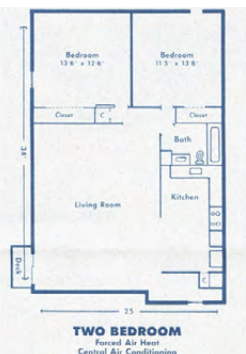

Cruise line passengers help offset flood losses

but we will also need to start looking at getting materials for additional repairs.” Watkins said the flooding kept numbers down in the early part of the season, but the cruise lines helped the fort rebound as far as attendance. He hopes that future years and the possibility of adding Viking Cruise Lines docking either in Fort Madison or nearby could result in more passengers being bused to the Fort.

“The boats have been an extremely positive addition,” Watkins said.

“The more of those we see, the better off we’ll be doing. I don’t know that we’re in dire straits or anything right now but we’re moving along as the facility has always done.”

He said the Old Fort was never planned to be a money maker, but to help bring people into the city to spend money in other places as well.

“We’re lucky to break even year after year. The real value is the money that is being spent all over town when these people come in,” he said.

“The flood last year really messed things up for us in general for the year. We didn’t even get opened until late July and then we had lots of repairs to do.”

Some of those repairs include fixing a wall that has fallen down. Watkins said the facility has the timbers to replace the walls, but they are in need of someone with equipment to come down and lift the wall so the timbers can be replaced.

“We don’t have that equipment. We have the materials but we’re hoping someone would donate some time and machinery to help us get that repaired as well.”

The Old Fort typically has attendance ranging from 4,000 to 5,000 during a three month season in the summer and fall. He said if cruise line traffic continues and improves it could double those figures.

The North Lee County Historical Society launched the fundraising drive in December. A release from the society said funds allocated from the city have been exhausted. The society announced the fundraiser on Facebook indicated \$10,000 was needed and has had some response from inside and outside the city, but additional funds are still needed.

“As Fort Madison business, industry and individuals have donated thousands of dollars to the PORT trails, Central Park bandstand and other causes the Society feels we need to support Fort Madison’s Number 1 tourist attraction in the same spirit,” the release indicated.

“We need the funds now as the uniforms must be special made from suppliers and may not be purchased at retailers but ordering now may insure delivery by tourist season.”

thought she’d try something. She bought Larry a metal detector for his birthday.

Larry was excited. He read the directions, put the machine together, and went to the local park. His very first day of “detecting,” he found a Lincoln penny and a class ring. He was hooked.

Over the years, he’s found over \$3,900 in coins—he meticulously keeps track of everything, recording his findings in a ledger—including an 1887-S American five dollar gold coin, eight gold rings, many sterling silver rings, and several 14K gold class rings. Like a sleuth, he tracks down the owners of the class rings and returns them, if he can, giving him a satisfied feeling. The five dollar gold piece he had set in gold, put on a gold chain, and gave to his wife for her birthday. After all, she was the one who got him started on “detecting.”

To his wife’s satisfaction, Larry no longer carries a coat hanger in the trunk of his car.

Some days, he goes out in the morning, “detects” for a couple of hours, goes home for lunch, then returns in the afternoon. No one gives him grief for “detecting” because there may be one or two other people out there in the park or beach doing the same thing. Under backyard clothes lines, or where clothes lines used to be, are the hot spots. Larry always gets permission before he goes onto someone’s property. They may want a slice of the action.

For the hours spent, and the value accumulated, Larry knows he isn’t even earning minimum wage, but he doesn’t care. It’s free money.

One man asked him if his machine could detect dollar bills. “Only if it’s a silver certificate,” he told the man.
