NLCHS wants chimney facelift

CREWS OUT: Mayor would like long-term plan for 1908 Fort monument

FORT MADISON – A move to transfer ownership of the city's chimney monument at the site of the original Fort Madison has been put to the side as one group works to restore the monument.

Fort Madison Mayor Matt Mohrfeld originally had scheduled discussion on transferring ownership of the monument to the North Lee County Historical Society, but NLCHS representative Andy Andrews said that's not what the group is looking for.

Andrews told Mohrfeld at Tuesday's City Council meeting held via teleconference, that he was only looking for authorization to submit a grant proposal for \$20,000 to repair the monument.

Two years ago, city officials were unsure if the city even owned the monument, but since that time documentation has been uncovered that shows the historical piece had been deeded to the city.

Morhfeld told Andrews that the email he received from the historical society indicated a wish to take ownership of the monument and eventually move it to the Battlefield Park being built just to the east of

Dollar General on the city's east side.

"Right now we aren't asking to move it, just asking the council to approve a resolution to authorize us to get the \$20,000 then we can proceed with repairs," Andrews said via phone.

"We're not asking for ownership. If we want to move the property, then we'll come back to the council again."

Andrews said the grant has to be ap-

plied for by May 15th. He said the NLCHS has bids to repair the 1908 monument for about \$14,000. Workers would remove the chimney from it's pedestal, relocate it to the parking lot across the highway and do the repairs there, then reassemble the monument.

Councilman Bob Morawitz said he didn't

AMBULANCE SERVICE Councilor wants details on proposal

FORT MADISON – As city officials continue to work to put together a proposal to offer city and county ambulance services, a Fort Madison city councilwoman wants to see the proposal.

Fort Madison Fire Chief and Mayor Matt Mohrfeld have been involved in countywide committee discussions focused on shoring up an ambulance service for the county. The move comes on the heels of current provider Lee County EMS Ambulance, Inc., financial



struggles that have the service operating week to week as it struggles to meet payroll.

Just over a month ago, Lee County Supervisors authorized a \$36,000 pay-

ment to the Lee County Ambulance to help cover that weeks payroll on March 20. Supervisors have not had to make another payment for the past four weeks.

However, Lee County Ambulance's investors, headed by Richard Young, have not signed a new contract that would start July 1. In lieu of that contract, the Lee County Ambulance has submitted a new proposal, which would, in all likelihood, ask for supplemental funding from the county in excess of the current \$500,000 that is budgeted for 2020-21.

Supervisor Gary Folluo said his conversations with the company have indicated amounts of \$750,000 to \$1 million may be needed to offset very low Medicaid/Medicare reimbursement rates that have crippled the service. At Tuesday's regular Fort Madison City Council meeting, Councilwoman Rebecca Bowker asked if the city council was going to be able to any proposal from the city before it goes to the county.

HIGHWAY 61 PROJECT

City may wait until August to bid one-way project

FORT MADISON – City officials got a fresh look and timeline Tuesday for reconstruction of what are called the city's "one-way pairs" on Bus. 61 in Fort Madison. At Tuesday night's regular City Council meeting held via teleconference, Tim Cutsforth, a project manager for HR Green of Cedar Rapids, updated the council on how 2016 plans for the work have changed. Cutsforth said his firm was hoping to put the project out for bid in May, but with the virus and changing face of state and federal stimulus packages, the city



That fund, and the interest generated by it, are earmarked for the reconstruction project.

Phase 1 is currently underway with the reconstruction of the highway from 2nd Street to 6th Street.

Cutsforth said additional modifications to the plan also make a later bidding possibly a better option for the city. "We expanded the project by adding some water main. The original plan original plan wasn't to replace it, but city decided it was the right time to do that so we added that in," he said.

might see an advantage to waiting until the August bid letting period to put the work out.

The project is part of the Avenue H and Avenue L reconstruction that is being paid for with proceeds from a \$13.9 million payment given to the city by the state after the bypass was completed.

"Then the virus hit and slowed our production a little bit. I think it would be

to be in by 5 p.m. April 30. Herren said he's meeting with Keokuk city officials Thursday to iron out some final details before sending a proposal to the county board.

Bowker said that takes any investigation by the Fort Madison City Council off the table.

"Will we be able to see that proposal before it goes to the Board of Supervisors or will when will we get to see it," Bowker asked at the meeting.

Mohrfeld said the city will be making a preliminary report to the county and then the city council would have a chance to weigh in on the proposal.

"The problem is that it ends up being a cart and horse thing," Mohrfeld said. "It's been a whirlwind thing and I can't compliment Joey and his team enough, especially when you're working shoulder to shoulder with a sister city."

Bowker pressed the issue.

"At that point we don't have any wiggle room," she said.

Mohrfeld asked Bowker what she meant by that and Bowker said if the details are approved by the board, then basically the city is "rubber stamping" the plan and wouldn't have any say what's in it.

"I'm assuming we're getting money from the county for that new venture, but what does that look like?" she asked.

Mohrfeld said transparency to the council and the city is part of the process and the council would have the authority to decline the proposal.

In addition to the Lee County Ambulance proposal, the county also has a proposal from Global Medical Response, the parent company of the local AirEvac service with a base behind Fort Madison Community Hospital.

Other providers are also welcomed by the county to submit proposals for Lee County service before the April 30 deadline.

State DOC now has 10 positive for coronavirus

CORALVILLE- Yesterday, the department, in cooperation with the Iowa Dept. of Public Health, began implementing expanded investigatory testing at the Iowa Medical and Classification Center (IMCC) in Coralville, IA. The testing is initially focused on the inmates who came from county jails in the special intake quarantine unit at IMCC, where the first positive inmate case was located.

So far, there have been 69 new tests completed on the inmates in this unit in the last 24 hours, and 4 tests completed on staff that have worked in this area. Of those, 10 results for inmates have been found positive. 11 tests are still pending.

48 tests were negative. The department has also ordered an additional 150 tests that will be conducted on staff and inmates.

The department intends to continue expanding testing of inmates and staff that have worked in specific areas at IMCC, primarily those involved the intake process and quarantine units. Once these tests are completed, testing will expand to other areas of the facility. Inmates with positive test results will continue to be moved to medical isolation cells where staff use full PPE when required to have direct contact with these inmates.

The IMCC staff have moved quickly to expand mitigation efforts at the

prison. They have implemented a prison-wide restricted movement, and are currently conducting a deep-cleaning of the affected unit. Staff continue expanding their efforts to separate healthy inmates from those that have tested positive, while following procedures that mitigate the risk to themselves and inmates. This prison has also suspended all non-medical admissions and transfers at this time. At this time, the vast majority of inmates remain asymptomatic and they will continue to be medically isolated and monitored for any medical needs as they recover.

The department has been preparing for the eventuality of the introduction of COVID-19 since early March, and has been as transparent as possible with all of the increased efforts across all nine prisons. This information, including a link to the department's pandemic policy is available at <u>doc.iowa</u>. gov/department-corrections-steps.

The department plans to continue to expand testing at IMCC, and as the results of those tests are returned, the department will update relevant statistics at doc.iowa.gov/ <u>COVID19</u> each day.

Dept. Director Beth Skinner had the following comment on the situation: "The members of the IMCC team have and continue to do everything possible to mitigate the impacts of COVID-19. The expanded testing

Panel wants to put historic locomotive on register

think it was a responsible move to repair the monument without moving it to it's permanent location. He said the current location subjects the piece to vibrations from trains and vehicles.

City Manager David Varley said the current plans for the reconstruction of that section of Highway 61 include a pull-off area where cars can stop and view the chimney with the fort and Mississippi River in the background.

Mohrfeld said he'd like for the historical society and the local Daughters of the American Revolution, who originally owned the piece, to get together and formulate a long-term plan.

Councilman Rusty Andrews said the first priority is to preserve the monument. He said the top five feet has substantial cracking and over the years moisture has gotten in and frozen in the winter causing more damage.

"If an entity like the historical society or the DAR wants to get involved and preserve it, neither can apply for grants without the blessing of the city," he said.

"The city needs to embrace someone out there who wants to raise funds for it, because nobody has the money right now."

Mohrfeld said he heard from the DAR and they wanted to pull back from the project and take another look at what needs to be done.

The council did approve the NLCHS request to apply for grant funding by a 6-0 vote. Tyler Miller was absent from the meeting.

In an unrelated issue, Fort Madison's Historical Preservation Commission is asking the city for permission to put the #2319 Locomotive on the National Register of Historic Places. The locomotive currently sits in Riverview Park.

Morhfeld said the move equates to taking on the locomotive for life and maintaining it.

Commission President Chris Sorrentino said he's spoken with state officials on several occasions and he didn't see a downside to applying for the national register.

Councilman Mark Lair, who serves as a liaison to the commission, said recent bouts of flooding have done damage to the tiles the locomotive sits on, and the city may consider moving it to a better location. He suggested moving it west by the caboose closer to the museum on a little higher ground.

"It's not a matter of if, but when, we're going to spend money to replace the ties," Sorrentino said. "If further conversation takes place to move it closer to the caboose we'd entertain that, but we have not been able to find any downside for it being added to the register."

Having the locomotive on the national register could open up the commission and the city to grants to help maintain and market the locomotive.

Varley said he believes the move wouldn't put any additional strain on the city.

"There are no regulatory conditions that go with it. I concur with what Chris is saying. The application has to be done online, and that will take a little bit of work that has to go through State Historical Preservation Office and they have to decide if it's worthy. They have to give it their blessing and then it gets bumped up to the federal level for approval." In other action, the council:

• approved the first reading of an ordinance to rezone 2324 and 2332 Avenue J as a high business district. The move would require to more readings or a council-approved waiver of the second reading.

•approved a contract with Meller Excavating to resurface city parking lots at 8th Street and Avenue D, and 8th Street and Avenue F, with permeable pavers as part of a grant-funded storm water mitigation project.

Iowa News/Ag News USDA sees record contracts for crop risk coverage

WASHINGTON, April 21, 2020 – Producers signed a record 1.77 million contracts for the U.S. Department of Agriculture's Agriculture Risk Coverage (ARC) and Price Loss Coverage (PLC) programs for the 2019 crop year, which is more than 107 percent of the total contracts signed compared with a 5-year average. USDA also reminds producers that June 30 is the deadline to enroll in ARC and PLC for the 2020 crop year.

"Producers for several years have experienced low commodity prices, a volatile trade environment and catastrophic natural disasters," said Richard Fordyce, Administrator of USDA's Farm Service Agency (FSA). "Farmers looking to mitigate these risks recognize that ARC and PLC provide the financial protections they need to weather substantial drops in crop prices or revenues."

Producers interested in enrolling for 2020 should contact their FSA county office. Producers must enroll

by June 30 and make their one-time update to PLC payment yields by September 30.

FSA attributes the significant participation in the 2019 crop year ARC and PLC programs to increased producer interest in the programs under the 2018 Farm Bill and to an increase in eligible farms because of the selling and buying of farms and new opportunities for beginning farmers and military veterans with farms having 10 or fewer base acres. Enrollment for 2019 ended March 16

State closing in on 100 deaths from COVID-19 illness

DES MOINES - Today, the Iowa Department of Public Health (IDPH) has been notified of 107 additional positive cases for a total of 3,748 positive cases. There have been an additional 522 negative tests for a total of 24,496 negative tests to date, which includes testing reported by the State Hygienic Lab and other labs.

According to IDPH, an additional 7 deaths were also reported, 272 are currently hospitalized, and 1,428 Iowans have recovered. The state now has 90 deaths from the virus

New stimulus could help with some of project's costs

very optimistic to bid this is in May and if we did, as we found out earlier, the bids would be high."

Cutsforth then recommended pushing the bid back to August where the city may be able to take advantage of some additional stimulus that may come out as part of the nation's recovery from the coronavirus.

He said his company is hearing rumors that the next stimulus could focus on city and state governments and could including transportation projects and city-type work.

"What we're hearing is that bill could come out at the end of this month or beginning of next month. We don't know what that will look like, but it could be similar to (President Barack) Obama's plan back in 2008 looking for shovel-ready projects," he said.

"Provided that the easements could be acquired fairly quickly and depending on the dates and contingencies in that bill, it's something we should look at to see if we don't want to utilize that for this project."

The plans include changing all the oneways to two-way, three-lane traffic with a shared turning lane around the "square" that is defined by Avenues H and L from

18th Street to 20th Street. Right now 18th Street runs one-way north and 20th Street runs one-way south, carrying all Bus. 61 traffic through Fort Madison.

Originally the plans created in 2016 called for reducing the offset at the intersection of 20th and Avenue L for north and southbound traffic. However, Cutsforth indicated that acquiring property on the northeast corner was proving difficult so new plans don't reduce the offset as much.

The plan also calls for closing off 18th Street from Avenue L south to the alley. That intersection will also include a slight bend to the north on Avenue L on the east side of the intersection to allow it to "T" with the main roadway.

Original plans also included trees on both sides of the roadways, but current plans only have trees on the inside of the square, where an 8-foot recreation path is being planned as part of the city's recreational trails.

He said if the construction in those rights of way gets too tight, the trees can be omitted from the project.

Cutsforth said if bids are secured in August, preliminary work could begin on the project by Thanksgiving.
