Auge, Santiago on judicial list

DES MOINES - According to Judge Mary Ann Brown, the chairperson of the state's 8B judicial district nominating commission, six area candidates have submitted their name as candidates for a seat vacated by District Judge John Linn.

Linn submitted his letter of retirement, effective Dec. 14. The 8th Judicial District was granted approval to fill the vacancy and the application deadline closed at noon on Friday.

The candidates who've submitted their names for consideration include:

Kimberly A. Auge, a Fort Madison attorney; Amy K. Beavers, with the Des Moines County Attorney's office; Adam D. Parson, an attorney with the Louisa County Attorney's office; Wyatt Peterson, a Winfield attorney in the Henry County Attorney's office; Artemio Santiago, a Fort Madison attorney with the Lee County Attorney's office; and Heidi D. Van Winkle, a criminal defense attorney in Burlington.

Interviews will be conducted on Wednesday, at the Des Moines County Courthouse, 513 North Main Street, Burlington, Iowa. The interviews will be open for public observation and listening. The public shall not be allowed to ask questions or make comments. Applicant submissions and materials will be open to the public.

Prior to May 30, 2018, the public will be permitted to submit comments or recommendations regarding the qualifications of an applicant by email to <u>cathy.reck@</u> <u>iowacourts.gov</u>.

The Commission will submit the names of two nominees to Governor Reynolds, who will then appoint one within 30 days.

She was preceded by her parents, husband, E.J., brother, Wayman, sister, Debbie and a grandson, Jake Little.





Senior Maya Rashid pulled a hat trick in the 92-degree weather, for the Crusaders with three goals on three shots on goal and added an assist. Junior Taylor Boeding had two goals and Elle Rashid, Taylor Crabtree, Claire Pothitakis and Katie Scoville all added goals for HTC.

Sam Pothitakis has four saves on the night and head coach Mike Sheerin said the two goals were with Pothitakis the lone defender on the run.

"Maya Rashid dominated midfield play with Elyse Pothitakis whilst Malibu Mohrfeld did some dizzying dribbles from the back and through crowds of players. Emily (the Machine) Box made countless runs from the backline notching up three shots on goal five shots total," Sheerin said.

One display that Wilbur designed and is particularly proud of is a trellis with purple and white clematis. Wilbur had glass panels built and hung between the two different colored clematis so that they don't intermingle. He plans on having an icecream social in his backyard and inviting friends, neighbors and family. You won't want to miss it if you're invited.

Wilbur took Ginnie and me to the Riverside Restaurant in Ottumwa for supper because that is where Ginnie and I met. We also got engaged there. (I had written about it in my column.) On this occasion, Ginnie and I had all-you-can-eat walleye (it was Friday), while Wilbur had liver and onions—a delicacy he allows himself three-or-four times a year. He does all his own cooking, and watches what he eats religiously, allowing himself no sugar or salt. Liver and onions, although rich in vitamins and minerals, is loaded with saturated fat. The last time he bought sugar was twenty years ago to make syrup for his hummingbirds. Still able to do 100 situps, Wilbur's attention to diet has paid off.

The waitresses at the Riverside hover and fuss

over Wilbur like a celebrity, which he is. Wherever he goes, people know him. (He still drives.) Wilbur Swindler is perhaps the most positive person I have ever met. When he was in the hospital for twoand-a-half months with complications from shingles, he never got bored. "I'm a happy person," he chortles, and the waitresses and nearby diners nod their heads in agreement. And happiness is what Wilbur attributes to his longevity. "You get back what you put out. I can't remember in my whole life ever being despondent. If my doctor told me I had two weeks to live, I'd say, get out of the way, doc, I'm going dancing!" Wilbur is a war hero,

having been a paratrooper with the 11th Airborne Division during World War II. He completed 11 jumps and was about to partake in the invasion of Japan when, "Truman dropped the bomb." Wilbur is pleased that the surrender took place on the USS Missouri, because both he and Truman are from Missouri. "The discipline and respect I learned in the Army has followed me all my life," he states emphatically, a chunk of liver suspended on his fork.

Back at home, Wilbur reclines in his lift chair. Buddy, feeling right at home, jumps up on Wilbur's lap for a face washing. Wilbur's day is complete, Ole Buddy has come for a visit.


Sabrina Fullhart, a member of Holy Trinity's Class of 2018, remarked that she would miss her classmates after graduation.
