New building will bring 'Harmony' to church

FORT MADISON - The folks at Harmony Bible Church are close to opening a new place of worship in Fort Madison.

Pastor Andrew Wiese said construction is fully underway and they have set a grand opening for Feb. 12 at 1602 Avenue F.

The organization is part of the larger Harmony Bible campus in Danville and will now have their first physical footprint in Fort Madison.

The building is a former church and former satellite location for Southeastern Community College. Fort Madison High School leased the lower floor for its Creative Learning Center curriculum from the college.

Wiese said he's excited about the possibilities and the programming the new building will make possible.

"One of the things we have scheduled is a group meeting called 'Celebrate Recovery', where we help people deal with hurt, habits and hangups," Wiese said. "It's really a great program. We have one in Burlington on Mondays and we'll do ours on Tuesday. It's a good place for people to find some freedom from things like addiction, and non-addiction issues."

There will also be Sunday School classes on the lower level during worship but only through second grade. Wiese said he would like to see that program grow to fifth grade as attendance grows.

The deceptively large worship auditorium has been pulled back into shape from when the original church was functional. Natural wood ceilings arch up to a peak with decorative supports running across the span of the peaked ceiling. The church has put in an 8-foot

FORT MADISON - A Fort Madison businessman and sitting city councilman has been charged with a misdemeanor aggravated fraud charge in connection with a title issue on a vehicle at his dealership in June.

According to the Iowa Department of Transportation's Motor Vehicle Enforcement Division, a complaint was filed in district court on Jan. 20 against Chris Greenwald, owner of River City Motors Plus Inc. in Fort Madison and first ward

councilman. According to the complaint, on June 21, 2016, Greenwald, "did commit a fraudulent practice in the third degree by knowingly conceal a material fact concerning the ownership and transferability of a vehicle while obtaining a Iowa certificate of title representing a 2004 Chevrolet truck. The defendant having a financial exposure of \$7,000 but the truck having a security lien of \$11,500. Actual value of the truck to the dealership being \$7,000." The affidavit on file at

the North Lee County Courthouse also alleges the Greenwald was aware



application for the title. An application for the title of the Chevy Silverado was filed at the Lee County Treasurer's office. The document also alleges that, "Greenwald had knowingly and willingly accepted the truck as a trade in vehicle and was aware that the Chevrolet truck title had been "skipped" and the person trading the truck was not the title owner and the truck title

was not negotiable for transfer."

According to the investigation notes on the affidavit signed by Officer Chad White, an investigator with the Iowa Department of Transportation's Bureau of Investigation and Identification Protection, it was discovered that the vehicle had an active 1st security lien notation on the vehicle and the dealership wished to obtain a title for the truck to allow resale. "The defendant's business knowingly concealed the material facts of the title skip fraud and existing 1st security interest when Iowa title was issued and

immediately transferred to another party," White indicated in his notes on the affidavit.

Attempts to reach Greenwald for comment on Wednesday and Thursday at his home, his business and his City Council line were unreturned.

He is being represented by Elaine Fehseke Gray out of Fort Madison. Attempts to reach Gray for comment were also unreturned.

An initial court hearing was set for Thursday at the North Lee County Courthouse but was moved on a motion filed

large screen monitor in the front stage area and Wiese said pews will be put back in place that will accommodate 200 in the parish. The auditorium will have full audio and video capabilities.

"Our attendance right now with children and adults is right around 100 so we've got some room to grow," Wiese said. "Our services typically average around 80..sometimes we get more and sometimes less, depending on the seasons and time of year."

There is a fellowship area inside the front doors with full restrooms and in the basement is a kitchen area, a nursery and about 4 other classrooms and a modernized fire sprinkler system that SCC had installed.

All in all, Wiese said the

construction didn't have any real hiccups because SCC had taken such good care of the property. Crews are putting in all new parquet wooden floors in the basement and most of the upper level.

Some blacktop has been brought in to provide for additional parking on the lower level. Wiese said volunteers will probably work on repainting and landscaping outdoors when the weather is more suitable.

"We purchased the building on Sept. 30. It got pretty cold quick and we didn't have time to get that work done," he said. "But we have been able to put up new gutters."

The church paid SCC \$230,000 for the building and budgeted \$170,000

in the next 10 days. for renovations. But Wiese said renovations to this point are at about \$80,000 with some stuff to still come in.

The church had been meeting in the Riverview Park pavilion, renting that space from the City of Fort Madison. "We've been meeting at the pavilion for a year and a

half. We've been looking for a building for the past year and a half," he said. "We've looked at a lot of buildings, some weren't available, some were available for the wrong price. This then came available and it used to be a church so we came in and took a look."

The church will be holding a grand opening on its first day of service that will begin at 10:30.

Greenwald was originally charged with three counts, the first being the aggravated misdemeanor fraud, which has been consolidated by the court with one count of failure to maintain motor vehicle records and one count of failure to obtain a manufacturer's or importer's certificate.

White said as part of the investigation, the department reviewed the records for the vehicles on the lot at River City Motors and found another vehicle with a title issue but only one complaint was filed.

FORT MADISON - The Fort Madison Bloodhound wrestling team made quick work of BHS Thursday in a conference dual meet. The key word being quick.

The Hounds won 54-30 as both teams combined for seven forfeits in the last dual meet prior to districts Feb. 11 in Mt. Pleasant.

Despite the quick win over the Greyhounds, Head Coach Ryan Smith said there's still some room for his wrestlers to improve before districts.
