LCEDG group pumps panels for ideas, goals

Hounds gear up for state qualifier

Cordray, Settles look to return to state tournament next week

FORT MADISON - The Fort Madison Bloodhounds have had an undulating regular season, but with state qualifying set for Saturday, head coach Ryan Smith hopes his squad will rise, and not fall.

The Hounds are coming off a 61-12 loss at North Scott in a regular season dual meet where only three Hounds came away with wins.

But Smith wants the Hounds to leave everything on the mat Saturday as the districts, which begin at noon at Cedar Rapids Prairie High School, weed out two finalists in each weight class for the right to go to the state meet.

The state meet this year is Thursday, Friday, and Saturday, Feb. 14-16 at Wells Fargo Arena in Des Moines.

Smith said the season-ending loss at North Scott won't have an impact on the wrestling team.

"That was a tough one up there, but at the same time, we're happy we can put ourselves in that situation where we face some of the toughest wrestlers in the state," Smith said.

"We're gonna see seven different schools on Saturday and I feel good about our kids and where they're at."

The Hounds' Class 3A district includes Iowa City High, West and Liberty, as well as Prairie, Mt. Pleasant, Clear-Creek Amana, and Burlington.

Each weight division, with the exception of 126 lbs,

Dennis Fraise, the senior economic development director and CEO of the group, said LCEDG is making strides in cutting into the workforce issues facing Lee County, but said it's time to go bigger, faster and better.

"Now we're at the point where we can put our foot on the gas and get some things done. We've have gotten some things done, but we have to be better," he said.

He said the reality is that Lee County doesn't have the workforce it needs to take us through the next decade. Allan Luers, at right, from Axalta Coatings in Fort

"I don't think that's a surprise to any of you that are trying to hire people. So Bigger, Faster...Better," Fraise said.

Fraise said the Governor's Future Ready Iowa program talks about a goal to have 70% of Iowans having some form of formal training after high school to



STEMFest returns to SCC Feb. 23

WEST BURLINGTON – The sixth annual Southeast Iowa Regional Science, Technology, Engineering, and Math Festival (STEMFest) will take place at SCC's West Burlington campus on Saturday, February 23 from 10 a.m. until 1 p.m. The event is a joint effort between SCC, the Southeast Iowa STEM Hub, local businesses, manufacturers, and educators.

STEMFest introduces kids and adults to careers and opportunities in STEM-related fields through hands-on activities, exhibits, and demonstrations. Participants explore STEM careers through robotics and healthcare simulations, as well as electronics and renewable energy exhibits.

With the growing demand for jobs requiring digital and technical skills, a background in STEM is essential for many careers. SCC Work-Based Learning Specialist Leanne Krogmeier, says STEMFest is also great way for students to explore careers in Southeast Iowa's industries.

"STEM jobs continue to dominate the list of hot

careers," says Krogmeier. "That's why it's so important we get kids interested while they're young. STEMFest is a fun and creative way to show kids ideas and career paths they may not have seen or considered before."

This year's event will feature animals from Niabi Zoo, kid-friendly demonstrations by Absolute Science, and Iowa Public Television will lead families in the creation of small motorized contraptions called Wiggle Bot. People may also tour the SCC's Health Professions Center.

The popular event attracts hundreds of people every year.

"Our goal is to continue to show students and parents how fun STEM can be," says Krogmeier. "We've got another great lineup of exhibitors from across the region and plenty of cool activities."

"Gavin could be there. He's doing very well, works hard, and has a determined mindset," Smith said. "I won't count anybody out, especially when they have the work and mindset he has."

Elton and Owen Kruse, at 113 and 106, both have had solid years and have come on late in the season. Elton, the older brother and senior, has district experience and that should help him in that bracket. But Prairie's Austin Kegley should be the favorite, currently ranked 3rd in the state.

At 120 lbs, Dayne Cordray has state experience going as a freshman and

again as a junior last year after skipping his sophomore year. Standing in the way will be Hunter Garvin of Iowa City West and Kael Scranton of Clear-Creek Amana. Both those wrestlers are freshman with Garvin currently No. 2 in the state.

"That's a really balanced weight class. The Garvin kid is probably the favorite, but two through five will be balanced and Dayne is really dialed in right now," Smith said.

Junior Danen Settles will be looking for a return trip to state at 285lbs after making it last year in a dramatic district wrestle back at 220 lbs.

Settles is wrestling at 285 this year. As a sophomore he had to wrestle back at districts and ended up beating wrestlers from Burlington and Mt. Pleasant, both of whom had beaten him in the regular season.

Jacob Murry from Iowa City High is ranked 4th in the state at 285.

Smith said districts are a place of surprises and anything can happen, but he just tells his wrestlers to stay focused.

"The big thing is make sure your head's in the right place and you're ready to finish strong. Some kids don't do that toward the end of the season," Smith said.

"You have to believe in

yourself and your training throughout the year. Make sure when you step off, you left everything out there and, win or lose, you feel good about yourself."

At districts, the champion and runner-up both advance to the state tournament. A third-place finisher can advance if either of the other two are unable to compete in Des Moines on championship weekend.

"From my perspective, all I care about is that the kids bring good effort and good attitude. That's what I look for as a coach, wins and losses will take care of themselves," Smith said.

jumpstart the workforce in the next 10 years.

He said Lee County is 88th of 99 counties in that category with a percentage in the lower 20s, and the county also has the third highest generational poverty rate in the state. He said Bridges out of Poverty has raised the money to hire a part-time coordinator for the county and that program should up and running shortly.

"That's taken a lot of work for those of us who've raised the money, but we're there and that program will launch. We've had tons of volunteers, but couldn't do anything until we had the money," he said.

He said a recent survey showed that 40% of students in Lee County don't have a plan for after high school. Fraise said that's a problem, but also an opportunity. Fraise said the county shouldn't get bogged down in doing "stuff", and not be afraid of pivoting from things that aren't working.

Dana Millard, economic development project director at LCEDG, talked about the efforts aimed at students in the area and filling skills gaps needed by local employers now....not 10 years in the future.

She said 92% of Lee County schools have participated in the STEM scale up programs in the last four years. She that flows into how the county can go bigger, faster and better.

"When we started this program we were one of the lowest participating counties in the state and now we're one of the highest," Millard said.

She said more than 400 students in Lee County

joined in exploring career paths through Career Exploration Day for high school and 8th grade students.

"When we talk to our high school principals if the students do it right, they can half a day or more for their juniors and senior years available to do things like career exploration, industrial maintenance programs, but that planning starts in eighth grade," she said.

Fraise challenged those in attendance in a group setting to come up with hurdles that get in the way of a bigger, faster, better mentality.

Issues that surfaced included poor retention of graduates in the area, underserved areas of financial literacy, entertainment and quality of life issues, poor rental and housing inventory, awareness of paths from minimum wage to higher paying jobs, and roadblocks to career and technical education teacher certifications, regional collaboration, and preconceived notions of available companies and those jobs.

Fraise then asked the groups to come up with stretch goals for the county that address some of those issues.

A sampling of those ideas included flipping the the county's ranking of Iowans with some form of education or training beyond high school from 88th of 99 counties to the top county in the state. Increasing the county population by 20% over the next five years, and creating a regional education/training center in three years.

Fraise said LCEDG would compile all the information from the session and forward to those in attendance to see what's on the minds of the people that are going to help bigger, faster, better become a reality.
