# FM school board has 22 days to appoint director

FORT MADISON - With the tragic passing of Fort Madison school board member Gayla Young on Dec. 31, the Fort Madison school district is under a pret-

ty tight timeline to appoint her replacement, and is actively seeking members of the district to step into the vacancy.

At Monday's Fort Madison Community School District Board of Directors workshop held at the Fort Madison Middle School, the board gave Superintendent Dr. Erin Slater a consensus to put a notice out that the district is actively looking for someone to fill Young's position.

According to state code, the district has 30 days from Young's vacancy to appoint someone to fill the position, otherwise the vacancy must be filled with a special election at a cost to the taxpayers.

Iowa code 279.6, also states that eligible voters in the district can call for a special election with 14 days of the publishing of the notice to fill the vacancy by appointment. Anyone wanting the position to be filled by a special election would have to petition the district and the petition would have to include either 100 eligible signatures or 30% of the voters in the last general school board election. In Sept. 2017, 1,762 ballots were cast which would indicate unofficially that 529 signatures would be required to call for a special election.

If no one steps forward and the district can't find someone to appoint to the board by Jan. 30, District Secretary Sandy Elmore would be required to call for a special election no earlier than March 2 and no later than March 12, according to current code.

# Folluo to chair county board

FORT MADISON - For the first time in seven years, a supervisor from the southern part of the county will chair the Lee County Board of Supervisors.

Supervisor Don Hunold stepped down as chairman Wednesday at the board's first meeting of the new year. Hunold didn't seek re-election to the board and was replaced by Rich Harlow who won the spot in the general election.

After Hunold excused himself, Supervisor Rick Larkin, as vice chair, took over the meeting and asked for nominations for the 2019 chair. Supervisor Matt Pflug nominated Folluo as the 2019 chairman and Folluo seconded the motion. Both supervisors' districts are in the southern part of Lee County.

During a very brief discussion on the motion, both Larkin and Supervisor Ron Fedler spoke against the nomination.

"Well, for obvious reasons, I won't support that resolution," Larkin said.

"I agree with Rick," Fedler said.

The two didn't elaborate on their opposition and, with no additional discussion, the motion was voted on with Pflug, Harlow, and Folluo voting for the motion, and Fedler and Larkin voting against the motion.

Folluo, who was vocal about the chairmanship not going to someone from the south part of the county last year, said he was surprised by the vote.

"I'm completely surprised - but pleasantly surprised, and I accept that responsibility and the duty and look forward to the next year," Folluo said.

He said he doesn't have any set plans to change the

### Abandoned house burns Monday morning

FORT MADISON -An early morning fire has destroyed an unoccupied house in the 1400 block of Avenue I.

City firefighters were called to 1418 Avenue I at about 5:15 a.m. Monday to find the house fully engulfed in flames. LeeComm dispatch put out an "all-call" for the department at about 5:25 a.m. No one was in the home at the time of the fire. Witnesses said the home was abandoned. had no utilities connected, and may have had squatters living it. The 2-story structure had a taxable building value of \$10,557 and is listed as being owned by Janet Krogmeier.

The cause of the fire has not been released.

# Lady Hounds get first win of season

FORT MADISON - Fort Madison's Anna Kester scored a season-high 18 points as Fort Madison got their first win of the season Saturday at home against Albia.

The junior went 4-of-13 on the night and hit on a couple three-balls to lead Fort Madison (1-11). But it may have been the defensive pressure of the second half that secured the win. Fort Madison allowed the Lady Dees just 12 points in the second half, six in each of the last two quarters to pull away for the win.

The Hounds have struggled shooting from the field most of the year and also struggled on the offensive board. But on Saturday, senior Jassmine Bass wrangled 17 rebounds including 12 on the offense end to allow her to finish with 10 points on the night. Bass was 4-of-18 from the field and 2-of-8 from the free throw line with two blocks on the night.

Fort Madison jumped out to a tight 16-15 lead at the end of the first quarter after trailing 2-7 with five minutes left. The two teams went back and forth in the second period, but Fort Madison went on a 8-0 run in the final two minutes to take a 35-27 lead into the break. Kester and sophomore Nadia Boeding led the Lady Hounds with eight points each.

The Hounds put up a stifling second half defense and kept all Albia scorers under three points led by senior Taylor Colwell who had three in the second half.

"It's great the girls can get a win. They have had a ton thrown at 'em in a very short time," said head coach Todd McGhghy. "I've also demanded of them and held them accountable in a very intense and unwavering way. It's been quite the cultural shock. In fact, we had a very intense halftime discussion after allowing 27 points."

McGhghy said the girls responded to the talk and held Albia to 12 points in the second half. He said Albia changed some things over the break that disrupted the Lady Hounds game plan.

"They didn't look like a 1-7 team. A win is a win and we'll take it."

Kester led Fort Madison with 10 points in the second half including going 5-of-6 from the free throw line.

On Friday the Hounds spotted Fairfield a 22-6 first quarter advantage and couldn't get a player in double figures as sophomore Maddie Rashid led Fort Madison with

Fort Madison scored in double figures in the second quarter outscoring Fairfield 12 to 5. The Lady Hounds held Fairfield to just eight points in the third quarter, but only managed four points themselves as the Lady Trojans pulled away. Fairfield exploded for 18 points in the final period to secure the win.

Fairfield is a very good transition team. Right now we have to be a half-court trap-

ping and pressure team to generate offense," said head coach Todd McGhghy. "They made it very difficult to do that with their tempo."

### Box scores 25 as HTC rolls Mt. Pleasant

FORT MADISON - Holy Trinity girls basketball coach Tony Johnson said the Crusaders still aren't playing their best basketball, but Monday's 60-43 win over Mt. Pleasant was pretty darned close.

The Crusaders shot 47.8% from the field featuring senior Emily Box who scored 25 on the night to lead all scorers. Senior Taylor Boeding followed up her 18-point performance last week in a loss to Central Lee, with 15 points Monday. Junior Ashlynn Haas also added 15 for

The girls opened the game on a 14-4 run in the first quarter as the Lady Panthers couldn't figure out HTC's proficiency getting the ball inside to Box who scored eight in the first period and pulled down five rebounds.

Box said the game wasn't nearly as physical as the Central Lee game Friday night where the Crusaders comeback fell short 50-46..

"They were playing a man-to-man and we had a lot of looks where I was wide open tonight," Box said after the game. She's currently fourth in the Southeast Iowa Superconference in scoring at 14.1 points per outing.

She said this year she feels more comfortable with the ball in the lane and from about 10 feet.

"It's just coming with more experience being on the court. I'm out there more

this year because I'm not getting into as much foul trouble," she said.

In between Box's points in the first quarter, Boeding shot a cool 2-6 for five points but began to heat up in the second quarter hitting a couple of 3-balls from the left baseline. After Mt. Pleasant's Sadie Carasco scored at the end of the first quarter, Lydia Stewart opened the second quarter with a three-pointer for Mt. Pleasant to cut the lead to seven.

But Boeding would hit from the left side to start an 11-0 run with a bucket from Box and two more long balls from Boeding and Haas to push the lead to 27-9. The Panthers would make a couple free throws and Haas would add two for HTC as the Crusaders stretched the lead to 31-19 at halftime. The Panthers Karsyn Lamm would get a put-back to fall at the buzzer to set the score at the

Haas and Boeding were able to keep the inside game working as the Crusaders would work the ball around the perimeter looking for interior passing lanes or open looks. At several points Boeding and Haas would have open 18-footers, but would step back outside the arc to shoot the three.

"Three games ago we looked at film and we had a lot of shots where our toe or heel were on the line, so if you're gonna shoot a 19-footer you might as well step back. I'm fine with that if it's in the flow of the game," Johnson said.

"If they're gonna triple team Box, you're gonna be wide open you might as well shoot 'em. If you make 'em they're going to have to come out and then Box can score at will inside. I want that inside/out game, but I like it when we can bet the ball inside like we did tonight."

The Panthers would never make a charge in the second half with HTC holding a consistent 13 to 16 point advantage throughout the game. Box and Haas scored back to back buckets with about 4:30 minutes left in the game to

# Hocker gets pin to seal Hound win

FORT MADISON - A string of three falls in a row and a dramatic pin by Chance Hocker at 170 lbs were enough to give the Bloodhound wrestlers a big come-from-behind conference win over Washington Thursday night.

Fort Madison was wrestling in their first home meet of the year, outside of the Invitational Tournament last month, sweeping Washington and Mid-Prairie Wellman 39-36 and 51-24 at the HoundDome. The win over Washington put the Hounds in the driver's seat for the Southeast Conference title after the Hounds took down Mt. Pleasant back on Dec. 13 39-31.

Fort Madison held a 33-16 lead going into the final five matches. Junior Danen Settles started the rally for the Hounds in the heavyweight match against Washington's Tristan Allender. With the Hounds down 12-6, Settles held a 2-0 advantage in the first period, but got an escape and a takedown in the second period and then scored a near fall to take a 13-0 lead. Settles, who was ranked as high as 7th in

the state earlier in the season, was able to roll Allender on his back again at the edge of the circle for the pin at the 4:57 mark.

Owen and Elton Kruse, wrestling at 106 lbs and 113 lbs scored back-to-back pins with Owen Kruse's coming just 46 seconds into the match with the Demon's Caden Evans. Elton Kruse needed a bit more time, but scored a fall after leading 4-0 with 23 second left in the second period, over Matt Collett. The two pins gave Fort Madison a 24-12 lead.

Senior Dayne Cordray couldn't get anything going against Walker Ikerd at 120 lbs losing a 14-0 major decision to allow Washington to close the gap to 24-16, but freshman Gavin Wiseman fought off the Demons' Brandon Dickel at 126 lbs after trailing 3-4 at the end of the first period. Wiseman was able to get Dickel in the air in the second period and spun him to the ground where he worked a fall with 53 seconds left in the second period to give Fort Madison a 30-16 lead.

Will Larson would snap Washington's Justin Simmering to the mat early in the first period at 132 lbs. and almost get a fall off the takedown, but Simmering would wiggle out of the hold. Neither wrestler would score another point the rest of the way through the three periods and Larson would hold on for the decision 5-0 for a 33-16 Hound lead.

Washington would then score four straight wins over the Hounds to take the lead at 33-36. Garrett Walker would score a technical fall over the Hounds' Nathan Steffensmeier 16-1 at 138 lbs and Dalton Woolever, couldn't catch Dillan Sanders in the third period losing just 3-1 at 145 lbs. Sanders would score an escape with 1:03 left in the second period for the 3-1 lead and Woolever couldn't get control of the match in the third period.

Both Jakob McGowan and Keaton Poe lost by pins to set up the final match between Hocker and Washington's Keaton Murphy

Despite needing only three points, Hocker rushed Murphy off the whistle and scored a quick take down just :11 seconds into the match. Hocker worked Murphy in the corner of the mat in front of Head Coach Ryan Smith and scored a near fall with :57 left in the first period and

"Elton against Washington that was a big win, That was solid opponent and for him to not just get a win, but a pin, is huge. That was probably one of the key wins. Him and Gavin Wiseman both had big pins tonight."

The win gives the Hounds victories over Mt. Pleasant and Washington, with Fairfield coming up on Thursday on the road and Keokuk the following Thursday at home to wrap up confer-

ence action.

"Washington's held the conference title for a few years now, so it's been on our checklist to get it back where it belongs," Smith said.







# School board reacts to Young's death

FORT MADISON - Fort Madison School District Superintendent Dr. Erin Slater has confirmed this morning that current school board member Gayla Young died this morning at University of Iowa Hospitals and Clinics.

The cause of Young's death has not been released by the family, but Slater issued a statement on behalf of the district at around 4 p.m. Monday night. District staff was notified via email this morning.

volunteering efforts, and her love of learning will be deeply missed. Our

thoughts and prayers are with the family at this time," Slater wrote in an email Monday.

Fort Madison School Board President Dr. Tim Wondra said Young's impact will be missed throughout southeast Iowa.

"It's a great loss for Fort Madison and everything she was a part of on the board, but it's also a loss for Danville where she taught, and it's a tremendous loss for Denmark with all that she was involved in in that community," Wondra said.

"Gayla was a great person, quick to help, would also be there for anyone, anytime and she was so smart. I am truly a better person for having known and served with her."

Young, a teacher in the Danville school system,

was re-elected to the Fort Madison board in September 2017 after serving her first four-year term winning her seat in 2013. She was the current vice-president of the school board.

Other school board members also shared in the grief of Young's passing.

Lois DiPrima worked at Denmark Elementary School during the 1980s with Young, when Young was a cook with the district and decided she wanted to do more.

"She wanted to be more of a part of her children's education and other people's education. The day she went back to school, she was so excited. She wanted to make a difference in people's lives and teaching was the way to do it. I remember her saying those exact words to me," DiPrima said.

"In the last four years on the board I have seen a family grow. This is losing a part of that family."

Board member Dianne Hope said didn't know Young before serving on the board with her, but said she didn't just lose a fellow board member, but a friend.

"Gayla was a dedicated board member and brought a classroom educator's view to the table. She also followed legislative issues and what was going on in Des Moines. She will be missed as a board member and as a friend."

Jared Hotop said Young was a big advocate for education and the students of Fort Madison.

"She always had the district's best interests at heart," he said.

Fellow board member Carol Ross said Young gave education everything she had.

"Gayla was a great person. She was passionate about education and gave 110% in everything she did," Ross said. "I enjoyed getting to know her and she will be missed. My condolences to her family."

Young was also a member of the Denmark Volunteer Fire Department.


