## Fundraiser gives P.O.R.T. a Booooo-st

*Annual event helps provide resources to stretch city's recreational trail to FMCH*

FORT MADISON - A kangaroo with a joey in its pouch, Buzz Lightyear, and a mayor dressed as a Viking, a clear nod to Norse gods of cruise lines, all took part in the fifth annual PORT Boo-Athlon fundraiser, which helps fund efforts by the group to continue with recreational trail construction on the city's west end.

Rachel Benda, the chairman of the PORT group said the community has been the catalyst for the group's success.

This year featured 128 runners and several bike riders. The runners ran the 5K run along the PORT 1 and 2 Phases and up into the Fort Madison Middle School ending and starting at the Baxter Sports Complex.

Bike riders ran a course from the sports complex up Bluff Road and over to 24th Street, down to Avenue E and east to Lincoln, where they turned around and rode the same course back to 48th where they continued on Bluff Road to Hwy 2 and turned around and rode back to the Baxter complex.

Amanda Alexander, one of the organizers, said 128 runners registered this year which is up about 10 from

2017.

Rachel Benda, the chairman of the PORT Committee, said the city had a lot on the schedule Saturday, so it was great to see an increase in numbers.

"We had an increase over last year, which was great," Benda said. "Great weather, same great sponsors supporting us which is amazing. This is our fifth

## Hellige improves 32 spots from 2017 state mark

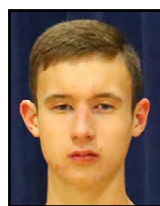
FORT DODGE - Holy Trinity Catholic's Matt Hellige was all smiles after improving almost 32 spots over his 2017 performance at Saturday's State Cross Country Meet in Fort Dodge.

Hellige, running in his second straight state Class 1A track meet, finished with a time of 17:49.3 in the 5K run at Lakeside

Municipal Golf Course at Kennedy Park in Fort Dodge, good enough for 58th place out of 140 runners. Madrid senior Sean McDermott won the 1A meet with a time of 16:16.

Off the gun, Hellige stayed in the center of the field as the course tapers from a full line of all 140 to a 10-foot track around the golf course grounds. At about the 1-mile point, Hellige was in the pack with the mid 60s and picked off a couple run-

and then another couple on the downward slope to the finish line.

"I definitely wanted to take advantage of the hills of the course," Hellige said. "There are lots of tiny hills on this course and I trained this year on more hills so I thought I could

Hellige said he felt good on the run in just about perfect weather.

"I felt really good on my warmups and the start of the race," he said. "It was really good weather. Last year it was a windy day, chilly and cloudy, not the best. This year was almost perfect, really."

In 2017, Hellige ran the course in 18:04.4, a 14.1 second improvement over his sophomore perfor-

mance. He missed the cut as a freshman in 2016 at qualifying by two spots. The top 15 at qualifying and the top three teams winning qualifying all advance to the state run.

HTC Head Cross Country Coach Matt Mohrfeld moved to areas around the course where he could see Hellige.

"I was tickled that he didn't try to overrace the first half-mile and then it looked like he was picking up spots the whole race

and at the end he picked up a couple more spots," Mohrfeld said.

Hellige said he didn't want to run out of steam as the race went on.

"Last year, and this year really, I tried not to get out too fast and then burn out of energy toward the end. That's really easy to do in races like this," Hellige said. "Our training plan was really good this year and I think that

## P.O.R.T Phase three could turn into two parts

year and hopefully next year we'll run on the third phase, which will be exciting."

She said the committee will go out for bids for the third phase, which will connect the end of the second phase on 48th Street and run to the pond trail at Fort Madison Community Hospital. Benda said a tentative schedule would have the work being done before winter next year.

"That's the goal and hopefully that still happens," she said.

She said the committee has the majority of the money they need to finish the third phase. She said Wellmark donated \$100,000 in a grant conditioned upon a match of \$100,000, which the committee got from the Southeast Iowa Regional Riverboat Commission. They also got a \$280,000 Transportation Alternative Program grant and a \$91,000 state trail grant.

The third phase will have some wetlands mitigation and then the committee wants to put in some safety mechanisms at the street crossing at the end of Phase 2 crossing 48th Street. The path also has nothing on 48th Street coming down from Bluff Road to the middle school entrance so they'd like to work with the school on that effort, as well.

"We'd really like to get something along the east side of 48th street because there's nothing there right now. Hopefully we can work with the school to get something done."

The first Boo-Athlon held in 2014 netted about \$10,000 and Benda said

the event is a large revenue generator for the project.

"It's our biggest fundraiser. We did our Ugly Sweater 5K last year in December and we'll do that again this year. We didn't have sponsors for that last year and that was a great fundraiser that we didn't have sponsors for, and we'll discuss that but it's also just a great way to promote health and wellness."

Benda mentioned, for the first time, a Phase 3A and possible Phase 3B which would possibly connect the living areas by Sunnybrook and connect that area to Fort Madison Community Hospital and create another big loop on the trail.

"That may be in the plans and maybe a portion where we get some support. We've had other businesses and large industries come to us and say they want to help so we want to find a way to keep that momentum going," Benda said.

She said the group is also working with the current effort underway to look at trails, bike trails, and water trails in southeast Iowa, western Illinois, and northeast Missouri. She said it would be wonderful to get the path connected with Montrose, and other areas close to the community.

"We're not done, we're thinking that way. We're also thinking big picture it would great if we go to Montrose and Keokuk could come to Montrose we'd have a whole path there. We could go to (Lake) Geode or we could go Burlington, it's all still there," she said.

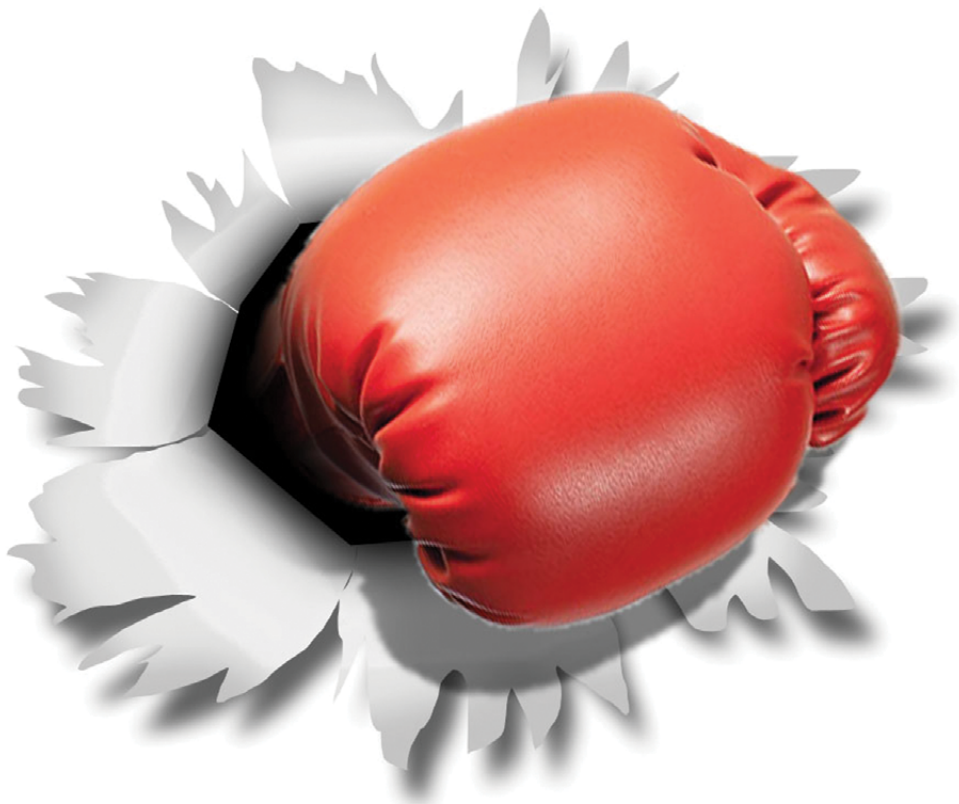

definitely helped.”

He said next year’s plan is to just keep improving on his time and place and maybe integrate a few more miles into the training routine as he ramps up his performance with college just a year and a half way. Hellige said he wants to run at college.

Mohrfeld said this year’s training plan was strong and Hellige executed well in the run.

“He said he definitely wants to run in college,” Mohrfeld said. “So we’re gonna bring his miles up next year and we’ll probably talk to a couple perspective college programs and overlay that so he has a nice transition going forward.”

Hellige’s dad, John, who’s also HTC’s head boys basketball coach, said his son ran a good race.

“I thought he ran a really good race. This year he had a much more strategic approach,” John said. “That’s a result of maturity and coaching, and he spent a week at a cross-country camp this last summer at Wartburg, which I thought was a real difference maker. He was around a lot of high school kids who like to run and learned a lot of mental preparation for racing.”

With about 150 Class 1A schools represented at Saturday’s final race of the year, John Hellige said his son is just about at the top level in the state.

“He’s in the top three to five in southeast Iowa. When you get here you got the best of 150 schools and if you finish in the top 50 you’re pretty much the cream of the crop and we hope to keep cutting this in half each year.”

# HAPPY HALLOWEEN

Halloween is an exciting time of year for kids, and to help them have a safe holiday, here are some tips from the American Academy of Pediatrics (AAP). Feel free to excerpt these tips or use them in their entirety for any print or broadcast story, with acknowledgment of source.

## ALL DRESSED UP:

Plan costumes that are bright and reflective. Make sure that shoes fit well and that costumes are short enough to prevent tripping, entanglement or contact with flame.

Consider adding reflective tape or striping to costumes and trick-or-treat bags for greater visibility.

Because masks can limit or block eyesight, consider non-toxic makeup and decorative hats as safer alternatives. Hats should fit properly so they don't slide over eyes. Makeup should be tested ahead of time on a small patch of skin to make sure there are no unpleasant surprises on the big day.

When shopping for costumes, wigs and accessories, look for and purchase those with a label clearly indicating they are flame resistant.

If a sword, cane, or stick is a part of your child's costume, make sure it is



not sharp or long. A child may be easily hurt by these accessories if he stumbles or trips.

Do not use decorative contact lenses. While the packaging on decorative lenses will often make claims such as "one size fits all," or "no need to see an eye specialist," using decorative contact lenses without a prescription is both dangerous and illegal. This can cause pain, inflammation, and serious eye disorders and infections, which may lead to permanent vision loss.

Review with children how to call 9-1-1 (or their local emergency number) if they ever have an emergency or become lost.

## CARVING A NICHE:

Small children should never carve pumpkins. Children can draw a face with markers. Then parents can do the cutting.

Consider using a flashlight or glow stick instead of a candle to light your pumpkin. If you do use a candle, a votive candle is safest.

Candlelit pumpkins should be placed on a sturdy table, away from curtains and other flammable objects, and not on a porch or any path where visitors may pass close by. They should never be left unattended.

## HOME SAFE HOME:

To keep homes safe for visiting

trick-or-treaters, parents should remove from the porch and front yard anything a child could trip over such as garden hoses, toys, bikes and lawn decorations.

Parents should check outdoor lights and replace burned-out bulbs.

Wet leaves or snow should be swept from sidewalks and steps.

Restrain pets so they do not inadvertently jump on or bite a trick-or-treater or run away.

## ON THE TRICK-OR-TREAT TRAIL:

A parent or responsible adult should always accompany young children on their neighborhood rounds.

Have flashlights with fresh batteries for all children and their escorts.

If your older children are going alone, plan and review the route that is acceptable to you. Agree on a specific time when they should return home.

Only go to homes with a porch light on and never enter a home or car for a treat.

Because pedestrian injuries are the most common injuries to children on Halloween, remind Trick-or-Treaters:

Stay in a group and communicate

# HAVE FUN & BE SAFE!



Carry a cellphone for quick communication.

Remain on well-lit streets and always use the sidewalk.

If no sidewalk is available, walk at the far edge of the roadway facing traffic.

Never cut across yards or use alleys.

Only cross the street as a group in established crosswalks (as recognized by local custom). Never cross between parked cars or out of driveways.

Don't assume the right of way. Motorists may have trouble seeing Trick-or-Treaters. Just because one car stops, doesn't mean others will!

Law enforcement authorities should be notified immediately of any suspicious or unlawful activity.

### HEALTHY HALLOWEEN:

A good meal prior to parties and trick-or-treating will discourage youngsters from filling up on Halloween treats.

Consider purchasing non-food treats for those who visit your home, such as coloring books or pens and pencils.

Wait until children are home to sort and check treats. Though tampering is rare, a responsible adult should closely examine all treats and throw away any spoiled, unwrapped or suspicious items.

Try to ration treats for the days and weeks following Halloween.

### HALLOWEEN AND FOOD ALLERGIES:

Halloween can be tricky for children with food allergies. It's important that parents closely examine Halloween candy to avoid a potentially life-threatening reaction:

Always read the ingredient label on treats. Many popular Halloween candies contain some of the most common allergens, such as peanuts or tree nuts, milk, egg, soy or wheat.

If the ingredients aren't listed, arrange for a treat "exchange" with classmates or friends. Or, bag up the goodies your child can't eat because of an allergy and leave them with a note asking the "Treat Fairy" to swap them for a prize.

Be aware that even if they are not listed on the ingredient label, candy is at high risk of containing trace amounts of common allergy triggers, because factories often produce many different products. Also, "fun size" or miniature candies may have different ingredients or be made on different equipment than the regular size candies, meaning that brands your child previously ate without problems could cause a reaction.

Teach your child to politely turn down home-baked items such as cupcakes and brownies, and never to taste or share another child's food.

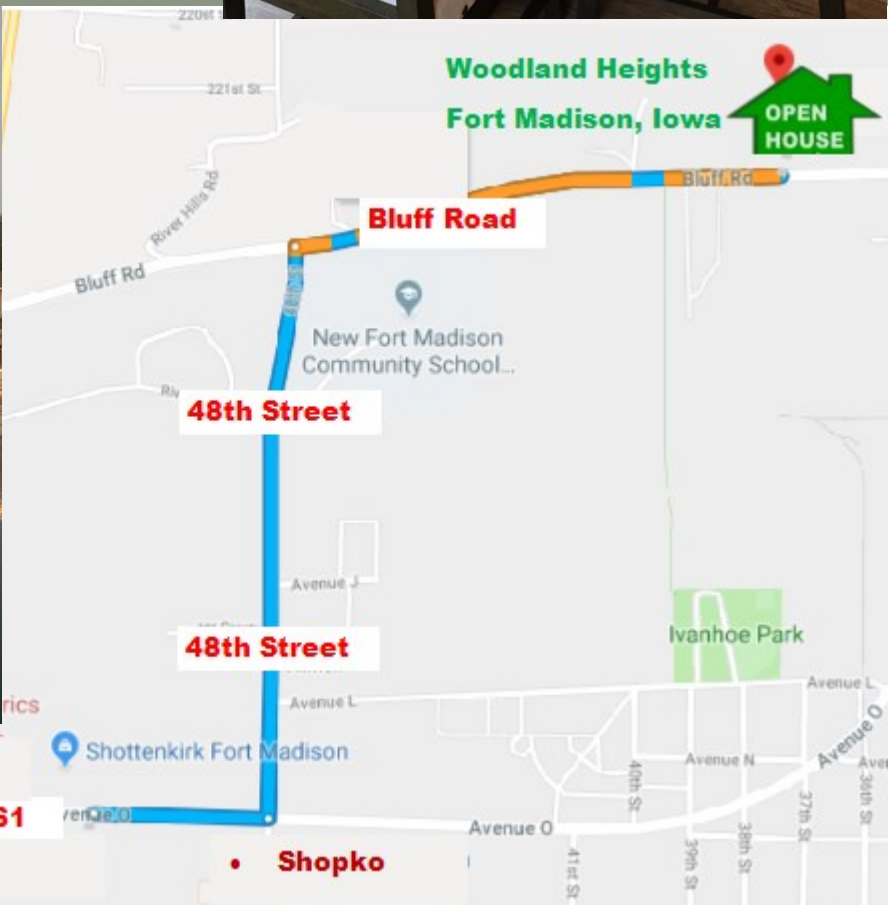
