Pen City Current launches year two with scholarship drive

FORT MADISON - Tuesday marks the one-year anniversary for the Pen City Current's presence in Fort Madison.

Chuck and Lee K. Vandenberg started the news gathering company's website on Dec. 5, 2016 and

launched an e-Edition on Dec. 12 and are excited about the possibilities in the second year

of operation.

Lee K. Vandenberg, co-owner and President of Market Street Publishing, the parent company of the Current, said the first year has been a learning experience and an opportunity to provide a still-emerging service to the readers and businesses in the area.

"Year one was a whirlwind and I don't see year number two slowing down much," Vandenberg said. "It's been wonderful working with area businesses trying to help people get as much digital exposure for their business as possible, while we continue to grow ours. It really has been a challenge that we've welcomed."

The all-digital news outlet has offered free subscriptions and donations subscriptions for the first year because Vandenberg wanted everyone to

be able to read the news for free. While donation subscriptions and advertising have helped support the costs of the business, year two will offer a special feature.

Pen City Current is asking for a one-year subscription at a cost of \$50 to help jump start year two. As an incentive for the donation, 15% of all one-year subscriptions will be used to create a scholarship program for local graduating seniors who have an interest in media communications studies.

"Since day one, we wanted to play a larger role in education and incorporating students into our news gathering efforts," she said. "We've recently brought on board Ava Peitz, a student at Holy Trinity, to intern with us, and now we're looking at creating a scholarship program as well."

The donation subscription drive will run through Friday and Vandenberg said the goal is to sign on 200 annual subscriptions in four days.

Editor and co-owner Chuck Vandenberg said trying to expand coverage deeper into Lee County is something he wants to accomplish in year two and the subscription drive will help kick start that effort.

"We had many people ask us to extend coverage

Supervisors approve third request for courthouse funding

Costs have shot passed estimates by 36% on south building

MONTROSE - A request for additional funding has been approved for continuing work on the South Lee County Courthouse, but in an amount smaller than was discussed last week.

John Hansen of Midwest Construction Consultants, requested up to an additional \$4,000 for tuck-pointing, draining, and electrical work on the courthouse. E & H Restoration out of Davenport was awarded the tuckpointing contract originally for \$311,425.

On two separate occasions in October, the board approved a total of approximately \$110,000 in additional funds for the tuckpointing work. The tuckpointing work is now at just under \$426,000, a 36.7% increase over the original contract.

Work to replace the roofing on the courthouse began in September with original contracts from two companies, Meyers & James Roofing of Keokuk and Hopkins Roofing of Pella, totaling \$258,000.

Supervisor Gary Folluo said the costs, even though higher than original estimates, and bids are within the five-year plan approved for the buildings.

"But in the five-year plan, we knew it was going to be \$1.5 to \$2 million to address the things in that five-year plan. We knew that," he said. "A lot of the issues that we had have been addressed by the main-

tenance department before we even started these projects."

Supervisor Matt Pflug agreed with Folluo and took it a step farther and said this is what the taxpayers said they wanted.

"I think what they're saying is that they're willing to spend a million or whatever, but they weren't willing to spend 8, 10, 12 million whatever on a new building. That's the message they sent...that we'll spend the money, but we need to get these buildings up to snuff"

Supervisor Ron Fedler said he remembers Hanson and Ed Soenke of Design Partnership saying the cost of the project will continue to climb.

"Well I want to respond to Gary's comment that it was going to cost between \$1.5 and \$2 million and

HTC girls falter in 4th quarter

Crusaders commit 36 turnovers in loss to West Burlington

WEST BURLINGTON - West Burlington Head Coach John Vandenberg's girls basketball teams have a pesky habit of coming back to beat Holy Trinity in the fourth quarter.

Vandenberg, in his first year at West Burlington, lead the Lady Falcons back from a three-point deficit in the final period Tuesday night to down the Crusaders 60-52.

At Wapello last year, Vandenberg came back from a 20-point fourth quarter deficit at the Southeast Iowa Superconference Shootout to beat the Crusaders.

Holy Trinity lead by as much as five points in the third period when Emily Box hit a bucket inside and was fouled. She missed the free throw on the end. The Falcons, who took 46 free throw attempts in the game, missed four in a row including a lane violation after Box scored, but the Lady Falcons' Jerri Price converted a bucket to make it 40-43 going into the last period.

West Burlington then went on an 11-1 run pressing the Crusaders and forcing turnovers. HTC only converted two buck-

ets in the final quarter, but those were back-to-back three pointers by Sam Hoenig and Ashlynn Haas to Holy Trinity back within one point at 50-51.

The Falcons, who would only convert one bucket as well in the last 4 minutes, would go to the free-throw line 11 times over the span converting seven. With the West Burlington pressure forcing HTC into turnovers and keeping them out of their half-court offense, the Lady Falcons were able to hold on for the win.

Box led HTC with 14 points followed by Brett Schneider's 12. Avery Hopper, Ashlynn Haas and Eryn Anderson all had six points, while Hoenig and Taylor Boeding each scored three and Madison Mohrfeld added two points.

Freshman Sydney Marlow led all scorers with 19 points for West Burlington. Holy Trinity Head



Coach Tony Johnson pointed to miscues and forcing the tempo of the game as the main reasons for the loss.

"We turned it over 36 times, they shot 46 free throws, we shot 11. There's your game," Johnson said.

Many of the Crusaders turnovers were on their own end of the court in transition.

"I like to control the tempo, but we were out of control tonight," he said. "The biggest thing was 46 free throws. we just committed too many fouls. Hopefully, we'll play a little better Friday and get home for once, it's been a long

time."

Johnson said a scheduling hiccup resulted in WACO being played on the road instead of at home earlier this year, so the 2-3 Crusaders have spent the last five games on the road, but play Friday night at home against Cardinal of Eldon.

It's been good for us," he said. "One of the good things is we know we've got 10 or 11 at home now. Another good thing is that the conference is pretty evenly balanced and anyone can beat anyone else on any given night. We're only five games in so I'm not panicking yet."

Crusaders squander 4-point fourth quarter lead in loss

WEST BURLINGTON - Holy Trinity used speed and a bit "craftiness" to hang around with West Burlington on Tuesday night at the Falcon's gym.

However, the Crusaders got caught up in an 11-5 fourth quarter run by the Falcons and couldn't get back in the game falling 51-57 in Southeast Iowa Superconference boys' basketball action to move to 1-3 on the year.

With a 42-38 lead going into the final period, the Falcons scored six unanswered to start the period before HTC sophomore Reed Fehseke converted a 3-pointer from the right wing to put the Crusaders back on top by one 45-44. But West Burlington's junior Jonah Marlow answered with a bucket that would give the Falcons an advantage they wouldn't relinquish as the Crusaders would only manage four free-throws the rest of the way failing to convert on any shots from the field.

The Crusaders also lost senior Collin Thornton in the fourth quarter when Thornton drove from the left side and was called for a charge. Thornton fell to the ground with several other bodies on the play and hurt his wrist and wouldn't return.

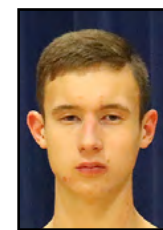
"Yeah, he hurt is wrist on that play. We hope to have him back on Friday," said Head Coach John Hellige. "Obviously losing your sole senior really hurts in that stretch, but I was proud of our underclassman. I thought they stepped up and played hard."

The Falcons rushed out to a 5-0 start in the first quarter and looked to be outmanning the Crusaders, but speed and some clutch outside shooting, coupled with sophomore Matt Hellige's play inside the lane against some much taller opponents, kept HTC in the game.

Fehseke nailed a 3-pointer with just over four minutes to play in the opening period to knot the game at 10, but the Falcons' Tanner Snodgrass answered with a three of his own and Colten Hohenthauer converted a bucket before Thornton answered with another 3-pointer to make it 16-13 Falcons.

West Burlington would push the lead to 21-13 but then Fehseke connected on back-to-back three pointers from the left side of the offense and Quentin Schneider converted inside to tie the game again at 21. Marlow, who would lead all scorers with 21 points, hit again from long range and then Thornton banked in a 3 and the Crusaders were within one 24-25 at the end of the first half.

HTC went on an 10-5 run to start the third quarter highlighted by Hellige's eight points and an Adam Rauenbuehler bucket. But West Burlington went on

Bloodhounds can't find way to win across the river

Cresswell leads FM with 14 in loss

WARSAW - The Fort Madison Bloodhound basketball jinx when playing across the river in Illinois is still intact.

The Bloodhounds mounted a second-half comeback but came up short

in a 45-51 loss to West Hancock Tuesday night at West Hancock High School in Warsaw.

Senior Kaleb Cresswell put up eight fourth quarter points including a 3-pointer as the Hounds battled back from a 27-15 first half deficit. Senior Treavor James-Kokjohn added a three pointer and junior Logan Rashid chipped in with three 4th quarter points before FMHS ran out of clock.

Cresswell led the Hounds with 14

points followed by James-Kokjohn's 13. Rashid finished the game with 7 points and Lorenzo Riles, who was playing in his first game since joining the squad two weeks ago, went 4 of 4 from the free throw line for four points on the night. Sheymouhr Redd-Donald added three points and Brandon Keester and Jayden Fedler each added a bucket for the Hounds.

Logan Dorethy led all scorers with 20 points, followed by Drake Hammel's 12.

Coming into the game, James-Kokjohn was second in the conference in scoring at 20.5 points per game. Cresswell was fourth at 12.5 a game. Keester and Rashid were 6th and 7th at 10 and 9 points per game respectively. James Kokjohn leads the conference in rebounds at 14.5 per outing for the 2-1 Hounds.

The Hounds travel to Centerville in a junior varsity/varsity double header on Saturday beginning at 1 p.m.

their own 8-5 run with Marlow accounting for six points to make it 30-38 HTC at the end of the third.

Hellige said West Burlington made adjustments throughout the game to stop HTC's momentum at different points, specifically switching up defenses to slow Hellige in the paint and Fehseke on the perimeter.

"I think they started keying just a little bit. Matt's a little crafty for his size under there and sometimes teams underestimate that," Hellige said. "I think they made an adjustment and covered him up there. He's a good coach and good coaches adjust - and good teams adjust."

"I was proud of our effort," Hellige said. "We keep taking steps in the right direction and grow a little each day. I feel like they're learning our system. Were taking little steps forward every time. Our plays were way out of whack the first two games and we're still not there, but we're getting closer."

Holy Trinity ended a four-game road stretch with the loss, but gets it's first home test on Friday night as Cardinal of Eldon rolls into town.

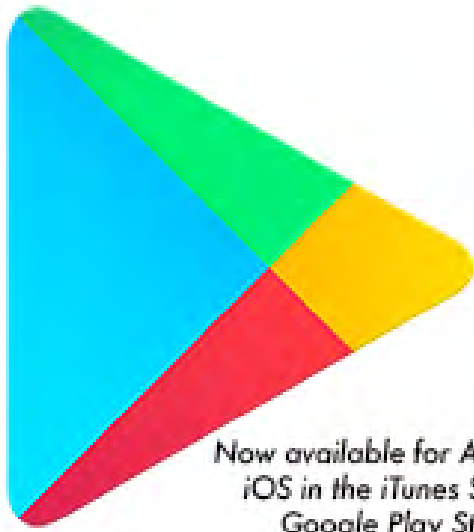

that was by the architect, but last week I heard you and Ed admit that it was going to be higher than that," Fedler said. "The estimate for tuckpointing was 90K and we're five times that much. If tuckpointing estimates were that far off, how far off is the \$1.5 million total. It's common sense. Its going to be far more than the

Hanson said he was not part of the study at that point.

Supervisor Don Hunold said he was voting for the extra \$4,000 but cautioned everyone that the costs are already out of line.

"I'm just saying these bids original and estimates are so far off it's not even funny," Hunold

to the folks and said we're looking at building a new courthouse what do you think, these were the numbers we used instead of these super-realistic numbers. All of a sudden we're damn close to a million dollars - we're not there yet - but we're gonna get there and that's just one building."

"Why are we second guessing the tax payers here. They spoke," Pflug said.

At that point, Board Chair Rick Larkin cut him off and then asked for a vote and the motion then passed 4-1 with Ron Fedler voting against the extra spending.

After the meeting, Pflug said he represented the whole county and was moving the direction taxpayers had indicated.

"We represent the tax payers is all I'm saying. They spelled out what they wanted here and this shouldn't get back into whether I want one building or buildings in both cities," Pflug said.

"We have to do what tax payers have asked us to do. It's not like we're spend an ungodly amount of money here. We knew this going into it that it would take x amount of money to get these buildings fixed. I do represent the whole county and that's where I'm coming from and I think we'll get where we

want to be. Let's remember what they voted on. They didn't want an \$8.5 million building, they wanted us to fix these."

County Budget Director Cindy Renstrom asked the board for a budget amendment hearing to move a \$475,000 appropriation into the local option sales tax funds to cover the costs of the repairs. The board voted 5-0, to set the public hearing on the amendment for Dec. 19 at 9 a.m.

In other action, the board:

approved, 5-0 to enroll in the National Association of Counties, which will allow county employees to utilize the services of the national group as well as providing a health discount card for residents of Lee County. The cost to enroll was \$500 but that was picked up by the regional county association.

approved, 5-0 to hire a full-time replacement maintenance foreman for the Secondary Roads department for an employee that was retiring.

approved 5-0 to appoint Larry Kruse and Kathy Gabel to the county compensation board.

approved, 5-0 an amended sheriff's fee resolution that corrected a fee for acquiring a firearm from \$15 per year to \$40 for five years.
