# City to take kink out of Avenue L this fall

Old Hwy. 61 to start this fall on the other end of town

FORT MADISON – Fort Madison will have two projects going on at the same time on the former Hwy. 61 this fall.

As part of the funds received from the state of Iowa

when it turned over the stretch of Old Highway 61 to the city, crews will begin working on straightening Avenue L at the "S" curve.

Public Works Director Larry Driscoll said that stretch of road was determined, along with the intersection of Avenue L and 27th Street, to be one of most dangerous in the city with the highest accident ratings.

"We did finish 27th Street a couple years ago and I thought that intersection was greatly improved. Some people disagree and that's fine. But on the 'S' curve the plan was to straighten this out and we came to the city council about a year ago and talked about this," Driscoll said.

The cost of the project will be around \$550,000, similar to the cost of the Avenue L/27th Street project.

The city plans to take some of the northwest curve out of the stretch of roadway and make the road curve to the southwest and then straighten out before bending back west after 36th Street.

The money to be used comes from city funds in the Old Hwy. 61 fund. The project was originally scheduled for 2022, as rebuilding the entire highway through Fort

Superintendent says Wilson's accusations are misleading, misrepresented



FORT MADISON - A current Fort Madison High School coach has shed light on alleged interference from Superintendent Dr. Erin Slater on behalf of her

son, who just finished his junior year. Ryan Wilson, the head basketball coach at Fort Madison High School, confirmed on Monday morning that he was called to a meeting with Slater in January, where the superintendent



mandated that her son get 16 minutes of WII SON playing time at the junior varsity level, or Wilson would be fired.

Pen City Current had referred to varsity sports action in an editorial that ran on Sunday. And although her son has played both varsity baseball and basketball, Wilson confirmed that the issues discussed focused on junior varsity playing time only, and the Current regrets that error.

"The thing that I want to accomplish is just getting this out there. Knowing that this isn't what Fort Madison is about. And we don't want to continue to lose





## Panthers throw cold water in Hounds' streak

FORT MADISON – Fort Madison baseball had only been shut out once in the 15 games leading up to Monday's double header against Mount Pleasant.

The Bloodhounds had already faced Mount Pleasant in a double header earlier in the season, splitting the two games 3-2, 5-2. The Panthers pulled ahead in the season series 3-1 after Monday, shutting out Fort Madison in both contest winning 10-0 through five innings and then winning 11-0 through six.

"There's a lot of things," Fort Madison Head Coach Ron Walker said about the reason his team didn't show much effort.. "There's a lot of things going on within our team and we were split up tonight with coaches at different locations. It's something we have to play through. I have to take some responsibility for it as well. But as bad as tonight was, we did not handle ourselves very well tonight as human beings and represent the Bloodhound uniform."

The story of game one was Mount Pleasant starting pitcher Jaxson Hoyle. Through four innings, Hoyle had logged seven of the teams' 12 total outs on strikeouts. Thanks to big innings to start the game, Hoyle also had the run support as well.

An error put Corbin Broeker on first to begin the game before Nik Coble walked. Clayton Lowery then brought home Broeker and Coble with a bases clearing double for the 2-0 lead. Chase Lamm then delivered with a sacrifice fly ball to put Mount Pleasant ahead 3-0 before Fort Madison got its first at bats.

The Bloodhounds didn't do themselves any favors at the dish, going three up three down, before the Panthers exploded again in the top of the second.

Mt. Pleasant added four runs before the Hounds were able to record the first out of the inning. Fortunately for Fort Madison, that out turned out to be on a double play, as Reed Fehseke made quite possibly the best fielding play of the season for the Bloodhounds. On a ball that was ripped up the middle, Fehseke drifted to his right, picked up the ball with his glove and flipped it to Jason Thurman covering second, as he then threw it down to twin brother Vasin Thurman at first for the double play.

"I was hoping that double play would give us some energy and we would start taking some at bats and start chipping away," Walker said. "Unfortunately, that did not happen."

A walk, a hit-by-pitch and a single loaded the bases for Mount Pleasant in the top of the second, before Broeker then walked to bring in the first run of the inning. Coble followed with a double to plate two. Lowery singled the following at bat to bring in one more run before the fielder's choice double play plated another run for an 8-0 Panther lead.

Fort Madison went three up, three down to end the second, third and fourth innings, before the Panthers put the nail in the coffin on a two-run shot from Brennan Bender for the 10-0 lead.

Hoyle then ended the game with a clean bottom of the fifth, as Fort Madison never sent more than three batters to the plate in any inning of the opening contest.

"First off, tip your hat to (Hoyle)," Walker said. "He came out and was around the strike zone all day and took the game to us. He came out and competed hard and came right after us. We didn't respond very well.

"We were soft with our energy level. We didn't play real hard. The first batter of the game reaches on an error, walk the next guy on four straight pitches and that doesn't set the tone very well for the start of the game. We didn't have a lot of energy and never could recover."

#### GAME TWO

Things did not improve for Fort Madison in game two, though the Hounds did compete for the first three innings.

Mound Pleasant put the first runs of the game on the board again in the top of the second inning after Trace White started the frame with a triple. Bender plated White with a sacrifice fly, before two-straight singles combined with a wild pitch helped the Panthers grab a 2-0 advantage.

The Bloodhounds showed signs of life with back-to-back singles in the home half of the second, but three straight outs

#### followed.

Three-straight singles, an error, another single and a sacrifice fly had Mount Pleasant ahead of Fort Madison 5-0 before the Hounds got an out. The sac fly was followed with another sacrifice fly ball, putting Mount Pleasant in the driver's seat with the now 6-0 lead.

The Panthers put the game on ice in the top of the sixth inning, again kickstarting things with singles. A Lamm single was followed by a White one bagger. Lamm then scored on an error before Dalton Gardner singled in White to make it 8-0. A Chase Williamson single, another Broeker single and a Coble double put the ten-run rule into effect for the second straight game, as Mount Pleasant went on to take game two 11-0.

After the game the first thing Walker had his players do was run wind sprints.

"To be honest with you, I kind of lost count," Walker said about how many down and backs he had his guys run after the combined 21-0 losing effort in the two games combined. "It had nothing to do with the score. The 21-0 wasn't why we were running. We didn't show up to compete and our body language and our attitudes were horrible tonight. It's kind of disappointing when we have the community standing behind us and we talk about taking pride in who we are. We as a team did not do a very good job about that. I apologize for the way we showed up tonight."

From a player's perspective, the same sentiment was shared about effort or lack there of, also stating the drive the Hounds once displayed doesn't seem to be there.

"I don't think we showed up to the field ready to play," Fort Madison senior Dayne Cordray said. "I knew when we walked in the gate and everybody was kind of messing around ... We weren't here mentally.

"We've just kind of gotten OK with where we're at right now with how many wins we have. We're not hungry anymore. I think we kind of lost that drive. I think we're going to get it back though here soon."

The Hounds fall below .500 at 8-9 on the year and travel to Davenport North on Thursday for another double header.

## Lady Hounds drop two to Panthers at home

FMHS has lost four of last six games

FORT MADISON – Fort Madison softball played a double header earlier in the season against Mount Pleasant. The two contest were actually the first two losses on the season for the Bloodhounds, as the two losses dropped them to 1-2 on the year.

Fast forward to June 17 and again the Hounds and Panthers competed in a Southeast conference double header, this time on the Bloodhounds' home diamond.

Much like the first go around, Mount Pleasant was able to come away with two wins in the two games, but unlike the first time the teams faced, Fort Madison lost by just two runs in both contest.

#### GAME ONE

Game one started with both teams producing three-run innings. Two doubles combined with a single gave Mount Pleasant a 2-0 lead before the Hounds recorded the first out. Cassie Powers answered with back-to-back strikeouts, before another single brought in the third run of the inning.

Olivia Williams was hit by a pitch to put a runner on for Fort Madison to start the bottom of the first. Kylee Cashman moved Williams to second on a sacrifice bunt, before a Mount Pleasant fielding error put Williams at third. Ivy Geerdes had a sacrifice groundout for the Hounds' first run, before a Powers double brought in Featheringill to cut the lead to 3-2. Neeley Rehm came in to run for Powers and scored on a Mount Pleasant fielding error the next at bat, tying up the game at 3-3.

All of the runs in the game came from two innings of play, as the next runs weren't scored until the top of the seventh inning with Powers holding Mt. Pleasant to just four hits from innings two through six. The seventh is when the Panthers' bats got hot again.

A double, a walk and a single loaded the bases for Mount Pleasant in the top of the seventh. Another single to center field plated the final two runs of the game, as Mount Pleasant went on to take game one 5-3.

Geerdes and Powers had the lone RBIs for the Bloodhounds in game one. Powers tossed 115 pitches over seven innings, giving up 11 hits and five earned runs while striking out eight.

#### GAME TWO Fort Madison led

Fort Madison led through four innings in game No. 2.

Kylee Cashman came in to score on a wild pitch in the home-half of the first, providing the only run of the game through the first four innings. Katelyn Dennis was able to maintain the lead from the circle, starting off with two three-up, three-down innings before allowing her first hit in the third on a single.

Singles were the difference maker for Mt. Pleasant in game two, as the Panthers rallied with back-to-back singles in the top of the fifth with two outs. An error allowed one of the singles to turn into a run, before another single gave the Panthers the 2-1 lead. A double in the top of the sixth inning extended Mount Pleasant's lead to 4-1.

Vanessa Golowach hit a double to try to keep things alive for Fort Madison in the bottom of the seventh, later coming in to score and make it a 4-2 game. The run was short lived, as Mount Pleasant retired the next three batters in order, coming away with the 4-2 victory and the sweep.

Williams collected the lone RBI for the Bloodhounds. Dennis was hit with the loss, throwing 101 pitches over seven innings, allowing seven hits and just one earned run while striking out seven.

The Hounds fall to 8-10 on the year and have lost their last four. They host Washington on Thursday night for a double header.



## Slater says she won't respond further to allegations

great people in our community, staff in the district, community leaders, teachers, coaches, players, whoever," Wilson said.

Wilson said he was called to a meeting Jan. 5 at Slater's office in the central office building at 11:30 a.m. The meeting included Slater, Fort Madison Athletic Director Jeremy Swink, and Wilson.

"At that meeting it came down to there would be a revamping of the athletic department and my job would be posted if playing time expectations weren't met for her son," Wilson said.

"I couldn't believe it happened. I walked out of the meeting shocked and appalled that this meeting just took place. It was a matter of now I gotta figure out a plan to make this happen."

He said Slater's expectations equated to half a game in the junior varsity contests.

Pen City Current provided Dr. Slater with Wilson's comments via email after contacting her for the article, and Slater responded via email Monday night.

'These accusations are misrepresented and misleading. As the superintendent of the Fort Madison Community School District, I will not comment publicly on school district personnel issues or employee discipline," she wrote.

"I will no longer answer accusations from a disgruntled part-time employee of the athletic department."

Slater issued a letter on Jan. 7, summarizing the Saturday meeting. Slater

said Wilson had agreed at an earlier meeting on Dec. 20 that varsity players who play junior varsity are there to get game experience and should be contributing in at least half of the game minutes.

Wilson said Slater's son questioned him about playing time and he had a conversation with him and the junior varsity coach. And Slater's son didn't get the full 16 minutes with the exception of a couple games because Wilson said that's not how his program works.

"Essentially it just came down to becoming a better basketball player and a lot of the way we play – the style we play – sometimes doesn't fit his skill set," Wilson said.

"But I'm not going to give playing time based on demands, wants and needs, and ulterior motives from parents. If you're gonna play 16 minutes, you're gonna earn it. So had I lost my job at the end of the season because an individual didn't play half a game – so be it."

Wilson said he had a conversation with Swink after the Saturday meeting to figure out a plan going forward. The two then requested a meeting with Fort Madison School Board President Dr. Tim Wondra, to discuss the issue and met with him on Sunday.

He also said the follow-up letter he received on Jan. 7, was substantially different than the conversation that took place in the office on Saturday.

Slater wrote in the letter... "moving forward , it is expected that the two varsity players that were discussed should be contributing in at least half the JV game minutes. It was recommended that

Ryan think about subbing or having to cover the JV coach game responsibilities due to the JV coach not following expectations and apparent targeting."

Wilson said the targeting language was the first time anything had been communicated to him or to the JV coach.

"Nothing had been communicated to me or the JV coach at all prior to that regarding that situation."

Wilson also contends the Saturday morning meeting violated established team rules for no parental contact 24 hours before or after a game. The Hounds played Fairfield on the Friday night before and then Albia later that night after the meeting.

"That was a violation out of hand, but also was she coming at me as a superintendent and using that power and authority, or is she coming at me as a parent?" Wilson said.

\_\_\_\_

"And why does it have to be in the superintendent's office. This is an athletic situation, why wasn't it at the high school in the athletic director's office?"

Wilson was also reprimanded for discussing the issue with people outside the district. The reprimand was signed by high school principal Greg Smith and Swink.

The reprimand was a big factor and Wilson said his position as Executive Director was also a concern for him in not coming forward sooner.

"There was some thought that I could be done and things went through my head and I was losing sleep at night over was it really worth

it. This is what I do at the Y, I work for the kids and create programs for the community. Coaching is a huge part of my life... Ideally, I'd think I can continue coaching," he said.

A video surfaced Saturday that showed Scott Slater, Dr. Slater's husband, confronting Wilson and calling him 'vindictive' in a 20-second exchange. Most of the video is inaudible.

Scott Slater was also suspended for a game by the district for violating team rules about a parent approaching a dugout during a baseball game this spring.

The Slaters have open enrolled their son out of the district for the upcoming school year.



## Council ready to bump sewer rates

Madison was planned with the money from the state. At the same time, the city will begin work on the stretch of Old Hwy. 61 from 2nd Street to 6th Street. That project has been delayed for a year.

"We started that project in 2018 and had some delays through the state," Driscoll said.



He said, answering questions from Councilman Chris Greenwald to explain the delay, the state history and archeological officials got involved and wanted to make sure dig sites were done to help protect any potential history in the ground.

"We initiated the startup for construction and designs in the spring and we just now finished all the documentation they wanted last month, so we will bid that section of road in July," Driscoll said.

He said the city made a compromise with the state historical society to regulate how the city will proceed with digging on the highway, at an additional cost of \$100,000.

'This has slowed us down to the tune of about 12 months," Driscoll said.

Greenwald then asked how many blocks of overlay on Avenue F the city could get for \$100,000 to which Driscoll replied five.

"That's putting a price on history," Councilman Rusty Andrews said to Greenwald with a chuckle.

"I find that comment out of line," Greenwald replied. The detour will use 34th Street and Avenue M for motorists to get around the construction as Driscoll said the city will completely shut down that stretch of road, after talking with business owners in the area. The shut down will take 30 days off the construction time. The council approved a resolution ordering the construction, setting public hearing and bid letting for the

project, 6-0. Councilman Chad Cangas was absent.

In a related issue, the council moved forward with having Driscoll get designs to reconstruct the lower parking lot in Riverview Park to allow access to the depot museum during high waters. The city will also redo the parking lot at Avenue F and 8th Street. The cost is at about \$880,000 and will come from the reimbursement of interest paid on the waste water treatment loans.

That money was originally earmarked for the Avenue G sidewalk project. That project popped when estimates came in almost double what the city's engineering firm had originally estimated. The funds have to be used for storm water projects. The parking lots will have permeable pavers and a base to allow storm water to be absorbed by the lots rather than run into the city's storm sewer system.

In other action, the council:

• voted 5-1 to approve a second reading of sewer rate increases that will bump overall sewer rates on an average home using 4,000 gallons per month about 13% over the first two years. The ordinance needs a final reading before it takes effect.

• voted 6-0 to authorize Driscoll to file an application with the Iowa Department of Transportation's State Recreational Trails program for construction of Connecting Fort Madison! Phase 4. Phase 4 would connect the path from Baxter Sports Complex to River Valley Road on the west side of 48th Street.

• voted 6-0 to spend \$8,662 on eight computers for the Fort Madison Police Department's squad room. The department will also soon be getting onboard computers for vehicles and City Manager David Varley said the state will be picking up the tab for those computers.
