Alliant wants \$204 million annual rate boost

FORT MADISON – For the second time since 2017, Alliant Energy, will be asking the Iowa Utilities Board for a rate increase.

Alliant's Iowa electric utility, Interstate Power and Light Company is requesting the new rates beginning Jan. 1, 2020. Alliant said the rate increase will generate \$203.6 million annually across all classes of service.

A mailing sent out to its Iowa customers indicates that investments in windfarms, energy grid technologies, including advanced metering infrastructure and

environmental controls reducing emissions, are driving the request for additional revenues.

A chart in the mailing shows a 24.5% base increase in residential rates taking a typical bill with average usage of 756 kilowatt hours per month, will climb from \$82.31 to \$102.44 for an increase of \$20.13.

On April 1, the company will begin charging an interim rate increase which is allowable by law, to allow the Iowa Utilities Board to investigate the rate increase proposal.

That rate will be a 5.5% boost, as part of the overall request, and is subject to refund with interest should the IUB decline the rate increase.

The IUB has 10 months to complete a review of the request, which was submitted on March 1. At that time, the IUB will establish the final rates.

Fort Madison Partners Executive Director Tim Gobble said Alliant provides some of the best service in the country and continually invests in Iowa's infrastructure.

"Obviously, we value the excellent service and our relationship with Alliant Energy," Gobble said. "They have continued to make large investments in the state with wind and natural gas and they need to see earnings from those investments, but these rate propos-

Group plans Battle of the Badges

FORT MADISON – Plans are underway for a tri-county event to raise funds for emergency responders in the Lee, Des Moines, and Henry counties this summer in Fort Madison.

Cale Heitmeier, a Burlington firefighter, has been engaged with raising funds for emergency responders for five years through his Boots vs. Badges charity softball event in Burlington.

This year Heitmeier is teaming up with Fort Madison's RiverFest, YMCA, and Baxter Sports Complex marketing director Shawna Ross to bring an event to Lee County on July 13th, 2019 at Baxter Sports Complex in Fort Madison. Proceeds to benefit Henry, Des Moines, and Lee county's emergency responders and Department of Corrections

The event is scheduled for July 13th at the Baxter Sports Complex and will feature a 5K run that is open to the general public at 8 a.m. and then a kickball tournament with teams made up of employees and volunteers of emergency response units including police, sheriff departments, EMS services, dispatch officials, and Department of Corrections staffers.

patients with a terminal illness.

The training class prepares volunteers to work with terminally ill patients and their families. Topics covered are: Hospice program and services, the volunteer's role in helping patients and families, communication techniques, comfort/care measures, grief process and how to help someone in grief. Volunteers are required to have a criminal background check and to receive a TB test before working with hospice families.

“One of the biggest concerns of new volunteers is the idea that they would like to be a hospice volunteer but feel maybe they are not quite ready to volunteer in a client's home. We encourage them to take the class anyway and then set them up to volunteer in the office or with community events until they are ready,” stated Jeri Giebelhausen, Support Services Coordinator.

Hospice started over 40 years ago as a total volunteer organization and now with Medicare guidelines Hospice requires that a percentage of direct client care be provided by volunteers.

Lee County Health Dept-Hospice started 30 years ago and has been very fortunate that over the years that so many community members have supported the program by becoming volunteers.

“We still have a few of the seasoned volunteers that went through the training back in the early 1990's with our organization today.” Giebelhausen shared, “Families are very grateful for the time volunteers spend with their loved ones. We know we could not run the program without them.”

Lee County Health Department – Hospice is a Medicare certified program providing in-home care and support services to the terminally ill and their families in their homes and nursing facilities in the Iowa counties of Lee, Des Moines, Van Buren and Henry and in the Illinois counties of Hancock and Henderson.

Heitmeier said Ross and RiverFest Director Charles Craft have had conversations about the event after RiverFest became a sponsor of Boots vs. Badges' annual slow-pitch softball event last year.

"We formed a partnership when they sponsored my event and then we got to talking more about co-sponsoring an event together to make more money for public safety, in a way that would be fun and entertaining for everyone who wanted to participate."

The event on July 13th will kick off with an 8 a.m. 5K Hero Run/Walk managed by the Fort Madison YMCA. The public is encouraged to participate. Entry fee is \$25. 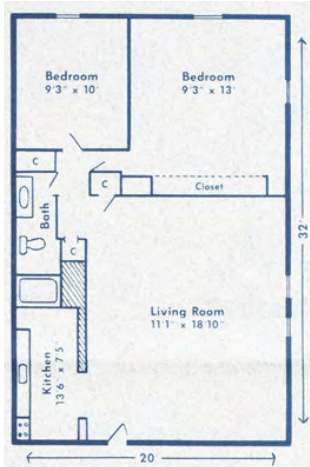
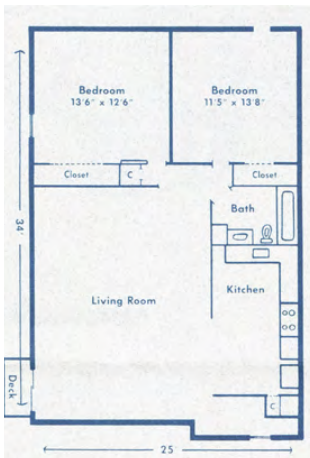
