# City officials to take up fireworks ordinance

City Manager says item will be on agenda for discussion at next City Council meeting

FORT MADISON - City officials in all likelihood will be working on the city's fireworks ordinance at a meeting this month.

City Manager David Varley indicated at the end of Tuesday's regular city council meeting that discussions on the ordinance could be up for debate at the next council meeting in October.

The topic has come up on several occasions since the state legalized sales in VARLEY Iowa beginning in 2017.

The item was listed on the agenda as topics that could come up at a future meeting and Councilman Mark Lair asked what the time line was because many of the complaints are coming from people in his ward.



I have people asking if they are going to get anything done with the fireworks ordinance before the Jan. 1 deadline when they're allowed to have them again.

"A lot of these complaints are coming from people in my ward so I'm just asking if things are going to happen before the next time fireworks are allowed again around January," Lair asked.

Mayor Brad Randolph said that was the plan.

Varley said the council could have the item on the next agenda for discussion.

## Several injured in Tuesday Wever mishap

The apartment's located at 2815 Lincoln Avenue lost their management group Keyway Management Group in December and Pflug, Wood and partnership board member Steve Celania have been overseeing day-to-day operations of at the facility.

"Since that time Matt and I have unilaterally managing that on a voluntary basis to try and keep things together knowing that neither one of us has sufficient time and energy to do it to the utmost ability that it should be done.

WEVER - At least one person was injured in a two-vehice accident in Wever near Grace Bible Church at about 7:45 p.m. Wedensday night.

According to LeeComm dispatchers, Wever Fire and Rescue, Lee County Sheriff's deputies and Lee County

EMS were called to the scene where two-vehicles had collided on 175th Street just east of Hwy. 61.

Rescue personnel tried to call in AirEvac and Med-Force helicopters for the injured person, but no helicopters were available and Lee County and Burlington ambulances were called to the scene to transport the injured.

Dispatchers indicated that two rollover accidents in Henry County both required air support and weather was hindering access to services out of the Quad Cities. No names or conditions were readily available. She said marketing has slipped due to time constraints and as the number of residents drop so does the financing of the property.

"Acting as property manager in light of not having a registered property manager at this time, we're investigating the possibility with your permission to transition that property under the umbrella of Lee County once again," Wood said.

FORT MADISON -Seniors Taylor Boeding and Emily Box combined for 28 kills as Holy Trinity swept visiting West Burlington Thursday night in Southeast Iowa Superconference action.

Boeding had one of her best nights on the court with 15 kills on 33 attacks. Boeding also had 10 digs patrolling the back side of the court for the Class 1A No. 3 Crusaders and went 9 of 9 serving with one ace. Box had 13 kills on 33 attacks and was 13 of 13 serving with one ace.

Holy Trinity improves to 26-2 on the season with its only losses coming over the weekend to Class 5A powerhouses Ankeny Centennial and Waukee in Urbandale.

Sophomore Bailey Hellweg has 19 assists and freshman Kassi Randolph had 17 to set up the attacks. Hellweg also was 19 of 19 serving with two aces. Senior Mya Lawlor was 14 of 15 with four aces on the night. Box had four blocks at the net.

**Regional pairings** were also announced on Monday night. Holy Trinity will get a bye in Class 1A Region 8 action. The top half of that bracket includes WACO, Burlington-Notre Dame, Moulten-Udell, Seymour, Moravia and Twin Cedars.

Holy Trinity will play the winner of the WA-CO-Burlington Notre Dame match up, which is Tuesday, Oct. 16, on Monday Oct. 22 at 7 p.m. at HTC.

Third round games are set for Thursday, Oct. 25th at 7 p.m. with locations to be determined and the regional final will be played on Tuesday Oct. 30th at Ottumwa's Evans Middle School at 6 p.m.

FORT MADISON - The Fort Madison Bloodhounds squandered a 2-0 lead Tuesday night and fell in five sets to visiting Fairfield in Southeast Conference high school volleyball action.

Class 4A regional pairing were released Tuesday night and the two teams are on a collision course for a season tie-breaker.

Fort Madison has a bye in the bottom half of the Region 8 Class 4A six-team bracket and will face the winner of the Oct. 17 Fairfield-Mt, Pleasant matchup on Oct. 23 in Fort Madison at 7 p.m. At the top of the bracket is Class 4A No. 2-ranked Cedar Rapids Xavier. The Hounds were eliminated by the Lady Saints in the regional finals in 2017.

The regional finals would be played at the home of the highest ranked team on Oct. 29th at 7 p.m.

Other teams in the bracket include Washington and Keokuk who play in Washington on the 17th at 7 p.m.

In Tuesday's action, the Hounds won the first game in fairly quick fashion 25-17 and had to come back in the second game from being down as much as five at one point to win 25-21.

The Hound then dropped the third and fourth games 22-25, 23-25 and fell 14-16 in the first-to-15-by-2 tiebreaker.

"We missed out on some opportunities in games 4 and 5 to win it. We had the momentum and made a serving error along with a couple of hitting errors," Bailey said.

"This was a hard fought match between two good teams. Ultimately, Fairfield made the plays and pulled it out. Give them credit. We will learn from this and get better."





"The fireworks ordinance will be on the next agenda. We're gonna put a proposed ordinance for the council under discussion items and throw out here's what we have and let you disucss is and if you want ot change the times or days or whatever than you can discuss it and then we'll bring it back to a following meeting once we have a consensus form the council on what you'd like to do.

Varley said the item won't be on the agenda for action, but discussion and then action could be at a follow up meeting.

City Police Chief Tim Sittig said he and Fire Chief Joey Herren have been working on a proposed ordinance looking at other ordinances in the state.

Residents at three straight city council meetings this summer complained about the how the fireworks were effecting family, pets and neighborhoods.

Randolph said this summer that he wanted to take a look at the fireworks ordinance after being downtown during the city's 4th of July celebration and observing what he called a "free for all" and fireworks going off in places they shouldn't be.

Current city ordinance is the same as state ordinances

The Iowa State Fire Marshals office listed three locations in Fort Madison that sold fireworks this summer including Bellino's Fireworks Tent at Fairway, Dollar General, which sold only second class fireworks, and the Fort Madison High School Football team sold under the license of RiverFest as a fundraiser in Hy-Vee's parking lot. Bellino's sold only first-class fireworks. The tent at Hy-Vee sold first- and second-class fireworks.

City Finance director Peggy Steffensmeier said the city has no way of telling how much revenue from the 1% local option sales tax was generated from fireworks sales as the state pays the city 90% of projected total sales in the city and then in November does a catch up for the difference.

Iowa laws allow for the setting off first and second class fireworks from Dec. 10 through Jan. 3 in the winter from 9 a.m. to 10 p.m. and from 9 a.m. Dec. 31 to 12:30 a.m. Jan. 1.

She said she will be going to region board to inquire about financial assistance at that time so that financing of any sort not from rent, could be possibly come from regional sources.

She said there is an active request into the Iowa Finance Authority to discover what would be the repercussion to close down Great River Progressive Housing and Lincoln Ridge Limited Partnership with the intent of moving under the county government umbrella.

"Once we have that information back, we will have a better idea of what the pros and cons are for that," Wood said.

Pflug said there are 16 apartments and right now there are nine people renting at the facility.

He said the facility is paid off but it's a tax credit property and the partnerships have to guide by certain guidelines. He said no management firms have expressed an interest in running the facility. He said the partnership is looking at possibly using money from the county's Fund 10 which helps fund mental health programs.

"The problem is our check book is getting low and the building is getting old and it's taking more money to take care of things. Census is down and we're not seeing a batch of new people coming in and the situation is getting urgent," Pflug said.

Supervisor Ron Fedler asked if the county took over what department would it fall under. Wood said it would move back under the county's mental health department.

Supervisors recommended that the Wood get back with supervisor's as soon as she here's back from the state's finance authority as to what hoops need to be cleared before the county could consider taking ownership of the facility.

The apartments were built for those needing transitional and supportive care, but Wood said the apartments are open to the public but require low-income guidelines.


