## LCEDG gets another state program award

DES MOINES – The Lee County Economic Development Group continues to collect plaques for the walls of the Keokuk office as state groups recognize the local efforts to bolster business retention and expansion.

On Thursday, LCEDG COO Dennis Fraise and Dana Millard, the group's marketing project manager, were on hand to receive the award from the Best in State Overall Business Retention and Expansion Program from Gov. Kim Reynolds at the SMART Economic De-

velopment Conference in Des Moines.

Millard said the award is the third in four years from the Professional Developers of Iowa and is a testament to the collaboration going on

in Lee County between industry and manufacturing leaders and the LCEDG's highly touted Grow Lee programs. She said it shows the power of what's happening locally in Lee County.

"I believe it does. People want to be associated with successful organizations and programs and this is another third party validating that what we're doing here in Lee County is a success," Millard said Monday morning.

The award recognizes the overall efforts of LCEDG for healthy business retention, including the group's 12-Plus program and the Basic Industrial Tech certification that was recently created.

She said a lot of communities are still trying to find

## Thurman twins return in doubles

*FM, Keokuk, and Central Lee runners qualify in track*

FAIRFIELD – The fun story of a couple of twins from Holy Trinity Catholic continues to unfold as Jason and Vasin Thurman earned a return trip to the Byrnes Park Tennis Center in Waterloo May 24-25th and the Iowa State Tennis Tournament.

This time the two, who play for Fort Madison High School in a shared tennis program, will be taking HTC senior Sam Avery along for the ride.

The Thurmans swept through the doubles field at Friday's Class 1A district tennis meet at Fairfield Middle School and will have a seeded-spot at the state tourney.

Senior Sam Avery was the top seed at the districts in singles action, but was tripped up by West Burlington/Notre Dame's Travis Wills in the finals 6-3, 6-3.

"He played a really thought-out match and was really consistent today. He really played a good match and was more relaxed than I was. He's a good player," Avery said.

In 2018 Avery teamed up with senior Austin Krueger in doubles and just missed following the Thurman's to the state meet, so the trip this year is a goal reached.

"I've been trying to do this since I was a sophomore and I'm really glad to know I am able to do it in my senior year."

Avery got a bye in the first round and then knocked off Mt. Pleasant's Clayton Henriksen 6-1, 6-0. In the

# Keokuk's Haner just misses tourney again

semi's Avery moved easily past Davis County's Luke Snyder 6-2, 6-1, to set up the championship with Wills.

Wills dumped Keokuk's Abbot Haner in the semi's 6-1, 6-4 and then got a 20 minute break before the title match.

Avery opened the match with a win on serve, but then Wills would take the next three games for a 1-4 lead. Avery would break Wills service to go to 2-4 and then would close out his next service game to get with in one at 3-4 in the first set.

Avery, touting one of the fastest serves in the field, had trouble getting his first serve in and was regularly forced to put the second in play allowing Wills to get into each point. Wills would break Avery at 3-6 to win the first set.

In the second set Wills jumped out to the early lead 0-1, but Avery would battle back to take a 3-2 lead. Wills again would break serve in the next game and then retake the lead 4-3 on his own serve. Avery struggled again to get his first serve in and was broken again to trail 3-5. At 0-30 in the final game, Avery just missed on a running forehand to his right that fell just outside the lane, and a strong overhead by Wills put the match away on the next point.

Avery will go to the singles tournament in the at-large pool. Wills will get a seed for winning the district.

The Thurman twins had very little trouble in breezing through the districts receiving byes in the first two rounds. The duo drubbed Keokuk's Kaden Stoneking and Callum Tackes 6-0, 6-1, before rolling Davis Coun-

ty's Kade Tharp and Noah Zmolek by the same score.

The two then faced off against Mt. Pleasant's Corbin Broeker and Jaxon Hoyle.

Hoyle and Broeker took the Thurman brothers to a 6-5 first set lead and had the Bloodhounds off balance. A short conversation with head coach Dean Hogan seemed to right the ship as the two won the next two games for a 7-5 first set win and then rolled to a 6-2 win for the title.

"They stayed in the mode they usually do and took to openings created by the opposition," Hogan said. "They're good about getting the ball deep into the court and they just have that natural chemistry being together their whole lives."

He said the two had to wait so long between matches, it kind of hurt their cadence in the title match.

"We talked about energizing and moving feet faster and attack the net as we do in other practices and dual matches. They were just playing flat and realized they weren't playing up to their potential and they did," Hogan said.

"These kids at Mt. Pleasant and the Wills kids at Notre Dame are just like backboards and they keep the ball in play."

Hogan said Wills just kept more balls in play in the title match.

"Travis is a backboard himself and today he seemed to have a higher percentage of shots in. They both played the net very well. Sam came up short, but he's working hard and playing hard."

Fort Madison won the district team event with 20 points and advances to substate team action in Pella Saturday morning.

Vasin Thurman said having a year of state experience under his belt will help this year.

"We know that's going to be a lot tougher competition than there is here, but we're ready for that. We've been preparing for that since last year," Vasin said.

"We see a lot different stuff up there and those guys play a lot of tennis and hit the ball a lot harder than we're used to seeing."

Jason said success this year will be not to finish where they did last year, which Vasin said with a smile, was "dead last."

"We're more prepared this year. It's still going to be tough tennis, but we'd like to finish in the top 8, maybe top 5," Jason said.

Keokuk sophomore Abbot Haner captured third place in the singles division with a consolation win over Snyder. He just missed the tournament last year in doubles.

Haner also sent the Bloodhounds' Reed Fehseke home in the second round with a 6-1, 6-4 win.

Fehseke is playing in his first year of organized tennis and won his first match over Austin Dell of Centerville 6-0, 6-0 before falling to Haner.

"It was really whoever was serving was in command until the very end and then he started hitting to my backhand. He's a good player and pretty smart," Fehseke said.

Haner said he's struggled finding control of his backhand this year and Wills was able to capitalize on that.

"I thought I played well on my serves and forehands, but my backhand need a little work," the sophomore said.

"Wills kept nailing them at my backhand and it's not good enough to keep all the balls in play, but I'll work on that more."

Fort Madison Levi Sissell and Bryce Workman were eliminated by Davis County's Trevor Slayton and Carson Zeitler, 6-0, 6-2 in first round action.

# FM, Central Lee girls shuttle hurdle teams qualify

MT. PLEASANT – It was a bittersweet day on Friday afternoon for the Fort Madison Bloodhound boys and girls track team...but a bit more on the sweet side.

The Hounds qualified six runners for state at the State Qualifying event held Friday afternoon at the MapleLeaf Complex in Mt. Pleasant.

Junior Matt Hellige will be running in both the 3200- and 1600-meter runs at Drake Stadium on Thursday and Saturday. Hellige finished second to Mt. Pleasant's Cody Mertens in both events Friday. Mertens suffered an injury at the beginning of the season and had been closing in on Hellige gradually throughout the year.

Mertens' win in the 1600 was the first time he'd beaten Hellige in that event this year.

Quentin Schneider will represent the Hounds in the 400-meter hurdles with a second place 56.60. Schneider was a second behind Fairfield's Ethan Hunt.

The girls shuttle hurdle relay team of Reyna Lampe, Taylor Barnes, Olivia Williams and Raquel Schneider surprised everyone by beating their season best by close to six seconds and took second for an automatic bid.

Schneider was a late-season addition to the squad and ran the final leg trying to catch Mt. Pleasant speedster Karsyn

Lamm. Mt. Pleasant won the event at 1:09.62, while the Hounds were right behind at 1:10.37.

Head Coach Brian Mendez said Schneider, who's a freshman this year, was informed on the van ride up that she would be running her leg against Lamm.

"Oh no!.....Who's that?" Schneider said.

It will be the first trip to state for the either of the four girls and Williams, the

only senior in the group, said she's was surprised by the time.

"We just were trying to do our best and PR. We knew we'd have a shot at qualifying, but we didn't know we'd have that time," she said.

Mendez said Fort Madison girls haven't qualified in a hurdle event in a long time.

"We've had most of our success in distance events. If you were to tell anyone

back in Fort Madison that we qualified in the shuttle hurdle they probably wouldn't believe you," Mendez said.

The girls numbers were way down this year, but Mendez said the performance of the shuttle hurdle exemplifies what the year has been like.

"Never once have the girls given up this year. We tell them we need another second or two and they go get it. We've

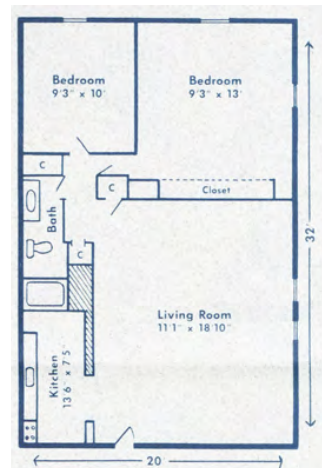
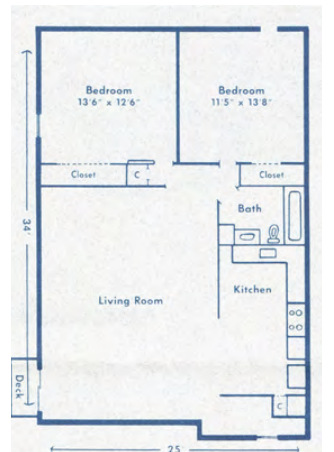

# Hellige returns to state in 3200, adds 1600

had personal records all through the year...but this was six seconds better. I don't even know where that came from," he said.

Hellige is the only Bloodhound returning to Drake Stadium for the state meet. He qualified in the 3200-meter run as sophomore where he finished 22nd with a time of 10:36, but had a season best 10:08 in 2018 and has run a sub-10 minute time on several occasions this year.

"Getting here I just had a good feeling about tonight. It was sunny and not too windy and really good race conditions," Hellige said.

"This race I really just wanted to give it my all and try my best to qualify. I have had some really good races in the 3200 and 1600 this year and I don't necessarily think this was my best effort but qualifying was the most important thing tonight."

In the 1600, Hellige crossed at 4:36.95, 3.4 seconds behind Mertens.

Schneider will be making his first trip to the state tournament qualifying with 56.60 in the 400 hurdles, about a full second behind Washington's Ethan Hunt. Schneider's time puts him in the top 40 runners in the state in that event. Hunt has a 55.47 time that has him in the top 20 in the state.

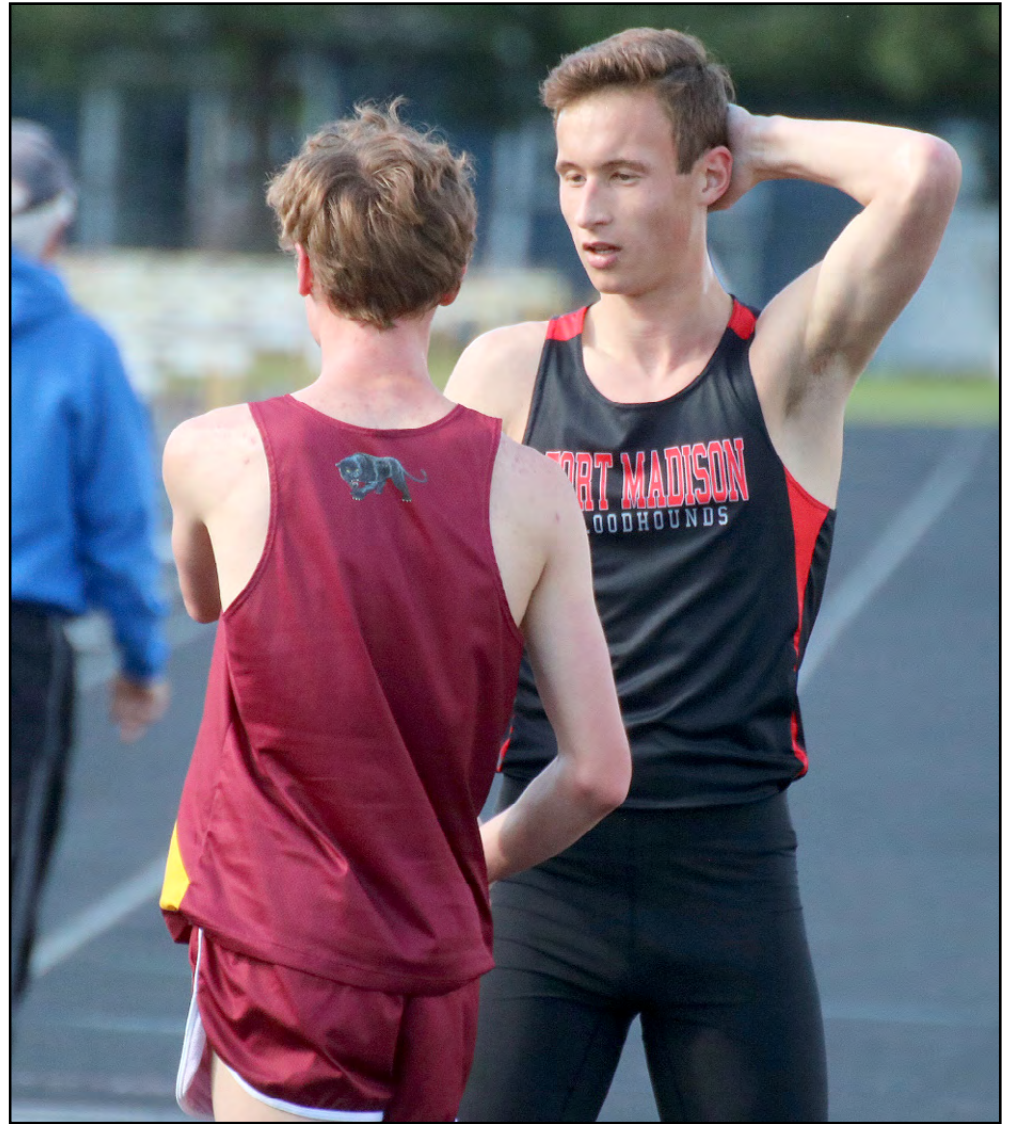
Schneider had about a 10-meter lead after the third set of hurdles, but Hunt caught up to him on the fourth turn and outraced him down the final 90 meters for the win.

"I always want to be the first one to the first hurdle that's kind of my goal. I think it's 5.66 to the first, that's what I think it should be, and then keep that pace going. Then on the back stretch kick it in as much as I possibly can," said a winded Schneider after the run.

"I'm happy that I get to go to state. I would have loved to win, but Ethan Hunt is a fast kid."

The bitter of the event came in the 4x400 relay team. The Hounds won that event at the conference meet last week with Brock Califf, Garrett Hannum, Andrew Schaeffer and Schneider with a 3:34.19. But came in fourth Friday behind Washington, Mt. Pleasant and Centerville, who finished the night's events with a trio blaze to the line that brought the crowd to it's feet.

"I think we kind of had a target on our back in that event after winning the conference meet," said Fort Madison's co-head coach Mike Schneider. "We had high hopes

for that event, but Mt. Pleasant I think had a bit of a different team and Washington just ran awesome."

Co-Head Coach Chad Hannum, said the boys have run hard all year.

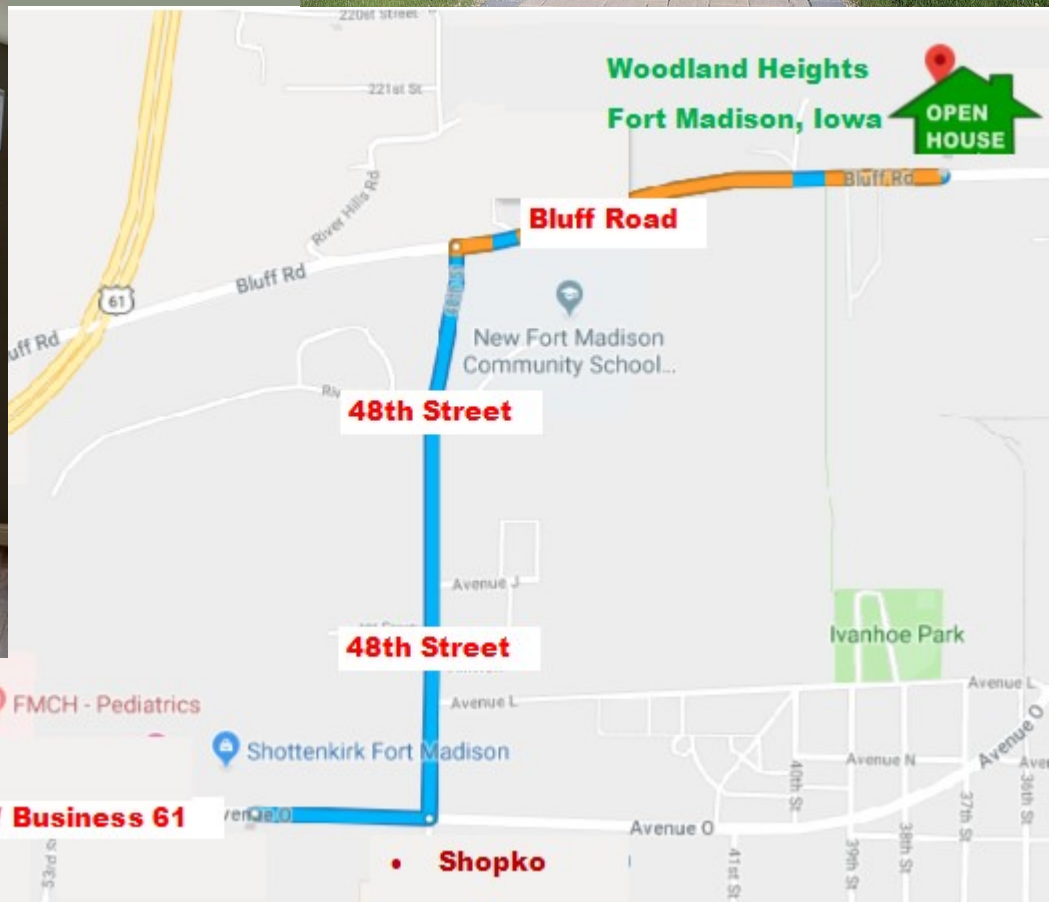
