## District moves ahead with facilities assessment

*Hotop, Menke question whether move violates policy*

FORT MADISON – The Fort Madison School Board was updated Monday night on the progress of a facilities’ assessment that is scheduled to take place in the coming months.

At Monday’s board workshop, things got a bit tense when board members Jared Hotop and Brad Menke questioned why the recommendation from the district’s facilities committee wasn’t brought in front of the board.

Board member Brian Steffensmeier read a prepared statement to the board that indicated FMCSO Director of Operations Nic Chiri is moving forward with the facilities study with Estes Construction, a construction firm with offices in West Des Moines and Davenport, that specializes in K-12 educational planning.

The Iowa Association of School Boards has worked with Estes to create the Iowa Construction Advocate Team. The program offers what it calls an Integrated Project Delivery model which has been used by many Iowa school districts, including recently Burlington and Central Lee.

According to the statement, “Any future solution,

whether it’s new construction, renovations, or additions, will require the district to pursue financing options for funding improvements.”

Those possible funding sources could include a Physical Plant and Equipment Levy (PPEL) which board member Carol Ross said would require a 50% +1 approval from district voters; general obligation bonds; and/ or local options sales tax, now called SAVE, funds, which would require another approved Revenue Purpose Statement. That statement would also require a 50% +1 approval.

The district last approved an RPS in September 2009 with a 54.3% approval. In August of 1999, district voters approved using local option sales tax money for

## Voters to pick school, city officials today

LEE COUNTY – Voters in Lee County will go to the polls Tuesday in a heavy field of candidates for area city and township elections, along with school board seats.

For the first time in more than two decades the Fort Madison mayoral election doesn’t feature an incumbent. Current Mayor Brad Randolph indicated this summer that he would not be seeking re-election to the post.

Randolph has served as mayor since the death of Steve Ireland in 2012. Fort Madison businessman, current 3rd Ward councilman, and former Lee County supervisor Matt Mohrfeld has to be considered the front-runner for the seat.

Newcomer Joe Helmick is running in a grass-roots campaign as the non-establishment candidate. Helmick’s a meat cutter at Fareway Grocery and campaigns as the average Joe and fresh face of city leadership. Rodney Hoskins II is also on the ballot. Hoskins has previously run for city council.

1st Ward councilman Chris Greenwald also announced this summer that he wouldn’t be returning to the council this term. Iowa State Penitentiary executive officer Rebecca Bowker, and Over the Road operator/owner Chris Sorrentino are in a ramped up battle for that seat. It’s Bowker’s first foray into public office. Sorrentino challenged Randolph for the mayor’s seat two years ago.

The At-large seat up this election is a hotly contested seat between four-term councilman Kevin Rink and





newcomer Jerry Hamelton. Hamelton's embarked on a fiery campaign and, at the center of the debate, is the newly approved golf cart law and the idea of a franchise tax to help the city out of financial woes.

Rink supported the golf cart/ATV ordinance. He is also open to the idea of a franchise tax on city utilities to help bring the city out of debt. Hamelton calls the idea of a franchise tax morally corrupt and said wasteful spending is to blame for budget woes. He also has called Rink out for not representing the voice of the people in voting for the new golf cart/ATV ordinance.

The 3rd Ward seat is also being vacated with Mohrfeld's run for mayor. Twenty-one year old Tyler Miller is the only candidate for that spot. Chad Cangas is running unopposed for the 5th Ward seat.

In the Fort Madison School board seat, four seats are open with six candidates.

Incumbents Dianne Hope, Jared Hotop, Carol Ross, and Lois DiPrima are trying to hold onto their seats while Josh Wykert, who held a school board seat for about two months, is seeking a more permanent position. Newcomer Candice Smrt is also running.

The new board will again be saddled with trying to find a solution to aging elementary schools as well as how best to utilize the extension of the state's Secure an Advance Vision for Education (SAVE) funds through 2050.

Elsewhere in north Lee County, Houghton has six candidates for five Council member seats with Marty Bentler, Cheryl Brock, Jay Henrich, Kurt Lowenberg, Russell Schwartz, and incumbent Andy Wilson all seeking seats. Gale Thompson is the only candidate for the mayor's seat.

Donnellson has no contested seats with Jennifer Estrada and Jan Fraise running for two at-large seats and Brian Moeller and Selissa Weber are running to fill two at-large vacancies.

Montrose incumbents Mayor Ron Dinwiddie, and council members Jeff Junkins and Darcie Uhlmeier are all seeking re-election unopposed.

St. Paul Mayor Janice Neuweg is running unopposed and incumbents Rod Cox, Mark Hymes, Randy Neuweg, and Stephanie Schinstock, all incumbents, are running with John Dingman for the five open seats.

Central Lee has three seats open on the board with Kimberlee Hasek (District 1), Bill Young (District 2), and Mark Hulsebus (District 3), all running unopposed.

In West Point, Mayor Paul Walker is unopposed, while all five current city councilman Bruce Wellman, Dan Waters, Will Stuekerjuergen, Brian Meierotto, and Joseph Loving are all on the ballot again for the five seats.




# Policy says committee recommendations are to come to board for action

educational purposes with a 54.5% approval. However, at the time, that vote didn't carry a sunset clause, so state legislators later imposed a 2030 sunset on approvals throughout the state.

Approval of the RPS would allow the district to borrow on SAVE funds, which were recently extended by state legislators through 2050. According to board president Tim Wondra, the district can't use any of the SAVE money until after the middle school has been paid off.

Superintendent Dr. Erin Slater said the earliest the district could put the RPS in front of voters would be in March.

But Hotop and Menke expressed concern that the board may have violated board policy by not bringing the recommendation before the board before moving forward with the project.

According to the School board policy 208-R, "The Board of Directors possesses certain legal powers and prerogatives which cannot be delegated or surrendered to others. Therefore, all recommendations of an advisory committee must be submitted to the Board for action."

"It looks like decisions were made and, according to our policy, committees are to recommend things to the board. It looks like the decision was already made and I hadn't seen any board voting come across for that \$22,000," Hotop said.

He said he was in favor of moving forward with the assessment, but argued the board was breaking policy by not allowing board action.

School policy doesn't, however, require board approval on consulting services that don't exceed \$25,000.

Slater said the committee made the recommendation to have Chiri to spend the money on the assessment because it was under the \$25,000 and a vote by the board wasn't required.

"This did not meet that threshold. This is a staffing decision by the facilities committee to recommend that Nic's department conduct this assessment. Once the assessment is done, we will bring it back for any decisions that will be made by the board," Dr. Slater said.

Menke said he was in agreement with Hotop and said committees are a board tool for research and not to tell people to spend money.

"If you would have brought it in front of us, it would have gotten voted on," Menke said.

Steffensmeier, who sits on the committee, said he agreed that it should have been brought in front of the board.

"I agree, Jared, to get transparency we should have had a vote on it," Steffensmeier said.

Hope said the transparency is in the letter of the recommendation and any talk of a general obligation bond is off the table.

"What we're looking at is our facilities as a whole and what do we need to serve our students based on what we currently have," Hope said.

"The transparency is coming here at this point in time. It's an interim report, because the facilities report will be coming from Estes and that will be shared with the facilities committee and then it will come to the board."

"(The policy) doesn't say the board will vote on anything," Slater said. "Recommendations will be brought to you. You're being informed about the recommendation that was made."

Ross, Steffensmeier, and Hope, along with District Director of Marketing and Online Technology Sebastian Seifert, Marketing Specialist Kayla Schwartz, Slater, District Business Manager Sandy Elmore, Curriculum Director Kim Harmon, and Chiri all sit on the committee.

Wondra, along with Hope, DiPrima, and Ross all indicated that the committee is working properly by recommending Chiri move forward with the project, which is expected to begin immediately and last about two weeks.

# City outlines leaf burning rules

SUBMITTED ARTICLE

FORT MADISON - The City of Fort Madison Fire Department will allow the controlled burning of leaves only from November 9 to December 8, 2019 without application for a temporary burning permit, subject to the following restrictions per International Fire Code:

1. The open burning of leaves shall only be allowed from one hour after sunrise, to one hour before sunset.

2. No open burning will be allowed on any Public Street, alley, or sidewalk.

3. The location of the burning area is not less than 50 feet from any structure or not less than 15 feet from any structure if an approved waste burner is used.

4. A competent person shall constantly attend all fires until the fire is completely extinguished.

5. A working garden hose or other fire extinguisher is readily available for use.

6. Any fire causing a nuisance or reported discomfort shall be immediately extinguished.

7. The Fire Chief may prohibit any or all open burning when atmospheric conditions or local circumstances make open burning hazardous.

Applicants for temporary fire permits for any purpose must be obtained from the City Fire Department.

Adherence and conformance with these procedures outlined should be of positive benefit to the citizens of Fort Madison.

The City of Fort Madison hereby notifies the citizens and property owners of the proper procedures for disposal of the fall accumulation of leaves.

According to City Code Title 6, Chapter 3, Section 14:

**LITTERING:** No person shall throw, rake, deposit, drop, or spill leaves, litter, solid waste material or foreign material upon the streets, sidewalks, or other public rights of ways within the city.

This section of the City Code prohibits the raking of leaves into the street or alley for the purpose of disposal. The Primary reason for this prohibition is to keep the leaves from entering the storm drain system. An accumulation of leaves can block the storm drain inlets or clog the storm drainage pipes that could result in flooding.

Residents have the option of bagging leaves in approved yard waste bags for pickup by city crews or to haul the leaves to the Landfill for composting. There is no charge for dumping yard waste at the Landfill.
