FM, County may ink interim police chief deal

Deal would have city pay \$50K to county over six months

LEE COUNTY – The Lee County Sheriff's department is a vote away from overseeing the Fort Madison Police Department for six months.

In front of the Lee County supervisors at Tuesday's

regular meeting will be a 28E agreement that would designate anyone captain level or higher in the Lee County Sheriff's Office as interim Fort Madison Police Chief until a permanent replacement can be found.

WEBER Fort Madison Police Chief Tim Sittig announced his retirement from the department two weeks ago effective May 31.

Under the agreement, the city would pay the county roughly \$50,000 in salaries and benefits, plus weekly stipends and any difference in salary for sheriff's staff

who step up to fill in for whomever is designated to fill the interim position.

The agreement would still need approval of the Fort Madison City Council which will consider the document at its regular meeting Tuesday evening.

Lee County Sheriff Stacy Weber could assign anyone captain level or above to oversee the police department operations during the interim period as Fort Madison conducts a search for a new chief.

The interim chief would have authority to hire, sus-

Two Chiefs, one Hound medal Friday

DES MOINES – Keokuk High School's Miracle Ailes added to her 2019 medal count, while teammate Braylon Edwards and Fort Madison's Quentin Schneider grabbed their first medal ever during Friday action at the 2019 Iowa State Track meet.

Schneider pulled away around

the final corner on the blue oval at Drake Stadium in Des Moines on his way to a 55.62 time in the Class 3A 400-hurdles.

The time was a personal best for Schneider on a cool, rainy day that started an hour late due to inclement weather. It was his first trip to state since his freshman year where he ran with the Bloodhounds distance medley team.

"It felt really good," he said "It was raining and it didn't really affect me. I told myself that it was affecting everyone the same way so just go out and run."

Schneider said he felt if he could win his heat, he would have a decent shot a medaling. He had

Kobelt's passion should be bottled and sold

For the first time I can recall, if ever, the Fort Madison High School held a signing day for seniors who have been accepted to college trade programs, full-time trades positions, or apprenticeships.

I've always been torn on the value of publishing these types of events for simply selfish reasons. Both of my girls entered college with more than \$10,000 in annual scholarships and they didn't get a signing day.

They worked jobs or were in sports, drama clubs, band, all that type of stuff. So balance was as critical for them in their success as the athletes and now trades students who get special mention. But that's the way it goes.

We do graduation coverage and award nights for seniors, but I think we can all stipulate it's just not the same

But I went to this signing day on Wednesday and saw something I wasn't really expecting, but should have been because I've witnessed it before at Fort Madison High School.

It's an understatement to say that Clint Kobelt is no slouch in Building Trades instruction. He, along with a progressive eye to the future from FMHS principal Greg Smith and FMCSD administration, has quickly built FMHS' trades program as the best in the state, and probably one of the top programs in the country.

I told Greg Smith he should take out billboards and start recruiting kids into that program. It's valuable, attractive, and open enrollment allows it.

I say best because Kobelt's students have won state



2019 State Track - Saturday results

Ailes wraps up state with two more medals

DES MOINES - Keokuk's Miracle Ailes and Fort Madison's Matt Hellige wrapped up the final day of the 2019 Iowa State Track meet in a neat little package.

Ailes won two more medals to go with the two she won on Thursday and Friday, including the state title in the girls' 3A high jump. Hellige, running in his first ever state mile run, finished 12th after getting caught in the pack at the end of the third lap.

Ailes finished third in the 100-meter dash with a 12.73 behind Davenport Assumption champion Carly King's 12.42 and Dubuque Wahlert's Libby Wedewer's 12.6. About an hour later she wrapped up a sparkling sophomore state track meet with her fourth medal of the three-day meet in the 200, taking 5th place and walking gingerly off the track.

"I wasn't feeling it," she said of the start of the 200. "Coming around the curve I felt something pop in my foot and I started to slow down, and then at the end I just tried to keep going and I passed a girl and it was good. I got fifth and I was proud of myself."

She said her success at this year's meet will serve as a springboard for a 2020 junior season that she's already looking forward to.

"I feel pretty good. Coming in I was just focusing on the high jump, but you know, I medaled in everything and I'm really proud of myself and I can't wait to see what I'll do next year," she said.

In the 100-meter dash, Ailes said her start was key to the strong finish.

"I was really digging coming out of the blocks. I felt really good because usually my starts aren't the best, but that was one of the best starts of the season."

Hellige, running with the top Class 3A milers in the state, said the distance events can get a little physical.

He got off the start in the middle of a pack and quickly moved to the front five where he stayed until most of the way through the first three laps despite getting arm bumped on turn one of the second

lap. Halfway through the third lap, the junior slipped back into the middle of the pack and then tried to make a move in front of the first turn of the final four but couldn't find room with runners five and six abreast coming into the final lap.

His 4:37.06 was good enough for 12th place overall and Hellige was happy with the performance despite not medaling in

He said the improvement came from working on different tactics and strategies.

"I really worked on race strategy and pacing and lots of hard workouts. There were those days when I was feeling tired and I just made myself get out there and do it. I had a mindset that I wanted to qualify in both these races so I just told myself get out there and do it."

Pothitakis scores 3 in HTC win

Claire Pothitakis was a force for the Crusaders, leading the team with three goals on the night. Elle Rashid, Elyse Pothitakis, Eryn Anderson and Taylor Crabtree also chipped in a goal apiece.

"The girls turned in an excellent performance after a week off," Holy Trinity Head Coach Michael Sheerin said. "We controlled the game

for the most part other than giving up a penalty kick.

"Tonight's stellar defense was back with a full squad with Maille Sheerin and Mya Lawlor returning from injuries. We were very happy that no one else was hurt tonight and the girls turned in a great team performance."

Keeper Sam Pothitakis had a rather uneventful night between the crossbars for the Crusaders, logging a single save.

Fort Madison's next contest is against Southeast conference foe Fairfield back home at Baxter Sport Complex. Holy Trinity's next game is Tuesday at Keokuk against the Chiefs.

The Crusaders move to 10-5 on the season, while the Bloodhounds slide to

the top time through two of the three 3A heats, and after the race, turned to watch the final heat come down the back stretch with times in the 54-second range. He then looked to the video board and watched times come off and saw his time was 7th best, prompting a wide smile.

"That was my goal, I wanted to just come up here and place. I wanted to win the heat so that was I tried to do. I knew if won the heat, I could probably catch a place," he said.

"I just wanted to give it my all. It was my last race of the year and I gave it everything I had."

Ailes, just a sophomore, said her counting was off a bit in the finals of the long jump, but she was looking forward to working on the event in the off-season and having better results next year.

Dubuque Wahlert's Aliyah Carter set a new meet record on her first jump of her flight with 18' 8.5".

During the finals Ailes took off on her last two leaps prior to the board and ended up with sub 16-foot jumps.

"I'm not supposed to look down and I was counting in my head and I think I just got off on my counting," she said.

"But I'm going to keep working on this in camps during the summer and off-season and I think next year can be a very good year for me in this event."

Ailes won the girls 3A state high jump

event on Thursday and will be searching for a couple more medals in Saturday where she will compete in the finals of the 100 and 200-meter dash beginning at 11:45. The Saturday schedule has been moved up to an 8 a.m start time instead of 9 to avoid additional inclement weather.

Martinez made to the finals after qualifying in the top 8 in the 3A boys long jump with a leap of 20' 3.25" in the first flight, which was long enough to win the flight and qualify him for the finals. He fouled on his second two leaps, but of which were under 20'.

The Keokuk boys 4×200 team of Martinez, Cory Skinner, Dylan Jeffers and Anthony Potratz, didn't medal after finishing 6th in the second heat with a time of 1:33.73, about a second off their fastest time of the season. The 8th place team, Harlan, medaled with a 1:32.7

"It just didn't work out for us, said Potratz, who ran the final leg of relay for the Chiefs. "The only thing that changes is there's people in front of us here and I just think I gotta go catch 'em now. That's the only thing that changes...we just have to chase them here."

Skinner said the team's best time of the year was 1:32.70, and they would have needed that performance to medal.

"This is definitely an atmosphere change. These are teams we've never seen before... and they run fast," Skin-

ner said.

Saturday's events have been moved up one hour due to incoming inclement weather so Ailes will compete for the 100-meter dash title at approximately

11:50 a.m. and the 200-meter dash at about 1 p.m.

Fort Madison's Matt Hellige will be running in the boys 3A mile run with a projected start time of 1:25 p.m.





Program positions students for income, not debt

trades competitions the past two years and are going to a national competition in June. It's not a guess, these kids are perennially smart with real world skills that take them from high school to a well-paying job, not necessarily the nightmarish debt of college. A debt bubble, I might add, I believe will pop in the very near future because in my small macroeconomic mind, the income potential does not clear the hurdle of the debt.

But what grabbed me on this occasion, and a couple others in my time covering FMHS, is the emotion with which this teacher talks about his students.

Kobelt literally stammers through public speaking because his emotions run so high for the kids he teaches. It's a passion for teaching I haven't seen since my mom, who taught for 32 years, had it when she first started. The flicker went out with her as a science teacher as mandated curriculum removed most of the one-on-one time with the students.

Kobelt seems to cling to that and is making a tremendous success. Each of the four students that were honored Wednesday got a big hug from Kobelt who talked briefly about a project the students were going to see through, even it if meant staying past graduation to get it done

"These guys said, 'Mr. Kobelt, we said we were gonna do this and if it's not done, we're not leaving. We're not leaving. They worked their whole lives for this moment when the doors are open and all they have to do is walk out.... We're not leaving. Who does that?!...," he said rhetorically to the 30 people in the room.

"Who does that?!."

The students included Dom Franz, Elton Kruse, AJ Nolting, and Brandon Keester. Keester was accepted to a Southeastern Community College program, Kruse was going to work right away for Carl A. Nelson, Frantz was going to work and then planned on entering an apprenticeship with the International Brotherhood of Electrical Workers, and Nolting was accepted to a Kirkwood Community College trades program.

It's not the recognition of the students that's striking to me. We've written about all these boys....and this program as well, many times in the Pen City Current. What was striking was the passion and emotion that Kobelt, as a public school teacher, exuded for these students.

In a world of Chapter 22s that have soured some teachers, social media influences that have soured some



kids, and short funding that has soured us all, this man sees something else. A way out for kids without a way.

I was moved... by him being moved. I was moved to write about this man because as we search for, and are starved for, role models, he is one. Not just for students....teachers too.

Graduation season is upon us. Congratulations to all the students crossing the stage this spring. We here at Pen City Current congratulate you on all your accomplishments, and we wish you well in each and every endeavor you take on. Take it from us... you never know what you're gonna get.

Sheriff would need city approval on personnel issues

pend, discipline, and fire officers with the coordination and approval of Fort Madison City Manager David Varley and the city's attorney. The approval is also required of any expenditures of city funds in excess of \$500.

The agreement also stipulates that whomever serves in the capacity as interim chief would "not be obligated to take phone calls or other direction from elected officials of the City, except as communicated by the City Manager".

The agreement requires the sheriff's department to consult with the Fort Madison City Attorney with regard to any issues dealing with Iowa Code 80F which governs the administrative rights of the state's peace

officers and emergency personnel, including city police.

Also on the agenda is continued discussion of possibly installing solar panels on county property under an agreement where a third party would install the panels at no cost to the county, The county would then pay the company that fronted the cost of the installation for electricity provided by the panels. Two companies, one from Burlington and one from Fort Madison, have bid the project to Supervisors.

The county will also hold a public hearing on the sale of two lots of county-owned property in Argyle, including a maintenance shed and adjoining property.


