City rolls out welcome wagon

American Cruises latches on to Fort Madison riverfront for first time

FORT MADISON – It arrived about 90 minutes early, but the five-level Queen of the Mississippi paddlewheeler latched onto the Fort Madison pier Tuesday morning in the first of 14 American Cruise Lines dockings this year.

Dignitaries, community leaders and just interested parties flocked to the pier where Mexican Fiesta dancers, a middle school band, some Old Fort staffers in era-dressing, awaited passengers to come down the pier.

Jackie Roeske, of Greenville South Carolina said she opened her curtains after she woke up in her stateroom on the ship and looked out and was struck by the spires reaching up out of the town.

“When I woke up and pulled the curtains, the first thing I saw was the church steeple. It's just gorgeous

– so pretty and it just watches over the town,” she said after being greeted by Fort Madison Mayor Brad Randolph.

“It actually made me think about moving here,” she whispered as her husband Davis walked down the pier behind her.

Davis Roeske quipped it was the first time such a group was glad to see him arrive anywhere.

“I was just thrilled at how important it made me feel to get off this boat and have everybody so pleased to see me. I haven't had that many people pleased to see me in a long time, if ever,” he said with a laugh.

“It is so wonderful to see a small town be so enthusiastic about something like this, and seeing a bunch of old people come in off a boat and welcome us and the boat. Hopefully, it will be good for your businesses in the future.”

The city has been courting Viking Cruise Lines, the but company is still several years away from building

any domestic cruise ships. During initial negotiations with Viking, who needs about \$1.7 million in upgrades to the city's dock, American showed interest.

American stepped into the picture in May only requiring about \$30,000 in repairs and upgrades to the pier to begin docking. Director of Guest Relations, Bret Bullock said the process was very efficient and he was kind of blown away by the reception.

“Well, I think it's remarkable. I think any time you have an inaugural call to a port, you'll have a special event of some sort,” he said.

“But this is very special indeed to have such a turnout from the townspeople. We're just as excited as they are, we've been working with city leaders for the past several weeks on excursions. But to have the whole city come out and the band and the dancers – this is just very exciting.”

Hardships not hurdles for FM's Luke Booten

FMHS alum earns Iowa Games Official of the Year Award

FORT MADISON – When Fort Madison High School graduate Luke Booten wrapped up his senior season of soccer at the state finals, he didn't know if he would ever be involved with soccer again. That fear was nothing compared to the fear his parents felt when Luke had to have a shunt put in when he was just six days old. On top of that, he was also born with Hydrocephalus, causing a disability for Luke that affects the left side of his body.

While watching Luke officiate, he walks the sidelines with a noticeable limp. Other than that, no one would ever know the hardships Luke and the Booten family have been through during his life.

"We encouraged Luke to use his left hand as much as possible but it still has limited use," Nancy Booten, Luke's mother said. "Even with that he finds out how to get things done. He has always worked hard at everything he does."

"But that has never stopped him from playing the game or refing the game. When he was young and started playing, it was hard for him to throw the ball in correctly and keep his foot on the ground. However, he worked hard at overcoming that."

That motivation to continue to work through any struggles he faced is what led Booten to his career in officiating soccer games. With a deep passion for the game having started playing soccer around the second grade, staying involved with the sport as an official was and continues to be a dream come true for Booten. He never would have guessed that after a decade of officiating, his efforts and love for the game would be recognized in the form of the Iowa Games Official of the Year Award.

"It felt good," Booten said of winning the award. "I was surprised, but it felt good. It was an honor to be selected as the official of the year."

It may have come as a surprise to Booten that he was nominated, but for those around the tri-state high school soccer scene, it shouldn't have been.

Booten is a regular staple during the season and can be found on the sideline wherever he's needed, regardless of the location and distance of the match.

"This would have been his eleventh year," Nancy Booten said. "He always goes. He travels about three hours to get there. This has been all free and volunteer. They recognize that."

"They always offer to give you mileage and they offer a college dorm, but we don't take those things because I go up and take (Luke) because he enjoys doing it."

Booten's extensive background with soccer made him the perfect candidate when a family friend inquired about Luke's interest in officiating.

"I was real excited when Ted Schneider asked me if I wanted to referee," Booten said. "I remember



him asking me in grade school, I think I was in fifth grade. I said, 'Yeah, I would like to know what it's like to be an official.'"

Booten continued to build on his knowledge of the game in high school, being a part of the varsity teams that went to state both his junior and senior seasons, including a fourth-place finish his junior year.

"Good memories for me," Booten said in reference to the Bloodhounds' state runs. "I look back at my plaque and all those guys."

"Every summer we have an alumni game where all the guys that played in the program play the current team. Friends, guys that played years before us, and

everyone plays it out and we have a good time. We try to keep track of how many times we win, or how many times they beat us."

Schneider didn't forget about Luke's interest in continuing to be around the game of soccer and upon graduation of high school, asked Luke again, to which he happily agreed.

"I had to go through USFF training and he was my trainer," Booten said of Schneider and his help getting started. "I went through training and test and all of that. Then I started at the YMCA and he was there with me the whole time. Then he said I was ready for the next level."

The next step was working on getting into the varsity ranks at the high school level. Booten first had to start with some junior varsity contests, but once he had the hang of it, was moved up to varsity.

With Booten now a regular on the sidelines, he has been able to cultivate relationships with his fellow officials and says the teamwork involved with officiating is something he enjoys being a part of. Not to mention he still gets to watch soccer.

"Working with the different guys I know around here in Burlington and Fairfield," Booten said is one of his favorite parts of the gig. "And going to different schools, doing to competitive matches."

When asked why he continues to do it and if he had any intentions of stopping officiating, Booten continued to reference his love of the game, something that will never leave him.

"Just from my days of playing and being with my friends that I played with," Booten said is why he loves it. "Even when I was in grade school I was like, 'Yeah, this is what I want to do most of my life.'"

He said the quick timeline was handled well on both ends.

"It was extraordinarily efficient, when you have a city that wants us to be here as much as we want to come to the city – it's a perfect fit. Between the mayor and your city manager and other city leaders, it was a breeze."

City Manager David Varley said it is good to see a ship in Fort Madison again.

"I think it's great. I'm glad to see this many people show up to welcome them here and it's really exciting to see another ship here in Fort Madison."

Eric Cade, of Salem Oregon said Fort Madison is beautiful from the shore and he enjoys the small town feel.

"It's very picturesque. It reminds me of home," Cade said. "I'm from a small town in Oregon and the train park and brickscape behind it and steeples. I love it. I'm a small town guy and I just love it."

The excursions on the port of call included two tours on Trailways buses, one focusing on the history of Fort Madison including the old prison and Old Fort, while the other was an agri-tour featuring retail farms including stops at Hinterland Dairy and Harvestville Farms.

Cade said he was taking the agri-tour because he had his two children with him. Another option included a SEIBUS shuttle that would loop around the historical downtown and park areas picking up and dropping off passengers throughout the six-hour layover.

Queen of the Mississippi Capt. Brad Vandiver, who lived for a short stint in south-east Iowa a few years back, said he was excited to learn the boat would be stopping in Fort Madison.

"I didn't expect this much and I can't think of a better place than Fort Madison for our guests to experience this part of the world," he told the crowd gathered by the pier to welcome the ship.

He presented Fort Madison Mayor Brad Randolph with a plaque in honor of the first stop. Randolph said the cruises are another story for the history of the city.

"We think this is a new day and a new chapter for Fort Madison and our community," he said.

"The volunteers and everyone that came out and welcomed these visitors to our own little piece of the pie down here, speaks volumes to our community and American Cruise Line for choosing us for a destination."

Other 8 a.m. arrivals occur on Aug. 18, Aug. 26, Sept. 8, Sept. 19, Oct. 3, and Oct. 7. All the 8 a.m. arrivals are six-hour ports of call. The other seven stops are 9 a.m. arrivals, which are the 8.5-hour stays and those are on Aug. 15, Aug. 28, Sept. 4, Sept. 18, Sept. 28, Oct. 12, and Oct. 16.

The cruise lines will be sending three different ships to the Fort Madison shores including the Queen of the Mississippi, the America, and the American Harmony.

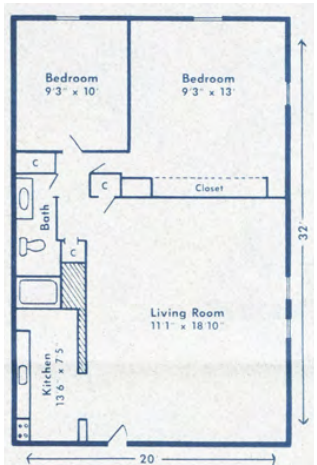
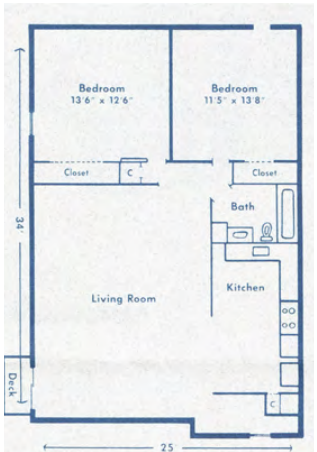

Council motoring along with golf court ordinance

FORT MADISON – City leaders continue to entertain the thought of allowing golf carts, and possibly ATVs and UTVs on city streets.

The issue was back on the council agenda at Tuesday night’s meeting after City Councilman Matt Mohrfeld brought the issue up two weeks ago.

Councilman Chris Greenwald, Kevin Rink and Mohrfeld made comments in favor of moving forward with the discussion, while Bob Morawitz advocated against allowing the vehicles on city streets.

The council voted 6-1 to move forward and have city staff draft an ordinance to bring back to the council for further discussion at a future meeting. Any ordinance would require three readings before being approved.

“We had this before and we voted it down. They safety issues haven’t changed and I’m not in favor it,” Morawitz said.

Mohrfeld countered with the argument that the environment has changed now with Lee County and West Point having adopted ordinances allowing permitted vehicles operated by licensed drivers. He also said Fairfield allows the vehicles.

Mohrfeld said he favored allowing the vehicles on all city streets except for Business 61 and only from dawn to dusk.

“They need to adhere to all our city driving codes, speed limits, stop signs, right of ways. They cannot operate on sidewalks and would have to park like a vehicle. They can’t go on the PORT trail, but I would suggest keeping them off of Business 61.”

Mark Lair agreed with Morawitz that the city has been down this road before and the people didn’t want those vehicles on the street.

“We’ve been through this once already and people told us they did not want it,” Lair said.

“They are still telling me, most of the people I’ve talked to are telling me, they do not want it.”

Greenwald said he’d heard of constituents who told him they didn’t want the boat to come that just docked at the riverfront Tuesday morning.

“But you were elected by the people, for the people, to do the job they want,” Lair countered.

Greenwald said he wasn’t voted to do the will of the people but to make the best decision with the information he has in front of him.

Morawitz said it also comes down to additional enforcement for the police department.

“I don’t know if we have enough police officers,” Moraw-

itz said.

Greenwald said it wouldn’t be the end of the world either way the council moves on the issue.

“And the thing to remember is the floodgates aren’t going to open and there’s not going to be a hundred golf carts on the streets,” Greenwald said.

In an unrelated agenda item, the council asked City Manager David Varley to reaffirm the city’s intention to donate the Idol Rashid Building to the Fort Madison Food Pantry.

The issue was put back on because a family member with the Rashid family, who has final approval of any transfers of the building, would rather see the building go to the Head Start program through Community Action. Giving the building to the Head Start would leave the food pantry without a local home.

Lair asked if the city could give the property back to

the Rashid family to do with as they please. Varley said he didn’t think giving the building to the food pantry, by way of Lee County, was off the table yet.

In other action, the council:

- approved signing an application for a REAP grant for additional funds for the Phase IV of the P.O.R.T. trail 48th street connection.
- approved a resolution to set a public hearing to order construction for Old Highway 61 from 2nd Street to 6th Street. The project was scheduled to begin in the fall, but Mayor Brad Randolph hinted that it probably should begin next year.
- approved a resolution appointing Jane Bartlett to the city’s Library Board and Mary Whitcomb to the Planning and Zoning Commission.
- approved spending \$3,650 for an inspection of the pedestrian bridge over the railroad tracks near the depot.
