Second chase lands Illinois man in jail

MONTROSE - A man who led southeast Iowa law enforcement on chase from Des Moines County into Lee County on March 14, has been arrested after a second chase through the area today.

The Lee County Sheriff's Office reports the arrest of Travis W. Peterson, 39 of Raritan, Ill.

Peterson had eight warrants for his arrest stemming from a pursuit involving the Des Moines County Sheriff's Office that ended in Wever on March 14, 2019.

Peterson was located today by Des Moines County authorities, and he led them to Henry County in a pursuit. Henry County Sheriff's Office and the Iowa

Department of Transportation took the lead on the pursuit into Lee County where deputies of Lee County assisted the Iowa State Patrol in the pursuit.

Peterson lost control of the car he was driving, then abandoned it and allegedly took another vehicle on 130th Avenue, just inside the Lee County jurisdiction.

Peterson then continued to lead Lee County Deputies and Iowa State Patrolmen into Van Buren County where he was taken into custody after STOP STICKS were deployed, disabling the stolen vehicle he was driving.

Assisting in this arrest were LeeComm Dispatchers,

West Point Police Department, Iowa State Patrol, Iowa Department of Transportation Motor Vehicle Enforcement, Van Buren County Sheriff's Office, Henry County Sheriffs Office, and the Des Moines County Sheriff's Office.

Additional charges will follow from the March 14th incident, including Eluding, and multiple traffic offenses. Peterson is merely charged with these crimes, and he should be considered innocent until proven guilty in a Court of Law.

Weber said the sheriff's office appreciates the assistance provided by the community and the other members of law enforcement who assisted in this incident resulting in the arrest.

Psychologist, C.O. hurt in ISP skirmish

FORT MADISON - Two staff members were assaulted by an inmate at the Iowa State Penitentiary on Friday, March 29, 2019 at approximately 4:30 p.m.

While a staff psychologist was meeting with an inmate in her office located in one of the housing units, the inmate began to physically assault her. A nearby correctional officer heard the assault taking place, and quickly responded to the assault. The inmate resisted

the attempts by the officer to restrain him, and struck the officer several times in the struggle. The officer was able to deploy oleoresin capsicum (pepper spray) to gain control of the inmate until additional officers arrived to restrain the inmate.

The staff and the inmate that were involved in the assault were assessed by institution medical professionals and found to have not suffered any major injuries.

This incident remains under investigation.

Rauenbuehler goes for hattrick in 4-2 win over Danville

FORT MADISON – The Holy Trinity Crusaders opened the season with a win on a long day of soccer Saturday at the Baxter Sports Complex, but finished the day 1-2 for fourth place at the Fort Madison Soccer Invitational.

The Fort Madison Bloodhounds lost their first match, but battled back through the consolation bracket for a 6th-place finish overall.

The Crusaders knocked off Danville 4-2 in its opening match of the day behind three goals from senior Adam Rauenbuehler.

Holy Trinity fell behind early 0-1 when the Bears' Tristan Miller slid a ball passed the fingers of HTC keeper Blake Crabtree, who dove to the right side of the north goal on field 3.

But the Crusaders Audrae Vincent returned the favor about three minutes later with a shot of his own to the right side of goal to tie it up at 1-1.

Danville would take the lead again off a penalty kick to go up 1-2 before Rauenbuehler pulled off the hat trick, scoring three unanswered two of which came within two minutes of each other.

Head Coach Ryan Culbertson said this was the first week he's been able to get all 13 players together.

"We've had a bit of trouble getting all the players together on the field at the same time for practice. I'd have to drill with six here or seven there, but it's been hard to get everyone together. So all in all I think we think we played pretty well today," he said.

Facing Mt. Pleasant in the match for 3rd place, the

Crusaders led through most of the game, but the Panther's put up two goals, one off a penalty kick that slid to the left of the "wall" and past a diving Crabtree. HTC got the ball on the Mt. Pleasant side of the pitch down 2-3 with two

minutes left. The Panthers keeper came out and tangled up Tyler Snaadt while help arrived to snuff out the drive and preserve the win.

The Crusaders dropped their second round game to Burlington Notre Dame.

For the Bloodhounds, an opening round loss to Mt. Pleasant 1-0 pushed them into the consolation bracket where they then knocked off Central Lee 2-1 to face Danville in the 5th place match.

The Bears would get the best of the Hounds 4-2, despite a comeback in the second 30-minute period where FM outscored Danville 2-1, but the Hounds spotted the Bears an early 3-0 lead.

"Danville put us down 3-0 and we answered with 1 and they came back with one, but we scored again to make it a 4-2 game," Head Coach Kevin Wellman said. "We should've been better in that game, but maybe there was a little fatigue. Granted Danville was going through the same thing, but I would've like to have seen a better result in that game."

He said the Central Lee game was probably the best teamwork he's seen in the early season, which up to Saturday had just been two scrimmages.

"We ended up having some really neat combination play through the midfield in that game," Wellman said. "We had a hard time converting and scoring goals in that game. We did get two, but would have been nice to get more there."

"The boys played well. I was not displeased with what we did, we just need to do a better job of converting the opportunities we get."

Davenport North ended up winning the tournament after knocking off Burlington Notre Dame.

Both the Crusaders and the Hounds are in action Monday night with Holy Trinity traveling to Keokuk, while Fort Madison hosts Fairfield at the Baxter Sports Complex.

Dennis, Lampe lead Lady Hounds at MP Co-Ed meet

Hellige second in 3200, Schneider takes second in 400-meter hurdles for boys

MT. PLEASANT - HTC juniors Matt Hellige and Quentin Schneider led the Fort Madison boys, while Katie Dennis and Reyna Lampe paced the girls at Thursday nights Mt. Pleasant Co-Ed track meet at the Mapleleaf Stadium.

Hellige took second in the 3200-meter run with a time of 10:11.18, just 12 seconds off the pace of Ryan Threlkeld-Wiegand of Iowa City High. Schneider earned second place in the 400-meter hurdles with a mark of 59.61 a half a second behind Iowa City High's Soren Ostby.

The Lady Hounds freshman Dennis ran to a 3rd-place finish in the girls 3000-meter run with a time of 11:59.48. Lampe also earned a 3rd place in the 100 meter hurdles with a time of 17.29, a mere .05 off second place and .6 seconds from Cedar Rapids Jefferson's Meghan Prohaska's 16.47.

Dennis also earned points in the 1500-meter run with a 6th place finish at 5:39.82.

Sheymouhr Redd-Donald took third in the 200 meter dash with a 24.32 his best time of the year in that event. Hellige got the boys another 3rd place mark win the 1600-meter run with a 4:45.57, five seconds off the pace.

Raquel Schneider took 3rd the girls 400 hurdles with a 1:20.40 mark in what is becoming a family event for the Schneiders. Older sister Brett went to state in the 400 hurdles last year's event as did mom, Carrie.

In the relays, the boys 800 spring medley motored to a fifth place mark with Calem Maclearn, Redd-Donald, Brock Califf and Schneider finishing at 1:41.60, 2.5 seconds off the winning time.

For the Lady Hounds, the distance medley team of Aleaya Klesner, Julia Seel, Dennis and Schneider captured a 5th place finish at 5:00.64. The boys distance medley of Schneider, Garrett Hannum, Califf and Hellige also finished 5th with a

Reynolds cuts talks with UnitedHealthcare

DES MOINES - Iowa Governor Kim Reynolds announced late Friday that she is ending negotiations with United-Healthcare to provide health insurance under the state's managed care system.

Reynolds issued the following statement this afternoon.

"Today I ended negotiations between the State of Iowa and UnitedHealthcare because of terms that I believed to be unreasonable and unsustainable.

"From the day I was sworn in as Governor I have been committed to ensuring a sustainable managed care program that protects patients, supports providers, and holds the insurance companies accountable.

"We have continued to work in good faith, along with the legislature to make improvements to the managed care system, including a substantial increase to funding this past year.

"Unfortunately, UnitedHealthcare continued to make additional demands that I found to be unacceptable, including a provision that would remove pay for performance measures that would hold them accountable.

"I want to assure Iowans that the state will work closely with UnitedHealthcare over the next several months to minimize disruption and ensure a smooth transition to the two other managed care companies."
