FORT MADISON -Big moving equipment, trailers and a lot of dirt are taking up about four square blocks on the southwest corner of 18th and H, but it's all in the

name of progress. Fareway Grocery, of Boone, Iowa announced the new opening and broke ground this fall and began demolition right away.

Corporate Outreach and Communications Director, Emily Toribio said work on the site is going well.

Toribio says there haven't been any snags so far.

"Not to my knowledge. We are all good and our hope is to open in the fall," she said.

When asked for an opening date, Toribio said Fareway sets new openings for seasons so they can adjust for any unforeseen circumstances... such as the weather.

"We set it for a season and hope that we can reach that. We'll have something of a more concrete date by late summer.

The building is planned to be 19,000 square feet located at 1820 Avenue H. But Toribio didn't have an idea of how many employees would be hired.

"We leave that up the open interview process and local management team to determine how much of a staff they will need," she said.

"But the store will have our unmatched meat department, great produce and low competitive prices. And we also have our personalized To-Your-Car carryout. We're really excited to be coming to Fort Madison and we're hoping that's reciprocated. It'll be nice to provide for those area residents."

## **District owed** \$100K in meals

FORT MADISON -After writing off close to \$60,000 in unpaid meal bills at the end of the 2015-16 school year, the district is already \$35K in the hole to start this year.

Quereto the director of the district's food program, advised the board the school district is already behind \$35,000 this year. District Secretary Sandra Elmore confirmed the figure and then reminded the board the figure only represents accounts that are over \$200. Then Elmore reminded the board that the district had just written off \$60K to start the year.

"We wrote it all off and sent those to a collection agency and now we're

important to understand that the district would not deny a child a meal, but the district may have to look at alternative means to offset the unpaid accounts. One idea suggested included having students who have unpaid accounts pick up a separate lunch from the office and then return to the cafeteria. The board took no action on the issue, but was certainly geared up about the continuing loss of revenue.

"This is a hard thing because we don't want any child to go hungry. However, this is essentially \$100k out of our nutrition budget. It's like were enabling people to not pay. I wish we could wave a magic wand and take care of this, but it's just not that easy," said board member Dianne Hope.

"We can't keep writing these amounts off," said board member Gayla Young. "How can your department eat \$100,000?,"

FORT MADISON - The Fort Madison School District continues to set their gaze upon a new elementary school in the

At Monday's meeting of the district's school board, Superintendent Erin Slater questioned the board on their feelings of moving forward again with placing a bond issue on the ballot.

about two things; time frame and focus. Do we want to focus on the original bond question or focus on what we're hearing in our feedback for constituents," Slater said.

Some of these questions are coming up again to expand voter base by adding something additional like fine arts, or some other theater space. And would that create a second bond question.

"As far as a time frame, Feb, April, June, September those are the next opportunities," Slater said. "I was told that there was a strong possibility the (Lee County) Health Dept. could put a bond issue on the ballot in May. That makes it a bit tricky for us because last time we were very close to the courthouse issue. And April would put us close to that bond issue and possibly even June.

"We don't want to lose that momentum that we've already created with the Kids Committee and social media and we could start that back up in January."

Several members thought September presented concerns.

"My only concern about September is that that's when everyone gets their tax statements and they're gonna be angry with that." board member Tim Wondra said.

Lamb said you also run into the same problem with April as far as taxes and said September gives the board more time to address other issues.

"Maybe they want to see a bus-

of it being in flood plain and show them that (the property) is no longer in a flood plain," Board President Timm Lamb said. "September allows us to answer those questions."

Board member Dianne Hope said she was more inclined to move quicker with the issue.

"I'm concerned about September because we've lost everyone for June, July and August and now it's September and you've got Labor Day and Rodeo and I just hate to lose what momentum we have going." Slater said September gives her and volunteers on the referendum's 'Kids Committee" time to seek out and address specific voter issues on why they didn't support the new building.

"This will give me time to get out to people who have concerns and talk to them and try to answer the questions they have. I could go out and find those groups, with the Kid's Committee and ask, 'What would it take for you to vote in favor of this," Slater said.

She said some of the things people had concerns over included having an auditorium included in the plans, athletic fields and busing issues.

But she said there are still a lot of comments coming in on social media, including on Monday, that can help the district prepare better for a second run at the referendum.

Lamb said he didn't feel the voters rejected the school, but more of the planning and the issues around the building that need to be addressed this time around.

## **Grocery brings history of service**

#### History

The first Fareway Store opened for business at 624 Story Street in Boone, Iowa, on May 12, 1938. According to the Fareway website at www.fareway.com, the first ad featured coffee at 14 cents a pound and a "regular package" of Wheaties for 10 cents.

Fareway's concept of a self-service grocery store was considered revolutionary, allowing shoppers to pick out their own groceries rather than submitting a list

to someone who would package everything for them. Shopping carts were a novelty, referred to as "rubber-tired gliders" that carried shopping baskets.

The name Fareway was originally chosen to convey a "wide range of stock of foods," with the word "fare" meaning food. "Bill of fare" was also the commonly used phrase for "grocery list". The name also symbolized the idea of treating employees and customers fairly-where hard work deserved a fair wage, customers could expect to pay fair prices.

# District looking hard at handling overdue meal accounts

she asked Quereto. "It's like we said, some high school (families) are taking advantage of this."

Board Vice President Tim Wondra said there is no incentive to make district residents who are behind on their meal accounts to pay.

"I'm one that pays full price for meals for my kids. But what's my incentive to keep paying when others don't," Wondra said.

Board President Timm Lamb said it's a sticky situation and needs a specific solution.

"I know we all agree that there's a problem, but we're not sure what the the school to address the issue.

"If there is some way that you can fend this off before the student gets in line (to get a meal)... I want there to be as little trauma to the students as possible," Hope said.

At a recent state school board convention, board member Lois DiPrima said that issue was addressed and some schools were putting alternative sack lunches in students' lockers who had substantially overdue meal accounts. DiPrima also asked the board if district employees had overdue accounts, and could wages be garnished to recoup the money. Quereto said the bills would have to be sent to collections first and legal paperwork would have to be drawn up.
