County attorney election to go on May 2 ballot

Editor's note: It was incorrectly reported that the election for the Lee County Attorney would be held in the 2018 election cycle as that was the discussion among Lee County Board of Supervisors when Ross Braden was appointed last week. However, according to statute the election must be held on the first countywide ballot which will be May 2 when the referendum to build a new Lee County Health Department will be decided.

MONTROSE - Fort Madison attorney Ross Braden was sworn in as Lee County Attorney this morning at the regular meeting of the Lee County Board of Supervisors.

Interim County Attorney Clinton Boddicker, who has been filling in since the retirement of former Lee County Attorney Mike Short at the end of January, was to be sworn in as well, but according to Lee County Auditor Denise Fraise, he was in court at the time.

The Lee County Attorney's position will go up for election May 2 as part of the special election for voters to decide if a bond referendum will be passed to build a \$2.6 million Lee County Health Department building on property the county currently owns as part of the jail campus in Montrose. The building, if approved, will be built on the west end of the property.

Boddicker had said after the appointment last week that he would be considering filing for a special election, but the May 2 election would make that a moot point.

Braden was sworn in by District Judge John Wright.

"First of all I want to thank the board for giving me this opportunity to serve as Lee County Attorney. Like I said, prior to going to law school, this was the goal I've always had and I look very much forward to serving in this role to the best of my ability," Braden told the board.

According to Fraise, in order to get on the May 2nd ballot, a candidate for County Attorney must submit an affidavit of candidacy and a petition with 228 signatures by April 7th at 5:00 p.m. to the Auditor's Office. That is 1

percent of the registered voters in the Lee County on July 2016 per Iowa Code 45.1.

A phone call to the Lee County Attorney's office for comment from Boddicker was unreturned.

County holds levy in 2018 budget **BY CHUCK VANDENBERG**

MONTROSE - A \$11.7 million county budget will be submitted to the public on March 7 with a levy of \$10.388/\$1,000 assessed valuation.

The rate was originally proposed at about 1.5 cents cheaper but a large deficit in the 2018 Fiscal year proposed budget prompted supervisors to move the levy back to current levels.

County budget director Cindy Renstrom submitted the final budget at Tuesday's regular meeting of the Lee County Board of Supervisors. The budget sets the levy at the same rate as 2017 and Renstrom says the county can whittle away at Mental Health Services and debt service to offset about \$500,000 in additional budget shortfall for 2018, however, the budget worksheet still shows a deficit of about \$1.58 million for 2018.

The county has budgeted a fund balance at the end of the fiscal year 2017 of \$12.2 million and projected 2018 ending fund balance of \$10.6 million.

Supervisors also asked all department heads to reduce their budget.

"I was able to get the deficit down to \$1,059,000 by taking out the deficits

for mental health and debt service," Renstrom said. "So we left the levy the same

Board Chairman Rick Larkin said he appreciated all the work of staff to help reduce the deficit.

"We asked all the departments to come through with with a 1 percent decrease in their budget. Which they all did," Larkin said. "We appreciate that and thank the elected officials and department heads for working with the board."

Renstrom also said she cut \$250,000 at the direction of the board from the county's own economic stimulus fund. The county, after several meetings and discussions, decided to continue their \$210,000 commitment to the Lee County Economic Development board. The board also had Renstrom pull a

proposed \$160,000 maintenance building out of the budget for the engineering

Another hotly debated budget was the sheriff's department's budget which included funding for a canine unit, two additional deputies and a part-time jail

Lee County Sheriff Stacy Weber told the board on several occasions that private funds will probably be sufficient to cover all the costs of the canine unit as private support has been overwhelming.

If that's the case Renstrom said the funds for the dog would just stay in the






