Poppe staying true to her music

Tickets still available for Friday night show

FORT MADISON – Iowa native and 2018 American Idol winner Maddie Poppe said despite fame and fortune she wants to stay true to her writing.

The 21-year-old will be holding a concert at Fort Madison High School on Friday following the annual North Lee County Relay for Life starting at 9 p.m.

Tickets are \$40 each and there are a very limited number of \$100 VIP tickets that are still available at www.relayforlife.org/northleecountyia or by calling Fort Madison Community Hospital.

Poppe is set to launch a nationwide tour in October.

In an interview with The New Mix in Burlington, the Clarksville, Iowa native said fame that has come with winning American Idol is not what she expected.

“It’s completely different than I thought it would be. It’s hard to understand it unless it happens to you,” She said.

“I thought it would be different and didn’t realize it was as much press, and radio was a whole different world. I didn’t realize everything that comes along with it.”

Poppe is coming off playing at the Iowa State Fair to a packed house on opening night and then recently returned from a trip to Sacramento where she was diagnosed with

laryngitis. But she said therapy has allowed her to keep performing.

She said her influences are Sara MacLachlan, Sara Bareilles and Ingrid Michaelson, who she is touring with starting in October.

She said she is looking forward to the tour and is hoping to try some new things on stage, but said sticking to her musical roots is important.

Poppe has 10 original songs on her first album “Whirlwind” but says the songs aren’t written by her.

“It can sometimes take months or even years to get a song written and I had a couple months to get the album out. There were so many good songs that came in that it was hard to get something of my own out there,” she said.

But her plans are to move forward with writing and sticking to more wholesome songs, despite what some fans may want to hear. Most of what Poppe is doing now involves cover songs.

“I don’t want to just be a cover artist, but it’s hard.

People like to hear songs they know and so we like to play those live, so I like to throw those in there, but I don’t want to fully rely on those,” she said.

“If that’s what people are drawn to, but I grew up to family-friendly music. I don’t want to make music where parents have to turn the station if my song comes on. I want it to be appropriate for everyone and that’s important.”

She said when she’s creating songs, she likes to

Conagra employee triggers \$5K gift to P.O.R.T trail group

FORT MADISON – An observant employee at a local manufacturing facility has created a windfall for a local non-profit group.

ConAgra Brands announced Monday that its facility in Fort Madison has been awarded a Sustainable Development Award for work in reducing the amount of waxed cardboard going into local landfills.

Kristine Mulford, manager of Corporate Communications out of ConAgra’s Chicago corporate office, said the former Pinnacle facility was given one of five company awards for projects that reduce water, waste, energy, and costs across the brand’s business channels.

“Each year we do Sustainable Development Awards and these are employee-led teams or facilities that submit projects that really support sustainable business, climate change, energy efficiency, waste reduction/recycling, and water conservation,” Mulford said.

The Fort Madison plant was able find a way to save about 320,000 lbs. of annual cardboard waste from going into local landfills.

“It came about because a team member noticed a trash driver was having trouble handling all this waxed cardboard at the facility. It was forwarded to the engineer overseeing recycling. They made several calls to facilities to see who could handle that waxed cardboard and were able to divert 160 tons of cardboard that would have gone to the landfill,” Mulford said.

She said the company now has the cardboard hauled out by City Carton of Mt. Pleasant who recycles the waxed cardboard.

As a winner of the brand’s waste reduction award, the facility was given a \$5,000 grant to donate to a local non-profit whose focus also is on sustainability.

The Fort Madison plant chose the P.O.R.T. (Promoting Outdoor Recreational Trails) to receive the grant and Mulford said the group has already received the money. The grant will fund beautification enhancements to Phase III of the trail that connects the trail at Avenue L to the Fort Madison Community Hospital.

She said ConAgra officials were happy to see the new Pinnacle plants participating in the sustainability programs.

“It’s heartening to see a lot of former Pinnacle plants come on board and embrace this program wholeheartedly,” she said.

think of her grandparents and little girls.

"I do have a lot of younger fans that come to the shows and there are videos out there of them singing my songs. I try to be a role model for those young kids because there's a lot of music out there and I don't think kids always know what they are listening to," she said.

"I don't think I would gravitate toward the kind of lyrics that are in today's pop music. It makes it challenging to stand up to that when there are songs people want you to sing and it might be a No. 1 hit song but there might be a lyric you can't support. At the end of the day it comes down to putting your foot down and saying even if the song comes with fame or money, that I don't think I can do this."

Central Lee takes home HTC Classic trophy

FORT MADISON – It’s an odd feeling for a Fort Madison volleyball team to not be on the floor for the championship match of the annual Holy Trinity Classic.

But that’s what happened Monday night after six hours of volleyball found the Burlington Grayhounds and the Central Lee Hawks squaring off for the classic trophy.

The Hawks had just eliminated HTC in two sets 21-17 23-21 and the Grayhounds walked all over Wapello in the last match of the silver pool play.

Central Lee took the first game of the championship 21-17. Burlington came back in the second game and

rolled the Lady Hawks 21-9, but a 15-13 tiebreaker gave the Hawks the Classic title.

The Grayhounds had beaten the Hawks in pool play early in the tourney.

The Crusaders had early leads in both the semifinal games with Central Lee. In the first game, HTC went up 4-2 before the Hawks went on a 10-3 run that included six straight with junior Mya Merschman serving. Kaylynn Summers capped the run with a kill at 12-7, but an error at the net killed the drive.

HTC would then pull off a five-point run to knot the score at 12, highlighted by consecutive kills from junior Katie Denning, freshman Brooke Mueller, and sophomore Kassi Randolph. Randolph’s came on a marathon point that ended with her finding some wood behind the front line.

The teams would get tied up again at 17 and then Central Lee would rip off the next four straight to take the game.

Holy Trinity would again pull out ahead 5-1 to start the second game, but Central Lee would fight back and tie it up at 5 when Merschman flipped the ball over the block of senior Avery Hopper and Denning.

They would tie it up four more times at 7, 8, 9, 10, and then HTC would pull ahead by as much as four at 17-13 on a Hawks’ net violation. HTC would commit three straight errors to let Central Lee close to within one 17-16.

A Hawk error pushed the HTC lead back to 3 at 20-17, but the Crusaders couldn’t get the final point as Central Lee went racing by including a 20-20 tie on a kill by Summers. The two teams would knot up again at 21 and then another Summers’ kill put Central Lee up by 1 and senior Andrea Brenner finished it off with a soft kill to the left side to end it for HTC.

“We need to win one of these close games. We’re right in there and staying with them,” HTC head coach Melissa Freesmeier said.

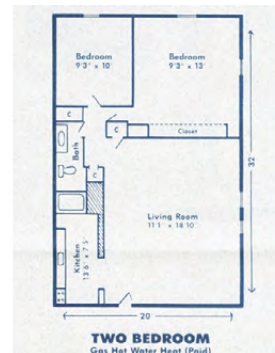
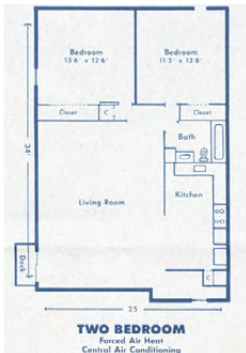

“But I just think we’ve improved a ton from three weeks ago. We’re getting better. Our middles are getting stronger and we’ve got more shots.”

She said defensively, the team is picking things up better, but they haven’t gotten over that one big hump yet.

“We’ll come into the gym tomorrow and Wednesday and get ready for the conference tourney on Thursday. It doesn’t get any easier from here,” she said.

The Crusaders knocked off Keokuk 21-11, 21-11 and then saddled Winfield-Mt. Union with a 21-7, 21-11 loss before sending Danville away 21-9, 21-13.

In the silver pool, Central Lee knocked off Fort Madison 21-8, 21-11, then fell to Burlington 20-22 and 21-15, before coming back to nip at Wapello 21-17 and 21-18.

Fort Madison didn’t come away with a win on the night, but gave Burlington all they wanted and then some in the Bloodhounds’ final match of the night.

The Hounds had Burlington down 19-18 in both games but let the lead slip through their paws.

In game one, Fort Madison held leads of four and five on several different occasions, but a kill from Kylie May on a point following an attack from FMHS’ Kylie Cashman that went long, tied the score at 19 each.

The two 4A schools would knot it up again at 20 and 21, but a kill from Burlington’s Angel Baylark gave Burlington a lead it wouldn’t surrender as they went on to the 23-21 first game win.

Fort Madison again would take a commanding lead in the second set, going up by as much as four at 18-14, but couldn’t get the ball to the right person at the end. The two would tie it up at 19 and the Grayhounds would get a block for a point from Bailey Weimann and then senior Jillian Wiseman would send an attack deep on the left side.

“We’ve gotta find a way to finish. To get the ball to the kid that’s going to do that for us and we’ve got to figure out who that is beyond Jillian,” Head Coach Kent Bailey said.

“We’ve got other kids that can and they show it during practice. It’s just one of those things where they have to get that mentality.”

Bailey said the first two matches were more of a struggle, but the final match with Burlington is where he said the girls played close to their capabilities.

“The first two matches were a struggle and you gotta give Central Lee credit. They played and they took us out of what we wanted to do and Wapello kept digging some balls up. We probably had that match won but they dug a couple up and got the win,” he said.
