## Food pantry's Gaudette to retire....again

*U.S. Army veteran said he thought it would be a 1 year gig*

FORT MADISON - Sometimes it really is easier by the dozen.

The North Lee County Food Bank has been basically run by George Gaudette for the past 12 years. Gaudette said in February he'll step off the board that governs the food bank.

The former Washington D.C. educator and principal said he's been working for the food pantry since he and his wife, Mary Ann, moved into the area about 13 years ago.

Gaudette said when he and Mary Ann moved into the area after retiring as a teacher and principal in the Washington D.C. school systems, they weren't certain about their future, but took up a rental in the area offered by a church. He said Mary Ann had family in the area and a member of the church asked him to help out at the local food pantry in his spare time.

"I said I'd do it. I was retired. I needed something else to do," Gaudette said Friday afternoon, "I thought I'd do it for a year and here I am twelve years later."

Gaudette serves as chairman of the food pantry's local board, but said in February he's giving formal notice that he is resigning from the post.

The face of the organization for the past dozen years said he knows all too well how families can struggle for food.

"When I was a boy I used to remember my folks eating a lot of popcorn, towards the end of the month they were always

eating popcorn and, as kids, we didn't really understand it then, but we only had enough food for us kids."

Growing up in lean times usually meant the military for kids in George's generation. As such he ended up signing up for the U.S. Army and was stationed in Germany. There he didn't see any active combat, but only summarizes his time in the military as "intelligence."

"I did that for three years over there. If we heard of some Russian intel, we went out and got it daytime, nighttime it didn't matter," he said. "When I came back home, I did a little more of that after I became a civilian again, but it was intelligence."

After saving enough money, Gaudette said he bought a Volkswagen van and began to travel. He got all the way down to Marrakesh in Morocco. He said he traveled in the van and stayed wherever he could find a place to stop for the night.

At one point he said was in the Gibraltar on the southern tip of Spain and the government began to gather up foreigners and ship them from the country.

"I got back into the United States and decided I'd better find something to do

# HTC boys give Danville a surprise

*Fehseke hits for 29, Schneider throws in 20 as HTC rolls*

DANVILLE - The patience and steady growth of a young HTC team was rewarded Friday night as the Holy Trinity boys basketball team knocked off Danville 82-73 on the road Friday night.

Sophomore Reed Fehseke scored a season-high 29 points to lead the Crusaders, followed by Quentin Schneider's 20, a season-high for him as well.

HTC raced out to a 13-1 lead just four minutes into the first quarter, but the Bears cut the lead to eight 21-13 at the end of the period. Schneider led the Crusaders with eight points in the first quarter and Fehseke had a couple of 3s.

The Southeast Iowa Superconference South Division leading scorer, Max Wilcox, scored 16 points on the night, but only converted one bucket. He was 14-14 from the free throw line.

The Crusaders kept the 8-point lead through the second quarter heading into the lockerroom with a 42-34 edge. In the third quarter, the Bears cut the lead to four at 42-38 opening on a 4-0 run, but the Crusaders then went on 12-4 run of their own to push the lead to 54-42, sparked by nine on three 3-pointers from Fehseke.

The Bears wouldn't get any closer than 10 the rest of the night as they went into foul mode to try and slow the clock and get possession but the Crusaders hit 7 of 13 on the way to the win.

Matt Hellige had 12 points inside the paint for HTC followed by Collin Thornton's 11, Brant Holtkamp's

eight, while Blake Crabtree scored two.

"We did a great job on defense and we were strong with the ball on the Danville press," Head Coach John Hellige said. "We shot really well and took care of the ball. Defensive rebounding was much better.

Hellige said the win was a testament to the team's patience during the year and teamwork.

"The boys have been working really hard and Jay and I were hoping the boys would be rewarded for that hard work," he said. "Quentin was very explosive driving to the hoop and Blake played terrific from an overall floor game. Matt was tough inside. He and Quentin both had 10 rebounds and that was huge for us. It was a team effort. Even the kids on the bench were enthusiastic and energetic.

The Crusaders move to 4-13 on the season and travel to Wapello on Tuesday.

In the junior varsity game, the Crusaders won 61-41 behind Jason Thurman's 18 points and Jake Eaves' 16 points.

## HTC girls fall short against Bears

DANVILLE - Junior Taylor Boeding had 15 points and sophomore Ashlyn Haas scored 12 for the HTC Crusaders in a 54-61 loss to Danville in Southeast Iowa Superconference South division girls basketball action Friday night.

The Crusaders are getting limited action from senior Brett Schneider, who's averaging 15.6 points per game. Schneider is nursing a sore ankle and is playing and practicing sparingly.

The game was tight in the first quarter with the Crusaders down just a point at the end of one 14-13. But the Bears put up a 15-11 advantage in the second quarter to take a 29-24 lead at halftime. Boeding led Holy Trinity in the first half with five points including a 3-pointer. Haas was 4-of-4 at the free throw line.

The third quarter was evenly battled as both teams put up 14 points, with the Bears holding a five-point lead. Boeding accounted for nine of

the Crusaders' 14 with two from long range and 3-of-3 free throw shooting. Danville's Alyssa Pfadenhauer got to the free throw line eight times in the second half and finished with 14 points to lead Danville.

The Crusaders cut the lead to two points with five minutes left in the game on a 3-ball from Haas, and then cut it to one at 46-47 with less than three minutes remaining. HTC was on an 8-2 run from the seven-minute mark, but Danville was

able to pull away in the final two minutes outscoring Holy Trinity 14-8 the rest of the way.

Emily Box had nine for the Crusaders, Madison Mohrfeld and Avery Hopper each chipped in with five, Schneider had four, Sam Hoenig scored three, and Eryn Anderson had one to round out the scoring for Holy Trinity.

HTC is 8-10 on the year with a road trip to Wapello on Tuesday and then at home against New London before the SEISC shootout on Feb. 2.

## Hounds win Classic

FAIRFIELD - FMHS senior wrestler Harlan Steffensmeier continues his record-breaking senior year. Steffensmeier took first place at the Southern Iowa Classic on Saturday at 152 lbs.

Steffensmeier was also just the fourth wrestler in the history of the tournament to be a four-time champion. He won the title after receiving a bye in the first round and then recording two pins in the semifinal and championship match, winning the title with a pin over Wilston Wuthrich of Davis County in 1:28.

The Hounds also got two second-place finishes from Ryan and Aaron Steffensmeier. Ryan Steffensmeier took the runner up spot on the podium at 126 lbs with a pin in the quarterfinals and a 9-2 decision in the semifinals before being pinned by Centerville's Kayden Kauzlarich at 4:42.

Aaron Steffensmeier advanced to the championship at 145 lbs against Sage Walker, who's ranked 6th in Class 2A. Walker, of Eddyville-Blakesburg-Fremont, came into the match 37-1, and defeated Steffensmeier by a 7-2 decision. Steffensmeier had two pins and a 5-2 decision over Mt. Pleasant's Nate Wallace.

Elton Kruse at 106 lbs, finished third at the meet and the Hounds earned five fourth-place finishes at the meet, which was good enough to give the Bloodhounds the team title.

Complete results of the tournament are listed below.

**106 lbs - Elton Kruse (17-17) placed 3rd and scored 16.00 team points.**

The following Proposition is approved, and the Secretary is authorized and directed to submit and file the Proposition for the Ballot with the Lee County Commissioner of Elections at least 46 days prior to the election:

Section 3. That the Election Board for the voting precinct or precincts be appointed by the County Commissioner of Elections, not less than 15 days before the date of the election, a certified copy of which appointment must be officially placed on file in the office of the Secretary.

Section 4. The Commissioner of Elections is requested and directed to make publication of the Notice of Election at least once, not less than four days nor more than twenty days prior to the date of the election, in a legal newspaper, printed wholly in the English language, as defined by Iowa Code Section 618.3.

Section 5. The Daily Democrat, a legal newspaper, is published within the District and is hereby designated to make the publication of the Notice of Election.

Section 6. Lee County, Iowa is the control county of this School District; this election will be conducted by the County Auditor as Commissioner of Elections.

Section 7. That the County Commissioner of Elections shall prepare all ballots and election registers and other supplies as necessary for the proper and legal conduct of this election and the Secretary of the Board is authorized and directed to cooperate with the Commissioner of Elections in the preparation of the necessary proceedings.

Section 8. That the Secretary is directed to file a certified copy of this Resolution in the Office of the County Commissioner of Elections to constitute the "written notice" to the County Commissioner of Elections of the election date, required to be given by the governing body under the provisions of Iowa Code Chapter 47.

**Pantry need keeps growing**

so I went to college, a couple different ones actually, and got my teaching certificate," Gaudette said.

From there, he ended up in Washington D.C. teaching at all black schools in the district.

"I was the only white guy in the place," he said. "And it was very interesting. I would spend sometimes three hours a night preparing for class. I taught different things like history, English, and wherever they needed me."

It was in the district that he met his wife, Mary Ann, who was also employed by the district. He said they have been married now for close to 15 years.

He said the food pantry has undergone many changes during his leadership, including going from the sub-basement at the United Methodist Church to the current location in the former Ivor Fowler Library across from McDonald's on Business 61.

"When we were in there, we really had no space. There were a lot of small food pantries around the area and really you just came to the door and we handed you a bag of food. That was how it worked."

He said there was very little refrigeration at the church and food had to be cycled quickly between the time it was received and the time it was handed out.

Now, at the library, the pantry has more space and can work the pantry more like a grocery where volunteers can help residents pick the food they need and point them to healthier options like produce.

"It's been very well received since we made that change. Now they feel like they're shopping instead of just getting a bag of food."

The food pantry on Wednesday was given funds from the United Way of the Great River Region and at the luncheon, Gaudette informed the crowd that just in the past year, the pantry has served more than 275 more people than the previous year.

The food pantry reports inventories and participants to the Iowa Food Bank, who brings food down to Fort Madison on a regular basis. But the amount they bring has increased steadily to help the local areas. The Food Bank truck, which also sets up a mobile bank for residents in the Shopko parking lot, brings about 7,000 pounds of food on each delivery and the pantry is only charged .07 per pound.

The pantry is also getting supplementation from all three area grocery stores and several restaurants with food recycling programs. They also get contributions from local churches and monetary donations that total about \$65,000 per year.

Gaudette said that he will continue to help the pantry with food pickups and some of their events like the holiday food baskets that help feed families during the holidays.

"I'm retired," he reiterated. "I need something to do."
